Work shall include, but is not limited to furnishing all labor, materials and equipment necessary for completing the following scope of work: specified clearing and grubbing; select excavation and demolition; rough and finish grading; installation of a splash park and water treatment system with associated electrical and plumbing; renovation of two buildings; installation of concrete sidewalk and ADA parking stall; installation of raingardens, drainage structures, BMP's and E&S controls; topsoil placement and seeding for lawns and site restoration; signage; plantings; and other work associated with improvements at the site. Davis Bacon Wage Rates apply to this Project.

A pre-bid conference will be held at the project site (intersection of 10th Avenue and Washburn Street in West Scranton) at 10:00AM on Monday, April 15, 2019. Attendance at the pre-bid conference is mandatory for all bidders.

All Bids shall be submitted on the forms furnished, in sealed envelopes, clearly marked "The Novembrino Splash Park & Recreation Complex" and addressed to City of Scranton, Office of City Controller, 2nd floor, 340 N. Washington Avenue, Scranton, PA 18503. They must be delivered or mailed to the City so as to arrive by the time of the bid opening. No bids will be considered which fail in any respect to comply with the bid conditions and requirements.

Bidders' proposals must be accompanied by a certified check, certified bank treasurer's check, bank cashier's check or bid bond in the form provided in the Bid Package. A satisfactory corporate surety shall provide security in an amount equal to 10% of the base bid. All bonds must be secured.

The Contract shall be awarded to the lowest, most responsible general contracting, plumbing and electrical bidder; however, the City of Scranton reserves the right to reject any or all bids or any part of any bid and to waive any or all irregularities, mistakes, omissions or informalities relative thereto. All bids shall be considered binding and shall not be withdrawn for a period of thirty (30) calendar days from the bid opening date without the consent of The City of Scranton.
