The successful bidder within ten (10) days notification of the award of the contract shall be required to furnish a performance bond and labor and materials bond in the amount of one hundred percent (100%) of the total contract price. The successful bidder will be required to submit certificates of insurance, as specified, including public liability insurance. The contract will be awarded to the lowest most responsible bidder; however, the City of Scranton reserves the right to reject any or all bids or any part of any bid and to waive any or all informalities in the bidding in connection with said project. Bidding shall be in compliance with Section 603 of the Administrative Code of the City of Scranton. The contract, when awarded, shall be subject to the Davis Bacon Prevailing Wage Act. All work shall start on or before April 20, 2020 and be complete by May 18, 2020. The successful bidder shall be an equal opportunity employer. Envelopes containing bids shall be plainly marked specifying work covered by the bid and delivered or mailed to the Office of the City Controller, 2nd floor, City Hall, 340 North Washington Avenue, Scranton, Pa 18503. The OECD requires bidders to submit a statement of bidder's qualifications with their bid. The City of Scranton, OECD, encourages minority and women owned businesses to participate in the bidding.
