1 MR. DIBILEO: Are there any comments on

2 3-C? If not, received and filed.

3 MR. SAUNDERS: Clerk's notes, and I

4 have nothing at this time, Mr. President.

5 MR. DIBILEO: Okay. Thank you, Mr.

6 Saunders. And we're right into citizens participation.

7 MR. SAUNDERS: Fourth order, citizens

8 participation.

9 MR. DIBILEO: Okay. Before I call up

10 the first speaker, I'd like again to welcome all

11 audience members both here and at home. I'd like to
12 remind those wishing to speak to please refrain from
13 making remarks of a personal nature, and also please be
14 considerate of our time constraints and the time
15 constraints of others by not exceeding five minutes for
16 your remarks.
17 Please try to limit your remarks to
18 city business matters, and if you would allow me, I'd

19 like to take a moment to comment on the election.

20 All of us just went through a very

21 emotional election just two days ago, and I want to

22 thank all those who voted, it was a good number of

23 voters that showed up, over 25,000, and I think was

24 fantastic, and that was your opportunity to voice your

25 opinion.

1 I want to congratulate Mayor Chris

2 Doherty on a hard fought campaign. Also, I would like

3 to take this opportunity to congratulate the City

4 Council winners, Janet Evans, who's not able to be here

5 this evening, and new to the City Council will be Judy

6 Gatelli. And also Sherry Fanucci, so I'd like to wish

7 them luck and congratulate them, also.

8 You know, many people in our city were 9 divided over this election, some were neighbors, some 10 were friends, and some were even family members, but 11 now as hard as it might be, as hard as it might seem, 12 we have to unit for the betterment of our city. We 13 have a great city with great people and we have to join 14 hands now and move forward. 15 I'd also like to take a moment and 16 thank those that were too young to vote. As you may 17 know, a lot of young people of all ages took an 18 interest and paid close attention to this election, and 19 I want to thank them for that. I think that that was 20 wonderful. Some had elections in their schools, some 21 had debates at their schools, and young people, as you 22 know, are our future, and I even heard that I won some 23 of those elections at the schools, and I thank that the 24 students for that.

25 But I hope young people learn something

.

from this election, to stand up for what you believe is
 right, to set your goals and your dreams high and to
 work hard and never give up, and don't let people tell
 you that you can't achieve something or that you don't

5 have a chance.

6 You know, about one year ago I was told 7 by a Washington, D.C. pollster, and this is mainly for 8 the kids, that I should not run for mayor, that I 9 didn't have a chance, they said it would be a daunting 10 mission and they called it a real long shot, but even 11 though the odds were stacked against me, in the end we 12 ended up making it a race, and our campaign was up 13 against long odds, as the pollsters said, we were up 14 against a million-dollar campaign. 15 Our only newspaper, who happen to be 16 contributors to my opponent's campaign took their shots 17 at every opportunity that they had, and high ranking 18 politicians from both parties endorsed my opponent, and 19 these not sour grapes, I just happen to mention this. 20 I'd like to get something straight, 21 though, I did not run a negative campaign. I'm proud 22 of the fact that I never called anyone a liar and we 23 never lied about anything. 24 It was obviously the challenger in the 25 race and had my differences on the issues. We used

1 some humor or at times, and you have to have a sense of

2 humor, but we brought some important issues to the 3 forefront which hopefully will not be ignored. 4 But I want to bring up an example of a 5 charge of negativity that is, I think, a great example 6 of the misinformation that's out there. 7 In the newspaper yesterday was an 8 article from Chris Kelly. Chris Kelly's a good 9 reporter, but in the article he says here, What your 10 advisors probably did not tell you is that win or lose, 11 some of that mud will stick to you for life, and that's 12 just fine with the mudslingers. 13 The attacks were particularly vicious 14 on a certain young woman in the mayor's cabinet. Call 15 me old fashion, but I was raised to defend a woman 16 under attack by cowards. You would never stand by and 17 allow the same attacks on your mother, wife, sisters or 18 daughters, but that's just what you did here. Shame on 19 you, sir. 20 You know, I read that, and I honestly 21 had no idea what Chris Kelly was talking about, and a 22 little while later I was speaking to a friend and I 23 said, Did you read the Chris Kelly article in the 24 newspaper? And he said, Yeah. And I said, What did he 25 mean by me allowing attacks on a woman in the mayor's

- 1 cabinet? And my friend said, Well, what he's referring
- 2 to is Sara Hailstone, I'll say her name, that she took
- 3 some attacks, I suppose, from anti-Doherty supporter,
- 4 not a pro-DiBileo supporter, an anti-Doherty supporter.
- 5 It was actually a newspaper that was put out the last

6 weekend.

- 7 And I'll be honest with you, after it
- 8 was out, I took a look at it, never read anything, and,
- 9 therefore, I had no idea what that article was

10 referring to.

- 11 I had enough of a challenge trying to
- 12 figure out what I was going to say or do, let alone
- 13 what any anti-Doherty supporter was going to say or do.
- 14 But I had to ask that, and I'd like to
- 15 apologize to Ms. Hailstone, but I can't, because I had
- 16 nothing to do with it. And I wasn't even aware of it,
- 17 as I just explained.
- 18 But, you know, we received, I think,
- 19 11,517 votes, and I can't control what any of those
- 20 people might say or do, except for perhaps my family
- 21 members. I probably could control them, but, I hope,
- 22 but beyond that, I really can't control what other

23 people say or do.

24 But overall, it was a wonderful

25 experience, I made a lot of friends, and we had a lot

1 of fun in the process, and I would do it all over again

2 if I had to, and probably will. So, once I'm out of

3 here after the first of the year, try not to forget me.

4 But lastly, I just want to say that I

5 have the best group of core supporters in the area, and

6 I'd like to thank each and every one of them, and also

7 thanks for allowing me an opportunity to say this.

8 That's all.

9 Thank you very much. And with that

10 said, the first person on the list is Andy Sbaraglia.

11 MR. SBARAGLIA: Andy Sbaraglia, citizen

12 of Scranton. Fellow Scrantonians, regardless of what

13 The Times says, my main function of being here was

14 honest and efficient government, and that's the only

15 thing I ever cared about.

16 Whether it -- whether I seemed to

17 attack the mayor, it didn't really bother me, because

18 it was truth I was saying, and truth I stand by.

19 Political parties get their revenue

20 from patronage and contracts. We have a million

21 dollars spent in this campaign that's going to really,

22 really play heavy on this city.

23 Everything that comes before you until

24 you leave, you should look and see if it's political

25 payback, even though you're all Democrats.

1 Maybe that was the thing that was wrong

2 with the whole campaign to begin with that, that we

3 only had one party running, even though we had two

4 candidates.

5 But whatever it was, it's over, but it

6 still hasn't changed the facts. We're still in debt,

7 we still got crime, and we still got a lot of other

8 problems, mainly financial.

9 Now, I'm waiting for that, what is it,

10 CF-something loan that comes up so many, many times to

11 come up again. Well, let's think about mortgaging that

12 to a bank, that way we still own it and we just pay off

13 a loan, rather than sell it outright, because when we

14 sell it outright, it's gone and goes into a kitty where

15 he doles it out, but if you mortgage it, and it goes

16 into the treasury, it goes to pay off our debt, and

17 that's our problem, debt, and we got a lot of debt.
18 You got legislation before you
19 transferring money from one account to another account
20 for debt. Now, I don't know if they really saved \$72
21 million on our street lighting, but it's in there.
22 Now, whether we got that much savings,
23 I don't know, but if we do, we should bring it out,
24 then the contract was a good thing, because I think it
25 sort of would be positive one way or another with that,

12

1 if we got \$72,000 that are freed up, but there's no way
2 of checking, because no one ever did an analysis on
3 these things, no one ever saw how much the lights were
4 going to cost after we bought them, how much we were
5 going to save with the loan that we have to pay off
6 that has to be added in, and then also how much did we
7 have to pay to have somebody go out and fixing these
8 lights.

9 That was never brought up. I never

10 seen any figures at all brought up before any of you,

11 actually what goes into the, you know, the nuts and

12 bolts of a problem, and that's what it should be.

13 Everything that comes before you now, you should look

14 for the nuts and bolts, you should ask questions, you

15 should know everything about it.

16 In fact, when I come up before you and

17 say, I want to ask a question about this or that, you

18 should be able to give me an answer. I shouldn't have

19 to sit and ask questions, I should be willing to listen

20 to you, which I will.

21 I'll gladly sit here and listen to you

22 if you know the facts on all these things, because

23 that's the only way you learn.

24 Sometimes whatever you read you don't

25 necessarily get the whole story or you may get a

1 slanted story, and I'm not crazy about that. I like

2 the straight story.

3 I told you many times before, I'm a

4 black and white person, either it's right or it's

5 wrong. I didn't believe we should be putting money up

6 in Dunmore at one and a half percent interest. I

7 talked against that many, many times, but it fell on

8 deaf areas.

9 I don't know if you could have changed

10 it now. I don't know how the original contracts were

11 written up, whether we're locked in or not, but we

12 invested a lot of money up there in Dunmore, and I

13 don't know what we're getting out of it.

14 I asked this many times I came before

15 you how, much interest are we getting on the money

16 deposited up in Dunmore, and I have never got an

17 answer. In fact, many, many questions I asked you, I

18 never got an answer.

19 MR. SAUNDERS: Mr. Sbaraglia, what --

20 where in Dunmore?

21 MR. SBARAGLIA: Fidelity Bank. You got

22 money up there from the -- from the, what is it, ANC

23 Loans that has to be paid off, and also money up there

24 from -- I think you got the money deposited when you

25 sold the golf course.

And somebody actually told me that that
 golf course is down at the register's office as one and
 a half million was paid for it when it went on the
 books down there, and I know they got \$3.some million,
 so there's quite a discrepancy there, but there's
 discrepancy everywhere in the tax.
 You sat there, maybe you didn't

8 anything to do, maybe you weren't even informed, but we

9 lost millions of dollars taken off our tax rolls, not

10 only with the KOZs, that alone took a lot of money out

11 of the tax rolls, but then when they went down to

12 reassess, that alone took another \$1.7 million and

13 assessment was gone out the window.

14 No one ever went down there to

15 complain. I ain't saying you people knew about it, but

16 the school board didn't either.

17 So, I don't know where our officials

18 are when it come to protecting the money that belongs

19 to the taxpayers. And believe me, in a few months,

20 whatever do your best. Thank you.

21 MR. DIBILEO: Thank you, Mr. Sbaraglia.

22 Don Hart.

23 MR. HART: Thank you, Mr. President,

24 and the rest Council for the opportunity to make a few

25 remarks here tonight.

### 15

1 My name is Don Hart, and I live at 1810

2 Delaware Street Delaware Street in Dunmore, I'm an

3 international representative for the bricklayers and

4 allied craft workers union.

- 5 This construction season that we are
- 6 just ending has been a great one for the members of the
- 7 BAC that I represent that live and work in this area,
- 8 in Scranton and the surrounding areas.
- 9 For the first time in a long time, our
- 10 members have been able to stay at home instead of
- 11 travelling to New Jersey, Washington or Philadelphia to
- 12 do work.
- 13 For the first in many years, lots of
- 14 them were able to have dinner with their family,
- 15 instead of with Colonel Sanders, they were able to
- 16 watch their kids play little league and soccer, instead
- 17 of sitting in a hotel watching a baseball game.
- 18 I've been here several times asking you
- 19 to reconsider the CRF issue. I think that it's about
- 20 time that you look at it again and you revisit it,
- 21 because it's really for the betterment of the city and
- 22 to keep progress -- to Scranton moving forward in a
- 23 positive way.
- 24 I understand you have some concerns,
- 25 two of them that I understand are that you won't have
- 16
- 1 any say over the mayor's spending of this money, which

2 even if he could, I don't think he would, but I know
3 that Council will have the final say on where the money
4 goes, and if I'm not wrong, the money from the loan
5 program will stimulate more money, trigger more
6 targeted money, and it's only for specific purposes,
7 it's not for retiring debt or any other reasons, for
8 economic and community development, and that's been
9 what has been helping our members to be here and be
10 with their families, rather than traveling and working
11 out of the area.
12 So, once again, I would like to ask you
13 to reconsider, revisit this. I understand the majority
14 of the members on this board are in favor of this now,
15 and I think it's time we get it done. Thank you.

16 MR. DIBILEO: Thank you, Mr. Hart.

17 George Moran.

18 MR. MORAN: Mr. Moran, can you give me

19 just a second? Regarding Mr. Hart's remarks, I had

20 said in the past that I had spoken to Mr. Courtright

21 and Mrs. Evans about the CRF situation, and I've done

22 that again recently, and I actually had a conversation

23 with Mr. Courtright, and I'm going to call the mayor

24 tomorrow and ask him if he would speak to Mr.

25 Courtright, and if he is able to give him a couple of

1 things Mr. Courtright is looking for, I think Mr. 2 Courtright is going to be willing to make a motion to 3 pass the CRF -- or to revisit the CRF legislation for 4 another vote. Maybe you'd want to --5 MR. COURTRIGHT: Yeah, I was going to 6 speak later on about it. One the things that stopped 7 me from considering the motion was the many members of 8 the trade unions that came here, and I felt like they 9 were trying to force me into doing something I didn't 10 want to do, so I -- there was no way I was even going 11 to even reconsider it during the election, because I 12 thought you made it political, so I -- it's no secret 13 as Mr. DiBileo campaigned, I walked with him every day 14 with him knocking on doors, and every day he'd ask me 15 about it, you know, and I wasn't going to sit up here 16 week after week and try to defend him, I just kept 17 quiet about it. 18 He believed and he thought I should 19 look at it, but I said, you know, I have questions, and 20 the mayor didn't want to come and speak on it, and 21 every time another guy, or I shouldn't say guy, a 22 member came, I felt -- I understand that they want to

17

23 stay in this area, and I've been accused of being24 pro-union, I can't imagine how anyone would say I'm25 anti-union, and then I had a call from an individual .

18

1 that has something to do with the union newspaper 2 saying that certain individuals were saying I was doing 3 this because I was against the union members, and they 4 were, I'm not going to mention any names, but I know 5 there was two gentlemen they said were down there 6 saying, Mr. Courtright's against labor unions, which 7 I'm not, and I never have been, and I never will be, 8 but I just thought it got to be more political than it 9 was for the benefit of this city. 10 And if Mr. Doherty would like to speak 11 with me, Mr. DiBileo is going to call him and speak to 12 him hopefully, and if he does and I get the questions 13 that I have answered satisfactorily, I most certainly 14 will make the motion. 15 But if I don't get them answered 16 satisfactorily, I won't make the motion. I have a 17 couple of concerns and I don't choose to make it 18 political, so we'll see how it works out. 19 If Mr. DiBileo speaks to him and Mr.

20 Doherty speaks to me and it happens before next week, 21 you'll find out whether my questions were answered or 22 not by whether I make the motion or not, and I hope it 23 works out well for everybody, both the members of the 24 trade union and the residents of this city, and that's 25 my concern.

1 You know, it's a little over two years

2 ago that I made a statement, and I used to say it

3 almost every week, I'm sorry to hold you up, sir --

4 MR. MORAN: That's okay.

5 MR. COURTRIGHT: -- that when I got

6 into this, I wanted to make it about people and not

7 politics, and, boy, the last two years were really hard

8 for me to do that, so hopefully now I can continue to

9 try to make this particular issue about the people of

10 this city and the workers of the city, and not

11 politics, so maybe by next week we can have something

12 worked out. And that's all I have to say, Mr.

13 President.

14 MR. DIBILEO: Okay. Good. And I'll

15 call the mayor's office tomorrow, and I'll ask him or

16 at least leave a message for him to call Mr. Courtright

17 and see if we can't get Mr. Courtright's questions

18 answered. Thank you very much.

19 MR. COURTRIGHT: Sorry.

20 MR. DIBILEO: Go right ahead, Mr.

21 Moran.

22 MR. MORAN: George Moran, Green Ridge.

23 First of all, I'd like to say about the Chris Kelly

24 column, that was done on Election Day, so he actually

25 was trying to hurt somebody, but in there if you read

## 20

1 further on, calls speakers low-lifes and cowardly, the

2 people that come up and speak, but we are low-lifes,

3 that's for sure, we're people that come here because we

4 care about the city, and we're sure not cowardly,

5 because we come here.

6 And I think The Times is acting kind of

7 irresponsibly to even put something in there. They owe

8 us an apology at least.

9 Now, next day after the election they

10 say about how, this is in The Times, how Janet Evans

11 would be a logical choice to be the president of

12 Council, but then it says underneath about how Mrs.

13 Gatelli could serve as a swing vote here, too, throwing

14 the presidency to a Council member more in line with

15 Mr. Doherty.

16 So, what are we going to have, a rubber

17 stamp, they're going to get everybody up here that's

18 just going to be voting for Doherty and that's it?

19 That don't -- that's what that sounds like.

20 About Southern Union, now, the

21 president quits, resigns or whatever, so that ends

22 that. So, is that completely shot now? Are they going

23 to put any people working there or not at Southern

24 Union?

25 MR. DIBILEO: That, I really don't

### 21

1 know, Mr. Moran, I'm not certain what the situation is2 there.

3 MR. MORAN: When they talk about, like,

4 losing the jobs, I don't ever remember them saying

5 bought ITT, it was above the Scranton Dry, like, at the

6 beginning of the year, they folded and they lost 60

7 jobs there, and I know a couple of people that worked

8 there, and they made a half-decent pay, too.

9 So, when he starts with his 3,000 jobs

10 or whatever he brought here, I wonder if he deducts the

11 60 that lost their jobs there.

12 And when they take these houses down to

13 put the river project in and stuff, on those lots, who

14 takes care of them lots after they're done? Like, is

15 that a city -- is the city responsible for keeping them

16 clean and --

17 MR. DIBILEO: I think the city does, if

18 I'm not mistaken.

19 MR. MORAN: That lot on Nay Aug Avenue,

20 the weeds are taller than me already.

21 MR. COURTRIGHT: We called on that

22 several times throughout the summer, and a couple of

23 times they did clean the lot, but I agree, not as often

24 as they should have.

25 MR. MORAN: There are houses still in

1 that area, but between the stores there and everything,

2 I'm sure there's going to be a lot of rats and who

3 knows what other kind of varmints are going to come out

4 of there.

5 MR. COURTRIGHT: They cleaned up a lot

6 of debris out of there the one time, but they didn't

7 cut it as often as they should have.

8 MR. MORAN: It's pretty tall. I don't

9 think they cut it at all.

10 MR. COURTRIGHT: We'll try to see if

11 they can do a better job next year.

12 MR. MORAN: There's one up on Sanderson

13 Avenue and Deacon Street, I mean, that's a mess between

14 the garbage and -- the people cut that at least once

15 this year, but, I mean, people just seem to just throw

16 their garbage there. I just want to know who is

17 responsible for that. And that's it. Thank you.

18 MR. DIBILEO: Thank you, Mr. Moran.

19 You know, I know that everyone up here makes up their

20 own minds on issues, and also I know that the new

21 Council members coming on board will make up their own

22 mind, too, like Judy Gatelli an Sherry Fanucci, so I'm

23 not certain what that article was referring to as far

24 as who they might be lined up with. I didn't make

25 sense out of that article Bill Jackowitz.

1 MR. JACKOWITZ: Good evening, City

2 Council. Bill Jackowitz, taxpayer, Scranton resident,

3 registered independent voter, retired military.

4 I would like to offer my appreciation,

- 5 respect and congratulations to the men and women of the
- 6 United States Marine Corps, who are celebrating their
- 7 230 birthday today.
- 8 I would also like to recognize all the
- 9 Veterans from the past, present and future, and I hope
- 10 everyone has a wonderful Veteran's Day tomorrow.
- 11 I would also like to congratulate Mayor
- 12 Doherty, his staff, his supporters, you have four more
- 13 years. Good luck.
- 14 Mr. DiBileo, you did the best, we all
- 15 appreciate it.
- 16 Mrs. Evans 17,277 votes,
- 17 congratulations.
- 18 November 2001, Mayor Doherty, 13,998
- 19 votes, Mr. Bolus 5,948 votes, Mr. Costa, 1,235 votes.
- 20 Total votes, 21,181.
- 21 November 2005, these numbers are from
- 22 yesterday, so they may be a little bit off, but I don't
- 23 think they're off by much, Mayor Doherty 14,001 vote,
- 24 Mr. DiBileo, 11,435 votes. Total votes, 25,346. As
- 25 you can see, Mr. Doherty gained a total of three votes,
- 24
- 1 three votes, since 2005.

- 2 My point being that there are a large
- 3 percentage of voters in Scranton that are dissatisfied.
- 4 These voters deserve to have their issues addressed,
- 5 also. We all pay the same taxes.
- 6 Mrs. Evans received the most amount of
- 7 votes 17,277. It's funny, because Mrs. Evans and Mr.
- 8 Doherty have not seen eye to eye for the last two
- 9 years, so what I'm thinking is maybe the voters of the
- 10 City of Scranton are trying to tell our elected
- 11 officials, it's time to get it together, people. It's
- 12 time to start working together, because we have the
- 13 largest vote getter, Mrs. Evans on one side, Mr.
- 14 Doherty, the newly re-elected mayor on the other side,
- 15 and I really think that the voters of the City of
- 16 Scranton are trying to tell us.
- 17 Let's get it together, let's start
- 18 working together, let's do away with all the
- 19 trash-talking and everything else that's going on.
- 20 As a proud Veteran, I wear a bracelet
- 21 every day since March of 2003, the bracelet says,
- 22 Specialist James M. Keel, US Army, 23 March '03, Iraq.
- 23 That's the day that Specialist Keel was killed in Iraq,
- 24 he was one of the first soldiers killed in the war.
- 25 I never met this man, I never met his

1 family, but as a proud Veteran and a supporter of all 2 Veterans, I will wear this bracelet until the day that 3 I die. 4 I feel that all elections are about 5 Veterans. Without Veterans, there would be no 6 elections. 7 In Iraq this year, 65 percent of the 8 citizens voted. There were being shot at, bombs were 9 exploding, and voters were Barre being killed. 10 The turnout in Scranton 2005, 11 53 percent; 2001, 44 percent; 1985, 71.2 percent, and I 12 don't think anybody was being shot at or bombed in 13 Scranton. I don't know why, people just don't turn out 14 to vote. 15 To all our elected officials, the 16 coverup is what leads to trouble, the coverup is what 17 leads to trouble. Examples, Watergate, Pete Rose, 18 Washington, DC, 2005. 19 The door to City Council is open for 20 all officials and citizens. I believe the door to the 21 mayor office will also be open now for all city 22 officials an citizens.

23 My belief in life and public safety is

24 much more important than money, and it always will be.

25 Life is more important than money ever will be.

1 To the Scranton Times, you are

2 definitely unfair. Examples, the accusations that Mr.

3 DiBileo harbored gang members never was substantiated

4 and never was proven, but yet that article was written.

5 Last week editorial accusing Mr.

7 West Scranton never was substantiated or never was

8 proven, but yet those articles were written. And they

 the EMS tax should not be used for tax abatement
 because of the fact that somebody is getting taxed and
 then that would be redistributing back tax to Scranton
 tax owners, and would be hypocritical in regards to our
 mission.

11 We also feel that infrastructure at

12 \$1.8 million that's estimated would not be enough to do 13 much for the infrastructure, so we recommend that this 14 money be given for police and fire, okay, and we hope 15 that the mayor would follow through on that, also, and 16 the City Council will through on that, also, for those 17 reasons.

18 The three budgets, you know, we have19 the county and the school district, the school district20 is planning their budget later on this week, they're

21 meeting on Wednesday, the second phase of the school

22 study, and we know we're going to get hit with a tax

23 with that, there's no doubt about it.

24 Presently they're \$131 million in

25 debtness, and when we met with them here, we were told

1 that they have a leeway of going another \$250 million.

2 Well, we as taxpayers don't want them

3 to go and just borrow money, okay? This borrowing has

4 got to stop.

5 And the City of Scranton, for instance,

6 we again are over \$200 million, \$205 million, and the

7 mayor wants to borrow, what is it, \$4 million for this

8 budget for operating expenses, you should never borrow

9 for operating expenses, and it's got to stop because of

11 one credit card to pay off another credit card, and it

12 just doesn't work. Why don't somebody get it, okay?

19 and we have to pay a garbage fee, and if you use the
20 ballpark fee, we have to pay a ballpark fee.
21 I mean, we're overtaxed, okay? And
22 with this winter, again, as you all know, it's been
23 predominantly about the heating fuel, people are just
24 not going to make it fly, they're just not going to
25 make if fly with another tax.

So, you really got to keep this in
 mind, and I would appreciate this City Council, because
 I know it's going to come back, it appears, if it's
 like other years, and that's the way it should be, and
 I would never want to see a Council to rubber stamp
 anything.
 And the next four years to come, I hope
 that City Council does not rubber stamp anything that

9 comes down here from the city administration. I hope

16 would like to honor you. Please call 343-1194 and give

17 them your name and your telephone number so we can get

18 back to you when our next meeting will be. That's

19 number one.

20 Number two, there was an increase in

21 persons registered to vote this year, some 52 people.

22 The total population for those who were able to vote

23 was 48,000. Of the 48,000, approximately 26,000

24 actually voted.

25 That means we went from 20 percent in

### 48

1 the spring to 50 percent. I hope that it was because

2 we asked you to vote. We asked you to do more than
3 that, we ask you to get involved with the city, we ask
4 you to get involved with the politics of the city, and
5 I mean all branches of government, the school board,
6 your school, your PTAs, your City Council, your
7 commissioners.

8 Please become -- the only way we're

7 every day just to go to work somewhere and make a

12 An interpreter was on hand for them.

13 When they got to their voting place,

14 they were denied the help. They were very intimidated,

15 even degraded at the voting booth.

16 A comment was made to the effect of

17 Gary is pulling them out of the woodwork, he even has

18 these dirt bags coming down here. They don't pay

19 taxes, and if they don't speak English, how do they

20 know who to vote for?

21 I'm sure I don't need to say that this

22 comment was made by the DiBileo camp. Keep in mind

23 this was the first time they were voting, and they were

24 faced with lawyers, sheriffs, poll watchers, the judge

25 of election and county judges arguing over whether or

2 registered nearly 40 people, 40 more people who are now

3 exercising their civic duty and privilege to vote.

4 I'll be anxious to see if they dare go to that voting

5 place again.

6 At yet another location, a constable

7 was standing at the entrance showing his badge, along

8 with campaign paraphernalia. That's not allowed.

9 He was told about it, removed the

10 paraphernalia, but yet still stood at the top of the

11 stairs with his badge out. Total corruption, it's

12 disgusting.

13 Now I will move onto the newspaper. My

14 suggestion is that all of the 11,435 who voted for Gary

15 cancel their subscription to the newspaper. I did it a
