- 5 MS. GARVEY: 3-D, CONTROLLER'S REPORT
- 6 FOR THE MONTH ENDING NOVEMBER 30, 2005.
- 7 MS. GATELLI: Are there any comments?
- 8 If not, received and filed.
- 9 MS. GARVEY: 3-E, There are no Clerk's
- 10 Notes this week. And Fourth Order, Citizens
- 11 Participation.
- 12 MS. GATELLI: Before I read from the
- 13 sign-in sheet, I would just like to say that we welcome

- 14 everyone to come up and speak.
- 15 As you know, the caucus starts at 5:30,
- 16 and you're all welcome to join us in the caucus room to
- 17 discuss any problems before the meeting. We will
- 18 continue to do that every week, and I hope that some of
- 19 you can make it. More on an informal basis, we can
- 20 have some conversations together and maybe come up with
- 21 some ideas.
- 22 The five-minute rule will be strictly
- 23 enforced. If you ask a Council member a question and
- 24 they respond, that will be part of your five minutes.
- 25 If you would like them to respond later in motions,

- 1 then you can have your full five minutes.
- 2 I would ask that you have respect for
- 3 everyone. We are all mothers and fathers up here, and
- 4 we don't want to be embarrassed, as we would not
- 5 embarrass you. So, please, let's all treat each other
- 6 with kindness, and we'll go a long way.
- 7 My mother always taught me that you get
- 8 more bees with honey. So, let's try to work together.
- 9 That's our goal.
- 10 Five people up here, and you people out

- 11 there, and we're going to work together to make this a
- 12 better place. The first speaker, Andy Sbaraglia.
- 13 MR. SBARAGLIA: Andy Sbaraglia, citizen
- 14 of Scranton. Fellow Scrantonians, well, first I'd like
- 15 to congratulate our new Council members and all the
- 16 Council members for sitting up there in that hot seat,
- 17 which is probably going to get real hot.
- 18 I have something about this bridge
- 19 we're building over the gorge at Nay Aug, exactly what
- 20 does the mayor have in line with the other side of the
- 21 gorge at Nay Aug?
- 22 Now, this bridge is going to cost the
- 23 taxpayers \$763,000 to go over it. It costs the city
- 24 \$127,000. Does anybody know anything about the
- 25 contracts for this bridge, who got the contract, and

- 1 exactly what he has in mind to do on the other side of
- 2 the gorge, which is important, because that used to be
- 3 where they had Luna Park. I don't know, I guess you
- 4 might, Judy, do you remember the bridge that went over?
- 5 Okay.
- 6 MS. GATELLI: Andy, I'm not that old.
- 7 Now, just because my hair is gray --

8 MR. SBARAGLIA: I am. Okay. There

9 used to be a bridge over the gorge, we had a bridge

10 over there, we tore it down for safety reasons, okay,

11 that's the reason why we tore it down, the kids used to

12 jump off it.

13 Now we're in the process of crossing

14 the gorge with another bridge, but the other side is

15 probably just wooded area. What does this mayor want

16 to do with the other side of the gorge that we need a

17 bridge across it? That is the first question.

18 The next question is, Who got the

19 contracts for this bridge? Because it's a bridge to

20 nowhere at present, because on the other side it's

21 probably nothing more than just old grove, not even old

22 grove, but grove forest because it hasn't been crossed

23 in a long time. The only people that go there is me

24 when I used to hike up there with the kids.

25 MR. COURTRIGHT: Andy, you know, I'm

1 sure he has something in mind. He's not going to build

2 a bridge to nowhere, so maybe we can ask Kay to send a

3 letter down to him and ask him, and when we get the

4 answer, we'll come back to you with it, all right?

5 MR. SBARAGLIA: You better ask how much

6 is it going to cost us, because even a better question

7 than building the bridge to nowhere, because the bridge

8 to nowhere is only costing us \$127,000, but to develop

9 that area may cost half a million dollars.

10 MR. COURTRIGHT: Well, Kay, if we can

11 just ask for his entire plan and the cost of it, then

12 possibly if he can get us that by next week.

13 MR. SBARAGLIA: Okay. Let's look into

14 some old questions. Now, we all know that The Icebox

15 owes us \$600,000, which we have never gotten, and

16 probably never will get in my lifetime, because you

17 should read that old contract, the original contract,

18 you should read, and then the renewed contract, the

19 addendum they added to the original contract, because

20 the original contract called for that site for 198

21 years for a dollar a year.

22 Of course, when they come out with the

23 addendum to it, they cut it down to \$600,000, but they

24 put a stipulation in that he has to agree to pay

25 \$600,000, he has to make a deal with the Scranton

1 Redevelopment Authority and so forth and so on before

- 2 any money comes to us, so I wish you can see if you can
- 3 put a little force, you know, a little -- well, a
- 4 little pressure to see if we can get that \$600,000,
- 5 because it's a shame to look at that site and to know
- 6 that we're owed that money and we ain't going to get
- 7 it, and the worst part about it, if you don't get a
- 8 raise with this and that KOZ runs out of that, the city
- 9 owns that, that property is owned by the city and only
- 10 leased for a dollar a year, so I don't know how it
- 11 would affect the taxes.
- 12 Would that man have to pay taxes on
- 13 land that the city owns or would we be responsible as
- 14 the taxpayers to just take the loss? These are
- 15 important questions to look at. These are just some of
- 16 them. I got about a thousand. I just didn't want to
- 17 bring them all up here.
- 18 But I would like you to think about Nay
- 19 Aug and the free swimming. I know you can't do much
- 20 with Nay Aug, except take it back, which I requested
- 21 that a 1,000 times to take -- disband the Recreational
- 22 Authority, take Nay Aug back into the city and actually
- 23 do what he was supposed to do up there.
- 24 That place was actually given to the
- 25 city for a recreational site for all kids to enjoy.

- 1 All the pools in the city were placed in there, and we
- 2 have been paying for them all them years for kids to
- 3 enjoy.
- 4 Last year was an ungodly hot summer.
- 5 As you know, I think they had a dollar a day fee up
- 6 there, I believe that was the fee for the pools, I'm
- 7 pretty certain that was the fee, but I think you should
- 8 put a little stipulation in there when the temperature
- 9 rises above 87 degrees, it should be free. Thank you.
- 10 MS. GATELLI: Thank you. Les Spindler.
- 11 MR. SPINDLER: Good evening, Council,
- 12 Les Spindler, Scranton resident. First of all, I would
- 13 like to wish everybody a Happy New Year, I'd like to
- 14 welcome the new Council members and wish them lots of
- 15 luck. I'd like to congratulate Kay Garvey on her new
- 16 position, Congratulations, Kay, and Attorney Minora,
- 17 also.
- 18 MR. MINORA: Thank you.
- 19 MR. SPINDLER: Okay. I think on
- 20 January 2, there was a great injustice done.
- 21 Mrs. Evans served this city and its citizens very
- 22 admirably for two years as vice president of Council,

- 23 and as chairperson of finance, she looked out for the
- 24 good of the taxpayers, also Mrs. Evans received by a
- 25 large amount more votes than anybody else.

- 1 Going by these facts, I think
- 2 Mrs. Evans deserved to be president, with all due
- 3 respect, Mrs. Gatelli.
- 4 Now, it looks like we're going to have
- 5 another rubber stamp Council as the past years. Once
- 6 again, the taxpayers are going to suffer.
- 7 Moving on on a couple questions, did
- 8 George Parker ever speak to the people on Hollow Avenue
- 9 about the problem they had up there?
- 10 MR. COURTRIGHT: I don't know if they
- 11 had the meeting yet, do you know, Kay? Could we ask
- 12 Mr. Parker?
- 13 MS. EVANS: If I might. Mr. Spindler,
- 14 the meeting has not yet occurred, however, arrangements
- 15 are being made, and I'll be notified when that does
- 16 occur, because I intend to be present.
- 17 MR. SPINDLER: Okay. The next thing,
- 18 this is a problem I've spoken about, this is the third
- 19 Council now I've brought this problem before, yesterday

- 20 it rained, the front of my house -- the sidewalks in
- 21 the front of my house get flooded.
- 22 It's a problem the city caused. They
- 23 put that handicap accessible corner in. All the water
- 24 from the street comes into my property. I can't get
- 25 out my front door, I can't go down my front steps, it's

1 all flooded.

- 2 This is the third Council I brought
- 3 this problem up for, and it still has not been solved.
- 4 MS. GATELLI: What's your address, Mr.
- 5 Spindler?
- 6 MR. SPINDLER: I'll tell Neil.
- 7 MS. GATELLI: Okay.
- 8 MR. SPINDLER: That's all I have.
- 9 MS. GATELLI: Thank you very much.
- 10 Please refrain from applause, thank you. Phyllis
- 11 Humphrey.
- 12 MS. HUMPHREY: I want to congratulate
- 13 everybody that's here, and I've been praying for
- 14 Mrs. Evans' husband. She's been going through a real
- 15 lot, and she's very blessed.
- 16 MS. EVANS: Thank you.

- 17 MS. HUMPHREY: And I'm praying for
- 18 everyone. But this is a -- I have a letter here, and
- 19 then --
- 20 MS. GATELLI: Excuse me. Can we have
- 21 your name and address, please?
- 22 MS. HUMPHREY: My name is Phyllis
- 23 Bernadette (UNTRANSCRIBABLE) Humphrey, and I live at
- 24 499 Mulberry Street in Scranton, Pennsylvania. My
- 25 mission is for ecumenical peace for the reconciliation

- 1 of churches, reconciliation of hearts.
- 2 MS. GATELLI: Mrs. Humphrey, I don't
- 3 mean to be abrupt, but we need to talk about city
- 4 business.
- 5 MS. HUMPHREY: This is about senate
- 6 business with Washington. It's the ACLJ, American
- 7 Center of Law Justice.
- 8 Dear Friend, European matters, I want
- 9 to make sure it counts. I have enclosed petitions to
- 10 the U.S. senators to insure they know where the stand
- 11 concerning the future of this country and the makeup of
- 12 the Supreme Court of the United States. You are
- 13 already know --

- 14 MS. GATELLI: Mrs. Humphrey, excuse me,
- 15 but we have nothing to do with the Senate of the United
- 16 States, so I'd ask you again --
- 17 MS. HUMPHREY: You have to do with law
- 18 and justice, right? I have a letter sent to the Civil
- 19 Rights Liberty Union.
- 20 MS. GATELLI: This is a City Council
- 21 meeting, and it has to be pertaining to city.
- 22 MS. HUMPHREY: Oh, okay, city business.
- 23 I'm a victim of abuse and crimes in the City of
- 24 Scranton, and I had two recent very bad attacks, which
- 25 I'm pursuing with the police department, and I know

- 1 they are going to support me in this.
- 2 There has been break-ins in the
- 3 churches, desecration, not only desecration of
- 4 churches, desecration of priests, desecration of my
- 5 faith, desecration of human beings here in our town.
- 6 People have been abused, and there's people that have
- 7 been used and abused, and I have a lot of proof to
- 8 exonerate a lot of our holy priests that are sitting in
- 9 jail at this point, and everything has been handed
- 10 over. Due to this, I had sexual harassment from one

- 11 person and I was attacked --
- 12 MS. GATELLI: Mrs. Humphrey, I'm sorry,
- 13 but we can't talk about those things at a Council
- 14 meeting. I'm going to ask you to, please, sit down.
- 15 MS. HUMPHREY: Okay. No. Excuse me --
- 16 MS. GATELLI: You cannot talk about
- 17 sexual abuse cases, that needs to go to the district
- 18 attorney's office.
- 19 MS. HUMPHREY: It's going to go to the
- 20 district attorney's office, but nobody has --
- 21 MS. GATELLI: Please, please, city
- 22 business only.
- 23 MS. HUMPHREY: This has to do with the
- 24 city, about the crime in the city, and me being a
- 25 victim --

- 1 MS. GATELLI: Oh, the crime is
- 2 absolutely a problem.
- 3 MS. HUMPHREY: I haven't seen anybody
- 4 come and show up to examine the crime area or anything,
- 5 I don't know what's going on there, but this holy
- 6 statue represents our church, everyone, goes to
- 7 Saint Ann's. Our police are dedicated and our city is

- 8 dedicated to St. Ann --
- 9 MS. GATELLI: Mrs. Humphrey, we can't
- 10 talk about saints at a City Council meeting.
- 11 MS. HUMPHREY: No, I'm talking about
- 12 the break-ins and the crime.
- 13 MS. GATELLI: There's a separation of
- 14 church and state, and we're not allowed to talk about
- 15 church at a Council meeting.
- 16 MS. HUMPHREY: That's why we need Mr.
- 17 -- Judge Alito, we need these people in, so we could
- 18 speak our freedom. Our --
- 19 MR. MCTIERNAN: I'd like to make a
- 20 motion that we --
- 21 MS. GATELLI: That's up to you,
- 22 Mrs. Humphrey. Please --
- 23 MR. MCTIERNAN: I'd like to make a
- 24 motion to recess, please. We need a second.
- 25 MS. NEALON FANUCCI: Second.

- 1 MS. HUMPHREY: This is wrong. This is
- 2 wrong. This is wrong. This is freedom of speech.
- 3 MS. GATELLI: No, it's city business.
- 4 MS. HUMPHREY: City business, there's a

- 5 lot of crime going on in the city.
- 6 MS. GATELLI: Next is Fay Franus.
- 7 MS. FRANUS: Fay Franus, Scranton,
- 8 Pennsylvania.
- 9 MR. COURTRIGHT: Excuse me, Fay.
- 10 MR. MCTIERNAN: Attorney Minora, do we
- 11 need to have a motion to resume the meeting, since
- 12 there was a motion to recess?
- 13 MR. MINORA: I didn't know it was
- 14 passed.
- 15 MR. MCTIERNAN: Yes. It was a little
- 16 loud, but --
- 17 MS. NEALON FANUCCI: I did second.
- 18 MR. MCTIERNAN: Motion to resume.
- 19 MS. NEALON FANUCCI: Second.
- 20 MS. GATELLI: You can start,
- 21 Mrs. Franus.
- 22 MS. FRANUS: Fay Franus, Scranton. I
- 23 just want to speak about something on the agenda that I
- 24 read.
- 25 Council's appointment of Tony

1 Marinucci again to the Recreational authority, I think

2 it's a disgrace. We've had problems with this man for

3 years and years and years, and he's been there for

4 political reasons only for the mayor, and to think that

5 you people would put him back again is totally wreaks

6 of political, political -- it's political, and there's

7 no two ways about it.

8 MR. COURTRIGHT: Fay, I think we

9 covered this ground once before in the past.

10 MS. FRANUS: No.

11 MR. COURTRIGHT: Please let me explain,

12 all right, or do you want me to wait? I don't want to

13 take your five minutes.

14 MS. FRANUS: Go ahead.

15 MR. COURTRIGHT: When he sends these

16 down to us, it's more or less considered a courtesy.

17 He -- we have no --

18 MS. FRANUS: How do you feel, Billy?

19 MR. COURTRIGHT: Well, I'm just trying

20 to explain to you the rules. We have no authority --

21 MS. FRANUS: You vote, don't you?

22 MR. COURTRIGHT: But the vote is a

23 courtesy. We have no control over it.

24 MS. FRANUS: No, but your vote will

25 stay still say how you feel. If you don't want this

- 1 person to get elected, you will vote no, whether it's a
- 2 courtesy or not, whether it's the mayor's appointment.
- 3 Let's see how you vote then. Let's see how you vote on
- 4 this amendment, who votes for Mr. Marinucci and who
- 5 doesn't, then we'll see who's political and who's not.
- 6 Take it from there.
- 7 If I knew I was sitting there, there's
- 8 no way in hell I would vote for him or this
- 9 Mr. Rempe, whatever his name is. They're all in it
- 10 together.
- 11 Go to a Recreational Authority meeting
- 12 and watch how he conducts a meeting. It's a disgrace,
- 13 and this man should not be there.
- 14 And, yet, here he is again. Here he is
- 15 again for another five-year term. I've asked how many
- 16 times at this meeting that they should appointment
- 17 anybody from the city, no political connections
- 18 whatsoever to get the job done right, and I think the
- 19 city should take back Nay Aug Park where it belongs and
- 20 let the City Council make the rules about whether
- 21 people should pay to go in Nay Aug Park.
- 22 The law is the law is the law. The

- 23 park is for the park in this city, not for the
- 24 Recreational Authority to take the money, and who knows
- 25 where it's gone.

- 1 Why don't you start tonight for the
- 2 first meeting and vote the way you should? We'll see
- 3 how you vote.
- 4 And, Judy, I know you're president of
- 5 the neighborhood association for many years, but
- 6 there's no way, there's no way at all, that I think you
- 7 should be president, when Mrs. Evans has been here for
- 8 two years and has done the job. I don't know how you
- 9 justify it. I don't have a clue how you justify this,
- 10 but I guess you figure you can. I don't know how you
- 11 people sleep nights. You either, Billy. I mean, you
- 12 voted. I don't know how you people sleep nights.
- 13 MS. GATELLI: Is there any other
- 14 speakers?
- 15 MR. BUDZINSKI: Good evening.
- 16 Fred Budzinski, Jermyn Apartments. First I want
- 17 congratulate Judy Gatelli, Sherry Fanucci for being
- 18 elected to the Council, and Janet Evans elected again
- 19 to City Council. Well over 1700, 300 votes. If you

- 20 were running for mayor, we'd have a mayor -- the first
- 21 time we'd have a woman mayor in the City of Scranton.
- 22 MS. EVANS: Thank you, Mr. Budzinski.
- 23 MR. BUDZINSKI: Thank God we have a
- 24 taxpayers association now to look after our city
- 25 finances and so forth.

- 19
- 1 I had some people tell me about the
- 2 Lackawanna bridge, one sidewalk is closed off, the
- 3 other sidewalk seems to be starting depressing in
- 4 certain sections. I think they'll want to have it
- 5 marked to watch out.
- 6 I don't know if that bridge has been
- 7 inspected when, but God forbid if that bridge should
- 8 collapse and fall down in the river, I don't think that
- 9 would happen, but that bridge should be looked at.
- 10 MR. COURTRIGHT: Fred, I think this
- 11 summer you might see some action on that bridge. It's
- 12 my understanding that this summer something is going to
- 13 happen there.
- 14 MR. BUDZINSKI: Okay. For now, that's
- 15 all I have to say. Thank you.
- 16 MS. GATELLI: Thank you.

- 17 MR. NEWCOMB, SR.: Good evening,
- 18 Council. I'd like to welcome the new members,
- 19 Mrs. Fanucci, Mrs. Gatelli.
- 20 I'd just like to make a few statements
- 21 and a few questions. The first statement I would like
- 22 to make is we talked here about our local newspaper,
- 23 and I just want to make something clear that there's
- 24 been some articles in the paper recently, I'm sure
- 25 everybody read about, my son who comes here to

•

- 20
- 1 meetings, and the way that the headlines read, Doherty
- 2 Critic Berating the Mayor, my question is, she's not
- 3 here, but, or to you ladies and gentlemen up there,
- 4 what does any of those statements have to do with what
- 5 was in the newspaper? It shouldn't have anything to do
- 6 with it.
- 7 My son comes up here, not as a Doherty
- 8 basher or berating the mayor, like it said in the
- 9 newspaper, he comes he like a taxpayer, like anybody
- 10 else, and speaks his mind. So, again, we definitely
- 11 see what should have been in the City Hall Briefs about
- 12 that big, took second page. There was a murder in West
- 13 Scranton in August, it took the third page. So, what

- 14 he did, took second. So, just and inkling about that.
- 15 And the question I have is, I'm sorry,
- 16 one more statement, Mrs. Evans I do also like to thank
- 17 you for your prior years of service, and I'm sure your
- 18 next four will be just as successful.
- 19 And like the gentleman here, I believe
- 20 he said 1700, but it was 17,000, 17,000 people had
- 21 faith in you, you did receive more votes than anybody
- 22 else, including the mayor, and I'll keep my opinion to
- 23 myself why you're not, you know, in the president seat,
- 24 because you all voted up for the president that you
- 25 have now, and I'll respect that, but I just feel that

- 1 you should have been in that spot, because you have the
- 2 experience to be there.
- 3 And one thing I respect you for is you
- 4 never change the way you feel and the way you vote. If
- 5 you think it's wrong from the beginning, it's wrong
- 6 from the beginning. Other Council members, they
- 7 thought it was wrong from the beginning, but later on,
- 8 you know, changed their vote for whatever reason, but I
- 9 do respect you for that.
- 10 And the question I do have,

- 11 Mrs. Gatelli, I believe when the swearing ceremonies
- 12 were last week and one of the news reporters asked you
- 13 about what your main concerns were going to be, I
- 14 believe you said it was finances, correct, is that what
- 15 you said, finances for the city?
- 16 Well, my question is, and I'm not
- 17 polling the Council, but I could appreciate it if
- 18 anybody could on an individual basis answer my
- 19 question, in this budget, I know we talked about there
- 20 was three positions put in there, an assistant to an
- 21 assistant was the first two, and the third one, I
- 22 believe, was for somebody answering phones.
- 23 The assistant to DPW, I believe, was a
- 24 \$50,000 position, the assistant to the director was a
- 25 \$50,000 position, and I believe for the hotlines we

- 1 were going to pay somebody \$35,000.
- 2 My question is, With the finances of
- 3 the city, we are still distressed, we lost a lot of
- 4 arbitrations, we owe a lot of money in arbitrations,
- 5 and now we're in debt for millions and millions of
- 6 dollars, on an individual basis up there, if you could,
- 7 do you find it feasible or do you agree that something

- 8 like that, an assistant to the assistant should even be
- 9 brought in a budget when we're in this financial shape
- 10 that we're in? Mrs. Evans?
- 11 MS. EVANS: No, I don't agree with the
- 12 creation of that position, furthermore, I feel after
- 13 all of the extensive research I've done on the
- 14 financial circumstances of the City of Scranton, it can
- 15 ill afford any job creations.
- 16 There should have been realistically a
- 17 downsizing within management, within middle management,
- 18 within the attorneys that have been employed, within
- 19 the consultants that have been employed.
- 20 I think you really have to sweep your
- 21 house clean first before you attempt to saddle all of
- 22 these people with a tax increase.
- 23 MR. NEWCOMB, SR.: I agree.
- 24 Mrs. Gatelli, do you have a response to that or anybody
- 25 else? Do you feel that those positions --

- -

- 1 MS. GATELLI: If I were here, I would
- 2 have voted against the budget.
- 3 MR. NEWCOMB, SR.: Okay. Thank you.
- 4 Okay. Good evening.

- 5 MS. GATELLI: Thank you. Anyone else?
- 6 Mr. Ancherani.
- 7 MR. ANCHERANI: Good evening, Council.
- 8 I'm Nelson Ancherani, I'm a resident and taxpayer, city
- 9 employee, and I'm also financial secretary of the FOP.
- 10 The newspaper criticized speakers
- 11 recently at Council, they believed the speakers had an
- 12 agenda, but they're right, the agenda that the Council
- 13 speakers have and had is the concern and well being of
- 14 the city, they come here because they care.
- 15 I'm a taxpayer, and I'm concerned where
- 16 my share of my taxpayer payments are going. I believe
- 17 that every other taxpayer in the city should be
- 18 concerned.
- 19 We're facing a \$200 million plus debt
- 20 for 28 more years. And now we read that Attorney Greco
- 21 is owed \$100,000 more since October 2004, and maybe
- 22 that may not be enough to cover the bills that are
- 23 sitting in someone's office waiting to be paid. This
- 24 \$100,000 will take it to \$500,000 that the city is or
- 25 will pay Attorney Greco.

1 I have to ask, and I guess this is a

- 2 question for our finance chairman, is Attorney Greco
- 3 also getting paid by OECD and the Scranton
- 4 Redevelopment Authority, and if he is, is this double
- 5 dipping? And don't we have city solicitors that could
- 6 do the job that he is doing for a lot less money? No
- 7 other administration had the number of attorneys on the
- 8 payroll as this one.
- 9 Another place on the finances, the DPW
- 10 budget came in 60 percent higher last year, more money
- 11 spent than allocated, and I don't see anyone jumping up
- 12 and down on that one.
- 13 About the \$5.5 million arbitration loss
- 14 to the American Anglican, the city didn't even appeal
- 15 that arbitration, and we, the taxpayers, are going to
- 16 have to pay it. Add this to the \$200 million plus.
- 17 Now the city is going to raise the
- 18 former Holiday Manor for \$100,000, and I understand a
- 19 lien is not going to be put on the price tag when the
- 20 land is sold.
- 21 Why not recoup that \$100,000 in form of
- 22 the lien, and a \$100,000 could be put back into the pot
- 23 to raise more blighted properties?
- 24 The city paid \$78,000 to raise the
- 25 building in the 1200 block of Bryn Mawr Street. That

1 \$78,000 was not recouped. Why?

- 2 The mayor is saying health care went up
- 3 \$3 to \$4 million. Sure, we fired the health care
- 4 consultant who saved the city millions. We forget
- 5 sometimes that we are also paying health care for 100
- 6 new employees that replaced those 100 employees that
- 7 were forced out.
- 8 We'll be losing approximately \$500,000
- 9 on the CRF loan. We also paid out \$3.4 million up to
- 10 the end of 2005 on raises and new hires that the mayor
- 11 violated the recovery plan on.
- 12 The recovery plan does not limit it to
- 13 union employees, it covers all city employees, so,
- 14 therefore, the raises violated the recovery plan, but
- 15 violating union contracts doesn't seem to bother this
- 16 administration.
- 17 All the mayor had to do four years ago
- 18 was to sit down with the unions and contracts could
- 19 have been worked out.
- 20 Millions could have been saved on
- 21 attorneys' and arbitrator's fees. One thing we have to
- 22 remember is that a happy employee is a productive

- 23 employee, but the labor tensions now you can cut with a
- 24 knife.
- 25 A lighter note is as for the new police

•

- 1 building, it was sorely needed, but it is too small.
- 2 Do I get one more minute or is that it? One more
- 3 minute, okay. \$3.6 million, and it is too small, some
- 4 offices oversized, and others too small.
- 5 From what I understand, also, that
- 6 there's sewage still crossing the Davis Trail at Nay
- 7 Aug. It's raw sewage from the zoo, and if I was an
- 8 official of the city, I would be really concerned about
- 9 the health and safety of its citizens. Diseases such
- 10 as E-Coli could be breeding there, and I would be
- 11 concerned about the stuff getting on my shoes if I was
- 12 walking there and tracking it into the house and
- 13 possibly having babies crawling around on the floor
- 14 where it was tracked in.
- 15 And just a remainder, the tax increase,
- 16 it's coming, the mayor said so. So, we as union
- 17 employees have learned to tighten our belts, as we have
- 18 not gotten a raise in four years. Tightening its belt
- 19 is something this administration has not learned.

- 20 Union employees have had to learn it. I hope the city
- 21 would also learn that. Thank you.
- 22 MS. GATELLI: Thank you, Mr. Ancherani.
- 23 Anyone else like to speak before Council? Mr. Morgan.
- 24 MR. MORGAN: Good evening, Council.
- 25 The first thing I'd like to say is about this little

- 1 girl, this eight-year old little girl in Olyphant that
- 2 was hit by a car, and they're doing a collection for
- 3 her at Penn Security Bank on 626 Cedar Avenue, and I
- 4 know the little girl is not a Scrantonian, but, you
- 5 know, I hope that everybody wherever they are in
- 6 whatever community outside Scranton, you know, even
- 7 social clubs, and just everybody, people who go to
- 8 work, they should take up a collection and send money
- 9 to the bank in this little girl's name because of the
- 10 tragedy this family is living through, and I just hope
- 11 that everybody would do that, and also pray for this
- 12 little girl.
- 13 The first thing I have is, you know, I
- 14 got here late, I just got here, and I only glanced at
- 15 the agenda, and Mrs. Gatelli, you ran for Council, and
- 16 I know you've been very active in the South Side

- 17 Neighborhood Association, and everybody has their own
- 18 opinions to what causes blight in the city, but when
- 19 you look at the agenda, from 5-B basically right to
- 20 5-G, it's layer after layer of taxes and taxes and more
- 21 taxes.
- 22 Now, there comes a point when you've
- 23 got to realize that everybody's not a slum lord, okay,
- 24 and that's not being critical of you, either, you know,
- 25 a lot of people come to this podium and people in

- 28
- 1 general, The Scranton Times, a lot of individuals, they
- 2 talk about slum lords, when the true reality of it all
- 3 is that this community is overtaxed, and what I'm
- 4 saying to you, Mrs. Gatelli, is that there seems to be
- 5 an avenue communication between yourself and the mayor,
- 6 it's time to open that up to a boulevard and let him
- 7 understand that all the positions that this gentleman
- 8 wants to create are counterproductive to a resurgence
- 9 of the City of Scranton.
- 10 For a true resurgence of this city, we
- 11 have to get rid of the 2.4 wage tax. And you know,
- 12 there's a lot of other things we can do.
- 13 Mr. Greco's contract should be ripped

- 14 up and thrown in the garbage. You know, I can't
- 15 imagine paying a man so much money in so many various
- 16 parts of the city's administration that we don't even
- 17 know where he is in all aspects of his services to the
- 18 city.
- 19 And it's time to realize that what we
- 20 really have to do is we have to change the city's
- 21 direction. And we're not going to do it with the same
- 22 failed techniques we've used of one time financing, tax
- 23 anticipation notes, prayers, they're just not going to
- 24 work, we have to go in a new direction, so maybe you
- 25 can discuss that with the mayor and we can head in a
- 29
- 1 new direction.
- 2 Now, we're talking about reappointments
- 3 and putting people on commissions, and my question is,
- 4 Of all these people that are listed here, do any of
- 5 them owe delinquent taxes? I think that's a very
- 6 legitimate question to ask.
- 7 I can't tell you at this point which
- 8 ones may or may not, but I think that if you're going
- 9 to serve a function in the city, that you should be a
- 10 leader and set an example that all your taxes are paid

- 11 and all your fees are paid, and I think before this
- 12 Council moves to put anybody in any position, it should
- 13 see that that's looked into first, even if we have to
- 14 wait one more meeting to introduce these things, so
- 15 that we put the right people that are setting the right
- 16 example for the taxpayers of the City of Scranton.
- 17 And with that said, the Scranton
- 18 Recreational Authority should have its function
- 19 changed. We need a playground program in the city, and
- 20 not only do we need that, we need to create four
- 21 full-time positions at Weston Park to create a program
- 22 for recreation for adults and children in this city,
- 23 and I think we've lost that, and I think that's a very
- 24 valuable tool, and I think that we should give it back
- 25 to the residents, I think the residents deserve certain

- 1 things, and that's one of the things I think they do
- 2 deserve. Thank you.
- 3 MS. GATELLI: Thank you very much.
- 4 Anyone else like to speak before Council?
- 5 MS. HUDACHEK: I'm a Scranton taxpayer,
- 6 I moved into this town --
- 7 MS. GATELLI: Can we have your name,

```
8 please?
```

9 MS. HUDACHEK: No. I moved into this

10 town --

11 MS. GATELLI: I believe that if you

12 speak, you have to give your name. Am I right?

13 MR. MINORA: It's in the rules.

14 MS. GATELLI: Yeah, you have to give

15 your name.

16 MS. HUDACHEK: Frances Hudachek. I

17 moved into this town from Hawley about six months ago,

18 I purchased a home, I thought it was part of heaven,

19 I'm beginning to think it's part of hell. I never

20 realized until I started coming to these meetings as to

21 how distressed this city is.

22 My husband right now is in Iraq trying

23 to secure us a future for our golden years. Come to

24 find out, we pay 3.4 percent occupation tax for him to

25 be over there, not only do we pay that, we also pay

_ .

1 property tax, school tax beyond anything that I ever

2 paid in Hawley.

3 I'm very, very, distressed that maybe

4 I've made the biggest mistake of my life, and I don't

- 5 know how to tell my husband when he comes home.
- 6 It's up to you people, that's why
- 7 you're given the privilege of being on the City Council
- 8 to protect the taxpayers, not to all your little
- 9 gameful things that you may have in store in the
- 10 future, but today right here and right now is to
- 11 protect the taxpayers, to protect the people of this
- 12 city, and I hope to God that you take your job
- 13 seriously.
- 14 I hope you're not just sitting up there
- 15 to look pretty or handsome or anything else, it's to
- 16 take your job seriously and to protect us, because we
- 17 can't do it, we can't walk into the mayor's office,
- 18 from what I understand, and say what we want to say.
- 19 We have to give it to you, and then you tell him what
- 20 we want to say.
- 21 Again, I hope I'm wrong, I'm hoping
- 22 things clear up within the next ten months before my
- 23 husband comes home, that I could tell him we have a
- 24 piece of heaven, not a piece of hell. Thank you.
- 25 MS. GATELLI: Thank you. Is there

1 anyone else?

- 2 MS. STOKER-O'MALLEY: Good evening,
- 3 Council. Happy New Year. And I came for several
- 4 reasons tonight, one, to welcome the ladies to the
- 5 Council.
- 6 MS. GATELLI: Can we have your name,
- 7 please?
- 8 MS. STOKER-O'MALLEY: My name is Sarine
- 9 Stoker O'Malley, and I live up on East Mountain.
- 10 I came hear for several reasons, one, I
- 11 came here with a petition last time about Moltke
- 12 Avenue, and literally we had glaciers on Moltke Avenue.
- 13 The city came up, thanks to Charlie Matthews and
- 14 Mr. Parker, and they dug up the street and they put --
- 15 whatever they put in there, big stone and a lot of
- 16 things, but we no longer need a dozer and a Zamboni to
- 17 get through to our homes, and I just want to say thank
- 18 you for that.
- 19 The other reason I'm here is when they
- 20 did East Mountain Road, they did a beautiful job, and I
- 21 understand that it's not finished, but when you come
- 22 out end of Moltke, it's not done there, and you have to
- 23 go bump, bump, bump, bump to get out onto East Mountain
- 24 Road.
- 25 I was told it's just not done, but that

1 causes a lot of problems when you're trying to make

- 2 that sharp turn to get up there in the wintertime when
- 3 it snows. I just want to make sure that that is
- 4 finished and completed when the East Mountain project
- 5 is done. They're, like, leaving part of it undone.
- 6 The other reason, of course, I'm here
- 7 is because Maple Street is not opened, however, the
- 8 city did come up and open East Elm, and that aggravates
- 9 me to no end, because I've been here for 12 years
- 10 saying I'm paying taxes on land I can't use.
- 11 Everybody here tonight is complaining
- 12 about taxes, well, I'm sure if they were paying taxes
- 13 on land they couldn't use, they'd be very annoyed.
- 14 Well, I'm past annoyed. I'm still paying taxes on land
- 15 I cannot use.
- 16 And my taxes, from what I understand,
- 17 are going to go up, and that's ridiculous. KOZ it or
- 18 something for me and until they can get this matter
- 19 straightened out.
- 20 I'm not asking for a ridiculous thing
- 21 here. Mr. Parker assures me that I'm on the list and
- 22 he's going to take care of me.

- 23 And I saw the mayor at the fishing
- 24 derby this summer when I took my kids up, and he
- 25 assured me, this is going to be taken care of. I'm

- 1 still waiting, twelve years I'm waiting, and I'm still
- 2 going to have to pay taxes on this land, and I'm still
- 3 waiting. I'm tired of waiting.
- 4 You know he -- Mr. Parker will say to
- 5 me, you know, we're going to come up, we're going to
- 6 take down the trees, well, that's a good start, but you
- 7 also got a six-foot ditch in there that some kid could
- 8 walk into and get hurt.
- 9 I mean, one day, this matter could be
- 10 straightened out. You come in there, cut down those
- 11 trees, a grater goes in, levels it out, throws some
- 12 stone down, and I'm out of your hair forever.
- 13 But enough is enough, I mean, honestly.
- 14 And I'm praying that the ladies of this Council can
- 15 show these gentlemen how it's done, and I'm a firm
- 16 believer in that.
- 17 Again, that's why I'm here. Thank you
- 18 to Charlie and to George, you did a fabulous job, we
- 19 don't have glaciers on Moltke Avenue and our own people

- 20 can get in and out and we can get in and out without
- 21 large problems and everything else. Thank you.
- 22 MS. GATELLI: Thank you. Are there any
- 23 other speakers? Kay.
- 24 MS. GARVEY: 5-A, Motions.
- 25 MS. GATELLI: Mrs. Evans.

- 1 MS. EVANS: Good evening. Ladies and
- 2 gentlemen, I ask for your prayers tonight, as Mr.
- 3 Morgan did earlier, for Mia Diaz, the sweet child who
- 4 was struck by a van on Monday morning, and for her
- 5 parents and her brother, as well.
- 6 First I have some citizens' requests
- 7 and a brief announcement. 913 Ridge Avenue, which is
- 8 located behind the Petersburg Bank, has not been plowed
- 9 either last winter or this current year. The bank's
- 10 snow removal contractor also pushes snow several feet
- 11 high into the block.
- 12 The 400 block of South Irving to the
- 13 dead end off Moosic Street, the 500 of Reece Street,
- 14 the 200 of Crown Avenue, residents of each of these
- 15 blocks complain that there was no plowing or salting
- 16 performed during the December 2005 snowfalls. Please

- 17 be sure to address these areas in the future.
- 18 And although East Mountain Road itself
- 19 is complete, the road signs for the intersection of
- 20 East Mountain Road and Yesu Lane were never replaced.
- 21 Please address as soon as possible.
- 22 ATVs are traveling through East
- 23 Mountain area and driving on ice on Mountain Lake, and
- 24 the neighbors are very concerned for the safety and
- 25 welfare of those drivers, and they would ask that

- 1 police watch the area.
- 2 And a resident of East Mountain
- 3 complained that East Mountain Road had not been plowed
- 4 or salted during the early morning hours. School buses
- 5 travel at these hours, as well. Snow often falls at
- 6 the top of the mountain when the remainder of the city
- 7 sees rain or no precipitation whatsoever, so please try
- 8 to address this for these the East Mountain residents.
- 9 A city resident reports that she's been
- 10 trying to obtain an apartment at Park Gardens since
- 11 1999, without success.
- 12 Although she contacted the Housing
- 13 Authority monthly in 2003, and also sent letters to the

- 14 Scranton Housing Authority board members in the later
- 15 part of 2005, she was told there were no vacancies, and
- 16 she never received a response to her letters; however,
- 17 I, myself, know of parties who have moved into this
- 18 development in 2005. And, so, I would like a letter
- 19 sent Mr. Baker requesting a response to my questions,
- 20 specifically, What is the criterion for selection of
- 21 tenants for Park Gardens?
- 22 Mr. Courtright, I know that in 2005,
- 23 you received similar complaints, did Mr. Baker ever
- 24 respond to your letters?
- 25 MR. COURTRIGHT: He responded, but not

- 1 that part, he responded to the part where there was a
- 2 parking problem up there, and the response I got is
- 3 they were looking into the rest of it, but I never got
- 4 the criteria. I did ask for it, I never got it.
- 5 Because I had two individuals, one was
- 6 waiting two years, and one was waiting three years, to
- 7 get an apartment in there, and they can't seem to get
- 8 it, so I'm still waiting. So, maybe your letter will
- 9 nudge him a little.
- 10 MS. EVANS: Well, thank you for the

- 11 update. Also, residents of the area complain about
- 12 parking on East Mountain Road. They claim that
- 13 Lakeview Drive, which is less travelled and wider, has
- 14 no parking signs.
- 15 Corporal Bachman examined the area on
- 16 December 12 and observed several vehicles parked the
- 17 right of the travel line, however, he states that the
- 18 city must install no parking signs in that area, if it
- 19 wishes to prevent parking. Please send a letter to
- 20 Mr. Parker requesting his opinion and the installation
- 21 of signs, if he deems them necessary.
- 22 Also, a letter to the tax office in
- 23 care of Mr. McDowell, are any taxes owed on the Holiday
- 24 Manor property, and if so, what is the amount of the
- 25 delinquency.

- 1 And a quick announcement, drop-off
- 2 sites for Christmas trees are Rockwell Park, Crowley
- 3 Park, Tripp Park at the end of Bulwer Street, and the
- 4 South Side Complex centers, and they will all be open
- 5 from eight to 5 p.m. through January 31.
- 6 Curbside pickup will be as follows:
- 7 West Side, tomorrow, January 13; South Side and

- 8 Minooka, the week of January 17; North Scranton, the 9 week of January 23; the Hill and Green Ridge, the week 10 of January 30; East Mountain and West Mountain, the 11 week of February 6.
- 12 Now, tonight Council will introduce all
- 13 taxes and fees to be levied on Scrantonians for the
- 14 year 2006, however, introduction of the EMS tax, that
- 15 is the new tax that replaces the Occupational Privilege
- 16 Tax and increases individual contributions to \$52
- 17 annually will be held this evening and introduced at a
- 18 later date.
- 19 Why? The legislation does not -- well,
- 20 the current legislation does not exempt workers earning
- 21 \$12,000 or less, nor does it allow for any type of
- 22 payment schedule.
- 23 Who dropped the ball? Your state
- 24 legislators. I find it amazing that Senator Mellow and
- 25 our representatives could remain in session overnight

- 1 to vote themselves a pay raises, yet they lacked the
- 2 compassion to remain in session in December long enough
- 3 to help their poor constituents, the little guy, who
- 4 can't forward to lose \$52 from one paycheck, because he

5 needs that money to pay his electric bill, and \$52 is a
6 great sum of money to lose if your take-home spay only
7 \$250 to \$300 per week; therefore, I could not vote for
8 the legislation as it stood. It is unjust and punitive
9 to the poor.

10 If, however, administration and this

11 Council will preempt the statement bill by exempting

12 those who earn less than \$12,000, and that appears to 13 be a strong possibility, and offer a payment schedule

14 of perhaps two to four payments in the first quarter, I

15 will happily support that legislation.

16 And incidentally, that payment schedule

17 would apply to those earning only above \$12,000

18 annually.

19 With regard to the demolition of the

20 Holiday Manor by the city and its failure to place a

21 lien on the property to recoup costs, I must pose a

22 question to the mayor, On January 2, the date of his

23 swearing in for his second term of office, Mr. Doherty

24 stated that he intended to focus on the neighborhood

25 and residents' homes for the next four years, yet I

. .

1 have in my possession pages and pages of condemned

- 2 properties throughout Scranton's neighborhoods that
- 3 have awaited demolition for years and months.
- 4 Mr. Mayor, Are you a man of your word?
- 5 The money is better spent in people's neighborhoods.
- 6 Enough corporate Welfare for the downtown.
- 7 At last check in November 2005, there
- 8 appears to be only \$150,000 available in CDBG funds for
- 9 demolition, however, I await an update from
- 10 Ms. Hailstone and Mr. Fiorini for firm and current
- 11 amounts.
- 12 Since Council's reorganization meeting
- 13 of January 2, a certain few anomalous activities have
- 14 occurred. Some colleagues were bothered or malcontent
- 15 with my request for information, specifically regarding
- 16 Attorney Greco's bills, some colleagues apparently feel
- 17 I should not request information outside of the DPW
- 18 committee or without the approval of the other four,
- 19 and I believe they're basing such a notion on
- 20 Section 306 of the Home Rule Charter.
- 21 The past practice of Council has been
- 22 the ability of five Council members to request any and
- 23 all information which is then disseminated among the
- 24 five. The precedent was set many years ago.
- 25 Further, violations of the charter,

- 1 specifically Section 304, salary, and Section 904,
- 2 capital budget, have been violated by former
- 3 Councilmen Pocius and Hazzouri, among others, and the
- 4 current administration respectively.
- 5 In addition, all Council members
- 6 receive the same information, hence, such an attempt is
- 7 merely ludicrous.
- 8 And the only reason I could possibly
- 9 consider such actions would be a plan to hide
- 10 information or ultimately to deceive the public.
- 11 I was also given a motion from some
- 12 colleagues this evening to amend the rules of Council.
- 13 The discussion of these ideas was not conducted openly,
- 14 and I was not a part of these discussions.
- 15 Further, the meeting will be elongated
- 16 to include an eighth order at the end of the regular
- 17 meeting, in which taxpayers may discuss city business.
- 18 Under fourth order, citizens participation, only
- 19 agenda items may be addressed. Is this legal and
- 20 within the rights of the new majority? Absolutely yes.
- 21 Is it right? In my humble opinion only, no.
- 22 Reading between the lines, I believe

23 this is an attempt to gag the speakers. You must

24 remain until the end of the meeting, late in the

25 evening, to address problems, concerns or suggestions,

•

1 and I wonder who wishes to do so at the end of a long

2 workday.

3 On the other hand, citizens do have the

4 opportunity to see the president prior to the meetings

5 off camera, but I see this as damage control, and it

6 sidesteps the awesome responsibilities of our

7 president, and I believe she can control Council

8 meetings, I believe without such measures, otherwise,

9 I would not have voted for her.

10 And I respectfully request that my

11 honorable colleagues consider the following prior to

12 passing such an amendment, we, the people of the City

13 of Scranton, recognize that government is competent

14 only when those who compose it work as trustees of the

15 people as a servant of the people. Good government

16 must be responsive to their basic human needs. This

17 quote is taken from the preamble to our very own Home

18 Rule Charter. That's it.

19 MS. GATELLI: Mrs. Fanucci.

- 20 MS. NEALON FANUCCI: I would like to
- 21 thank everybody for all of their support and their
- 22 wonderful help in us trying to guide these meetings in
- 23 a correct way.
- 24 I have to say that I would love, love
- 25 to say that this is exactly accurate, and what we've

- 1 been planning as a Council is actually coming together
- 2 and trying to make our decisions together.
- 3 We had sat for a long time trying to
- 4 figure out exactly what these rules of the meeting
- 5 would be, not to inhibit anyone's freedom of speech, in
- 6 fact, to try to make us work easier together, so that
- 7 not only will you come up and say, Oh, this is a
- 8 problem, but maybe we can come to some type of
- 9 solution. We were actually looking for ways to
- 10 actually make our meeting run better.
- 11 Now, we also had discussed, which I
- 12 don't know if Mrs. Evans was present, because she did
- 13 not get there on time, but if we can sit there and say
- 14 to each other, maybe we're not going to do this, we
- 15 didn't say it was in stone, we did not pass this
- 16 legislation, we did not say this was something we were

- 17 absolutely going to do, in fact, I believe, if any of
- 18 my colleagues want to disagree, that we said, Let's see
- 19 how the meeting goes, because we were new, we had no
- 20 idea.
- 21 So, to come in and really say this is
- 22 exactly what was stated was exactly not the truth.
- 23 That was not the truth. It might have been what was
- 24 interpreted, but I believed when we all left, it was to
- 25 say that we were not definitely going to do this at the

•

- 44
- 1 end of the meeting, it was to see how the people
- 2 reacted and how we responded.
- 3 On other business, I had gone and met
- 4 with OECD, this was something that I felt was
- 5 important, because this is going to be my new
- 6 committee, and to find out exactly what the functions
- 7 were of OECD.
- 8 When I got there, I was very impressed
- 9 with not only how the office had run, but all the
- 10 things that we don't know as taxpayers come out of that
- 11 place.
- 12 There is so much that we can find out
- 13 and benefit from in the city that we probably wouldn't

- 14 even know in the first place.
- 15 When I got there I said, Okay, well,
- 16 I'm not going to act like I know all this, so I need to
- 17 go by the step by step, but I hope to report to you
- 18 every single week, I'm going to meet with them every
- 19 week to find out not only the projects that they have
- 20 going on, but what we can do as a city to say, These
- 21 are what's available for the people out there.
- 22 There's so many programs that -- even
- 23 little thing like heating and helping with loans and
- 24 stuff that the normal avenue person would not know, so
- 25 I hope to keep you abreast of those situations.
- 45
- 1 But on a lighter note, I just want to
- 2 say that I am very honored to be here and I would hope
- 3 that instead of us getting pinned into a corner before
- 4 we actually get to where we need to be, that we can
- 5 actually just work together and get where we want to
- 6 get, and I don't believe that we can do it, if people
- 7 do not meet and find out what there is to do.
- 8 MS. EVANS: Mrs. Fanucci, could you
- 9 tell me, though, who drafted and printed this
- 10 information that was given to me this evening?

- 11 MS. NEALON FANUCCI: I would imagine
- 12 that was Kay, correct?
- 13 MS. EVANS: I don't know. It says, I
- 14 make a motion that we amend the rules of Council to
- 15 apply with --
- 16 MS. NEALON FANUCCI: Did you draft that
- 17 or did you --
- 18 MR. MINORA: I drafted it.
- 19 MS. EVANS: At whose order?
- 20 MR. MINORA: I'm not sure who's order.
- 21 I had a request of ideas and thoughts and put them
- 22 down. It was not supposed to have been, as I
- 23 understood, passed tonight. It was just a --
- 24 MS. GATELLI: It was just for
- 25 discussion.

- 1 MS. NEALON FANUCCI: It was a
- 2 discussion.
- 3 MR. MINORA: In fact we reviewed at the
- 4 caucus --
- 5 MS. EVANS: Yes, that's when I received
- 6 it this evening, but it reads in the form of first
- 7 person, I make a motion, I would also amend

- 8 Article 5, Section 1 B., as if a script for some
- 9 Council member to read.
- 10 MR. MINORA: That would be the only way
- 11 we would be able to do that.
- 12 MS. EVANS: Oh, well, yes, I know that,
- 13 it has to be in the form of a motion. I'm sorry. His
- 14 response --
- 15 MR. MINORA: I'll be happy to explain
- 16 it. I was asked to draw up a motion that would be
- 17 considered or thought up to comply with Judge Mazzoni's
- 18 order.
- 19 We've been following Judge Mazzoni's
- 20 order for a couple of years, but the rules evidently
- 21 have not been amended as they should have been, I
- 22 think, in 2003.
- 23 I happened to notice that at the
- 24 organizational meeting, that the rules were not in
- 25 conformance with his order, and was asked to draw a

- 1 motion with some ideas and on how that could be changed
- 2 and complied with. That's what was done.
- 3 It was brought before everybody at
- 4 Council at the caucus to review and look at to

5 determine if it made sense, if it was worthwhile, if 6 there are other changes that might be made, it was a 7 point of discussion.

8 MS. EVANS: Attorney Minora, I spoke9 with you on January 2, as well, about Judge Mazzoni's10 order, did I not?

12 Council members, but I mentioned that our rules had to

13 be amended.

14 MS. EVANS: Yes, to include that

11 MR. MINORA: I spoke with all the

15 citizens may address city business, rather than agenda

16 items, as had been stated in Council rules for the past

17 several years. That was the concern that I had

18 addressed with you, and your response was you would

19 discuss it with the Judge Mazzoni, and then draft a

20 piece of legislation that would properly comply with

21 his ruling, but I not discuss changing a time limit for

22 speakers, creating an eight order, et cetera, so I was

23 merely asking you, you know, I've obtained the answer,

24 yes, you drafted this, at the request of whom? It was

25 not my request.

48

1 MR. MINORA: No, it wasn't your

- 2 request. I spoke to Mrs. Gatelli, I spoke to
- 3 Mrs. Fanucci, I spoke to Mr. Courtright, I did not
- 4 speak to Mr. McTiernan, and I didn't speak with you,
- 5 but I passed it all out as a point of discussion,
- 6 because it's difficult to have the same conversation
- 7 five times sometimes, and it's easier to put together a
- 8 document as a point of discussion.
- 9 In my practice oftentimes when I have
- 10 situations like this, I find it most helpful to put
- 11 something together as a point of discussion when
- 12 everyone is in one room and all the ideas can then be
- 13 addressed. And if it's a bad idea, rip it up.
- 14 MS. EVAN: Oh, I agree with you,
- 15 absolutely, a point of discussion for five people,
- 16 that, you know, it's irrelevant perhaps to this
- 17 discussion, but that was exactly my point about any
- 18 discussions conducted with the mayor, that it should be
- 19 conducted with five Council members present, according
- 20 to the Sunshine Law, open to the public, but that never
- 21 came to fruition.
- 22 MR. MINORA: I'm afraid I don't know
- 23 what --
- 24 MS. EVANS: Well, that precedes your
- 25 taking this office.

1 MR. MINORA: You lost me there.

2 MS. COURTRIGHT: Mrs. Evans, could I

3 speak for one second? I had no knowledge of this

4 either until this afternoon. I spoke to Mr. Minora on

5 the phone, and that's the first I heard of it, so

6 correct me if I'm wrong, I think you're a little upset

7 with the fact you didn't know about it until you came

8 in tonight, I was a little upset with the fact that I

9 didn't know about it until this afternoon.

10 MR. MINORA: It was only drafted this

11 afternoon, by the way.

12 MR. COURTRIGHT: So, and I wasn't going

13 to speak on it, but you said you spoke to me, I don't

14 want anybody to think that I was the one, because I'm

15 not --

16 MR. MINORA: Oh, no.

17 MR. COURTRIGHT: I'm just clarifying it

18 for myself. I didn't say you're pointing the finger at

19 me, but I'll be leaving here and people will be saying,

20 Bill, did you draw that legislation? No, I didn't.

21 And at the time when I spoke to

22 Mr. Minora on the phone, I really didn't think it was a

- 23 good idea, I thought that maybe let's wait and see how
- 24 these meetings proceed.
- 25 If the new president has a problem

-

- 1 keeping it under control and we needed to make some
- 2 kind of rules, I would be willing to look at it then.
- 3 So, I think maybe where your concern comes in is that
- 4 you didn't know about -- am I correct, you didn't know
- 5 about this being --
- 6 MS. EVANS: Well, that's a secondary
- 7 concern, because actually I had gotten wind of it
- 8 before today, but I honestly didn't believe it would be
- 9 quite as real as what I'm seeing this evening, but --
- 10 MS. GATELLI: We spoke to
- 11 Attorney Minora when we met with Roseanne Novembrino
- 12 about different ways that we could allow the public to
- 13 speak, and he had an opinion from, I think,
- 14 Attorney Nealon --
- 15 MR. MINORA: Judge Nealon.
- 16 MS. GATELLI: -- and he said, I have
- 17 some good ideas, and I'll bring them before the Council
- 18 when we have our caucus, so that's why we talked about
- 19 it tonight.

20 MS. EVANS: Well --

21 MS. GATELLI: You know, it might not be

22 a bad idea, because people will get two opportunities

23 to speak. The first opportunity will be to speak on

24 agenda items only, so you will talk before we vote on

25 the agenda items, then you will be allowed to speak the

51

1 second time on other city matters. Well, if you're

2 awake. You're all here. I watch them, you're here

3 until one o'clock in the morning, now all of a sudden

4 you're going to go home? Don't go home.

5 MS. EVANS: Well, that's exactly it.

6 MS. GATELLI: You're allowed to come

7 into Council at 5:30. That's not damage control,

8 that's a neighborhood person. I've been doing that for

9 25 years. I'm not trying to control anybody. I just

10 got here.

11 MS. FRANUS: Why do you have to wait

12 for eight order?

13 MS. GATELLI: Well, you only get five

14 minutes then. The other way, you'd get ten.

15 MS. FRANUS: Why can't we speak on

16 anything, not just city business?

- 17 MS. GATELLI: Well, you can, that's
- 18 what we decided in the caucus tonight, that we were
- 19 going to do that.
- 20 MS. FRANUS: Now you just said on
- 21 agenda first five minutes on agenda only, and anything
- 22 else wait for eight order. Why can't we just keep it
- 23 like it always --
- 24 MS. GATELLI: Well, you can, because
- 25 when we met in caucus tonight, we decided not to do

- 1 that.
- 2 MS. NEALON FANUCCI: The whole point we
- 3 already decided tonight that this was not going to take
- 4 place tonight, this was not even an issue, in fact,
- 5 that's what the whole point is. This was not something
- 6 that we decided upon.
- 7 MS. FRANUS: It was brought up as a
- 8 motion.
- 9 MS. NEALON FANUCCI: It was not brought
- 10 up as a motion, it certainly was not.
- 11 MS. GATELLI: Mr. Minora wrote it that
- 12 way. It wasn't on the agenda.
- 13 MS. EVANS: Just to clarify,

- 14 Mrs. Franus, it could not have taken effect tonight, in
- 15 fact, because it must be moved, and then it must be
- 16 voted upon. It's a resolution, actually. The rules of
- 17 Council are in the form of a resolution, however, it
- 18 was decided tonight that for the time being we would
- 19 continue past practice, but it has also been agreed
- 20 upon that that is not written in stone and could change
- 21 at any time, so, I just felt it's very important for
- 22 the public to know what possible direction the new
- 23 Council could be heading in.
- 24 MS. NEALON FANUCCI: And I'd like to
- 25 state that this Council would like to head in a lot of

- 1 different directions, and I think that this is
- 2 something that we are considering as a learning curve.
- 3 We are going to go out there and we're going to try and
- 4 run this meeting the best that we can for all of us,
- 5 and in no way is it trying to gag anybody's speech.
- 6 In fact, we want this to be better.
- 7 Unfortunately --
- 8 MS. GATELLI: Excuse me. This is
- 9 motions, and no one else is allowed to talk.
- 10 MS. NEALON FANUCCI: Unfortunately we

- 11 cannot decide that without trial and error, discussing
- 12 things, putting things out there and then discussing
- 13 them and saying yes or no, and that's exactly what we
- 14 did tonight.
- 15 This was not intended for tonight, this
- 16 was not even going to be brought up tonight. So, to
- 17 me, the point is just probably not even made. I mean,
- 18 I don't think we need to go any further.
- 19 MS. EVANS: Well, just to end this, the
- 20 rules of Council, however, have to be adopted, and
- 21 accurately adopted. Most often, or rather normal
- 22 practice, is that they are adopted at the
- 23 reorganization meeting every two years, so to say that
- 24 this is a variable set of rules, is quite inaccurate.
- 25 A decision must be made, and those rules must be

- 1 adopted and adhered to.
- 2 MS. NEALON FANUCCI: This rule was not
- 3 going to be adopted, period.
- 4 MS. GATELLI: All right. Let's move on
- 5 with this. Are you done, Mrs. Fanucci.
- 6 MS. NEALON FANUCCI: I am.
- 7 MS. GATELLI: Mr. McTiernan.

- 8 MR. MCTIERNAN: Thank you, Mrs.
- 9 President. First of all, I'd like to welcome Neil. I
- 10 see in our packet there's an assignment as the new
- 11 assistant city clerk replacing Kay, so welcome, Neil,
- 12 and congratulations.
- 13 And second of all, I agree with some of
- 14 the speakers, and I think it's important that we do
- 15 talk about the issues, for example, the demolition and
- 16 recouping some of the fees regarding the demolition.
- 17 There is a serious discussion that
- 18 needs to be held whether or not it encourages
- 19 development, whether or not we can balance off the cost
- 20 of demolition, whether it does encourage, and I don't
- 21 think that's something that someone could just say
- 22 because, I think we need to do research, I think we
- 23 need to have that backed up with dollars and cents, I
- 24 think we need to look at the receipts that are
- 25 generated by these demolitions, we need to look at if

- 1 they generate jobs, transfer taxes, they are a lot of
- 2 factors that go in, other than the fact that it might
- 3 not feel right, and I'm not suggesting what my opinion
- 4 is, I'm saying that a very serious discussion does need

- 5 to be held, whether or not the cost of demolition is
- 6 placed in a lien against the property when the city
- 7 demolishes it. So, not expressing an opinion, just
- 8 expressing the fact that we do need top discuss that.
- 9 And number three, I had an opportunity
- 10 to meet with members of the law department and the
- 11 business administrator, Mr. Kresefski, and that was a
- 12 productive meeting.
- 13 I do encourage all of the public to
- 14 review the issues at hand, and by all means ask
- 15 questions in fifth and sixth order of a particular
- 16 ordinance or fifth order in a resolution, so that I can
- 17 contact the business administrator's office and try to
- 18 have the answers that you request. I intend to have an
- 19 open relationship with the business administrator's
- 20 office, and, no, I am not a certified public
- 21 accountant, but I will do the best I can to get you the
- 22 information you need. Thank you, Madame President.
- 23 MS. GATELLI: Mr. Courtright.
- 24 MR. COURTRIGHT: Yes. Kay, Mr. Pocius
- 25 a few months back made a motion that we get an engineer

1 report for the parking garage across from the Hilton on

- 2 Adams and Lackawanna Avenue, and we did not get that.
- 3 We did send that out, did we not?
- 4 MS. GARVEY: Yes.
- 5 MR. COURTRIGHT: So, could we maybe get
- 6 a second request, because we did do that by motion, and
- 7 Mr. Pocius actually made the motion.
- 8 And speaking of the garage, I will
- 9 speak with the police department and maybe we can
- 10 forward something to the Hilton.
- 11 I had a couple people tell me that when
- 12 the people are parked in the front of the Hilton and
- 13 they, I don't know if it's the valet parking or how
- 14 it's worded, but some people are coming out of the
- 15 Hilton and going South on Adams Avenue to get into the
- 16 parking garage, so now you're coming down Adams Avenue
- 17 and you have somebody coming at you head-on in the
- 18 wrong direction.
- 19 I went down there several times to try
- 20 to monitor it myself, but I didn't see it happening, so
- 21 I will speak with the police department to see if they
- 22 can take a look at it, and maybe we can ask the
- 23 management of the Hilton if in fact it's their
- 24 employees doing that or if it's just guests maybe
- 25 looking for a shortcut. I don't want to see a head-on

1 accident there.

2 Our own Chris Sledzinski brought this

3 up many weeks ago, and nothing's been done, and now

4 it's really bad. On the corner of Jackson Street and

5 Main Avenue where the Wachovia Bank is, a whole section

6 where the sewer lid is, it's just broken away. I don't

7 know in this weather, well, we've been having pretty

8 nice weather, maybe they can patch it or do something.

9 I tried to move it myself and put it back in place, but

10 I didn't do much good.

11 I was asked just today, so I didn't

12 have an opportunity to talk to the police department,

13 Are the Community Justice Officers gone? I think they

14 are. I'm not sure.

15 MS. GATELLI: They're gone.

16 MR. COURTRIGHT: Their grant's gone,

17 so, therefore, they are gone. I know people aren't

18 happy with that, but I don't know what I can do about

19 the grants are gone, so, therefore, they are gone. And

20 that's all I have.

21 MS. GATELLI: Thank you.

22 Mr. Courtright, speaking of the Community Justice

- 23 Officers being gone, I believe that the district
- 24 attorney's office is going to continue to try to get
- 25 more grants to fund the Community Justice Office.

- 1 I know in South Scranton we are
- 2 continuing or program, we will not have an officer, but
- 3 we will continue to have a housing officer, and the
- 4 office remains open.
- 5 I know it's your department,
- 6 Mr. Courtright, so I would request from you if you
- 7 could find out for me the status of beat officers and
- 8 bike patrols.
- 9 I know that we have one bike patrol
- 10 officer, but from what I understand, he's now in a
- 11 patrol car, so I'd like to know the status of the beat
- 12 cops and the bicycle cops.
- 13 MR. COURTRIGHT: All right. What has
- 14 happened is we're in January and everybody is bidding
- 15 their new shifts and everything, I don't know that we
- 16 have what they call fast cops or cops ahead left. We
- 17 might have exhausted those, I don't know if we have any
- 18 of those left or not, if we do, they're very few.
- 19 All we have now would be CommD

- 20 officers, and I don't know if they have a choice or not
- 21 whether they go on bikes.
- 22 Bikes were provided, thank God, by the
- 23 neighborhood associations, they all bought them for
- 24 these officers, and whatever accessories they needed,
- 25 so, the last count I think we had three fast cops,

- 1 which would be cops the City of Scranton has to pay a
- 2 portion of their salary, and then in the final years
- 3 the city has to pay it all, or in the final year, I
- 4 should say.
- 5 I think they might have gone as of
- 6 December, but I don't want to misspeak here, so I will
- 7 check and make sure, but we do have CommD officers that
- 8 are paid 100 percent by CommD money, and I'll get a
- 9 listing of where they're located and how many they are.
- 10 And the only thing I ask is, they go
- 11 like, CD3-A, CD3-B, things to that effect, 2-A, when I
- 12 -- I'll read the list so everybody knows where their
- 13 officers are in your neighborhood, the only thing I
- 14 will tell you is sometimes if 3-A, I just know for sure
- 15 is in West Scranton, because it's where I'm at, and
- 16 sometimes they're not -- if I tell you there's going to

17 be an officer at 3-A, on certain occasions they

18 relocated them to a different part of the city for

- 19 different events, so I don't want you to think I lied
- 20 to you if you look out there and there's no officer.
- 21 I know for, like, the Italian Festival,
- 22 sometimes they bring them down there, for the St.
- 23 Patrick's Day Parade they might relocate them to a
- 24 different location.
- 25 There's been questions whether or not

- 1 that's legal to do that, because it's OECD money paying
- 2 them or CommD money, I should say, paying them, and I
- 3 believe the answer to that is, not to jump on your time
- 4 here, but I believe the answer to that is when they
- 5 relocate, and if I'm wrong, I'm sure I'll find out the
- 6 minute I get out of here, when they relocate a CommD
- 7 officer, say, for instance to do the St. Patrick's Day
- 8 Parade, possibly they don't pay them out of CommD
- 9 money, it might be a CommD officer, and maybe that
- 10 officer might not be getting paid out of CommD money,
- 11 I've been told that in the past, I've never seen that
- 12 in writing, so I don't know, because I've had several
- 13 complaints when the officer was pulled from the area to

14 do the St. Patrick's Day parade of the Italian Festival

15 or whatever.

16 But not to go on and on, but I will

17 have that list for you next week.

18 MS. GATELLI: The other thing I want to

19 say was about the Emergency Services Tax, they did send

20 that down to be put on the agenda, and the President

21 does have the right to pull legislation from the

22 agenda, which I did, because that legislation said that

23 everyone making \$1,000 would have to pay the \$52 tax.

24 Now, the state says that it can go up

25 to \$12,000, and I believe that this Council is going to

61

1 support that \$12,000 with the suggestion of paying it

2 in intervals, rather than paying it all at once;

3 however, I don't know if they could change any other

4 things about it, but if we can look into possibly

5 writing to our state representatives and our state

6 senator and ask if we can do this tax in a percentage

7 basis, rather than paying a flat rate, you would pay

8 according to your salary.

9 So, someone making \$10,000 or \$12,000,

10 certainly would pay a lot less than someone making

- 11 \$50,000 or \$60,000. So, you know, write and see if
- 12 that's a possibility for them to consider.
- 13 I think that's all I have. We have a
- 14 lot on the agenda. Thank you all for coming, and we'll
- 15 continue with the business portion of the meeting.
- 16 MS. EVANS: Mrs. Gatelli, if I might, I
- 17 want to commend you on pulling that particular piece of
- 18 legislation.
- 19 MS. GATELLI: Thank you. Well, I
- 20 discuss that with you, you know, when I saw you the
- 21 other day.
- 22 MS. EVANS: Yes. And I think that was
- 23 a bold move and one that benefits truly the people of
- 24 the city, especially the poor, the middle class poor,
- 25 so on behalf of all of them, I thank you for doing
- 62
- 1 that.
- 2 And if I can just quickly add one more
- 3 thing, I agree with what Mr. McTiernan was saying in
- 4 terms of developing a better system by which -- well,
- 5 determinations of demolition will occur, but I did want
- 6 to correct one item, it's not a feeling, these aren't
- 7 feelings, these are realities, and when I look at the

8 corner of Sanderson Avenue and Green Ridge Street and

9 take a look over in Keyser Valley at developments,

10 beautiful developments that are going up with -- these

11 are going to be gorgeous condominiums for those who can

12 afford them, structures were demolished at the cost of

13 the taxpayers, and when we're particularly looking at

14 any institution, you know, whose net assets exceed \$100

15 million, I think it stands to reason that they could

16 certainly afford the cost of the demolition.

17 And for those pieces of property

18 throughout the city where, you know, we're talking

19 about safety hazards and blight conditions, those are

20 the areas that this meager amount of money needs to be

21 focused on, our neighborhoods. That's it.

22 MS. GATELLI: Kay.
