1 MS. GATELLI: This public hearing will now
2 come to order. Neil, roll call.
3 MR. COOLICAN: Mrs. Evans.
4 MS. EVANS: Here.
5 MR. COOLICAN: Mrs. Fanucci.
6 MS. NEALON FANUCCI: Here.
7 MR. COOLICAN: Mr. McTiernan.
8 Mr. Courtright.
9 MR. COOLICAN: Mrs. Gatelli.
10 MS. GATELLI: Here. Notice of said
11 public hearing is to testimony and discuss the
12 following: FILE OF COUNCIL NO. 17, 2006 - AN ORDINANCE
13 - CLOSING AND VACATING THE IDENTIFIED PORTIONS OF HILL
14 STREET, AN UNNAMED STREET AND UNNAMED ALLEYWAY SHOWN ON
15 EXHIBIT "A" LOCATED BETWEEN BOULEVARD AVENUE AND
16 OLYPHANT AVENUE NORTH OF PARKER STREET.

- 17 The first speaker is Eric Holecko.
- 18 Please note that Mr. McTiernan is also present.
- 19 MR. HOLECKO: Good afternoon. My name
- 20 is Eric Holecko. I'm here representing the Holecko
- 21 Corporation and its efforts to develop some land down
- 22 by Boulevard Avenue and Parker -- well, not so much on
- 23 Parker Avenue, but Olyphant Avenue, as well.
- 24 I'm here tonight to request a zoning
- 25 change before City Council. The portion that I'd like

- 1 to have changed would be --
- 2 MS. GATELLI: Mr. Holecko, that's the
- 3 second public hearing. This one is to vacate the
- 4 streets.
- 5 MR. HOLECKO: Okay. In order to vacate
- 6 the streets, we're looking to vacate a street along
- 7 that goes from Boulevard Avenue down to Olyphant
- 8 Avenue, a portion of the street that goes between
- 9 Olyphant Avenue and -- it's actually Hill Street --
- 10 it's called Hill Street on the map, and an alleyway
- 11 coming through Parker Street.
- 12 We would be looking to vacate these
- 13 streets to develop a self storage facility in that area

14 and generate taxes for the City of Scranton.

15 MS. GATELLI: Thank you.

16 MR. HOLECKO: I also have a surveyor

17 here, my surveyor, Bob Mendola, to --

18 MS. GATELLI: Mr. Mendola, would you

19 like to give testimony? Good evening. Bob Mendola,

20 professional land surveyor.

21 We generated the actual drawings from

22 aerial photography and we've done the land survey for

23 the boundaries, so we know exactly what areas we're

24 impacting.

25 And as Mr. Holecko said, and the first

1 part of our looking for a resolution for the vacation

2 of the said alleyways and streets, is that, number one,

3 the terrain, and we do have a telegraphic map, if you

4 want to review it, is so adverse that you couldn't put

5 a street there if you had to, that's number one; number

6 two, there's no purpose for those paper streets ever to

7 be opened, as I see it, in doing my survey and looking

8 at the adjoining properties, looking at the adjoining

9 houses, garages.

10 We're not affecting anybody's access or

- 11 reasons to get to their property, other than their own
- 12 reasons that they have to offer for the existing alley
- 13 or driveways, et cetera.
- 14 So, it's not going to affect the area
- 15 in that respect at all. So, we want the Council, and
- 16 if there's any neighbors here tonight, we want them to
- 17 realize that.
- 18 This would only help to improve and
- 19 take a greater area with a change in terrain, the
- 20 contours are so, you know, hilly and lumpy, that we'll
- 21 have a greater area to make it a better place to
- 22 develop the storage facility.
- 23 MS. EVANS: Go ahead.
- 24 MS. GATELLI: Thank you. Go ahead. I
- 25 was just going to ask if anybody was here.

- 1 MS. EVANS: I do have a list of
- 2 questions from some of the neighbors. I think many are
- 3 present tonight, and what I'm hoping is that you'll be
- 4 able to respond to these questions for them, but just
- 5 one or two that I might pose to you, again, these are
- 6 the residents' questions.
- 7 MR. MENDOLA: Absolutely. That's okay.

- 8 That's fine.
- 9 MS. EVANS: What will the distance be
- 10 from the existing properties to the proposed project?
- 11 MR. MENDOLA: Okay. In that respect,
- 12 that's a good question and the neighbors should be
- 13 concerned by that, too. We're going to abide by all
- 14 the setback requirements and buffer areas required by
- 15 Scranton Zoning to fulfill, number one, the integrity
- 16 of the neighborhood, the safe distances for whatever
- 17 we're going to have to do to improve their sight from
- 18 their proximity of their houses and yards and things of
- 19 that nature.
- 20 So, we will address that in a very
- 21 legal way, a very proper way, and I think a developer,
- 22 if he has to do something a little bit better than from
- 23 what the ordinance calls for, I think he'll -- he's
- 24 open to suggestions.
- 25 I'm not going to put the words in his

_

- 1 mouth, but I will at least leave it open for debate or
- 2 talking about other areas if anybody has a concern.
- 3 MS. EVANS: Have you any idea, though,
- 4 what the footage or yardage is according to the zoning

- 5 regulations?
- 6 MR. MENDOLA: I would say that in some
- 7 of the requirements you're looking at a buffer from
- 8 anywhere to 10 feet to 30 feet, so we will use those
- 9 distances to, number one, do it properly, and number
- 10 two, to serve the neighborhood, as well.
- 11 MS. EVANS: Okay. Also, there is a
- 12 water problem that exists, a very serious water
- 13 problem, in the area of East Parker Street and
- 14 Boulevard Avenue whenever it rains heavily. The street
- 15 floods, and frankly turns into a lake.
- 16 And we did have a caucus with
- 17 Mr. Parker, the city engineer, last summer, at which
- 18 time he indicated that this is a very difficult problem
- 19 to solve, in fact, he didn't see any solution, other
- 20 than possibly the purchase of an industrial pump by the
- 21 city to pump that water out whenever the area suffers
- 22 from an excessive rainfall.
- 23 Now in the meantime, to my knowledge,
- 24 that pump has never been purchased. I did try to speak
- 25 with Mr. Parker about it as recently as today, in fact,

1 but I haven't been able to get a response from him, he

- 2 hasn't called me back yet.
- 3 So, would your proposed project have
- 4 any impact on that situation for the better or the
- 5 worse?
- 6 MR. MENDOLA: I would say in this
- 7 respect, we're going to design that site by all means
- 8 of what science allows, what your ordinance requires,
- 9 and then -- and what you're mentioning now, I had heard
- 10 these situations you've mentioned.
- 11 MS. EVANS: Oh, you should see photos
- 12 of it. They were given to Mr. Parker.
- 13 MR. MENDOLA: I appreciate that.
- 14 Again, not to put words in my client's mouth yet or to
- 15 have him do more than he should, but if there's
- 16 anything we can do with our design and storm water
- 17 management, myself, as surveyor, along with Ceco
- 18 Associates, a very reliable engineering firm, we have
- 19 the task of designing this project, and we will do it
- 20 in the best manner to, number one, serve the ordinance
- 21 for the requirements; number two, for the grades that
- 22 are there.
- 23 As I mentioned, the adversity of the
- 24 area from yesteryear, what it was used for, we're going
- 25 to try to even that out and try to improve that site

- 1 for water runoff.
- 2 Also with respect to the storage
- 3 facility, we displace any land or woods or dirt and
- 4 that kind of things with impervious surfaces. We will
- 5 design it to accept things to be if not as what it was,
- 6 but better than before this was built.
- 7 MS. EVANS: Okay. So, I think what I
- 8 hear you saying is that by taking green space, which
- 9 would obviously absorb a part of the moisture that
- 10 occurs in that area, you intend to make up for that?
- 11 MR. MENDOLA: Absolutely, absolutely.
- 12 MS. EVANS: In fact, improve the
- 13 situation. And I think we have the -- I'm not sure,
- 14 are you the developer or the purchaser?
- 15 MR. HOLECKO: The developer.
- 16 MS. EVANS: I'm just tossing an idea
- 17 out there on behalf of the citizens. I haven't
- 18 discussed it with them at all. But since, you know,
- 19 there is such a tremendous problem in that area with
- 20 flooding, it's something that would affect you, as
- 21 well.
- 22 And when this occurs, believe me,

- 23 traffic comes to a dead standstill. No one can get
- 24 through this amount of water. Would you be interested
- 25 in perhaps sharing the cost of an industrial pump that

- 1 would address those flooding conditions as soon as they
- 2 begin?
- 3 MR. HOLECKO: How much does an
- 4 industrial pump cost?
- 5 MS. EVANS: That, I do not know. I can
- 6 find out for you, and we need to know, as well, from
- 7 Mr. Parker. I tried to have that information for this
- 8 evening, because I knew you were coming, because as I
- 9 said, he didn't return my call yet.
- 10 MR. HOLECKO: Okay.
- 11 MS. EVANS: But might you be willing?
- 12 MR. HOLECKO: I'd be curious to know
- 13 the cost.
- 14 MS. EVANS: The cost.
- 15 MR. HOLECKO: I mean, I don't want to
- 16 commit to something before I know the cost. I'd like
- 17 to know the cost of an industrial pump.
- 18 One thing that we're doing with this
- 19 site is we're engineering it so that it will not impact

- 20 any abutting or adjacent neighbors with any more water.
- 21 We would be looking to contain all the
- 22 water on site through the latest technologies
- 23 available. We would also have an access from Olyphant
- 24 Avenue, as well, an emergency access just in case the
- 25 problem did arise that traffic was unable to get in

- 1 through Boulevard Avenue, you would be able to get in
- 2 through the higher part along Olyphant Avenue. So,
- 3 that is all in some of the plans that we're currently
- 4 working on and drawing up.
- 5 MS. EVANS: Well, that sounds certainly
- 6 very encouraging. I'm just -- I'm going to give you
- 7 the bottom line here. Since we had this discussion, I
- 8 believe, in June of 2005, a public caucus with the
- 9 residents and Mr. Parker, the city has failed to take
- 10 any steps in that direction toward the purchase of this
- 11 pump, so the people are still suffering from the same
- 12 problems.
- 13 Again, not being a city engineer the
- 14 Mayor, I can't guarantee that this purchase is going to
- 15 be made, but it certainly is something that would be to
- 16 the advantage of all of you.

- 17 MR. HOLECKO: Sure.
- 18 MS. EVANS: Because, you know, as I
- 19 said, it's impossible to traverse the area when this
- 20 occurs, and it's not that it's a fluke, this is a
- 21 regular occurrence.
- 22 MR. HOLECKO: We would plan for -- we
- 23 would make plans for the pump, we would make plans if
- 24 the pump wasn't there, we would plan either scenario,
- 25 and hopefully even through some of the tax dollars that

- 1 this business would generate for the city, maybe that
- 2 would also go towards the purchase of a tax pump --
- 3 well, we might need a tax pump too, but --
- 4 MS. GATELLI: Are there any neighbors
- 5 that would like to give testimony?
- 6 MS. EVANS: Thank you both.
- 7 MR. FENTON: My name is Wayne Fenton.
- 8 I'm speaking on behalf of my elderly parents who live
- 9 on the corner of Parker and Boulevard, and all the
- 10 neighbors that are in the region, the area there.
- 11 The major concerns, as Mrs. Evans has
- 12 spoke about, is the water problem. How the water
- 13 runoff and the drainage is going to be taken care of.

- 14 The current survey markers that are
- 15 there are very close to the property lines of my
- 16 parents that have lived there for over 50 years, since
- 17 '55.
- 18 The markers, where they're put, there's
- 19 a Christmas tree that's been there for 40 years. I
- 20 wouldn't want to see that Christmas tree destroyed by
- 21 these people coming in to take that Christmas tree down
- 22 after it's been planted there since I was a high school
- 23 child, and I can't see destroying it.
- 24 We have a storage shed on our property
- 25 which also falls under their boundary lines. Back in
- •
- 13
- 1 1955, there was a fence that was there when my parents
- 2 bought the property, but over the years, they said that
- 3 the properties are on an angle on that street. So, the
- 4 way the street angles line up and the survey lines, the
- 5 existing area, the neighbor has a water pond on their
- 6 property, which would also be affected by this.
- 7 We don't want to see all these things
- 8 that hard work went into to be taken away from us in
- 9 regards to the neighborhood.
- 10 The traffic problems that exist in the

- 11 area on an already congested street with many accidents
- 12 and fatalities have occurred on Boulevard Avenue.
- 13 We're worried about the traffic that's
- 14 going to be increased by these storage sheds coming and
- 15 going all hours of the night, because most storage
- 16 sheds are open for people to access them during late
- 17 hours, and we don't want the storage sheds open late at
- 18 night where you're going to have people hanging there
- 19 and having beer parties and whatnot in the lots
- 20 adjacent to all the properties and homes.
- 21 We're concerned whether there will be
- 22 bright lights on the property, the noise and the debris
- 23 with a constant flow of traffic.
- 24 If they're not going to have fences to
- 25 block the existing properties, we're going to have a

- 1 problem with all that trash blowing over in the
- 2 neighborhood.
- 3 The neighbors have resided there for
- 4 over 50 years, my Godparents and whatnot. If we allow
- 5 the zoning to be changed for this project, such as a
- 6 new nursing home that was built there, it was never
- 7 brought before the neighbors, as far as getting their

- 8 interest in the nursing home. It was just
- 9 automatically put there.
- 10 It never went through the zoning board
- 11 as far as the neighbors were to come to a public
- 12 hearing like this. We're thanking you for having this
- 13 public hearing to allow us to speak, to try to get this
- 14 resolved before the storage sheds are put there.
- 15 I understand the storage sheds are
- 16 going to run from Olyphant Avenue all the way to
- 17 Boulevard. There's a big column dump there right now
- 18 which they're going to have to remove out of there,
- 19 from which I understand.
- 20 I'm wondering if it's going to be flat
- 21 land or if the storage sheds are going to be built on
- 22 different levels in this area because that will
- 23 increase the water runoff, which we have the problem
- 24 with the drainage already in the area.
- 25 And also, we would like to have a

- IJ
- 1 contact name of the people once the storage sheds are
- 2 put up there that we can contact them in case there's a
- 3 problem in the future.
- 4 Because like Mrs. Evans said about

- 5 Mr. Parker, we had the meeting in 2005 with him in
- 6 regards to the industrial pump, it fell on deaf ears.
- 7 To this day, if it rains heavy, the street floods, you
- 8 can't get through.
- 9 And the neighbors are mostly elderly
- 10 neighbors in that neighborhood, and they're not able to
- 11 get out of their homes, unless to be taken out by
- 12 boats, and it shouldn't have to be this way. Something
- 13 should be done in the neighborhood.
- 14 Thank you for allowing me to speak on
- 15 the issue and on behalf of the neighbors which are many
- 16 present tonight.
- 17 MS. GATELLI: Thank you. Are there any
- 18 other neighbors that would care to speak? Come up,
- 19 please. How many neighbors are out there for this
- 20 particular case? How many are against the project for
- 21 the moment? Okay. Thank you.
- 22 MR. SUMMA: Andy Summar, I live on
- 23 Olyphant Avenue. He mentioned access from Olyphant
- 24 Avenue to the storage sheds, where's the access going
- 25 to be? There's a column bank on one side, and I live

1 on the other side, so I don't know how you're going to

- 2 get in there from Olyphant Avenue.
- 3 MR. HOLECKO: If I could address that.
- 4 MS. GATELLI: Step back up, please.
- 5 MR. HOLECKO: We are currently, to
- 6 address a couple of the questions, I was writing a
- 7 couple of them down, we are currently working on
- 8 Olyphant Avenue to make it that partial, which is under
- 9 sale agreement, accessible, via Olyphant Avenue. We
- 10 are working on engineering that.
- 11 As far as the lighting, we will take
- 12 the measures necessary to make sure that the light does
- 13 not shine on the neighbors. We're working with a self
- 14 storage consulting firm, I guess you would call them,
- 15 to make sure that this site gets designed properly and
- 16 that it will be a first class storage facility.
- 17 As far as the garbage on the street,
- 18 garbage and beer parties going on at this self storage
- 19 facility, there will be none of that. I have a couple
- 20 of pictures that I would like to show the City Council.
- 21 This is some of the garbage that's down
- 22 there currently. We would be looking to clean up the
- 23 garbage. We're currently working to make this a
- 24 beautification process in hopes to attract new business
- 25 down by that Olyphant Avenue and Boulevard Avenue and

- 1 that area. We're looking to help lay the seeds, such
- 2 that the nursing home already did provide down there.
- 3 And this is not a KOZ land. There will be taxes
- 4 generated to the city.
- 5 Also, self storage is a low traffic
- 6 business. It doesn't generate a high amount of
- 7 traffic. The traffic that it does generate or the
- 8 traffic that will be going past here will be of the
- 9 local neighbors. That's who this self storage facility
- 10 is targeting.
- 11 It's for the people in green ridge.
- 12 It's so that they have more room to store some of their
- 13 stuff, whether it's a boat, a car, a motorcycle. It
- 14 will be a benefit to the neighborhood down there and
- 15 directly have a positive impact on the folks down
- 16 there.
- 17 As far as the pine tree, there is a
- 18 required buffer zone. I believe along the area that
- 19 the Fentons live, there will be an 8 feet green zone,
- 20 and actual buffer zone.
- 21 Any buildings from that area would have
- 22 to be set back an additional 30 feet. They are all

- 23 being addressed.
- 24 As far as having a contact, I did go
- 25 down, I did shake hands with all the neighbors down

- 1 there. I introduced myself. I gave them all my
- 2 business card and said if they had any questions, to
- 3 give me a call. I would be more than happy to work
- 4 with them. I'm looking to be a good neighbor down
- 5 there, and that is why I took this before them first.
- 6 And I do welcome questions. I do want to work with the
- 7 neighbors in that area to continue the beautification
- 8 process down there.
- 9 MS. EVANS: So, you would be the
- 10 contact person?
- 11 MR. HOLECKO: I would be the contact
- 12 person.
- 13 MS. EVANS: And, also, I remember one
- 14 of their concerns was the hours of operation, is it a
- 15 24-hour business?
- 16 MR. HOLECKO: The hours of operation
- 17 haven't been determined yet. I don't have a time
- 18 frame. Some places have 24-hour access. There may be,
- 19 I can't tell you the hours of operation yet.

- 20 MS. EVANS: Okay.
- 21 MR. HOLECKO: But it is a quiet
- 22 business. It's not that people will be partying down
- 23 there. There would also be all the protections in
- 24 place, a buffer zone.
- 25 We're actually going to have to plant

- 1 more trees down there in that buffer zone, particularly
- 2 it would have to be evergreens, so they make the best
- 3 buffers. So, I would not be looking to --
- 4 MS. EVANS: Is it a multi-level
- 5 project or --
- 6 MR. HOLECKO: We're still -- it will be
- 7 -- due to the elevation change, we will have -- it will
- 8 be multi-level. We're still working on developing it
- 9 and doing building layouts so that we meet the criteria
- 10 for the city, protect the neighbors. At the same time,
- 11 we want them to be our customer. We don't want them to
- 12 not like us down there.
- 13 MS. GATELLI: Have you already met the
- 14 with some of these neighbors?
- 15 MR. HOLECKO: Yes. I've met with all
- 16 the neighbors along -- boarding the property. I kept

17 going back until I spoke to everyone at least once down

18 there.

19 MS. EVANS: And I think I hear you

20 saying, also, that, but I'm not sure, which is why I'm

21 going to ask for a bit of repetition, they would be

22 allowed, these property owners, to keep their Christmas

23 tree, their pond?

24 MR. HOLECKO: A pond?

25 MS. EVANS: Yes. I heard something

•

1 about a small pond on one neighbor's property. I'm not

2 talking about the type one would ice skate on, just a

3 small pond.

4 MR. HOLECKO: You might be talking --

5 there's a pool. I don't know if this is -- here's some

6 more pictures. There's a pool that is actually -- that

7 would be in this section right here. I don't know -- I

8 think that's a safety hazard right there.

9 I can't -- I don't think that that

10 should even be there if that's the pond or pool.

11 That's the only watering hole in the whole area.

12 MS. GATELLI: Is the person here that

13 has the pond? Will you come up here and see if this --

- 14 this looks like just a swimming pool that has been
- 15 abandoned. Come on up. That's just a swimming pool
- 16 that has been abandoned, I believe. Is that what
- 17 you're talking about? No? Okay. Mr. Holecko, is
- 18 this swimming pool part of the property you're going to
- 19 use?
- 20 (WHEREUPON, discussion held at sidebar not on record.)
- 21 MR. HOLECKO: That's currently on the
- 22 property in the agreement of sale.
- 23 MS. GATELLI: Oh, so you will be taking
- 24 care of this?
- 25 MR. HOLECKO: That will have to be

- 1 another meeting after this. I'm looking to continue to
- 2 move forward, but hopefully we can settle that outside
- 3 of a court. I'm just here for the vacating of the
- 4 streets and the zoning change tonight.
- 5 MS. GATELLI: The woman with the red
- 6 coat, would you like to speak?
- 7 MS. THIES: Hi. My name is Barbara
- 8 Thies. I heard him say something about, like, an alley
- 9 off of East Parker Street, and I was wondering what
- 10 that is. Like, where my land ends and then this, like,

- 11 hill, like, that's right on top of me. So I was --
- 12 MS. GATELLI: Maybe he can show you on
- 13 the map.
- 14 MS. GATELLI: Mr. Holecko, hold up here
- 15 a minute. I don't know how the rest of Council feels,
- 16 but I think that you need to meet with these neighbors
- 17 in a meeting-type setting.
- 18 MR. HOLECKO: I have been going down
- 19 there since January, or since December.
- 20 MS. GATELLI: Well, then why do they
- 21 have all these questions?
- 22 AUDIENCE MEMBER: He's only came once.
- 23 MR. HOLECKO: I've gave them my card.
- 24 I've sent them a certified mail stating in that
- 25 certified letter that I mailed out in the beginning. I

- 1 said in that letter, I asked them if they had any
- 2 questions, to please contact me.
- 3 MS. GATELLI: Well, obviously they have
- 4 questions, and obviously they need to be addressed.
- 5 What I'm telling you is that I think it would be behove
- 6 you to have us table this for now and have you meet
- 7 with the neighbors and come back to us at a later date.

- 8 That's my suggestion, and I think the rest of Council 9 is going to agree with me.
- 10 MS. EVANS: Yes, I would tend to agree.
- 11 I'm not saying that the neighbors weren't contacted,
- 12 but from what they communicated to me, it seems you
- 13 went door to door, introduced yourself, gave them the
- 14 card, but they've never really seen the plans, heard
- 15 the specifics of what you intend to do, and obviously
- 16 you can tell they have numerous questions, and I do
- 17 think that they're here tonight for this public
- 18 hearing, not only because you informed them of it, but
- 19 because they really haven't had the opportunity to meet
- 20 with you.
- 21 And I know that, you know, and granted,
- 22 I think it's very respectful and very considerate of
- 23 you to have made this effort and knocked on each door
- 24 and given the card and made personal contact, but I
- 25 think it's difficult one on one; in other words, if

- 1 Mr. Fenton is going to call you about an issue, and
- 2 then Mr. Summa is going to call you about an issue, and
- 3 Mrs. Thies is going to call you about an issue. The
- 4 communication can be crossed then.

5 I think, as Mrs. Gatelli says, what

6 they need is one joint meeting with you where you can

7 address all of their questions and concerns, show them

8 the plans, and each side be a good neighbor and work

9 together to make this hopefully happen.

10 MS. GATELLI: And Mrs. Garvey just told

11 me that there is a large room next to this room, if you

12 would like to go over there now while you're all here.

13 MS. EVANS: That's convenient.

14 MS. GATELLI: That's convenient for

15 everyone, and, you know, discuss some of your issues.

16 MR. HOLECKO: Okay. I mean, I did

17 attend the neighborhood association meeting down in

18 Green Ridge, I have been there, I plan on going back to

19 the neighborhood association meeting this Tuesday night

20 again.

21 MS. GATELLI: I know, and you've been

22 here many, many times, but, you know, sometimes it

23 just, you know --

24 MS. EVANS: You know what the problem

25 is, though, with the Green Ridge neighborhood meetings,

24

1 they're really not well advertised. You know, for

- 2 example, I've been very anxious to attend them, and
- 3 since the time at which they had significant problem
- 4 with crime, it seems that everything settled down and
- 5 the publicity was cut.
- 6 And as a Councilwoman, I don't know
- 7 when their meetings are. I don't even know where
- 8 they're conducted, and I don't know if these residents
- 9 know that information or if they even attend the Green
- 10 Ridge meetings.
- 11 Perhaps they attend the meetings of The
- 12 Plot Neighborhood Association. There are two that, you
- 13 know, actually intersect in terms of the area in which
- 14 they live, so they may be going to one and not the
- 15 other. I think much of Green Ridge is upper Green
- 16 Ridge.
- 17 MS. GATELLI: Would you like to use the
- 18 other room?
- 19 MR. HOLECKO: Would we be able to come
- 20 back later on for --
- 21 MS. GATELLI: Amil, will they be able
- 22 to come back later, if they can settle? I don't know.
- 23 MS. EVANS: Well, yeah, why couldn't
- 24 they?
- 25 MR. MINORA: Tonight? I would suggest

1 another night.

2 MR. HOLECKO: At least just a chance

3 for them to give you their side. I mean, either way we

4 would be looking to develop this land. It's not --

5 there's been property lines set. We are looking to

6 develop this land. We're looking to do the best job

7 for the city in development, and we are looking to move

8 on that. I've been taking the correct procedures.

9 MS. EVANS: Yes, you have. And, you

10 know, it's a very good idea. I, for one, am very

11 pleased whenever I hear a business wants put something

12 on the tax rolls, rather than, you know, engaging in

13 more corporate welfare, but the number one priority, at

14 least for me, is the neighbor --

15 MR. HOLECKO: Sure.

16 MS. EVANS: -- the people who live

17 there -- who have been living there for 50 years,

18 40 years. They're invested in their homes and their

19 properties, so they have to be the number one concern.

20 And when they tell me they're happy, they're satisfied,

21 then I'm satisfied. So, that's why I need you to talk

22 to them.

- 23 MR. HOLECKO: I will be more than happy
- 24 to go in the room next door and meet with the
- 25 neighbors, but I would also -- if we could -- if it

- 1 would be possible to have a vote maybe --
- 2 MS. GATELLI: This is not a vote, this
- 3 is just a public hearing, but I think that we should
- 4 have the public hearing on the zoning change, too, so
- 5 that we're all ready, okay?
- 6 MR. HOLECKO: Okay.
- 7 MS. GATELLI: So, we will -- go ahead.
- 8 MR. LIVELY: My name is B.T. Lively,
- 9 I'm with the Green Ridge Neighborhood Association. And
- 10 as you know, we meet the last Tuesday of every month at
- 11 seven o'clock.
- 12 MS. EVANS: Honestly, I did not.
- 13 MR. LIVELY: You attended our meetings.
- 14 MS. EVANS: I attended the meetings
- 15 that you had when Mr. Cleveland was the president at
- 16 the American Legion Building, and this is when the
- 17 incident occurred on North Washington Avenue, but since
- 18 then, I haven't been able to ascertain any information.
- 19 MR. LIVELY: Correct. We meet the last

- 20 Tuesday of every month at seven o'clock on Deacon
- 21 Street. Mr. Holecko has agreed and accepted our
- 22 invitation to meet with the neighbors this coming up
- 23 Tuesday.
- 24 I, myself, have walked around and
- 25 talked to some of the neighbors. They obviously have

•

- 1 very many concerns. Many things go from hours of
- 2 operation to flooding, as we've spoken about this
- 3 evening.
- 4 There's also a concern from some of the
- 5 neighbors in that area of the paper streets that are
- 6 being closed, will they be permanently closed or will
- 7 that area be developed, because they run very close.
- 8 That area also on Parker sets on a
- 9 blind curve, which if it has any kind of development,
- 10 it becomes a safety hazard.
- 11 Hearing Mr. Holecko speaking on
- 12 Olyphant Avenue for an emergency exit. As we know,
- 13 emergency exits sometimes become exits. It's on a
- 14 downward blind slope. That area is roughly a traffic
- 15 hazard to say the least. It is consistently having
- 16 people running 40, 50 to 70 miles an hour.

17 MS. EVANS: I've witnessed that.

18 MR. HOLECKO: So, we have a concern

19 about that. We also have a concern for the buffer

20 zones and the setbacks. The developer has spoken with

21 interest of increasing the setbacks voluntarily. We

22 obviously have a concern about the integrity of the

23 neighborhood, where many people feel this area of

24 Green Ridge is not truly Green Ridge. The people that

25 live there do consider it Green Ridge. They do

•

28

1 consider the neighborhood and they do consider the way

2 it looks now with the woods, with the effort people put

3 in and have a great concern upon when entering that

4 area, is it going to look like an industrial zone.

5 They also have a concern with the

6 lighting and the security, as to whether or not it is

7 going to impede upon their daily life and their

8 nighttime life.

9 Mr. Holecko, as I said, has agreed to

10 meet with the neighborhood association this Tuesday at

11 seven o'clock to address these concerns and any others.

12 Those are right now our concerns that Council should

13 know about. Thank you.

14 MS. EVANS: Thank you.

15 MR. HOLECKO: Could I have one more

16 thing to address to Council? In the city's master

17 plan, the comprehensive master plan, on the map -- the

18 maps behind Page 112, it does have this section

19 designated as an industrial park section of the city.

20 That's what the city is trying to target in this area,

21 according to the master plan.

22 Self storage is actually a great

23 buffer, an ideal buffer zone, between residential and

24 industrial property, and that's what I'm looking to put

25 in there. I'm looking to do a first class facility.

29

1 The roofs are going to be high pitched, one, to

2 eliminate the light going over onto the residential

3 neighbors. I was also going to do a split faced block

4 so it doesn't have just the metal building look. It

5 actually has a nicer appeal.

6 And I really do want to do a first

7 class job here on this project, and it's would be

8 beneficial, and I'm looking to have a win/win situation

9 with the residents, as well as the industrial community

10 that I would hope the city would like to see go in

- 11 there someday.
- 12 MR. COURTRIGHT: This gentleman seems
- 13 to have a very good handle on everybody's concerns, so
- 14 I think maybe if you and him speak, maybe you'll be
- 15 able to work something out. He seems to have a pretty
- 16 good idea what everybody else in general has spoken on,
- 17 and he seems like a reasonable guy, so maybe you guys
- 18 can work something out.
- 19 MR. HOLECKO: Sure.
- 20 MS. EVANS: Well, I would add, though,
- 21 I think maybe you need to include some of the
- 22 residents. They need to be satisfied. I don't think
- 23 that's enough to speak to one, you've got to talk to
- 24 all of them.
- 25 MR. COURTRIGHT: I didn't mean to

- 1 exclude any of the residents, I just said --
- 2 MS. GATELLI: He'll just be the
- 3 conduit, as all neighborhood leaders are. Okay. Now
- 4 we have to conduct the second public hearing.

- 10 read the newspapers, and we come here every week, and
- 11 we're very well informed. And we have to remember one
- 12 thing, we are the future, and what we do now will
- 13 affect us in the future. Thank you.
- 14 MS. GATELLI: Thank you.
- 15 MS. GATELLI: Anyone else?
- 16 MR. MCTIERNAN: Doug, I just want to
- 17 thank you. Kevin and I talk often at the lunch and the
- 18 school, and prior to this he was talking about a birth
- 19 of progressive ideas in the city, and we most recently
- 20 he said that, you know, he thinks that with this new
- 21 City Council, we'll probably enter a period of great
- 22 intellectual fecundity, and I think we're going to have
- 23 a lot of growth and prosperity, and a lot of it will
- 24 come through you folks. We really appreciate it.
- 25 MR. MILLER: You're welcome. Thank

1 you. Thank you very much.

2 MS. GATELLI: Jackson. Before Jackson

3 starts his speech, I'd just like you to know that he

4 has all the equipment and he has donated it for the

5 meting in South Side, all the audio equipment, and he's

6 going to be taking care of that for us at the meeting,

7 and he's to be commended for that. Thank you.

8 MS. LOCKHEED: You're welcome,

9 Mrs. Gatelli. Good evening, Council. I would also

10 like to thank Mr. McTiernan and the City Council for

11 considering the idea that we have meetings with the

12 youth, with Scranton's youth.

13 It is really important. They do have a

14 lot to say, believe it or not, and I'm very excited.

15 And I can't wait until Doug has an update after the

16 meeting for you. Thank you.

17 MS. GATELLI: Thank you very much. We

18 have just a slight holdup. We have a proclamation for

19 this evening. Mrs. Garvey, is there someone here to --

20 MS. GARVEY: Is there someone here?

21 Theresa? Okay.

22 MS. GATELLI: Okay. We are presenting

- 23 a proclamation to Theresa Kluchinski.
- 24 Whereas, the Council of the City of
- 25 Scranton is desirous of honoring The Slovak League of

- 1 America in recognition of the Slovak League holding its
- 2 54th Congress in the City of Scranton; and whereas, the
- 3 Slovak League of America is a civic and cultural
- 4 federation of Americans of Slovak ancestry that was
- 5 founded in Cleveland, Ohio in 1907; and whereas, the
- 6 League was founded in response to the need to bring the
- 7 sad political and social plight of the Slovak nation
- 8 home; and whereas, The Slovak League of America
- 9 actively promotes close American-Slovak ties through
- 10 various cultural and educational exchanges and
- 11 projects.
- 12 As an umbrella organization, it
- 13 represents the overwhelming majority of organized
- 14 Americans of Slovak ancestry; and whereas, The Slovak
- 15 League of America remains a positive bridge uniting the
- 16 old world and the new in which Slovak culture and
- 17 traditions are better appreciated.
- 18 Slovak Americans can be proud of their
- 19 many contributions to the culture, education, business

- 20 and religious traditions which form the fabric of
- 21 American life.
- 22 Now, therefore, be it resolved, that on
- 23 Thursday, March 23, 2006, Scranton City Council wishes
- 24 to recognize The Slovak League of America, for holding
- 25 their 54th Congress in City of Scranton.

- 1 Be it further resolved, that this
- 2 proclamation be made a permanent part of the minutes of
- 3 this Council as lasting tribute to The Slovak League of
- 4 America. Congratulations.
- 5 MS. GATELLI: Also, before we start
- 6 with speakers, just to let you know that we had another
- 7 meeting today with the committee that's interested in
- 8 the non-profit organizations and the pilots, and we're
- 9 forming our strategy. I'm not going to tell anyone
- 10 just yet, because we don't want to show our hand, but
- 11 Amil is here assisting us, and we also had the Mayor
- 12 with us today, who assured us that he also will go
- 13 forward in trying to get the non-profits to contribute.
- 14 So, just to keep you updated, we are
- 15 continuing our progress in a positive direction with
- 16 the non-profits. The first speaker is Andy Sbaraglia.

- 17 MR. SBARAGLIA: Andy Sbaraglia, Citizen
- 18 of Scranton. Fellow Scrantonians, Judy, I'd like you
- 19 to expand that meeting with the 500 Lackawanna Avenue
- 20 project to include the people that are affected in that
- 21 project.
- 22 There's a lot of people that are
- 23 affected, and they should be brought here, too, and we
- 24 have it all in the open.
- 25 I got the brochure here. I went

- 16
- 1 through it. The State is coming up with \$9 million.
- 2 PennDOT Hometown Street Program, I assume they're going
- 3 to fix our streets in front of this project?
- 4 MS. GATELLI: I'm not sure. That's why
- 5 I'm having them come here.
- 6 MR. COURTRIGHT: I think it's the
- 7 streets and the sidewalks, I think, Andy.
- 8 MR. SBARAGLIA: Yeah, I think so, too.
- 9 You notice we can't get sidewalks in the neighborhood,
- 10 because we don't deserve them, but other people do.
- 11 Okay. Now this MUFFI funding program,
- 12 I assume they're going to come through with money to
- 13 fix some of the interiors of this building. It's in

- 14 your brochure, so they must coming through, or it
- 15 wouldn't be in here.
- 16 Now, who's paying for this park in the
- 17 back? They're going to put a park behind this complex.
- 18 I assume the city is. I don't know who else would do
- 19 it, but somebody has to.
- 20 Now, look what this man is getting.
- 21 Now he's getting \$9 million from the government. God
- 22 knows how much he's getting from these other entities.
- 23 His contribution is probably seven to \$8 million, which
- 24 he's going to borrow from the bank.
- 25 So, you're giving this man a free

- 1 building, because his money doesn't have to come. He
- 2 can use the bank money, because he got enough
- 3 collateral. He got all this money that you're giving
- 4 him, all public money. This guy isn't taking a chance.
- 5 He's given a gift.
- 6 Now, this is your payback schedule.
- 7 This is with \$550,000, supposedly a buyout. The
- 8 borrower shall provide the city with evidence that has
- 9 completed the improvements or the costs of at least \$2
- 10 million.

- 11 Notice we gave them \$9 million from the
- 12 State, to real properties described in B, which I don't
- 13 have, attached herein using the attached project report
- 14 Exhibit C.
- 15 Upon review and approval of the project
- 16 report, the city will provide the borrower with a
- 17 written statement that the borrower has completed
- 18 improvements with a cost of at least \$2 million to the
- 19 real property described in Exhibit A, and the city
- 20 shall mark the note evidencing that this loan satisfies
- 21 and paid in full as if the entire balance of principal
- 22 and interest under the terms therefore have been paid
- 23 in full. Do you understand what that means?
- 24 They're going to forgive him the loan
- 25 if he spends \$2 million of our state money into these

- 1 buildings; in other words, he's getting the loan for
- 2 free. You have a lawyer, if you want to ask him.
- 3 This project is a giveaway. Now, I'm
- 4 not saying it has, you know, it could be done, but not
- 5 the way they're doing it. You got too many other
- 6 people involved. You told me four buildings were being
- 7 excluded from this deal. Is that what you said last

8 week, four buildings were being excluded besides the

9 two tear downs?

10 MS. GATELLI: I think it's five.

11 MR. SBARAGLIA: Okay. Five buildings

12 is excluded. Now, does that make sense? Are we going

13 to -- is this \$9 million going to be used to fix their

14 buildings up in the front, too?

15 MS. GATELLI: Yes.

16 MR. SBARAGLIA: Okay. So, they're

17 getting a new front, but not entirely. So, if that

18 goes that way, okay --

19 MS. GATELLI: I don't know about the

20 interiors, that's why I said we I have to bring him

21 here. I don't know if the old Council knows, but, you

22 know, Sherry and I certainly don't know.

23 MR. SBARAGLIA: Because this man said

24 he had loft apartments to put into these buildings and

25 so forth and so on, but I can see the main thing of his

. .

1 building is to get a free office building brand new on

2 the taxpayers' back, and this is what he's getting.

3 This isn't a project that all this development is

4 there. This is a giveaway.

- 5 This mayor has given away a lot of
- 6 things. That hotel is a giveaway, them parking garages
- 7 are going to be giveaways, and the whole system down
- 8 there is going to be giveaways.
- 9 If that train should ever fall through,
- 10 we're going to have to go bankrupt, because there's no
- 11 way in heck all these people that are in there can
- 12 actually do what they want to do, because it's all
- 13 geared to that train coming from New York with these
- 14 New Yorkers escaping. Well, maybe coming from Jersey,
- 15 too.
- 16 And this is the whole premise of all of
- 17 this redevelopment in Scranton is that train. And
- 18 believe me, if that train doesn't come true, we're
- 19 going to be in one heck of a mess all the way around.
- 20 But I would like you to say -- invite
- 21 all the people involved with the developer. Let's have
- 22 an open meeting, because they probably have a lot
- 23 better questions than me. Thank you.
- 24 MS. GATELLI: Thank you. Mrs. Garvey,
- 25 maybe you would want to write a letter to all the

1 owners in the 500 block. I know I've gone past there,

- 2 and I don't see any addresses, so maybe somebody will
- 3 just have to hand deliver letters to each building for
- 4 them to come if they're interested, yes. Mr. Spindler.
- 5 MR. SPINDLER: Good evening, Council.
- 6 Les Spindler, city resident. Mrs. Gatelli, I'm very
- 7 disappointed last week in your vote for the Greco deal.
- 8 I have to say, I agree with Mrs. Evans.
- 9 I don't think you are for the people of this city. You
- 10 said you fought for the people for 25 years, that was
- 11 for the people from South Side. Now you represent
- 12 people from the whole city, not just South Side.
- 13 So, I'm wondering what kind of deal the
- 14 Mayor offered you to vote yes on this.
- 15 MS. GATELLI: The Mayor didn't offer me
- 16 any deals. I certainly wouldn't do that, Mr. Spindler.
- 17 Mr. Spindler: How can you justify
- 18 voting for Carl Greco? How can you justify that vote?
- 19 MS. GATELLI: Well, Mr. DiBileo did it
- 20 three times. He voted for Mr. Greco's contract.
- 21 MR. SPINDLER: I'm not talking about
- 22 the past, I'm talking about the present. I mean,
- 23 that's --
- 24 MS. GATELLI: I gave my reasons last
- 25 week.

1 MR. SPINDLER: That's the way the

2 politics is in this city, and I'm sick of the politics

3 in this city. It's because of politics in the city, I

4 can't get my sidewalk fixed in the front of my house

5 for a problem the city caused.

6 And Mrs. Gatelli, you took my address,

7 and you never even came up to look at that problem.

8 MS. GATELLI: I called Mr. Parker about

9 it.

10 MR. SPINDLER: Well, like I said,

11 because I didn't vote the way the Mayor wanted me to

12 vote, I'll never have that problem fixed. Mr. Parker

13 will never come up.

14 And I'm sick of the politics in this

15 city, and that's all that Carl Greco vote was last

16 week.

17 MS. GATELLI: Well, that's your

18 opinion, and you're entitled to that.

19 MR. SPINDLER: That's a lot of people's

20 opinion.

21 MS. GATELLI: You're entitled to that,

22 Mr. Spindler.

- 23 MR. SPINDLER: That's a lot of people's
- 24 opinion.
- 25 MS. GATELLI: You're entitled to that.

- 1 MR. SPINDLER: And Mrs. Fanucci, you
- 2 said the vote didn't matter, the Mayor could name
- 3 Mr. Greco anyway. Well, at least if you voted no, the
- 4 people would know where you stood, that you're behind
- 5 the people, not just being a puppet of the Mayor.
- 6 And that's another thing, it's just the
- 7 politics of this city, it's ridiculous. And you want
- 8 to move the city forward, Mrs. Fanucci? With politics
- 9 the way it's going in this city now, this city will
- 10 never move forward. That's all I have to say on that.
- 11 One thing, Mrs. Gatelli, I do have to
- 12 applaud you on talking about Channel 61 last week, if
- 13 it's not going to be funded by the library, you said we
- 14 will come up with -- Council will come up with money to

15 ---

- 16 MS. GATELLI: I'm sure it can be funded
- 17 with block grant money.
- 18 MR. SPINDLER: I was glad to hear that,
- 19 because so many people watch this station. And it

- 20 would be a crime, because it's the only way we get the
- 21 truth out to the people.
- 22 Lastly, you mentioned last week about
- 23 the -- you spoke to Gerry McNamara's mother, he said
- 24 that, you know, she could come in with her husband and
- 25 get the proclamation, I don't see the rush. When I

- 1 brought this up, I didn't mean there was a rush to do
- 2 this.
- 3 My point was to bring Gerry in
- 4 personally. I mean, I think Council could wait until
- 5 he graduates, and I'm sure there will be a Thursday
- 6 available. And I think that's the way it should be
- 7 done.
- 8 MS. GATELLI: Okay.
- 9 MR. SPINDLER: That's just my opinion.
- 10 I think that would be the right thing to do. Thank
- 11 you.
- 12 MS. GATELLI: Thank you. Bill
- 13 Jackowitz.
- 14 MR. JACKOWITZ: Good evening, Council.
- 15 Bill Jackowitz, city resident and taxpayer, registered
- 16 independent voter, retired United States Air Force.

- 17 First thing I want to start off with,
- 18 do you people realize that there's 12 zeros in
- 19 trillion, and we have a nine in front of it,
- 20 \$9 trillion federal debt.
- 21 And second of all, I don't know who's
- 22 in change of pigeons for the City of Scranton, but as I
- 23 speak right now, there's a large amount of pigeons
- 24 sitting on the Scranton Electric sign, and I think
- 25 something needs to be done about that before we have a

- 24
- 1 problem. And if all those pigeons were taxpayers, we
- 2 wouldn't have a debt right now.
- 3 Okay. I would like to start off by
- 4 congratulating Stacey Brown on receiving an award for
- 5 his article on the Everhart Museum, and also his
- 6 article in today's newspaper, St. Peter's Progresses.
- 7 I also commended Mr. Jeffrey Joyce for
- 8 speaking so openly about the St. Peter's Square
- 9 project. Also for securing high level institutional
- 10 funding for the project.
- 11 I interpret that to mean tax relief for
- 12 the citizens, also not a KOZ property. I also commend
- 13 him for that, which means developers are investing in

- 14 this city, not the city investing in developers.
- 15 That's great news for me.
- 16 It sounds to me that I was very close
- 17 to being accurate last week. The interstate system
- 18 passenger rail, Yorkers, travelers, money, very sound
- 19 plan for the improvement of the City of Scranton.
- 20 After reading today's article, I have a
- 21 better understanding of what is happening and why.
- 22 Trust is the key word. So, Mayor Doherty, City
- 23 Council, Chamber of Commerce, Mr. Joyce, Mr. Lynett
- 24 from the newspaper, do not let the citizens of Scranton
- 25 down. Please no backroom deals. Keep the information

- 1 flowing. And, Mrs. Fanucci, if you had anything to do
- 2 with that, I appreciate that, also.
- 3 Now, I'd like to get the same
- 4 information out on the 500 Lackawanna Avenue project.
- 5 Let's get it out there, people. We don't need no
- 6 backroom deals going on. Let's get it out.
- 7 Like I said, the North Scranton Junior
- 8 High article that was in Saturday's paper was great.
- 9 Again, it's telling us what's going on up there. It
- 10 went from apartments, now it's going to office

- 11 buildings, at least we know that now.
- 12 I'm not in favor of the office
- 13 buildings, because I think we have enough offices in
- 14 Scranton right now, but at least we know, so I have
- 15 something I can talk about.
- 16 Okay. Mrs. Gatelli, last week I spoke
- 17 for five minutes, I timed it.
- 18 MR. MINORA: No. You were at the mic
- 19 for 17 minutes, I timed it.
- 20 MR. JACKOWITZ: Yeah, but that was --
- 21 12 minutes of that was City Council's responses to my
- 22 questions. So --
- 23 MR. MINORA: I said you were at the mic
- 24 for 17 minutes.
- 25 MR. JACKOWITZ: I'm not arguing that

- 1 point. I'm saying I only spoke for five minutes. But
- 2 anyway, my point is, let's not change what's going on,
- 3 because we actually have good conversation going on
- 4 here.
- 5 We have debate. Mr. Minora and myself
- 6 just had a small little debate there. City Council
- 7 members are talking with each other. Before the votes

- 8 last week, there was a great discussion going on.
- 9 Mr. McTiernan and Mrs. Fanucci challenged the Minooka
- 10 project. Fantastic. That's what we need. That's what
- 11 these meetings are all about.
- 12 It's not about time. It really isn't.
- 13 If someone is up here for five minutes or 17 minutes,
- 14 it really doesn't matter, as long as there's good
- 15 discussion going on, an open debate, conversation.
- 16 If we get out of here 15 minutes later, big deal. At
- 17 least something was accomplished.
- 18 Now, if we have arguments going on,
- 19 character assassination, that's a different story. But
- 20 when someone's actually speaking about projects and
- 21 trying to get the city moving and cooperation.
- 22 Like I said last week community, the
- 23 first part of the word is communication, the second
- 24 part of the word is unity. That's what it's all about,
- 25 people. That's why we're here. That's why you're

_ _

- 1 here.
- 2 Okay. Another question I have is the
- 3 Granito project, the one going on in South Side. I
- 4 think we need to look into that one, too, and let's get

- 5 that out in the public. The South Side project, the
- 6 old Granito's there on Moosic Street and Pittston
- 7 Avenue.
- 8 MR. COURTRIGHT: So far the only monies
- 9 that's been put into that is loans that they have taken
- 10 from the bank. That's my understanding so far. That's
- 11 all that's been put into it as of now.
- 12 MR. JACKOWITZ: Right. Like I said,
- 13 let's get this out there. Let's find out what the
- 14 taxpayers are actually paying for and what they're not
- 15 paying for, what the developers are paying for and what
- 16 the developers are not paying for, and whether or not
- 17 it's going to actually benefit all the citizens, not
- 18 just a select few.
- 19 It's got to benefit the entire city as
- 20 much as it can. I know not everybody, but there's a
- 21 majority of the people that have to be benefit from
- 22 this.
- 23 And like I said, I really appreciate
- 24 the article that Stacey wrote, and I appreciate Mrs.
- 25 Fanucci's help, if she helped, and whoever else helped.

1 I thought the articles were great, and I really think

- 2 we need to do something about this. And Mr. Minora
- 3 just gonged me, so I guess I have to stop.
- 4 MS. GATELLI: Thank you. Stan
- 5 Narsavage.
- 6 MR. NARSAVAGE: Good evening, Council.
- 7 I gathered some information out of the local newspaper,
- 8 and we all know that's very accurate, their
- 9 information. So, I took it to heart and did a little
- 10 math.
- 11 And the article was about the schools
- 12 in the City of Scranton and how many children are in
- 13 each school and how many -- what percentage and how
- 14 many children come from low income families.
- 15 There were 19 schools listed, one is
- 16 closed, so that left a total of 18. From the numbers
- 17 that they gave, the numbers of students in each school,
- 18 I worked out the avenues, and the overall average comes
- 19 to 51.3 percent of the children in our schools come
- 20 from low income families.
- 21 Now, I'm really just putting that out
- 22 for information for now, but I intend to keep this
- 23 until the summertime comes and this Council votes, I
- 24 assume they'll vote again, I don't know if they will or
- 25 not, on fees for the schools -- or for the pools.

- 1 And I spoke about this last year. I
- 2 believe there were -- the only numbers I had, and help
- 3 me with this, Mrs. Evans, was it 600 students at
- 4 Scranton High that were getting free lunches? Do you
- 5 recall that?
- 6 MS. EVANS: I'm sorry. I don't, but
- 7 probably Mr. McTiernan would know.
- 8 MR. NARSAVAGE: Was that the number,
- 9 Mr. McTiernan?
- 10 MR. MCTIERNAN: Off the top of my head,
- 11 I don't remember, but I can have that for you next
- 12 week.
- 13 MR. NARSAVAGE: Okay. I'm just going
- 14 to use that as the number, because I think that's what
- 15 it was. But this is the overall picture, not just from
- 16 Scranton High School.
- 17 So, I think that's -- out of those
- 18 there were -- there's 8,930 kids in those 18 schools,
- 19 and out of that, 4, 581 children come from low family
- 20 incomes.
- 21 And to charge these kids to go to swim
- 22 at Nay Aug, I mean, what's behind that? Do they want

- 23 to keep these poor kids out of Nay Aug Park or what's
- 24 the bottom line? Anyway, I'll be back in the summer
- 25 and ask this same question, if that vote comes up.

- 1 Mr. Courtright, thanks for getting the
- 2 information I asked you for. It's helpful. And I'll
- 3 probably need some more in the future.
- 4 And the only other thing that I have is
- 5 that I contacted the Pennsylvania Liquor Control Board
- 6 and asked about how many feet an establishment should
- 7 be from a school to sell beer, and they sent me back
- 8 their -- the whole law and the whole form, and it says,
- 9 I'll just basically tell you they recommend 300 feet.
- 10 Now, in the Icebox there's a pizza
- 11 place, at the last one at the end of the strip there,
- 12 that sells beer, and I don't know how far it is, and I
- 13 don't know if anybody else here knows how far it is
- 14 from Scranton High School, but would you have an
- 15 educated guess, Mr. McTiernan?
- 16 MR. MCTIERNAN: I guess it's in excess
- 17 of 300. Probably 300 feet, a football field, so I'm
- 18 assuming a football field and the parking lot is --
- 19 well, our parking lot to the front door from the edge

- 20 to the property.
- 21 MR. NARSAVAGE: Right. Yeah. And the
- 22 only other thing they said is they wouldn't allow any
- 23 advertisement, especially in yearbooks or stuff like
- 24 that for an establishment that does sell liquor or
- 25 beer. Okay. Thank you.

- 1 MS. GATELLI: Thank you. Maureen
- 2 McGuigan.
- 3 MS. MCGUIGAN: Hi. Maureen McGuigan,
- 4 resident of Scranton. I just have two quick things
- 5 tonight. One is one I've been meaning to bring up for
- 6 a while, but I finally got to it tonight.
- 7 I'm really thrilled with a lot of the
- 8 progress in the city, especially in South Side, but
- 9 there's one area of South Side I don't know if we were
- 10 talking of, and I'm not sure what we can do with it,
- 11 it's that stretch between Cedar Avenue and South
- 12 Washington Avenue, which is a really important corridor
- 13 that goes from a commercial and industrial section to a
- 14 residential section, and it's really a mess.
- 15 I mean, I walk that street my whole
- 16 life, and it hasn't changed much. There's a lot of

- 17 glass and garbage, and one time I actually saw a fan
- 18 thrown there, and I'm just trying to think creatively.
- 19 I don't know how much it would cost to put lights there
- 20 or even some trash cans. I'm not even sure how to
- 21 begin looking at that, if a block grant would qualify.
- 22 MS. EVANS: Excuse me. Is that the
- 23 area in which the car business is hoping to relocate?
- 24 MS. MCGUIGAN: I'm not sure.
- 25 MS. EVANS: It's along South Washington

- 32
- 1 and --
- 2 MS. MCGUIGAN: Kane Truck Company or --
- 3 MS. EVANS: No, it's not a trucking
- 4 company.
- 5 MS. GATELLI: It's on Birch by the
- 6 bowling alley where you turn off where Cawley Brothers
- 7 Van Lines is.
- 8 MR. COURTRIGHT: Are you talking about
- 9 near the bridge?
- 10 MS. MCGUIGAN: There on South
- 11 Washington. There's Kane Trucking. There's also --
- 12 I'd love to find out who owns the land -- it's next to
- 13 Allied Company, but that would be a great pocket park.

- 14 I don't know who owns it or something. It's a really
- 15 large piece of land that's been sitting there literally
- 16 since I was born.
- 17 MS. GATELLI: Maybe you will want to
- 18 come to the meeting next week and give us.
- 19 MS. MCGUIGAN: Yeah. I mean, I'll do
- 20 what I can. I just thought I would make you aware of
- 21 it.
- 22 The other thing is, I was just a little
- 23 concerned about something I heard last week on Council.
- 24 This was the quote, I think it came out of the
- 25 discussion about the future of Channel 61. The quote
- 33
- 1 was, The bottom line, it's the administration's way or
- 2 the highway. So, if that's what they want to happen,
- 3 eventually that's what's going to happen. Whatever the
- 4 people want is irrelevant.
- 5 And I think that's -- I was just
- 6 concerned, because I wouldn't want the public to think
- 7 that that's the truth.
- 8 Because the reality is that the future
- 9 of Channel 61 lies in the hand of the fundraising
- 10 committee that's been set up, and the public, that it's

- 11 up to the committee to create a strong three to
- 12 five-year plan for the channel that uses a lot of
- 13 cross-section of funders that thinks outside the box,
- 14 maybe do more educational programming and draw in
- 15 sources from there.
- 16 So, I just wanted to bring that up so
- 17 that the public is aware that, you know, once 61
- 18 becomes incorporated and is a 501C, the administration
- 19 really doesn't have power over it. So, the people do
- 20 have power. So, thank you.
- 21 MS. GATELLI: Thank you. Are you on
- 22 the committee?
- 23 MS. MCGUIGAN: I have Emailed my ideas,
- 24 so I'm probably going to be speaking to them, so I --
- 25 MS. GATELLI: I think that you can

- 1 speak for this Council that we support Channel 61 and
- 2 we will all continue to support Channel 61.
- 3 MS. MCGUIGAN: Okay. Thank you.
- 4 MS. GATELLI: Thank you. Ron Elman.
- 5 MR. ELMAN: Ronny Elman again. These
- 6 glasses cost a couple hundred dollars and I can't read
- 7 out of them. These are from the dollar store. That

8 ought to teach you something. I don't know.

9 MS. GATELLI: These are, too, Mr.

10 Elman.

11 MR. ELMAN: Yeah. I got some notes, so

12 I wouldn't be just rambling all over the place. Before

13 I alienate you all people some more, I try not to be so

14 adverse about Mr. Doherty, but I can't help it. I just

15 -- I just had a bad experience with him, you know,

16 trying to deal with the city, and it seems to me that

17 his only hope of being a good mayor is having a good

18 administration, because he had no experience or

19 expertise in mayoring when he come in.

20 And the people that I've dealt with in

21 this administration, I don't mean the people in this

22 building that are working for him and doing office

23 work, the few people I dealt with, were just -- it's

24 just a terrible experience, and they just don't seem to

25 have the expertise. And they're just not

35

1 conscientious. Every one of them is hard to talk to.

2 I understand what you people have to go

3 through in trying to deal with him. You know, I think

4 he could go down the soup kitchen and hire some

5 qualified people that want to work and have a better 6 administration myself.

7 But I owe Mr. Doherty an apology. I

8 stood here last week or the week before and said his
9 number one priority was the tree house. Today's paper
10 said it's the blight on Linden and Wyoming, so I stand
11 corrected.

12 I was wondering if we're going to --

13 the city was going to tear down these buildings, like

14 we've been doing all over town for the builder and then

15 give the land away. You know, we did that on Sanderson

16 and Green Ridge. That cost a fortune to tear that

17 house down and use the city help and union help and

18 machines and send it to a landfill.

19 And then I was told a few weeks ago

20 that's why there's no money for blight when a house

21 burns down in the neighborhood, it's because that money

22 is wasted on wealthy builders.

23 You know, wealthy people just seem to

24 be able to buy an office in this city. You know, Todd

25 O'Malley is not qualified to be ahead of the school

36

1 board. He gave away tens of millions of dollars in KOZ

- 2 programs, and that's why Scranton is in such trouble,
- 3 if you ask me, and more knowledgeable people than me.
- 4 And I don't understand why we can't go
- 5 after the people in Tripp Park. You know, last week
- 6 they said there are programs to try to recover KOZ
- 7 money when it's been mistakenly used like that, but
- 8 when it's brought up, nothing is ever done.
- 9 Todd told me to come to a meeting and
- 10 say something, I went to a couple school boards
- 11 meetings, he wouldn't recognize me.
- 12 If somebody got 13 years free taxes on
- 13 their house, and they just have one child going to
- 14 school for -- that's over \$100,000, right?
- 15 We got a whole community full of people
- 16 that can afford \$200 and \$300,000 houses going to
- 17 school, and I have \$4,000 a year taxes on my house, I
- 18 don't know where they come from. It started out less
- 19 than \$1,000 11 years ago.
- 20 Well, I heard your bell. You know,
- 21 there's some people in this administration ought to be
- 22 investigated by a grand jury, not have their pictures
- 23 all over the newspaper.
- 24 There's just too much underhanded
- 25 things go on around here. I like to go to a little

- 1 auction on Thursday night in Olyphant, Mr. Savo's
- 2 Auction. I'm going to go back to the auction, because
- 3 I just get all mad and everything, you know, and I just
- 4 don't see nothing being done by you people.
- 5 You just don't seem to have any accomplishments.
- 6 I don't want to get you mad at me, but
- 7 really. What's done? Every day -- you say write a
- 8 letter to the Mayor, send the Mayor this, and I'll go
- 9 see the Mayor. The Mayor just doesn't appreciate you
- 10 guys. He doesn't appreciate these people out here that
- 11 keep coming to meetings.
- 12 He was in the building tonight, why
- 13 didn't he stay an extra hour here and listen to people?
- 14 Because he doesn't care. This administration doesn't
- 15 care about the little man in the city. That's what's
- 16 wrong when wealthy people can buy an office like this.
- 17 Thank you.
- 18 MS. GATELLI: Thank you, Mr. Elman.
- 19 Erik Johnson.
- 20 MR. JOHNSON: Erik Johnson, taxpayer
- 21 and North Scranton resident. Janet Evans, you need to
- 22 be recommended for the great input you did in the last

- 23 meeting for the Minooka project.
- 24 MS. EVANS: Oh, thank you.
- 25 MR. JOHNSON: You did a great job

•

- 1 there, okay?
- 2 MS. EVANS: Thank you.
- 3 MR. JOHNSON: All right. Scranton City
- 4 Hall building often has been a -- oh, wait a minute. I
- 5 want to recommend Michael Garzarella for his great
- 6 speech he made last week at the City Council meeting.
- 7 And lot of people are coming up to me recommending me.
- 8 They're asking me who he is and did he really make that
- 9 speech by himself, and I said, Of course he did. All
- 10 right.
- 11 Scranton City Hall building often has
- 12 been a metaphor for the City Hall and the city
- 13 government. The 1888 building structure reflects the
- 14 opinion and the solid prosperity of the city's
- 15 industrial heyday
- 16 But as mining and heavy industries
- 17 declined, so did the city's tax base and the city's
- 18 ability to tend to the upkeep foundation of the
- 19 building's structure.

- 20 As the city government attention was
- 21 focused elsewhere, mostly on economic survival, in the
- 22 1990s, the roof deteriorated equal to the city
- 23 government beneath it, rain damage to the interior
- 24 offices, heavy tiles fell to the sidewalk.
- 25 In keeping the building in its

- 1 historical pattern, a modern \$1.5 million renovation
- 2 project for the City Hall was announced Monday by the
- 3 city administration, which also includes converting the
- 4 City Hall building heating system from the painfully
- 5 high cost of steam heat central system to the updated
- 6 natural gas, which would be somewhat cheaper.
- 7 The City Hall renovation also reflects
- 8 the long overdue move of the police department out of
- 9 its cramped basement quarters to a state of the art
- 10 building near the Mall at Steamtown.
- 11 The space will be used for a cafeteria
- 12 and other space to benefit city employees. In all, the
- 13 project is a step forward for all the city employees
- 14 and taxpayers.
- 15 And renovation will be paid for through
- 16 rebates from the State Energy Program. Changing the

- 17 heating system will save tens of thousands of dollars
- 18 for the taxpayers and city employees.
- 19 St. Peter's downtown project, a \$50
- 20 million downtown commercial and residential development
- 21 is supposed to mean progress after three motionless
- 22 years. The downtown project will be on track. The
- 23 site now contains mostly unoccupied commercial
- 24 buildings and a parking lot. This project is KOZ free
- 25 and would add to the paying tax bases.

1 Nobody should not criticize the new

- 2 police headquarters, even has a workout gym for our
- 3 police officers and beats all that they had when they
- 4 were cramped in the basement of City Hall to the
- 5 Steamtown Mall's gas chamber room on the bottom tier
- 6 parking garage.
- 7 We as a city are safer than
- 8 Wilkes-Barre as for crime prevention, and we are a
- 9 leather city than Wilkes-Barre.
- 10 Our police department is mostly
- 11 responsible for the incredible job they are doing. And
- 12 we also should be concerned for the safety of our
- 13 police officers.

- 14 Also, when an officer makes an arrest
- 15 or is trying to arrest a criminal suspect and he or she
- 16 tries to take the officer's weapon away from them, the
- 17 officer has the right to protect themselves from the
- 18 criminal and intend to use the officer's weapon to kill
- 19 them.
- 20 The bottom line, the officer has a
- 21 right to shoot the criminal without remarks of who was
- 22 white or who was purple or whatever. Also, the law
- 23 officer by all means need not to abuse his or her
- 24 powers in making a supposed arrest in isolated
- 25 incidents. Thank you for letting me speak.
- 41
- 1 MS. GATELLI: Thank you. Lee Morgan.
- 2 MR. MORGAN: Good evening, Council.
- 3 MS. GATELLI: Good evening.
- 4 MR. MORGAN: You know, the gentleman
- 5 back here with the glasses on with the long dark hair,
- 6 you know, I'd like to agree with what he said that, you
- 7 know, for quite a considerable period of time we've had
- 8 a serious problem here.
- 9 You know, people come to the podium or
- 10 people write to The Scranton Times and they say, Well,

- 11 you guys keep debating the same issues, and that's
- 12 because previous administrations and previous Councils
- 13 haven't answered any questions.
- 14 When you take a look at the meetings
- 15 we've had, we know the city is in severe dire straits.
- 16 We've seen no budget cuts that we can really talk
- 17 about. The budget just continues to grow.
- 18 We keep borrowing, and one time revenue
- 19 sources, we've just done such a halituous job of
- 20 killing the city off.
- 21 And there's no answers, and there's no
- 22 way to pay all this debt off, and yet and still --
- 23 where's the \$6 million going to go come from to pay
- 24 American Anglican back? Where is all this money going
- 25 to come from?

- 1 You know, the school district in San
- 2 Diego in 2003 filed bankruptcy, and I'm going to say
- 3 this once more from this podium, it's time for the city
- 4 to file bankruptcy and quit kidding ourselves that we
- 5 have any way to pay the debt we possess at this time.
- 6 You know, it's come to pass, at least
- 7 in my own opinion, okay, that we're too worried about

8 taking care of people that have a ton of money, and

9 it's continued for a long time.

10 So, I mean, evidently it's time for the

11 people who come last for once to come first. And until

12 this Council decides that it's important enough to make

13 a change in direction, it's never going to happen.

14 Okay. We can all talk about how we

15 elect people to represent -- we elect public officials

16 to represent the people, but that's not really going on

17 in any level of American government from the federal

18 government right down, because they're all bankrupt.

19 We're selling all our fixed assets.

20 The toll roads in Indiana, the skyway in Chicago, I

21 mean, we're selling this country off piecemeal, okay?

22 And what I'm saying to this Council is,

23 when the next budget comes, let's cut it by $10\ or\ 20$

24 percent and let's send a strong message to the

25 administration and to the people in this city that

1 we're going to make a change in direction.

2 And to be bluntly honest with you,

3 probably the people in my age bracket are going to take

4 the hardest hit.

- 5 But you know what, somebody has to pay
- 6 the piper and we have to free these children and give
- 7 them a future, and it lies on us to make that change.
- 8 And the other thing I have is, in
- 9 regards to the playground at Nay Aug Park and in
- 10 regards to naming it in honor of Morris Jackson, has
- 11 anything happened in that regard?
- 12 MS. GATELLI: I got a letter from the
- 13 Rec. Authority saying that they didn't have the power
- 14 to do that.
- 15 MR. MORGAN: Okay.
- 16 MS. GATELLI: And I forwarded the
- 17 letter to the Mayor, but I haven't heard anything.
- 18 MR. MORGAN: Well, I think that
- 19 somebody needs to follow that up and make that happen.
- 20 MS. GATELLI: Okay.
- 21 MR. MORGAN: I had some questions on
- 22 payments to PEL, and, you know, you might have had them
- 23 last week, I wasn't here, and I'm just curious, do you
- 24 have that figure? Okay.
- 25 MS. GATELLI: We'll get it for you.

1 MR. MORGAN: Okay. I think that this

- 2 Council needs to take a good hard look at what causes
- 3 blight, because a lot of the city's blighted, and we
- 4 can't keep chasing blight all over the city, and I
- 5 think we need to take a welcome at the tax code.
- 6 I mean, there's a lot of answers here.
- 7 And I seriously question why we can't have a playground
- 8 program in this city. We've got money for all these
- 9 projects, but we have no money for the children in this
- 10 city. And I can't understand why the county can't
- 11 spend some money either.
- 12 I think we need to take a hard look at
- 13 the heroin and the crack problem in this city and
- 14 realize that there's a lot of gang violence outside of
- 15 this city.
- 16 As a matter of fact, there was a
- 17 shooting in Easton that was gang-related, and that wave
- 18 is going to come here. And if we aren't prepared to
- 19 spend money on children to give them an outlet, we're
- 20 only kidding ourselves.
- 21 And, you know, we can all talk about
- 22 what our future is. You know, the mayor's talked about
- 23 how the young people are our future in regards to
- 24 development, but really and truthfully, you know, our
- 25 future is the children in the communities.

- 1 And the last thing I have here is, you
- 2 know, I hope that the Junior Council, that we could put
- 3 one or two people on that Council that have dropped out
- 4 of high school, because I think it would be a good
- 5 thing to have them represented here, too, because they
- 6 are the youth of this city, and I think that we should
- 7 acknowledge that they exist and there needs to be two
- 8 seats at least made to seat them. Thank you.
- 9 MS. GATELLI: Thank you. Julie Jones.
- 10 MS. JONES: Good evening, council.
- 11 Julie Jones, Scranton resident. I'm here tonight for
- 12 several reasons.
- 13 Last week it was mentioned that we
- 14 should be happy that new businesses are coming to the
- 15 downtown. Well, I would be happy, also, but when it
- 16 affects the Scranton residents' money by putting the
- 17 city more in debt, then, no, I am not happy at all.
- 18 Also, the Mayor seems to only care
- 19 about the downtown and Green Ridge, and the heck with
- 20 the rest of the city. There are new businesses opening
- 21 up outside the city, but you never hear about them.
- 22 Speaking of that, I would like to

- 23 announce that a new business has opened at 1621 North
- 24 Keyser Avenue called Nature's Outlet. They carry a
- 25 variety of natural items for those of you who are

•

- 1 interested or are currently buying things from the
- 2 internet.
- 3 If they don't carry what you are
- 4 looking for, it can be ordered. But, once again, you
- 5 do not hear about these other new businesses, because
- 6 they are outside the city's inner circle and of no
- 7 concern of the mayor.
- 8 When I drove through town on the day of
- 9 the parade, I said to myself, Wow, why can't the city
- 10 look clean like this all the time?
- 11 Once again, I'm asking for your help
- 12 with few things. Did the letter go out to
- 13 Mr. Scopelliti, and if not, I am asking that this
- 14 matter be addressed. Spring is here and the problems
- 15 will be starting.
- 16 Also, at the corner of Feeney and Oak
- 17 Street, the catch basin is terrible. If by accident
- 18 your wheel was to land in it, you would never get out.
- 19 You would have to have a tow truck come to get you out.

- 20 Also, the people in that area are hoping that it is not
- 21 a sinkhole opening up.
- 22 Also, I need your help with another
- 23 never ending problem. Once again, I received a parking
- 24 ticket in the 200 block of Linden Street with
- 25 25 minutes still left on my meter. I am very

- 1 disappointed with the Scranton Parking Authority and
- 2 Mr. Wintermantle. I left several messages for him to
- 3 call me and no response.
- 4 Well, I guess that is just one more
- 5 city department ran by the behind-the-scenes ghost,
- 6 Mr. Doherty.
- 7 Can anyone tell me why they put permit
- 8 parking in the Hill Section -- when they put permit
- 9 parking in the Hill Section and why?
- 10 MS. GATELLI: I think it's in several
- 11 places in the Hill Section, and I think you have to --
- 12 so many names on a petition from the block.
- 13 MS. JONES: Well, I think parts of
- 14 downtown, especially where the high rises are where the
- 15 elderly are, permit parking should be put into effect.
- 16 The workers from downtown can pay to park in the

- 17 garages and give the little guys a break by spending
- 18 money they don't have on parking meters.
- 19 Also, I would hope to see from this
- 20 evening on that the same rules apply for Council
- 21 members as they do for the speakers.
- 22 Last week things were said by Council
- 23 members that if we were to say them, we would get
- 24 gaveled.
- 25 Finally, I would like to say that -- I

- 48
- 1 would like to say that Doug, if he doesn't already --
- 2 if he hasn't already, if he could -- being that Doug is
- 3 in charge should have a list of all Junior Council
- 4 members' phone numbers to call them if they absolutely
- 5 have to be at a set meeting, like, when they took the
- 6 photo for The Times.
- 7 My son has not been able to make the
- 8 past few meetings due to work. How many kids today
- 9 would be out there today working their butts off to pay
- 10 for a trip to Florida that holds a cost of \$750 to go
- 11 to?
- 12 We were able to help him a little, but
- 13 he did the rest. We could not help that much because

- 14 we, ourselves, are trying to stay afloat in this
- 15 expensive city.
- 16 In closing, I would like to say good
- 17 luck to Ms. McCollough and the advanced string students
- 18 at Scranton High, as they will be performing in Florida
- 19 next week, and I am proud to say my son Cory will be
- 20 part of that performance. I thank you for your time.
- 21 MS. GATELLI: Thank you. Pedro
- 22 Gonzales.
- 23 MR. GONZALES: Good evening, Council,
- 24 and all in attendance. My name is Pedro Gonzales,
- 25 South Side resident, taxpayer and registered voter.
- 49
- 1 I want to start off by apologizing to
- 2 La Senorita Gatelli and Ms. Fanucci. Last time I was
- 3 here, I didn't congratulate you guys on your seat. I
- 4 want to congratulate you guys. I apologize for that.
- 5 You come up here, everybody comes up
- 6 here and they have their little agendas, and so forth
- 7 and so on, and me, I'm a nervous wreck. I might not
- 8 show it, but I am. You know, you get the butterflies
- 9 in the stomach, the whole thing, but so be it.
- 10 I want to speak about the Lupus

- 11 Foundation, our function that we will be having at the
- 12 Boscov's at Steamtown Mall this Saturday, the 25th.
- 13 Please, I urge all in the city to come out, have fun.
- 14 Kids, family, grownups, Latinos, all people, please,
- 15 come on out. We will be having free health screenings,
- 16 blood pressure screenings, body fat analysis,
- 17 cholesterol screenings, free lupus testing, all of it,
- 18 again, all by volunteer people. It's just ten dollars
- 19 to register. You get a shirt, you get to walk in the
- 20 mall. I think it's about maybe two miles, if that.
- 21 You walk a couple times upstairs, a couple of times
- 22 downstairs, and hopefully someone could write about it
- 23 in the newspaper and we'll see how that goes.
- 24 The next thing I want to speak about is
- 25 the job placement. Please, all in the city, since the

- 1 last time I was here, we've gotten a lot of calls from
- 2 employers looking for employees.
- 3 So, anyone out there, Latin or not,
- 4 that needs a job, please, just because we or I
- 5 represent or we represent the Latin people, and I'm one
- 6 of the representatives, that means nothing as far as a
- 7 person that needs a job or needs to feed their family

- 8 and so forth and so on.
- 9 So, anyone in need of job, please call
- 10 504-4455, and we would gladly help you in any shape or
- 11 form.
- 12 And last but not least, I want to speak
- 13 about the Latin Day Parade that we're trying to
- 14 organize. I want to the police department, like you
- 15 told me to do, and they were great.
- 16 The police chief, Corporal Newcomb, my
- 17 hat's off to them. They were great, very respectful,
- 18 very attentive, and they are willing to do whatever or
- 19 to help in any shape or form.
- 20 We're shooting for August the 12th.
- 21 We're shooting for August the 12th. And it turns out
- 22 that you do not need a permit from the people upstairs.
- 23 It turns out that we need permission from them and
- 24 permission from the Council and the mayor's office.
- 25 So, we're in the process of forming a paper to write a

- 1 proper request for that subject, and we will present it
- 2 to you guys, and hopefully the Mayor will respond.
- 3 We've sent letters to him in the past,
- 4 and still have nothing from him. We've tried calling

- 5 his office, tried to contact him, he has not responded 6 yet.
- 7 Never seen the man, only on TV, so
- 8 forth and so on, I have nothing against him, so I can't
- 9 saw nothing bad about him, but he used the Latin people
- 10 for part of his platform to get re-elected, and, again,
- 11 still we have heard nothing about this man or from this
- 12 man as far as what is he doing for the Latin people in
- 13 the city.
- 14 I would love to know. And, again, if
- 15 someone can contact him and he could contact us, again,
- 16 the number is 504-4455. We would love to hear from him
- 17 or someone in his office. That would be great. That
- 18 is all I have for tonight. I want to thank you all for
- 19 listening and letting me express myself. Once again,
- 20 my name is Pedro Gonzales, God bless you all.
- 21 MS. GATELLI: Thank you, Pedro. What
- 22 time does the lupus walk start?
- 23 MR. GONZALES: It starts at eight in
- 24 the morning, so please don't hang out the night before,
- 25 but it starts about eight in the morning. 8:30 starts

1 to warmup, nine o'clock starts the walk. I will be

- 2 doing the warmup up on the stage. About ten o'clock we
- 3 will be having a dance, dancers from Keystone College,
- 4 he steppers, come out.
- 5 We have a vast amount of volunteers
- 6 from all over the city, students, students from the
- 7 high school, a lot of juveniles coming out, and, no
- 8 they are not delinquent, and we have Scranton
- 9 University is coming out, Scranton University students
- 10 are coming out, Keystone College students coming out.
- 11 A lot of different organizations will
- 12 be there, again, Mercy Hospital, the Lupus Foundation,
- 13 Uno Fitness. So many things are happening. The
- 14 Lackawanna Children's Library will be there doing
- 15 things for the kids. Everything, again, free of
- 16 charge.
- 17 We will be having free cooking demos,
- 18 healthy cooking demos, except for one. There will be a
- 19 hot dog sale. So, you know, that was out of my hands.
- 20 You know, I tried, I tried on that one, but, please, I
- 21 ask all the Latinos (UNTRANSCRIBABLE) come on out and
- 22 have fun and enjoy the day.
- 23 There will be tons of informative
- 24 information on brochures so forth and so on, English
- 25 and in Spanish. This event is very Latino friendly.

- 1 And, Lisa, sorry if I messed you up a little bit there.
- 2 MS. GATELLI: Thank you. Is there
- 3 anyone else who would like to speak before Council?
- 4 MR. DUDEK: Mike Dudek, 608 Depot
- 5 Street, Scranton, PA. I live in The Plot. As I'm
- 6 looking over our student council here, the thought
- 7 occurred to me, I going to speak tonight, but something
- 8 did occur to me that may be a worthwhile project to
- 9 consider, if you take a look where Electric Street,
- 10 Shawnee Avenue, Penn Avenue and Capouse Avenue
- 11 interlace in Green Ridge, it's in a section that people
- 12 who live there call the islands. Janet, do you know
- 13 where I'm talking about?
- 14 MS. EVANS: Yes, I do.
- 15 MR. DUDEK: Okay. At one time there
- 16 was a homeowner there who used to take one of those
- 17 islands and plant flowers on one of them, okay?
- 18 My thought was, and looking over here
- 19 we have a pretty good labor force, why not take all of
- 20 these islands and really do a project, a 12-month a
- 21 year project with these islands to keep them constantly
- 22 looking beautiful? You know, flowers for nine months

- 23 of the year, and then for the three winter months,
- 24 whatever the students want to do with it, do something
- 25 with it. That was one thought that I had.

- 1 On a more practical level, about
- 2 22 years ago a science teacher in Mid-Valley named
- 3 Sylvester Luckasiewicz, had his 9th grade science
- 4 students take different soil samples from throughout
- 5 the school district in the towns of Throop, Olyphant
- 6 and Dickson, and about ten of the samples came back at
- 7 13,000 times the normal amount of lead.
- 8 And those samples were so dangerous
- 9 that they were actually dangerous to handle in a
- 10 laboratory setting, so Mr. Luckasiewicz sent them off
- 11 to Penn State University, and that was the beginning of
- 12 the Superfund site in Throop, that, you know, about the
- 13 Marjol Battery. That's how it began. It began with
- 14 9th grade students doing a science project.
- 15 And, again, looking with the students
- 16 here, typical projects could be, for instance, taking
- 17 samples of water quality along the entire length of the
- 18 Lackawanna River, also where Roaring Brook comes into
- 19 the city and meets the river.

- 20 There's a number of science projects
- 21 that perhaps could be done to see whether or not
- 22 Scranton may have their own hot spots of danger, just
- 23 as the Mid-Valley School District accidentally found
- 24 about 20-some years ago.
- 25 Just a couple of thoughts that I want

- 1 to run by Council, and perhaps something very
- 2 practical, very oriented to their abilities to do the
- 3 job, and yet at the same time something useful could
- 4 come out of it. Thank you.
- 5 MS. GATELLI: Thank you.
- 6 MR. DAVIS: Assalaam Alaikum and
- 7 (UNTRANSCRIBABLE). I heard something on television as
- 8 I was coming up tonight about the Lithuanians having a
- 9 celebration or getting a --
- 10 MS. GATELLI: The Slovaks.
- 11 MR. DAVIS: Slovaks. Well,
- 12 (UNTRANSCRIBABLE) is the wrong language? Did I say
- 13 something wrong? Is that correct? Thank you. I'm not
- 14 Polish. Okay. That's a school teacher.
- 15 Okay. The only reason why I came
- 16 tonight is to give these guys this picture. This

- 17 picture is your first picture that I've ever seen of
- 18 you guys together, and I think you should take it and
- 19 you could make copies of it. I'm going to give it to
- 20 the first guy here. You make copies of it and it's a
- 21 good copy, and pass it around. I did the best I could.
- 22 You guys move it around.
- 23 City Council, I'm so glad to be here.
- 24 I was down south last week, I had to go down to a
- 25 family gathering, and it reminded me of a lot of

- 1 things. It reminded me of the road that my father
- 2 travelled before he came here, and my grandfather
- 3 travelled before he came here, and my grandmother
- 4 travelled before, because they all died here in
- 5 Scranton, they all died in the arms of Ms. Franklin. I
- 6 give tribute to her, also.
- 7 But first of all, I give tribute to
- 8 God, because it's God who's allowed us, and we realize
- 9 that, he's allowed us to prosper in this land, also.
- 10 And I want the kids understand the
- 11 history of all of our people within the confines of
- 12 Lackawanna County, and then we are all very rich with
- 13 history, not just me, not just you, but we all have a

14 right to coexist peacefully and with prosperity as its
15 main goal. We want our kids to be as strong as they
16 can be, we want them to run as fast as they can be, but
17 we also want them to be as knowledgeable of this world
18 we have to live in.

19 We are tired of the fraud, we are tired
20 of the deception that's being placed upon us by
21 politicians for whatever reason, and the only way these
22 kids are going to know how to decipher the truth from a
23 falsehood is to listen with open ears and open hearts
24 and fetter it out all those things that don't match the
25 criterion of truth.

1 That means you got to stay in school,

2 it means you've got to study philosophy, metaphysics

3 and all those other things that go along with it,

4 because then you can get an idea of what they said

5 before you, before you are even thought of.

6 These are cultures that have always

7 tried to decipher the truth for the people and try to

8 gauge the people by what they wanted for the truth.

- 4 MS. GATELLI: He would have to notify

- 7 MS. GATELLI: He's the lawyer. Thank
- 8 you very much for cooperating with the neighbors.
- 9 You're to be commended for that. Thank you.
- 10 MR. LIVELY: Just to let Council know,
- 11 again, I'm B.T. Lively with the Green Ridge
- 12 Neighborhood Association. Mr. Holecko has agreed to
- 13 meet with the neighbors of the area this Tuesday,
- 14 answer their questions, which we'll be formatting for

- 17 He has also agreed at that point to

5 John Papp, I live on Eynon Street.

6 The reason I'm here is a couple things.

7 First of all, the pothole situation, we depend on the

8 public to call them, which they probably do, but why

9 can't truck drivers on the garbage truck if they see a

10 bad pothole, they're going to run over it, they know

11 it's there, jot it down.

12 What about the police? They're all

13 over the city, and I'm sure they got a moment to, you

14 know, jot down an address or a block number or, you

15 know, on these potholes, because I run into some big

16 ones.

17 MR. COURTRIGHT: They do do that. They

18 do call them into dispatch when --

19 MR. PAPP: Do they?

20 MR. COURTRIGHT: Yeah.

21 MR. PAPP: Another thing is two weeks

22 ago or three weeks ago I was here, and, Madame

- 23 President, I talked to you about having the dead end
- 24 signs fixed on 12th Street and Eynon, that's the block
- 25 before the intermediate school, it's right in between

- 1 there. Well, just a week and a half ago there was a
- 2 tractor-trailer down the street, and he can't get -- I
- 3 don't know if you remember.
- 4 MS. GATELLI: Did you give me the
- 5 photos?
- 6 MR. PAPP: Yes. Well, I have some
- 7 more, too.
- 8 MS. GATELLI: Okay.
- 9 MR. PAPP: Well, the same ones, but I
- 10 do have them concerning about the mud.
- 11 MS. GATELLI: That mud, yes. They said
- 12 in the spring, I told you, in the sprung --
- 13 MR. PAPP: In the sprung. I'm waiting.
- 14 I've been here before.
- 15 MS. GATELLI: It might be here soon, I
- 16 don't know. It's here on the calendar, but it isn't
- 17 here in the temperature.
- 18 MR. PAPP: I mean, it's terrible. Even
- 19 the kids walking out of school, they don't walk down

- 20 the sidewalk, they're walking down the middle of the
- 21 road. For one reason when it rains, there's a mud
- 22 hole. There's a mud hole now. It's always mud,
- 23 because everything just comes down that street because
- 24 of no curbing. It's terrible.
- 25 My landlord -- my house stinks half the

•

- 1 time when it rains. You know, and this has been going
- 2 on now for two years.
- 3 So, that's actually I have. And I do
- 4 have the pictures of the 1200 of Eynon, if you would
- 5 like them again, another set, just to remind you. I
- 6 know you're busy.
- 7 MS. GATELLI: I have them. They're in
- 8 my notebook at home. We'll be there.
- 9 MR. PAPP: That's all I have.
- 10 MS. GATELLI: Thank you, Mr. Papp.
- 11 MR. ANCHERANI: Good evening, Council.
- 12 I'm Nelson Ancherani. I'm a resident, taxpayer, city
- 13 employee, and a member of the FOP.
- 14 I heard that you have a letter there
- 15 for me, Mrs. Gatelli?
- 16 MS. GATELLI: Yes, I do.

- 17 MR. ANCHERANI: Okay. So, I'll get
- 18 that later? You ruined half of what I was going to say
- 19 anyway, so -- by having the letter.
- 20 Anyway, it's five weeks since Council
- 21 was going to talk to Ms. Moran about the \$200 a month
- 22 bonus for our returning city employee soldiers.
- 23 You didn't have an answer from
- 24 Ms. Moran, or you would have relayed it to us already.
- 25 Two weeks ago a motion was made to send

- 1 a letter to the Mayor about the bonus, and I bet
- 2 there's no answer from him yet.
- 3 The question about the bonus is now
- 4 ready for Council to draft its own legislation to give
- 5 these soldiers that bonus.
- 6 If it takes your own legislation or by
- 7 motion to do it, do it. There are five of you up
- 8 there, make a motion to pay them. Vote on it. And if
- 9 the Mayor vetoes it, then he shows his true colors.
- 10 Even if the Mayor vetoes it, if you
- 11 can't get four votes up there to override a veto,
- 12 something is definitely wrong.
- 13 We give \$20,000 to the Everhart Museum

14 a year, we give \$50,000 a year to the zoo. This is a
15 one-time payment for the soldiers of approximately
16 \$20,000. Let's show our appreciation. The animals in
17 the zoo don't protect our freedom. The exhibits in the
18 museum don't protect our freedom. They are there for
19 our enjoyment, which we wouldn't enjoy if we didn't
20 have our freedom.

- 21 In today's editorial in the paper,
- 22 because of the planned renovations at City Hall, it
- 23 mentions the police department was moving out of
- 24 cramped spaces.
- 25 I know a lot of people think that I

- 1 criticize the building. The building is a beautiful
- 2 building. We needed it. So, them building it for the
- 3 police department was great.
- 4 And I'm going to say it again, it's too
- 5 small. And the proof of that being too small is that
- 6 the juvenile unit and the training division are not in
- 7 that building.
- 8 The original intent of building that
- 9 building was to house the entire police department, and
- 10 it didn't do it. It's undersized, and it's undersized

- 11 because of budget constraints.
- 12 The parking is horrendous. You would
- 13 think that the parking would be better, but that's
- 14 cramped. Some offices are too big, some too small.
- 15 And at this time yet the juvenile unit still doesn't
- 16 know where they're going, but there has been talk that
- 17 the city wants to eliminate the juvenile unit.
- 18 I've said it before, I'll say it again,
- 19 the juvenile unit is not the city's favorite. We're
- 20 the orphans of the department.
- 21 And, Mrs. Gatelli, have you been by
- 22 Cemetery and Kane Streets since the one pothole was
- 23 fixed?
- 24 MS. GATELLI: Yes. I'm going to have
- 25 Mr. Parker draw up an estimate. He's in the process of

- 1 doing that now and having that done as a project.
- 2 MR. ANCHERANI: They did do one
- 3 pothole, so they did do the intersection.
- 4 MS. GATELLI: Yes, they did. It's the
- 5 water runoff that's the problem there. If they don't
- 6 address that, it's never going to get corrected.
- 7 MR. ANCHERANI: Right. That's even

- 8 Kane and Cemetery, that one is even worse, but I know
- 9 they can't do that in the winter anyway.
- 10 I don't even know if I should mention
- 11 this, but I'm going to. We have a wall right here
- 12 that's bear. We did have a mural at one time on the
- 13 old Storm Pfister Building, it was a mural, it was a
- 14 county building, but maybe some group or artist group
- 15 may want to volunteer with the history of the city. It
- 16 might be something that looks nice there.
- 17 Like, I don't have any contacts in any
- 18 of that, but maybe somebody might have a contact for
- 19 that. It might be something to think about. Okay.
- 20 Thank you.
- 21 MS. GATELLI: Is there anyone else that
- 22 would like to speak before Council. Mrs. Garvey.
- 23 MS. GARVEY: 5-A, Motions.
- 24 MS. GATELLI: Mr. Ancherani, the \$200,
- 25 you said it would cost approximately \$20,000?

- 1 MR. ANCHERANI: Yes, for all the --
- 2 there weren't that many that gone to Iraq. I think
- 3 there's either one policeman --
- 4 MS. GATELLI: Is there a way that you

5 could get us that information for next week?

6 MR. ANCHERANI: Yes.

7 MS. GATELLI: Okay. And then we'll

8 consider doing a motion to have that paid. Try to get

9 us the information, if you can. Thank you. I'd

10 appreciate it.

11 MS. GATELLI: Mrs. Garvey.

12 MS. GARVEY: 5-A, Motions.

13 MS. GATELLI: Mrs. Evans.

14 MS. EVANS: Good evening. Once again,

15 the CDBG program is under assault by the Bush

16 Administration.

17 The President's 20007 budget calls for

18 a \$1 billion reduction in CDBG funding, decreasing

19 levels to the absolute lowest funding we have witnessed

20 in the last 16 years.

21 As I did last year, I wish to make a

22 motion to send a letter stating Scranton City Council's

23 vigorous opposition to this measure and urging our U.S.

24 Representative and Senators to reject any cuts to the

25 CDBG Program.

1 Such letter is to be sent to

- 2 Congressman Kanjorski, Senator Spector and Senator
- 3 Santorum.
- 4 MS. GATELLI: I'll second that motion.
- 5 On the question? All in favor.
- 6 MS. EVANS: Aye.
- 7 MS. NEALON FANUCCI: Aye.
- 8 MR. MCTIERNAN: Aye.
- 9 MR. COURTRIGHT: Aye.
- 10 MS. GATELLI: Aye. Opposed? The ayes
- 11 have it and so moved.
- 12 MS. EVANS: Thank you. I also urge all
- 13 organizations who have received CDBG awards from the
- 14 City of Scranton to contact these elected federal
- 15 officials and voice your opposition in great numbers.
- 16 Kay, have we received a response from
- 17 OECD regarding a status report on the Mulberry Corridor
- 18 Project?
- 19 MS. GARVEY: No, we haven't.
- 20 MS. EVANS: Did we receive a response
- 21 to, I believe it was Mr. McTiernan's motion, that we
- 22 voted unanimously to support regarding the placement of
- 23 liens on all demolition properties by OECD?
- 24 MS. GARVEY: I don't believe we have,
- 25 but I'd probably really have to check that.

- 1 MS. EVANS: Okay. I know that our
- 2 office sent letters to Ms. Hailstone on the following
- 3 dates, January 30, February 3, February 24h, and again
- 4 on March 14, concerning the Mulberry Street corridor
- 5 project.
- 6 I really don't know what else can be
- 7 done there. Sometimes getting information -- maybe
- 8 Mrs. Fanucci can get it.
- 9 MS. NEALON FANUCCI: I was going to
- 10 say, I could probably help you out with that. I know
- 11 that there's been some issues, because PennDOT is
- 12 trying to change the roadway there, and until that goes
- 13 there through or they come to some type of conclusion,
- 14 I don't think there's anything that can be concrete
- 15 right now. I know that that's an issue right now that
- 16 they're dealing with.
- 17 They're trying to make it a two lane,
- 18 and whether or not the citizens are going to -- I mean,
- 19 there are some issues. So, that is definitely holding
- 20 up any information that we've gotten.
- 21 MS. EVANS: If you could find anything
- 22 else out, though, please.

- 23 MS. NEALON FANUCCI: Yeah, I will.
- 24 MS. EVANS: Also, as I travelled our
- 25 area, I met a wonderful family who has one very small

- 1 request of our city, they humbly ask if their
- 2 grandfather, Jerome Lacess, could be remembered with a
- 3 plaque which would be displayed at the Nay Aug Park
- 4 Zoo.
- 5 Mr. Lacess was a zoo attendant who had
- 6 but one credo, to see that the animals were fed and
- 7 comfortable. A shy, soft-spoken man who spoke in
- 8 broken English, he was the only individual who could
- 9 safely walk in and out of the pen of Tilly the
- 10 Elephant, and I know you're all too young to remember
- 11 Tilly the elephant, but I do.
- 12 The story was told to me by his
- 13 grandson, Raymond Herne, of how Mr. Lacess walked from
- 14 his home on West Mountain during the 1958 snowstorm to
- 15 get to the Nay Aug Park Zoo to see that the animals
- 16 were kept warm and fed.
- 17 This was typical of his devotion which
- 18 continued until his untimely death at age 75, which
- 19 occurred while trying to repair a broken water pipe in

- 20 the elk pen. He was gored by a bull elk and died from
- 21 his critical injuries several days later.
- 22 Therefore, I move that Scranton City
- 23 Council purchase a plaque from our Council budget fund
- 24 to honor Mr. Lacess. Further, that Council send
- 25 letters to the Scranton Recreation Authority and the

- 1 Mayor requesting that this plaque be displayed in a
- 2 conspicuous location within the Nay Aug Park Zoo.
- 3 MS. NEALON FANUCCI: Second.
- 4 MS. GATELLI: On the question?
- 5 All in favor.
- 6 MS. EVANS: Aye.
- 7 MS. NEALON FANUCCI: Aye.
- 8 MR. MCTIERNAN: Aye.
- 9 MR. COURTRIGHT: Aye.
- 10 MS. GATELLI: Aye. Opposed? The ayes
- 11 have it and so moved.
- 12 Oh, and before I do go on, I was given
- 13 some information by his grandson and great grandson,
- 14 and these are copies of the news articles, I believe,
- 15 from The Scranton Times in 1964, that include his
- 16 picture, and even some photos of George Lowry at the

- 17 age of 29, who was also injured that day.
- 18 So, if everyone would like to take a
- 19 look, and the Junior Council members might want to see
- 20 that, as well.
- 21 Last evening I attended a Lackawanna
- 22 county Taxpayer Association meeting where Commissioner
- 23 Cordaro addressed the public, I do commend him for
- 24 living up to his duties and responsibilities as an
- 25 elected official.

- 72
- 1 I listened closely to the taxpayers'
- 2 frustration, anger and passionate pleas for help. They
- 3 just wanted his help.
- 4 I listened to Mr. Luckasiewicz, Throop
- 5 Council President, who reminded Mr. Cordaro of his
- 6 roots and the stark financial reality of the majority
- 7 of the residents of Lackawanna County.
- 8 I listened to Mr. Cordaro remind me
- 9 that our county taxes constitute only 18 percent of our
- 10 tax bills in Scranton, but 18 percent for me equals
- 11 hundreds and hundreds of dollars.
- 12 Three critical points occurred to me as
- 13 a result of last night's communications, first, it is

14 so easy, in fact, far too easy for elected officials to

15 spend someone else's money; second, elected officials

16 have the obligation to listen to the people and to

17 carry out their expressed wishes.

18 We have no right to spend your money

19 without your agreement. Taxpayers aren't children.

20 They don't need any powerful politician making

21 decisions for them, rather an elected official serves

22 the people by carrying out the decisions of the people,

23 and, third, although the city and the county work

24 cooperatively on select purchase agreements, none of

25 the three taxing bodies, city, county, school district,

73

1 none consults any of the other on the issue of

2 taxation.

3 These are three reasons, I believe,

4 three major reasons why government fails you. I

5 believe elected officials need to dedicate more of

6 their time to the people to listening, discussing and

7 recognizing the people's needs and the people's

8 decisions.

9 I've learned more from my conversations

10 with citizens of this city and beyond than I ever have

- 11 from any discussions I've had with politicians.
- 12 I also believe that the only way to
- 13 control finances in Scranton is through it referendum.
- 14 I suggested to the taxpayers association to place a yes
- 15 or no vote on the ballot in 2006; for example, should
- 16 the Home Rule Charter be amended to place a financial
- 17 ceiling on the dollar amount a mayor can borrow, or if
- 18 a mayor intends to borrow beyond a specified dollar
- 19 amount, must such borrowing be approved by referendum?
- 20 And aside from the Home Rule Charter, I
- 21 also suggest that a yes/no question be placed on the
- 22 ballot regarding pay to play politics, that is
- 23 excessive financial constructions to candidates for
- 24 elected office.
- 25 Such restrictions could serve to

- 1 curtail the no-bid contracts, job creations, and
- 2 non-union pay raises we've witnessed.
- 3 It's my hope that some organization
- 4 will catch the ball I've pitched and run with it to
- 5 help all the people.
- 6 And finally, I have citizens' requests
- 7 for the week. First, the rear of 908 Pittston Avenue.

- 8 This house has been condemned for years. And although 9 the DPW boarded up the doorways after the doors were 10 stolen and cleared out the homeless who were residing 11 within, the windows are now broken, the siding was 12 painted with graffiti, and there is debris throughout 13 the property. The neighbors are concerned it's a fire 14 hazard and state that it has been in this condition for 15 at least five years. Please update.
- 16 The 300 block of Reece Street and
- 17 Greenbush, there are two vacant lots which are littered
- 18 with garbage and furniture. Please clear the lots.
- 19 And neighbors also request a no dumping sign be posted
- 20 on both of the lots.
- 21 Well, no, actually 408 Honesdale Court,
- 22 garbage has been piled on the side and back porches
- 23 since April 2005, and I believe the resident parks a
- 24 car in the court which causes other vehicles to
- 25 traveling through the court to drive over the

- 1 neighbors' properties. In the winter, snow is not
- 2 plowed because this car blocks the court. Please send
- 3 in an inspector to examine the property and a police
- 4 officer to address the parked car.

- 5 Roundwoods Place, which is located
- 6 between the 900 block of South 9th and Main Avenue in
- 7 West Scranton, specifically between Dunn's Bar and
- 8 Jerworski Printing, please fill potholes. Residents'
- 9 driveways are in this alley, and they report damage to
- 10 the bottom of vehicles. They also fear that someone
- 11 will be injured falling into these potholes.
- 12 Now, this is my third request. I made
- 13 the first request in August 2005; the second was in
- 14 October 2005. So, now I'm going to ask for a written
- 15 response, since both the residence and I have waited
- 16 for eight months, meanwhile potholes in the direct
- 17 vicinity were filled, yet Roundwoods Place was
- 18 bypassed.
- 19 Residents request the installation of a
- 20 stop sign at the intersection of Jackson Street and
- 21 Sumner Avenue next to St. Patrick's Rectory.
- 22 A letter to Mr. Wintermantle, what is
- 23 the monthly debt service on the Casey Garage?
- 24 Also, 926-928 Cedar Avenue, there is a
- 25 blighted property which is unoccupied at this time, and

1 I wanted to add that I received this notification

- 2 tonight from Mr. Garzarella of the Junior Council, and
- 3 I'm very happy to see that either he's reaching out to
- 4 his neighbors or neighbors are reaching out to him in
- 5 order to get their needs placed before Council. So,
- 6 thank you.
- 7 And please continue to send your paving
- 8 requests to www.Janettomkoevans.com. I am compiling a
- 9 list of your requests that will be submitted to our
- 10 office. And that's it.
- 11 MS. GATELLI: Thank you, Mrs. Evans.
- 12 Just to update you on the rear of 908 Pittston Avenue,
- 13 I think you might have been in the ladies room, I
- 14 talked to Mr. Fiorini about that today. I got calls
- 15 from Mr. and Mrs. Kingsley, and it's coming down Monday
- 16 or Tuesday.
- 17 MS. EVANS: Oh, that's wonderful news.
- 18 MS. GATELLI: I'm happy about that.
- 19 And as far as the five years, it's there since I was
- 20 here, so it's about 13 years ago.
- 21 MS. EVANS: Oh, okay.
- 22 MS. GATELLI: Yeah, it's a long, long
- 23 time.
- 24 MS. EVANS: Well, I spoke with Mr.
- 25 Kingsley, so he gave me the information.

1 MS. GATELLI: Mrs. Fanucci.

2 MS. NEALON FANUCCI: I don't have much.

3 I want to respond to a comment that was made last week

4 about meeting with the Chamber of Commerce. I have

5 spoken to them and they decided that we will have

6 weekly or biweekly meetings and maybe sit down and have

7 some communication so that I'm privy to what is going

8 on so that I could come back and report to you. So, I

9 think that that's a wonderful task. And I have to say

10 thanks for the, you know, the idea. It's a good one.

11 And they're very, very accommodating there, and very

12 excited about what we're doing.

13 Also, I have to say one person, oh,

14 don't leave, it's about you, you're right about the

15 fact that we write letters, write letters, write

16 letters and we are not getting where we need to get.

17 I feel that way myself. I think maybe

18 the problem is we need to start picking up our phone

19 and start asking and communicating with each other.

20 We're talking about next week with the soldiers and

21 trying to get them money. We wrote how many letters to

22 Mrs. Moran. Maybe it's time that I am personally going

- 23 to take that tomorrow and call her and see what her
- 24 response is.
- 25 I know I'm inundated with paperwork,

- 1 and I'm sure, as we all are, we get -- out boxes are
- 2 full like this. Maybe that is problem. I can't
- 3 guarantee that's what it is, but I do believe that we
- 4 need to open up the lines of communication so that we
- 5 can start in keeping what we're doing here going
- 6 further than this room.
- 7 So, I just want you to know that I am
- 8 going to make an effort to at least try to reach out
- 9 and pick up the phone and talk to people and say what
- 10 can we do. That's all I have. Thank you.
- 11 MS. GATELLI: Thank you.
- 12 MS. EVANS: Can I just respond to
- 13 something? As Mr. Ancherani knows, the issue of the
- 14 soldiers, active duty soldiers pay had been brought up
- 15 at City Council a number of times over the last two
- 16 years, and Ms. Moran was contacted, and her response
- 17 was, negative, and the Mayor's response was negative.
- 18 I believe you would remember that, Mr. Ancherani.
- 19 And then with regard to the letters, I

- 20 can tell you I also pick up the phone. Some people
- 21 answer a phone call much more readily than others, some
- 22 people perhaps are a lot busier than others, some
- 23 people never respond.
- 24 But in terms of, I think, being able to
- 25 hold an individual to their word, it's always wise to

- 1 get it in writing. Word of mouth can always be

- 6 MS. NEALON FANUCCI: I think that's
- 7 wonderful, but I also believe that actions speak louder
- 8 than words, so I'd rather someone get it done than talk
- 9 about it for a month, so that's why I thought that this
- 10 might be a good idea. That's all.
- 11 MS. GATELLI: Mr. McTiernan.

23 make sure that record is -- information is fair and on

24 the record. Thank you, and that is all.
