2 PROPERTY REVIEW COMMITTEE MEETING HELD ON JULY 11,

3 2006.

4 MS. GATELLI: Are there any comments?

5 If not, received and filed.

6 MS. GARVEY: That's all I have for

7 third order, and I have no clerk's notes tonight.

8 MS. GATELLI: Well, first I'd like to

9 welcome everybody back from our summer hiatus, is that

10 what we would call it? I'm sure that everyone up here

- 11 was bombarded, as I was, with activities and complaints
- 12 that we received at our homes and via E-mails. So, we
- 13 may not have been here, but we certainly were doing our
- 14 duties as Councilpersons.
- 15 I would like to thank George Parker for
- 16 paving Kane Street and Winfield Avenue. It really got
- 17 to be in very bad condition with all the rains, and he
- 18 did a pretty good job, although it's going to take a
- 19 lot of money to put drainage in there. That's really
- 20 the problem there, but for the time being, it's a
- 21 pretty good job.
- 22 I would like to warn everyone, I don't
- 23 know if you had anything like this going on in your
- 24 neighborhood, but last week I had two incidents, one in
- 25 Minooka at my daughter's house, where people were

- 1 selling door to door without a permit, and I called the
- 2 police and reported it.
- 3 The very next day, they were at my
- 4 house on my block trying to do the same thing and I
- 5 again told the gentleman that he did not have a permit,
- 6 if he would go to City Hall and get a permit, he would
- 7 be allowed to solicit door to door.

- 8 He got very nasty and left the porch
- 9 and continued to walk to the rest of my neighbors, and
- 10 I again called the police department, and they came and
- 11 asked him to leave.
- 12 The police officer told me that there
- 13 have been some incidents in the city where people are
- 14 conning the elderly and getting into their homes, so, I
- 15 would just like the people out there to pass the word
- 16 that there are people going around soliciting allegedly
- 17 and trying to get into your homes.
- 18 The elderly should not go outdoors with
- 19 these people for any reason whatsoever. They tried to
- 20 get them to go outside and distract them and then they
- 21 go into their homes and ransack them. So, I would
- 22 please ask everyone in the audience and everyone in the
- 23 viewing audience to pass that word along to be aware of
- 24 people knocking on your door.
- 25 I have a few pieces of correspondence

- 1 that I received, and it was too late to read them at
- 2 the last meeting. Dear Mrs. Gatelli and fellow Council
- 3 members, I'm writing to say a special thank you to the
- 4 Department of Public Works who paved the 800 block of

- 5 Crossen Court. They were polite and pleasant as they
- 6 worked at their specific job to pave the court.
- 7 As a homeowner and taxpayer I'm happy
- 8 to write this thank you. I don't know their names, but
- 9 I felt the least I could do was to sit down and write
- 10 this thank you so they could be recognized publicly at
- 11 Council.
- 12 I feel more people today need to be
- 13 thankful and recognized for a job well done. So,
- 14 thanks again to these DPW workers who did not only do
- 15 their job, but did it in an efficient, competent and
- 16 pleasant manner. Gratefully, Mary Jennings. So, we
- 17 will thank the DPW for that.
- 18 And as we were having the meeting on
- 19 July 27, one of our clerks, Sue Magnotta, took a call
- 20 from a woman and she wanted Council to know that there
- 21 are citizens in the city who are pleased with the work
- 22 of City Council, they appreciate Council's time and
- 23 effort and do not like the perception given by some
- 24 speakers.
- 25 The woman was hoping this could be read

1 on air, as she is very uncomfortable attending the

- 2 meeting. We thank her for her kind comments.
- 3 I met recently with George Parker
- 4 concerning the Tripp Park KOZ project up on Euclid
- 5 Avenue. There are many items that remain unresolved,
- 6 and Mr. Parker is not going to send anything to us to
- 7 take over the streets until he is satisfied, so, we
- 8 will probably hear from Mr. Parker within the next few
- 9 weeks regarding the Tripp Park KOZ project.
- 10 There were numerous potholes filled,
- 11 some streets were paved, Birch Street was also paved.
- 12 They're too numerous to mention because they're from
- 13 the whole summer.
- 14 I wanted everyone to know that I went
- 15 over to meet Sara Hailstone, and I got a copy for the
- 16 request for the block grant money for 2007.
- 17 If the rest of Council doesn't have it,
- 18 I will ask Kay to make copies for them. And the
- 19 requests add up to \$8 million. We will be getting \$3
- 20 million. So, as you can see, there's going to be a lot
- 21 of people that are going to be disappointed.
- 22 So, we will go through these, all of
- 23 Council, we will meet together to discuss them once
- 24 everyone gets an opportunity to look at them, and then
- 25 we will also schedule a public hearing to review these

- 1 applications. And I thank everyone for applying, but I
- 2 hope they would appreciate the fact that certain people
- 3 have to be cut, because, you know, it's almost triple
- 4 the amount of money that we're going to be allocated.
- 5 I also went to the city of Bethlehem
- 6 this summer, and it was a two-fold trip. I went with
- 7 the Architectural Heritage Association. They're trying
- 8 to come up with an ordinance that they can use in the
- 9 City of Scranton that would work in historic districts.
- 10 Certain buildings are historic and they
- 11 have to be remodeled and rehabed in a certain fashion,
- 12 and that has to come through City Council. So, I
- 13 thought it would be beneficial to attend.
- 14 We did attend an architectural heritage
- 15 meeting that they had in Bethlehem and got some great
- 16 ideas that John Moore, the president, brought back to
- 17 his body, and they're currently working on an ordinance
- 18 for that.
- 19 We also met with the director of
- 20 economic and community development there, and I got a
- 21 lot of information on the Elm Street Program that's
- 22 going to be taking place on the one through the six of

- 23 Cedar Avenue.
- 24 If anyone would like a copy of this
- 25 program, Leslie Collins of Scranton Tomorrow is going

- 1 to be the manager, and the goal is to revitalize
- 2 neighbors in proximity to the existing downtown by
- 3 improving the exterior appearance of buildings and
- 4 streetscapes.
- 5 It is to formalize a connection between
- 6 residential neighborhood areas with downtown
- 7 revitalization activities. So, it certainly is an
- 8 eligible project, and they are in the planning stages
- 9 and anyone can have a copy of this grant, also, if
- 10 Council would like a copy.
- 11 The last thing I have from Bethlehem is
- 12 their rental registration program. Down there when you
- 13 have a unit that has at least three unrelated people
- 14 there, you are considered a regulated rental unit.
- 15 Now, we do have a rental registration
- 16 program in Scranton, but it's not as rigorous as this
- 17 one is in Bethlehem. They make a lot of money for the
- 18 city of Bethlehem. They're able to take in a lot of
- 19 revenue.

- 20 In the meantime, they're regulating
- 21 housing, which seems to be one of the prime complaints
- 22 that City Council members receive. I, myself, I guess
- 23 I shouldn't speak for everybody else, but the most
- 24 often complaint I get is always related to housing,
- 25 whether it's overcrowded, whether the yard's a mess,

- 1 blighted condition, student housing.
- 2 So, I think that it would behove us to
- 3 also make copies of this for all of Council, sit with
- 4 Attorney Minora, sit with Fiorini, look at their
- 5 current ordinance and maybe we can work some of these
- 6 new things into it to make the program a little more
- 7 stringent.
- 8 I was happy to see that they're going
- 9 to have a blight task force. I hope that they're
- 10 successful, and I would certainly offer my services in
- 11 any way I can, as I was the previous director of that
- 12 department, and I had a very successful run as the
- 13 director of that program, and I would be willing to
- 14 volunteer my services at any time to help them.
- 15 There hasn't been a tavern closed down
- 16 since then, except for Tony and Mary's, and we had to

- 17 go through many loops and hoops to get that place
- 18 closed.
- 19 And there were ways to work on things
- 20 like with the task force, with the D.A. and the Liquor
- 21 Control Board, who were all involved back in those
- 22 days.
- 23 So, I would ask Council to please
- 24 review this, also, and Amil Minora, and maybe within a
- 25 few weeks we can meet with Fiorini and see if we can
- •
- 12
- 1 work some of these -- and Seitzinger, because I guess
- 2 he's the new blight guy, and see if we can get some of
- 3 these more stringent rules in there and really get the
- 4 properties to come up to shape, especially the student
- 5 housing.
- 6 All right. Before we start with the
- 7 sign-in sheet, I'm just going to read the rules of
- 8 Council that were adopted by this Council unanimously.
- 9 No person shall address City Council
- 10 for more than five minutes, unless extended by the
- 11 Council President. The five-minute limit includes any
- 12 time that Council may speak in response to a person's
- 13 question or comment. All comments shall be directed to

- 14 the Council President.
- 15 No person shall use his or her time
- 16 during citizens' participation to personally insult or
- 17 attack any individual. Personal insults, attacks, name
- 18 calling and other behavior that is inconsistent with
- 19 the purpose and intent of conducting official city
- 20 business shall not be permitted nor tolerated.
- 21 The Council President in her capacity
- 22 shall determine if and when any person violates this
- 23 section.
- 24 Any person violating this section shall
- 25 be ruled out of order by the President and removed from

- 1 the meeting at the President's request.
- 2 I don't think this will be necessary,
- 3 and I certainly will ask Attorney Minora's opinion, not
- 4 just my own, whether things would be inappropriate.
- 5 We welcome your comments, that's what
- 6 we're here for. We're here for you. You represent the
- 7 people, and hopefully we do, too.
- 8 So, I would ask everyone to please be
- 9 kind and considerate of each other. We will respect
- 10 you, and please respect us. We're here for you and

- 11 we're all trying to make Scranton a better place to
- 12 live.
- 13 The first speaker will be Douglas
- 14 Miller from the Junior City Council.
- 15 MR. MILLER: Good evening, Council.
- 16 Doug Miller. I would like to welcome everyone back. I
- 17 hope everyone enjoyed their summer. I would also like
- 18 to wish the best of luck to all the students as we
- 19 begin a new school year.
- 20 As I've said since day one, I feel it
- 21 is very important that involvement from the youth in
- 22 the city is important, children coming here, sharing
- 23 ideas, speaking out and showing their support.
- 24 The goal of the Junior Council is to do
- $25\ \mathrm{that.}\ \mathrm{I}\ \mathrm{encourage}\ \mathrm{all}\ \mathrm{young}\ \mathrm{adults}\ \mathrm{from}\ 18\ \mathrm{or}\ \mathrm{older}$

- 1 who haven't voted before to register. We are very
- 2 fortunate that we have this right.
- 3 Obviously we have the important
- 4 election in the next few months, so I encourage all
- 5 those to get out and vote.
- 6 The Scranton Junior City Council
- 7 continues to serve and take pride in our community.

- 8 This past summer, our Council completed its Clean Sweep
- 9 2006 Program, which was our four park cleanups that we
- 10 conducted at the Woodlawn Street Islands, the Dorothy
- 11 Street Playground, the Minooka Playground and McLane
- 12 Park.
- 13 On behalf of the entire Junior Council,
- 14 I want to thank this time to thank all those who came
- 15 out and supported us, and we really appreciate all the
- 16 support that we get.
- 17 We believe that the key to having a
- 18 strong city is having clean, safe and healthy parks for
- 19 all of our residents.
- 20 Our current projects include the
- 21 Scranton Skate Park, which there will be a fundraiser
- 22 for this Saturday at the Ice Box from five to 9 p.m.
- 23 Please come out and support this project.
- 24 Our most current project is raising
- 25 funds to purchase a children's handicapped swing set

- 1 for Nay Aug Park. All children with disabilities will
- 2 no longer have to sit and watch other children use the
- 3 playground rides and feel left out.
- 4 The Scranton Junior City Council began

- 5 fundraising for this swing set this past weekend at the
- 6 Italian Festival.
- 7 I would like to thank Cesare's Pocono
- 8 Resorts, Scooter's Hot Dog Hut, the Ground Round and
- 9 Alfredo's Pizza Cafe for their generous donations.
- 10 I am proud to announce we raised \$500
- 11 towards this project by selling these raffle tickets,
- 12 and we will continue to raise more.
- 13 I would like to thank all the citizens
- 14 who came out and supported us this weekend by
- 15 purchasing these tickets. We appreciate your help and
- 16 support and trying to make progress in the city.
- 17 Lastly tonight I would like to -- I
- 18 want everyone to hear this message. I'm very upset
- 19 that these meetings are considered to some as their
- 20 comedy hour.
- 21 Just this past week a local radio
- 22 station was airing audio clips from a past Council
- 23 meeting, and they were making fun and making jokes
- 24 about these meetings.
- 25 Now, some people come up here for their

1 five minutes of fame and share no ideas or ways to

- 2 improve this city. It's time that people take these
- 3 meetings more serious and not make a mockery of them.
- 4 We come here to conduct city business,
- 5 and if nobody likes that, then, please, I ask you don't
- 6 come here and waste time. Thank you.
- 7 MS. GATELLI: Thank you. Before we
- 8 continue, Mr. DiBileo, you're next, I have two
- 9 announcements that I forgot to make.
- 10 Charlie Spano asked that we call and
- 11 say that there will be a fifth anniversary gathering to
- 12 commemorate the 9/11 bombings. It will held at McDade
- 13 Park on Monday, September 11 between 8:30 and 9:30 at
- 14 the memorial site near the entrance to the park.
- 15 So, if you're free and you're able to
- 16 get there, it would certainly be nice to have a large
- 17 crowd there.
- 18 And, also, Saturday at eight on Wyoming
- 19 Avenue is the Race For the Cure. You can still
- 20 register the day of the race, and that certainly is a
- 21 cause, especially for women, but also men are affected
- 22 with breast cancer.
- 23 But I'm sure every one of you knows
- 24 someone that either died from breast cancer or is a
- 25 survivor of breast cancer, and most of the money is

- 1 used for research, 75 percent, which is a large amount.
- 2 So, The Race For the Cure is Saturday
- 3 at eight o'clock in front of the old Globe Store,
- 4 Diversified Records. Mr. DiBileo.
- 5 MR. DIBILEO: Good evening, City
- 6 Council members, Madame President Gatelli, Vice
- 7 President Courtright, Mrs. Evans, Mrs. Fanucci, Mr.
- 8 McTiernan, Neil, Kay, Amil, pleasure to be here.
- 9 I'm Gary DiBileo from Scranton. Until
- 10 about nine months ago it was my job to be here every
- 11 Thursday night, and I miss seeing you all, and it's
- 12 been a privilege to serve as a City Council
- 13 member.
- 14 It's no longer my job to be here, but I
- 15 wanted to come as a concerned taxpayer, a concerned
- 16 business owner, a concerned father of a young family,
- 17 and I wanted to share my concerns regarding the \$44
- 18 million of borrowing that's on your agenda this evening
- 19 and for the next two-week period, I believe.
- 20 I simply wanted to ask you to keep a
- 21 few things in mind as you begin to enter this decision
- 22 making process.

- 23 Firstly, this borrowing plan apparently
- 24 will include balancing the budget for this year. But
- 25 keep in mind that the last two years worth of budgets

- 1 being balanced were from borrowed money, also, and
- 2 apparently this plan also includes the next three years
- 3 of balancing the budget with borrowed money.
- 4 And just to me it seems as though that
- 5 doesn't encourage a tightening of the belt. It almost
- 6 seems as though knowing that your next three years'
- 7 worth of budgets being balanced by borrowed money is
- 8 like throwing fiscal responsibility out of the process.
- 9 It's no longer required, because you're already going
- 10 to be taken care of financially.
- 11 Also, you have to ask yourself, I
- 12 believe, have all cost cutting measures been
- 13 implemented prior to allowing for additional borrowing?
- 14 I'd like you also to please keep
- 15 working families in mind, people like most of us, like
- 16 myself, that work from paycheck to paycheck every week
- 17 or every two-week period.
- 18 Also please keep in mind our retired
- 19 workers that live on Social Security that struggle from

- 20 month to month making ends meet.
- 21 Also, this borrowing includes a tax
- 22 increase, and this just wasn't promised to people a few
- 23 years ago, and it's not something that I think people
- 24 can afford, so it has to be really looked at hard and
- 25 we're sure that you will do that.

- 1 And I think that you and the public
- 2 deserve to hear from the person at the top regarding a
- 3 plan for this borrowed money.
- 4 This could be a legal question, but I'm
- 5 thinking that perhaps this borrowing plan can be put on
- 6 the ballot as a referendum. I don't know. That's
- 7 something that maybe Amil Minora might be able to
- 8 address.
- 9 And lastly, as we all know, it's easy
- 10 to borrow money, but it's much more difficult to pay it
- 11 back. So, you know, I think that you can either cut
- 12 costs or cut corners.
- 13 And we're sure that you're going to
- 14 take a real hard look at this plan over the next two
- 15 weeks, it's not an easy decision, but it's one that I'm
- 16 sure you'll pay very close attention to.

- 17 And these are just some of the things
- 18 that I'd like you to consider as you enter this
- 19 decision making process, and I thank you for the
- 20 opportunity to speak, and I thank Channel 61 for
- 21 providing this agenda. Thank you.
- 22 MS. GATELLI: Thank you, Mr. DiBileo.
- 23 MS. EVANS: Mr. DiBileo, if I may, I
- 24 absolutely agree with you that the mayor owes not only
- 25 City Council, but all of the taxpaying residents of the

- 1 City of Scranton an explanation for not only this
- 2 particular borrowing, but for the lack of a five-year
- 3 plan for the dismal financial straits we find ourselves
- 4 in.
- 5 But as you well remember, I think it's
- 6 very difficult to entertain the presence of the mayor
- 7 in City Council, and perhaps if Council were Yankee
- 8 Stadium, we'd have a better chance of getting the mayor
- 9 here.
- 10 MR. DIBILEO: At a minimum possibly is
- 11 there was a program, I'm not sure if it's still active,
- 12 but Conversations with the Mayor, and I don't know if
- 13 that's now defunct, but maybe that's a topic that can

- 14 be put on Channel 61, if not, right here in City
- 15 Council chambers. So, thank you very much. I
- 16 appreciate it.
- 17 MS. GATELLI: Thank you for coming.
- 18 Bob Bolus.
- 19 MR. BOLUS: Good evening, Council. Bob
- 20 Bolus, Scranton. Welcome back, and I guess let the
- 21 games begin, because I'm sure we're going to have a lot
- 22 of them here.
- 23 First of all, I'd like to commend the
- 24 Junior Council. I worked with them throughout the
- 25 summer. Scooter's Hot Dog Hut, our employees
- 21
- 1 volunteered their time to see that hot dogs were served
- 2 to the people that were there. I'd like to thank them,
- 3 but more importantly the job they did. It shows what
- 4 character we're building in the city, and Council
- 5 should be applauded for allowing this to happen. I
- 6 hope other cities and areas take the lead.
- 7 Ironically, though, during La Festa, a
- 8 situation arose. Attorney Frank Costello, who's with
- 9 the La Festa Committee, actually stopped the kids from
- 10 selling raffle tickets. They're saying they have no

- 11 right to sell them.
- 12 They said other people want to sell
- 13 tickets, you know, various organizations, and he and I
- 14 engaged in a dialog about it. I can't say it was
- 15 heated.
- 16 He brought up issues about when I
- 17 campaigned in the city about signs and this and that.
- 18 This wasn't about me, it was about these kids and the
- 19 character we're trying to build in them. The last
- 20 thing he should do is encourage suppression.
- 21 He said, Don't threaten him. I didn't
- 22 threaten him. I said I was going to come here and talk
- 23 about him. I didn't appreciate what he did.
- 24 These kids have every right in the city
- 25 as this Council does this. Is a city property, it's

- 1 for a city function, it's for a city improvement to the
- 2 handicapped kids. To say these kids couldn't do it was
- 3 totally wrong, and I think he should be taken to task
- 4 on it.
- 5 Other members of the committee came
- 6 forward. We compromised somewhat to allow the kids to
- 7 stay in one corner, which was totally wrong.

- 8 No one was complaining, only Mr.
- 9 Costello. I don't think he had a legal right to do it.
- 10 And he's an attorney, and he should know better.
- 11 Let's talk about Mr. Doherty and
- 12 ballparks. While he traveled around looking about how
- 13 ballparks are played, maybe he should go to South Side
- 14 and see how he kicked everybody out of there, what he
- 15 did with our own ballpark. Tell other people how we're
- 16 giving our ballpark away to the University of Scranton
- 17 spending \$30-some million up here on Mulberry Street
- 18 and we're not getting anything out of it, other than
- 19 they're getting a tuition and we'll get a token dollar.
- 20 He should have spent more time talking
- 21 to people about distressed cities, how to bring KOZs
- 22 and non-profits in to pay a fee and educated himself
- 23 with a recreational idea. We're not here for
- 24 recreation. We're here to pull Scranton out of the
- 25 debt he's created.

- 1 You cannot borrow to get out of debt.
- 2 You know, what he could do is show him maybe how to
- 3 bankrupt the city. And we will get bankrupt, Mrs.
- 4 Fanucci. I hate to say that, but, yes, the city can go

- 5 bankrupt, and I believe we're heading there.
- 6 And maybe we need a trustee to take the
- 7 reins and use our assets to be profitable here in the
- 8 city instead of squandering them on a \$1 lease, as we
- 9 did in the one over here with the old station or the
- 10 old garage we had, the old DPW.
- 11 Sometimes I question the relationship
- 12 Mr. Doherty may have with the owners, if it's more of a
- 13 personal relationship or not, and I'd like to explore
- 14 that, why this went on.
- 15 You know, maybe he should give a lesson
- 16 to other cities, show how to borrow to get out of debt
- 17 with smoke and mirrors and then eventually tax your
- 18 taxpaying people that you bury them.
- 19 That when Parade said this is a place
- 20 to come and buy a property, bury them so bad in debt,
- 21 that we give our property away, rather than as other
- 22 cities.
- 23 And I just travelled for the summer
- 24 throughout the continental US mostly on a motor trip,
- 25 and I saw progress in many, many areas, progress that

1 should come here, progress that should show that you

- 2 paw for our assets here, not take them away and give
- 3 them away because our management at the top has an ego,
- 4 an ego to consume our money by frivolous spending.
- 5 He blames unions for not implementing
- 6 the unions -- our Recovery Plan. But isn't it Mr.
- 7 Doherty whose arrogance did not sit here publicly with
- 8 the unions and negotiate as the man as a leader as all
- 9 leaders do in business to sit here and work it out, he
- 10 buried us in debt with arbitration hearings with his
- 11 arrogance. He was going to teach them a lesson.
- 12 He didn't teach them anything, not a
- 13 dime come out of his pocket, but it's out of ours.
- 14 That's the arrogance of leadership.
- 15 The responsibility here with this
- 16 Council is to say no to \$44 million. Find a way to
- 17 make the KOZs, the non-profits, the leachate line that
- 18 I brought up coming from the landfill where you
- 19 generate several million dollars a year here to pay
- 20 this debt. If you take that over a ten-year period or
- 21 20-year period, you do not need to borrow. What you
- 22 need to do is rein this man in --
- 23 MS. GATELLI: Wrap up your thoughts,
- 24 Mr. Bolus.
- 25 MR. BOLUS: I understand. My thoughts

1 are, Give Scranton's citizens the break they need,

2 utilize our assets to generate income, make Chris

3 Doherty, his administration, don't see that Carl Greco

4 gets another raise because he got \$44 million to

5 squander and other people out here, stop the taking of

6 places like Buona Pizza and disgracing the city on

7 national TV because we're incompetent enough on how we

8 run this city and how we discredit our citizens and the

9 taxpayers to give us away. It's Council's

10 responsibility.

11 MS. GATELLI: Thank you, Mr. Bolus.

12 MR. BOLUS: Bring him in to task. Sit

13 him here and let him answer us, how we're going to pay

14 this back how these kids are going to pay it back in

15 20 years. Thank you, Council.

16 MS. GATELLI: Thank you. Bill

17 Jackowitz.

18 MR. JACKOWITZ: Good evening, City

19 Council. 137 percent increase in Scranton. Bill

20 Jackowitz, taxpayer and South Scranton resident, legal

21 citizen, parents and grandparents also legal citizens,

22 retired United States Air Force, my observations and

- 23 opinions.
- 24 \$44 million additional loan to close
- 25 the city budget gap of more than \$6 million in

- 1 anticipated red ink for the next four years.
- 2 A \$6 million deficit in the 2007 city
- 3 budget, which this additional \$38 million will plug.
- 4 This money might be used for police and fire contracts.
- 5 What will the borrowed, and I repeat borrowed money, be
- 6 used for?
- 7 My hope is that Scranton City Council
- 8 has all the correct answers before approving this loan
- 9 of \$44 million.
- 10 The Legion of Doom raised the
- 11 possibility that the mayor was going to borrow \$40
- 12 million again this year, but yet City Council acted
- 13 surprised and stunned when the information became
- 14 public.
- 15 My hope is that City Council will not
- 16 be surprised or stunned when they're called upon to
- 17 vote on this loan.
- 18 My hope is that Council will act
- 19 professionally and have all the answers with legal

- 20 documentation before casting your vote.
- 21 That same vote applies when the vote
- 22 comes up for tax increases. Please do the right thing
- 23 for all the legal citizens of Scranton. We're going to
- 24 be paying for the illegal law breakers.
- 25 I have been reading the articles and

- 1 editorials and letters to the editors in regards to the
- 2 rebuilding of South Scranton.
- 3 Being a resident born and raised in
- 4 South Scranton, I would like someone to explain to me
- 5 how Scranton will benefit by allowing illegal
- 6 immigrants to migrate, live and work in Scranton.
- 7 Does Council, South Side Neighborhood
- 8 Association and the administration realize that illegal
- 9 immigrants do not pay taxes, vote, defend the country?
- 10 What they do do is raise health care costs, raise
- 11 taxes, cause numerous communication problems and more
- 12 than likely the crime rate will arise.
- 13 Again, I am only speaking about illegal
- 14 immigrants. Is that what our politicians and
- 15 neighborhood associations want? If so, so be it.
- 16 Personally I've experienced the

- 17 situation three times, states of New Mexico, Texas and
- 18 Minnesota. I cannot believe that some people are
- 19 blaming the decline in population on the fact that
- 20 people are dying.
- 21 People die everywhere every day. If
- 22 you take the time to read the obituaries, concentrate
- 23 on the surviving family members; example, children,
- 24 brothers, sisters. See where they reside. I'll bet
- 25 that it is not Scranton.

- 1 And while you're reading the paper,
- 2 read the marriage announcements. See where the newly
- 3 married couples will be residing. I bet that it is not
- 4 Scranton.
- 5 67,400 citizens in Scranton currently.
- 6 3,100 jobs lost in Scranton/Wilkes-Barre July 2006.
- 7 Mayor, Council, neighborhood association, it is not
- 8 population, it is the economy, stupid.
- 9 That includes wages, taxes, wages are
- 10 low, taxes are high and going higher. Homeownership.
- 11 How can you own a home at \$20,000 a year? Maybe four
- 12 families moving into one house.
- 13 I'm a very patient individual. My hope

- 14 is that your children, grandchildren and great
- 15 grandchildren have the same patience that I have.
- 16 My advice to the young, do not build or
- 17 buy a house in Scranton unless you are willing to
- 18 educate, feed, provide medical care and deal with the
- 19 crime caused by the illegal immigrants of Scranton,
- 20 Pennsylvania.
- 21 What will bring vitality to the city
- 22 will be the next wave of family sustaining wages and
- 23 lower taxes? It is the economy, stupid, not jobs or
- 24 office buildings or giveaways. Wages, money.
- 25 Why do you think real estate agents

- 1 sell homes, teachers teach, nurses nurse, office
- 2 managers manage, karate instructors instruct and
- 3 Councilpersons govern? For money and wages. It is the
- 4 economy, stupid.
- 5 Wake up, Scranton citizens. Voice your
- 6 opinions. Attend Council meetings.
- 7 137 percent increase in foreign born
- 8 babies in Scranton Hospital. Who is paying, Junior
- 9 City Council? Today I am. Tomorrow you will be
- 10 paying. Good luck.

- 11 City Council, what is the primary
- 12 responsibility of an elected official? Safety of all
- 13 legal citizens. When elected officials and department
- 14 heads are not prepared for emergency situation, that
- 15 amounts to a scary situation.
- 16 We could be talking about human lives.
- 17 How would you like for you and your family to be living
- 18 in unsafe environments like they are in public housing?
- 19 Citizens, attend City Council meetings,
- 20 voice your opinions. We all have one. You cannot
- 21 ignore any longer, unless you are willing to pay for a
- 22 long time. Show up, let your faces be seen and your
- 23 voices be heard, not anonymous unsigned letters.
- 24 Legion of Doom, fair, honest and open
- 25 government. That's what Legion of Doom stands for.

- 1 Until that happens, I will continue to speak and ask my
- 2 questions, hopefully answers.
- 3 Any intelligent person knows the best
- 4 way to solve a deficit is to grow the economy, not run
- 5 up our taxes. It's the economy, stupid.
- 6 MS. GATELLI: Thank you. Mrs. Krake.
- 7 MS. KRAKE: Good evening, Council. My

8 name is Nancy Krake. And, Mrs. Gatelli, I would love 9 you to give those rules to The Scranton Times, the two 10 that were just adopted by Council, because the shirt I 11 have on is what they called us. They have no rules to 12 abide by.

13 MS. GATELLI: Well, unfortunately we

14 can't discuss The Scranton Times here, because if I

15 owned it, it would be a lot different.

16 MS. KRAKE: I would love that actually.

17 And, in fact, I believe the Pennsylvania Economy League

18 should be the people that are called the Legion of

19 Doom, and I'm going to send them this T-shirt after

20 tonight.

21 In fact, the Pennsylvania Economy

22 League has been lying to us for the past 12 years.

23 Jimmy Connors knew that. He had his own Recovery Plan.

24 Three of you Councilpeople served under

25 him under his administration. He never felt that we

31

1 were distressed.

2 By the time he left office, he had

3 accomplished everything that the Pennsylvania Economy

4 League claims they want to accomplish today, and he did

- 5 it without them.
- 6 He brought us out of debt and he gave
- 7 us a nice little surplus. He settled eight union
- 8 contracts with cost of living raises, he paved roads,
- 9 had parties in Nay Aug for everybody, and many, many
- 10 other things he gave us.
- 11 And by the way, he did all this and
- 12 more while being sanctioned by the state. Oh, no. Is
- 13 that what we're supposed to be afraid of now? I guess
- 14 he must have been pretty darn courageous. In fact, he
- 15 must have been brilliant. Maybe we should have hired
- 16 him as a consultant. It probably would have been a lot
- 17 cheaper than the ones we hire now.
- 18 In fact, the Pennsylvania Economy
- 19 League are the consultants to whom we Scrantonians owe
- 20 a debt we will never be able to repay, that is to say,
- 21 the mountain of debt they coerced, encouraged this city
- 22 to become burdened with, and our children and
- 23 grandchildren, if they're still here.
- 24 I think we should take our destiny back
- 25 into our own hands, I think we should be at least as

1 courageous as Jimmy Connors.

- 2 No Pennsylvania Economy League, no
- 3 borrowing, because that's the easy way out. We should
- 4 all work together on a budget.
- 5 Council needs to lead this fight to
- 6 take back our economic future from out of town
- 7 consultants. And I know we would all be willing to
- 8 help. Thank you.
- 9 MS. GATELLI: Thank you. Ron Elman.
- 10 MR. ELMAN: Oh, well. I'm sorry I
- 11 missed the fireworks last time. Before you lay down
- 12 the law, I didn't have nothing about Ms. Fanucci on
- 13 here, except a suggestion. My father once told me
- 14 don't put anything in writing you don't want to come
- 15 back and haunt you.
- 16 See, I only got four things here. It
- 17 shouldn't take much over an hour. The second -- now, I
- 18 want you people to listen to this. I went to McCongee
- 19 about a month ago for a three-day antique car show.
- 20 McCongee is ten or 15 miles from Allentown, and you go
- 21 down a brand new four lane in the middle of nowhere,
- 22 cut through virgin countryside, and guess what's there?
- 23 A sound barrier.
- 24 Scranton has been trying to get Bobby
- 25 Sheridan and those people for eight or ten years.

- 1 There it is sitting out there a half mile on each side
- 2 of the road with nothing around it. And I think that's
- 3 a kick in the teeth for the city and Bobby Sheridan,
- 4 and I think you people need to find out why a half mile
- 5 on each side of the road is in the middle of nowhere.
- 6 And thirdly, I was going to complain
- 7 about these 500 houses that were on the sheriff's sale.
- 8 One of them is right behind me. The poor guy, he told
- 9 me a couple weeks ago, beside losing his house, he said
- 10 he had no oil heat. There's just no way he could make
- 11 it this winter. He had been there seven, eight years,
- 12 I guess.
- 13 I just about paralleled everything Mr.
- 14 Bolus said about trying to borrow ourselves out of
- 15 debt. It's never been done in the history of the world
- 16 that I can find out.
- 17 And I realize Mr. Doherty, you know,
- 18 inherited some problems, a lot of financial problems.
- 19 The problem we face today can't be fixed by the same
- 20 methods used when they were incurred years ago. And
- 21 that's what we're doing.
- 22 You know, years ago there was 25,

- 23 30,000 people, eight, ten, fifteen years ago. Now the
- 24 population is dwindling. The tax base is down to
- 25 nothing, and we got officials that think it's their

- 1 own. You know, what was good then isn't necessarily
- 2 good now.
- 3 We need to find someone that can stop
- 4 this insane borrowing program. The taxpayers --
- 5 there's no tax base left here. This man has to be
- 6 stopped right now. It just can't go on.
- 7 I mean, my taxes have more than
- 8 doubled, and now we're going to really have a mess down
- 9 there when Century 21 starts up, because everybody that
- 10 gets their taxes raised are going to go down and
- 11 complain. It's going to be tied up for years.
- 12 And let me tell you something that I
- 13 bet none of you know, years ago we had a lady, a very
- 14 capable young lady, I forgot, eight or ten years ago
- 15 maybe, she was hired to set up computers, start this
- 16 tax assessment and all of that. Do any of you know
- 17 that?
- 18 And guess what happened to her? There
- 19 was a change in the administration, all the nepotism.

- 20 They hired a young guy that didn't even know how to use
- 21 computers. That office went down the drain in a couple
- 22 of months.
- 23 We're paying double right now for all
- 24 that that was done then. And the real estate company,
- 25 I don't care what they tell you, they cannot be biased.

- 1 They're going to continuously want the highest rate on
- 2 a house.
- 3 I've had some people come by and
- 4 appraise my house for this reverse mortgage, and
- 5 they're crazy. I said, My house, you couldn't sell it
- 6 for two-thirds of that. They say, That's what we think
- 7 it's worth, two different companies.
- 8 In closing I just want to say one thing
- 9 that doesn't even pertain to this, but I'm talking to
- 10 one individual out there in that audience, I hope.
- 11 Three weeks I took my bride over to JC
- 12 Penney. There was a little cat that was three or four
- 13 weeks old running around the parking lot. All these
- 14 women are driving. Nobody is trying to avoid the cat.
- 15 My bride jumps out, tries to catch it.
- 16 It got away. I went home. Then she phones me, I got

- 17 the cat. I went back, and I am not a cat fancier, you
- 18 know. Lump comes to me. I say, Lump, come here, he
- 19 comes to me. Cats just don't come to you.
- 20 Anyway, I'm stuck with this cat. But I
- 21 want to say that somebody is lower than a snack's belly
- 22 to put a little critter out in a parking lot like that,
- 23 and I hope they get my message. Thank you.
- 24 MS. GATELLI: Thank you. Jim Stucker.
- 25 Jim, I think I saw Bill riding the scooter the other

- 1 day.
- 2 MR. STUCKER: Everybody tells me that
- 3 over town.
- 4 MS. GATELLI: I'm just teasing you.
- 5 MR. STUCKER: Yeah.
- 6 MS. GATELLI: Okay. We have an old
- 7 problem again. We have over by the Globe Store and
- 8 Oppenheim's, they're parking their cars again there
- 9 where the busses are parking, and there's no way the
- 10 buses cans park there and pick up people on account of
- 11 the -- they've been parked there and they go inside the
- 12 jewelry shop or donut shop or any place and they just
- 13 park and leave their cars there and they go to the

- 14 bank, and what happens, they turn around, the busses
- 15 are blocking the cars in. So, I don't blame them. I
- 16 don't blame the busses blocking them in.
- 17 MS. GATELLI: We will report that, Jim.
- 18 MR. STUCKER: Yeah. And up on Parrot
- 19 Avenue by the school, there's them holes again. They
- 20 never got to fix them. The city never did. They never
- 21 black topped that.
- 22 And we have a -- I have a friend that
- 23 lives over in my building upstairs, he's been going to
- 24 soup kitchens a lot, he works there, what he's doing,
- 25 he's bringing cakes and pies from there and selling

- 1 them to people. I want to see one of you do something
- 2 about it.
- 3 MS. GATELLI: Maybe you can talk to us
- 4 after, because I don't want you to say any names on the
- 5 air, okay?
- 6 MR. STUCKER: Yeah, yeah. I've been
- 7 doing a lot of work cutting grass.
- 8 MS. GATELLI: Good.
- 9 MR. STUCKER: So, I'm moving again.
- 10 I'm moving over Adams Avenue. I'm going for a knee

11 operation Monday.

12 MS. EVANS: Good luck.

13 MR. STUCKER: Yeah, Mercy.

14 MS. GATELLI: If you need a good nurse,

15 call me.

16 MR. STUCKER: All right. Okay. I seen

17 you at the Italian Festival. I seen you there.

18 MS. GATELLI: Good luck to you, Jim.

19 MR. STUCKER: Yeah. Okay.

20 MS. GATELLI: Thanks. We'll address

21 your concerns.

22 MR. STUCKER: All right. Okay. Thank

23 you. Good-bye.

24 MS. GATELLI: Les Spindler.

25 MR. SPINDLER: Good evening, Council.

•

1 Les Spindler. I would like to welcome you all back. I

2 couldn't make the last meeting in July, so I would like

3 to comment about some things that Mrs. Fanucci said.

4 She accused Mrs. Evans of writing

5 speeches for people here. I've been coming to these

6 meeting for the better part of five years, and I can

7 safely say Mrs. Evans has never written anything for me

8 and I can safely say she hasn't written anything for 9 anybody else in the audience. So, I think you owe her 10 an apology, Mrs. Fanucci.

- 11 Next thing, at the last meeting in
- 12 July, the first part of the meeting lasted twenty
- 13 minutes until citizens participation started. I wonder
- 14 why you had to leave so soon, Mrs. Fanucci. It just
- 15 shows me you don't care what the people have to say. I
- 16 don't think you had to be back from your lunch after
- 17 only 20 minutes.
- 18 Next thing, end of your comments at the
- 19 last meeting said you want to work with the people to
- 20 keep the city moving in the right direction, but at the
- 21 previous meeting you said you won't answer people's
- 22 questions, that they have to write letters to you and
- 23 they might not be answered for 90 days. I don't call
- 24 that working with the people.
- 25 Don't shake your head no, because other

- 1 people here heard that and it's in the minutes.
- 2 And also, if you wanted to work with
- 3 the people, you wouldn't have voted against free
- 4 swimming, that's not what I call working with the

- 5 people.
- 6 And I wondered why you changed your
- 7 mind on that vote. Oh, I know why, Chris Doherty told
- 8 you to change your mind.
- 9 Next thing, Mrs. Gatelli, you were
- 10 quoted in an article in The Times July 25, you said --
- 11 you're speaking about the public speakers. You said,
- 12 Many of them think they represent people as a whole,
- 13 but they only represent themselves. Do you remember
- 14 that quote?
- 15 MS. GATELLI: Yes.
- 16 MR. SPINDLER: Well, I don't think you
- 17 could be any further from the truth. If you knew how
- 18 many people came up to me and said they're glad there's
- 19 somebody like me to come and speak for them. You
- 20 wouldn't believe it.
- 21 MS. GATELLI: That's good. I'm glad
- 22 that you represent the people.
- 23 MR. SPINDLER: Wherever I go, people
- 24 tell me that, so your comment was totally false.
- 25 MS. GATELLI: That's your opinion, Mr.

1 Spindler.

- 2 MR. SPINDLER: No, that's a fact. Next
- 3 thing, the mayor doesn't agree with Mayor Barletta's
- 4 law about the illegal immigrants in Hazleton. Well,
- 5 illegal immigrants don't pay taxes, so I guess that
- 6 means citizens that are here legally don't have to pay
- 7 taxes either. I wonder what would happen if we tried
- 8 doing that.
- 9 Next thing, the party on the Casey
- 10 Garage they had a few weeks, the mayor was blowing his
- 11 horn about the downtown renaissance. What downtown
- 12 renaissance? \$16 million empty building?
- 13 If the mayor wants to have parties in
- 14 high places, he should try having one on the mountain
- 15 of debt he's created.
- 16 Moving on. There's two places in this
- 17 city where I've asked for couple of years to have lines
- 18 painted and they still haven't been done, the entrance
- 19 to the Steamtown Mall on Lackawanna Avenue. For a
- 20 couple of years they have not had lines painted there.
- 21 And also the corner of Franklin Avenue
- 22 and Spruce Street. It's normally three lanes. People
- 23 don't know what lanes to get in there, and that's also
- 24 a couple years lines haven't been painted.
- 25 The next thing, the intersection of

- 1 North Garfield and West Gibson, it's by the Cathedral
- 2 Cemetery, there's no stop sign there. Someone brought
- 3 that to my attention. I never realized that. I travel
- 4 that way.
- 5 And the person who brought it to my
- 6 attention said they've almost gotten killed there a
- 7 couple times, and he brought it to somebody's
- 8 attention, and nothing's ever been done. I think
- 9 that's a dangerous situation. It should be looked
- 10 into. That's all I have tonight.
- 11 MS. GATELLI: Thank you. Mike Dudek.
- 12 MR. DUDEK: Good evening, City Council.
- 13 Mike Dudek, 608 Depot Street, Scranton. That's in The
- 14 Plot.
- 15 I'm going to start by commenting on
- 16 something Mrs. Gatelli said, because I'm so happy to
- 17 hear it, and I'm going to hold the other four Council
- 18 members' feet to the fire on it.
- 19 The very first time in my life I ever
- 20 spoke in front of Scranton City Council was six years
- 21 ago asking the City Council to go to the town of
- 22 Bethlehem and to pick up a copy of the model ordinance

- 23 they have in that city concerning housing and apartment
- 24 rental units in that town.
- 25 It is clearly the very best ordinance

- 1 on an apartments you're going to find in the United
- 2 States. This city needs that ordinance.
- 3 Scranton is an old city, by that I
- 4 mean, the housing stock in this city is perhaps the
- 5 oldest housing stock of any city in the United States.
- 6 Most of the housing in this city goes
- 7 back to the early 1900s. Most of the houses in this
- 8 city are wooden and are over 100 years old. And it's
- 9 my opinion that whenever an apartment changes hands in
- 10 this city, that a city inspector ought to go into that
- 11 apartment and really check it over before it's turned
- 12 over to the next tenant. That is an absolute must.
- 13 And, Mrs. Gatelli, thank you for
- 14 pursuing this. I think you deserve a lot of credit for
- 15 it. And, please, other members of Council, work with
- 16 her on this. It was the very first thing I ever wanted
- 17 to see done in this city once I moved here.
- 18 Second point I want to make, I would
- 19 like to thank The Scranton Times for making these

- 20 wonderful T-shirts necessary for us. Thank you to The
- 21 Times.
- 22 The circulation department of The Times
- 23 put out a little document back in August that shows
- 24 that the circulation of the paper has gone down nine
- 25 percent. Usually when a newspaper suffers that kind of

- 1 a decline that would usually mirror a similar decline
- 2 in the population of a city, but I don't think that's
- 3 the case here.
- 4 I don't think the population of the
- 5 city has fallen much more than four percent in the last
- 6 two years, but for the circulation of a major newspaper
- 7 without competition to fall nine percent, I think
- 8 that's something that they have to deal with. But it
- 9 is a rather frightening thing if it is tied to
- 10 population, okay?
- 11 And the last point that I want to make
- 12 is that we have a city police and fire department that
- 13 still doesn't have a contract after five years.
- 14 Now, later in this meeting the
- 15 president of Council will be reading a list of names of
- 16 police officers who, to me, I think are doing the most

- 17 incredible service I have ever seen. Out of their own
- 18 money, they are buying their own police cars and
- 19 donating them to the city and they are going to be
- 20 using them as their regular police cruisers.
- 21 You're going to be hearing more about
- 22 this most during this meeting and as the story finally
- 23 gets out in the paper.
- 24 But for a group of people, these
- 25 policemen not to have a contract with this mayor, to be

- 1 so dedicated to their jobs that they were buying their
- 2 own equipment to do the job, I think is one of the most
- 3 remarkable things I have ever come across. No wonder
- 4 we call them Scranton's finest. These people really
- 5 are. Thank you.
- 6 MS. GATELLI: Thanks. Dick Laske.
- 7 MR. LASKE: Good evening. Dick Laske.
- 8 Welcome back. Scranton resident. I'm just going to
- 9 tell you something. You can tell it to John Pocius
- 10 when you see him (UNTRANSCRIBABLE). That's Lithuanian
- 11 and it means -- interpreted, I'm old but I'm still
- 12 alive. See, there's no Lithuanians here I can converse
- 13 with now.

- 14 Okay. The Hollow Avenue fiasco.
- 15 City truck was definitely on private property. I
- 16 measured the 50-foot right of way, and it's on private
- 17 property. Mr. Parker can say whatever he has in mind
- 18 to, I'm going to the D.A. about this. I want an
- 19 investigation into this theft of services.
- 20 And while I'm on the subject, did you
- 21 contact Gene Barrett about sending a bill for the sewer
- 22 line on Hollow Avenue?
- 23 MS. GATELLI: No, I didn't. He told me
- 24 that they were being assessed, the property was being
- 25 assessed.

- 1 MR. LASKE: Okay. Well, it amounts to
- 2 a lot of money, because they had a gang up there for
- 3 over a week and they had some pieces of equipment.
- 4 MS. GATELLI: If you go to the Sewer
- 5 Authority, I'm sure you will be able to find out what
- 6 the assessment is.
- 7 MR. LASKE: Okay. All right. Now,
- 8 about the \$44 million. I wouldn't give him a dime. If
- 9 you approve this, you let the taxpayers down. This is
- 10 a time to unite and show the taxpayers you have some

- 11 compassion.
- 12 The senior citizens are at a limit with
- 13 their taxes now. I know some of you will concede to
- 14 the administration's wishes. It's awful the way this
- 15 man wastes money.
- 16 Now, before the meeting started you
- 17 said about Council members being out of order or
- 18 speakers being out of order, does that also apply to
- 19 Council members? Because I've been in this and I've
- 20 heard some nasty things said by one Councilperson to
- 21 another.
- 22 MS. GATELLI: Yes, I would hope that we
- 23 would refrain from such activity.
- 24 MR. LASKE: Well, I think it's a
- 25 two-way street here. If you're going to hold us

- 1 accountable, then you have to hold yourselves
- 2 accountable. Okay?
- 3 MS. GATELLI: That's a fair deal.
- 4 MR. LASKE: All right. Amil, do you
- 5 have the pictures?
- 6 MR. MINORA: No, Mr. Laske, I didn't
- 7 bring them with me. I didn't get your message until

8 this afternoon, and I was already out of the office. I

9 will bring them next week. I'm sure I have them in my

12 MR. LASKE: Okay.

18 MR. LASKE: All right.

21 Go ahead. He doesn't mind.

22 MR. MORAN: Very good. Thank you.

23 Good evening, Council. My name is Bill Moran, I'm a

24 resident of the City of Scranton. I've been so most of

1 First I'd like to say that I'm sorry

2 that we missed Mr. Parker this evening. Several of us

3 had taken time off from work and our family

4 responsibilities to be here to speak with the man. I'm

5 sure we had several things that we could have
6 discussed, maybe not ironed out, but at least put on
7 the table, and I would hope that he would be here in
8 the very near future to do so.

9 In regards to the \$44 million loan, the
10 first question I have to ask you is, look in front of
11 yourself right now. Do you see any documentation for
12 what that loan is going to be used for? Do you see a
13 proposal for the fire department arbitration? Do you
14 see a proposal for the police arbitrations? Do you see
15 a proposal for anything else in front of you? No. You
16 have a \$44 million loan proposal that is, for the most

18 I would liken that to a consumer who

17 part, no explanation why it's in front of you.

19 receives -- who can't pay his own mortgage, which let's

20 face it, we're \$6 million in the hole this year, we

21 can't pay our own mortgage, they receive a credit card

22 application with an amount of a million dollars,

23 whatever, and they say, Wow, this is great. I'm going

24 to go to Florida, I'm going to buy furniture, I'm going

25 to have a great time.

1 The only thing we're forgetting is when

- 2 that bill comes due, we do have to pay it, and we can't
- 3 pay our bills now. With the declining population, how
- 4 do we expect to pay that bill when it comes?
- 5 There's two ways to balance a budget,
- 6 cut spending and to raise taxes. Anybody who works
- 7 with people who have problems with credit understands
- 8 that you cannot borrow yourself out of debt. We can't
- 9 do it. We're only putting ourselves further into the
- 10 hole.
- 11 If we need to raise taxes, that's the
- 12 pain that we have to endure. It's going to happen at
- 13 some point. A loan is not going to solve our problems.
- 14 We have to understand that 23 percent
- 15 of our population in the City of Scranton as reported
- 16 by The Scranton times is under the poverty line. One
- 17 quarter of our people are under the poverty line. How
- 18 can we pay that money back?
- 19 I have suggestions. I hate to come
- 20 here and tell you we can't do this, we can't do that
- 21 without giving you some suggestions.
- 22 I personally can think of one position
- 23 in administration that was created, 65 K a year. That
- 24 along is 260 K in the next four years. There's one
- 25 solution.

1 There were five raises, I believe,

2 given out at \$10,000 a year. Rescind those raises.

3 That's \$50,000 a year, \$200,000 over four years.

4 People who are in those positions will

5 go on to bigger and better jobs after they get out of

6 the administration because of the experience they've

7 had with government.

8 There's no reason that they have to be

9 paid these salaries, they're not exorbitant, I'll

10 agree, they're not huge, but they're too much for what

11 we can afford.

12 Also, I'd like to say that Ms. Gatelli

13 has a fantastic idea when it comes to the landlord

14 licensing. I've read our landlord licensing law and I

15 found several major problems with it.

16 First off, I believe we currently

17 charge \$10 per unit. I worked with the groups that

18 developed the program in Allentown. I believe their

19 fee was \$30,000 a year -- excuse me -- \$30 a year per

20 unit.

21 What that did was pay for the

22 inspectors. The inspectors covered one-fifth of all

- 23 the rental units every year, so every five years every
- 24 unit was inspected, okay?
- 25 In addition, I think what they did was

- 1 go in there when units were sold. That's a good money
- 2 maker. We just brought a new gentleman on to do blight
- 3 control. Instead of paying for him out of the
- 4 municipal budget, let's pay for him out of the people
- 5 who are making money on it.
- 6 Once again, I do want to say I'm very
- 7 disappointed that Mr. Parker is not here. We had a lot
- 8 to say to him, and I think it shows a certain arrogance
- 9 that he would leave all of us hanging like this.
- 10 Finally I just want to say, Mr. Laske
- 11 is lucky to have a new great grandchild. She's lucky.
- 12 She doesn't live in the city. She won't have any
- 13 responsibility for our debt.
- 14 But those of us who do have children
- 15 and great grandchildren and grandchildren in the city,
- 16 those kids will be paying the debt if they live in the
- 17 city.
- 18 There comes a time when you have to say
- 19 no and enough is enough. We need to change what we're

- 20 doing. We're doing things wrong now. We need to make
- 21 a correction. You have the power.
- 22 I know each and every one of you have a
- 23 certain stance, but understand, we can't do it anymore.
- 24 You're breaking our backs. Thank you.
- 25 MS. GATELLI: Thank you. Erik Johnson.

- 51
- 1 MR. JOHNSON: Good evening, City
- 2 Council and staff. Eric Johnson, resident and taxpayer
- 3 of Scranton. Month-long City Council recess hasn't
- 4 calmed any of the troublesome waters that at times seem
- 5 to wave out of control of problems looming to the dark
- 6 side.
- 7 Unless drastic measures are
- 8 accomplished to solve ongoing old and new problems,
- 9 some of the very dark side of the questions that will
- 10 hurt the City of Scranton are, Should Scranton
- 11 administration raise taxes, should Scranton go the
- 12 route of bankruptcy, should the City of Scranton
- 13 contribute to layoffs in all departments from top to
- 14 bottom of all services, or should the city
- 15 administration and Council go for the mayor's \$44
- 16 million borrowing plan which would be used to balance

- 17 the budget over the next four years, make capital
- 18 improvements, as I see, one of the most important and
- 19 expensive issues to settle, the police and firefighters
- 20 contracts.
- 21 Which of the four issues is the least
- 22 damaging? If we raise taxes, which I think is going to
- 23 happen anyway, even if we go with any of the other
- 24 three, it will hurt business and working people to the
- 25 point that both will be leaving Scranton, possibly the

•

- 52
- 1 elderly and poor enduring harder times.
- 2 Bankruptcy would mean all union
- 3 contracts are divorced with the administration.
- 4 Scranton and no credit are progress for many, many
- 5 years to come. And as for capital improvements, forget
- 6 it. Capital would be history.
- 7 Cutting costs and cutting corners means
- 8 layoffs. I see it happening anyway in a possible mild
- 9 sense, but a massive layoff would hurt the City of
- 10 Scranton to the point where the city couldn't function
- 11 properly any more and for sure a rise in crime and
- 12 drugs that would make Wilkes-Barre without compare.
- 13 The last proposal, the \$44 million

14 borrowing plan, as people call the alcoholic plan, will

15 be a quick four-year fix and pay off the police and

16 firefighters arbitration awards and settle the

17 important police and firefighters contract, which I

18 think should be not a four to six-year contract but a

19 12-year contract for all city services, clerks, DPW,

20 building inspectors and police and firefighters. It

21 would benefit the city taxpayers, administration and

22 all the employees.

23 But that wouldn't never happen, so what

24 are we going to do? Whatever happens, it's a big hurt

25 to the taxpayers and the other residents of Scranton.

1 Does the Scranton city labor unions

2 have a better plan? If so, let's hear now before

3 taking on a \$44 million loan. Talking about a \$44

4 million loan from PNC Bank, what's wrong of having a

5 loan or considering First National Community Bank?

6 It's a local bank, who would be for the best interest

7 of Scranton, unlike PNC Bank for its self interest and

8 its headquarters in Pittsburgh. Thank you for letting

9 me speak.

10 MS. GATELLI: Thank you. Lee Morgan.

- 11 MR. MORGAN: Good evening, Council.
- 12 Mrs. Gatelli, you know, I hope you give the people
- 13 watching Channel 61, I mean tonight, Council's phone
- 14 number at the end of the meeting and invite them to
- 15 give their opinions besides the people that are here at
- 16 Council, what they think the city should do in regards
- 17 to borrowing, because there's a lot of unheard voices
- 18 in this city, and maybe they'd be confident enough to
- 19 pick up the phone and speak to Council secretaries or,
- 20 you know, maybe one of the people on Council would be
- 21 there and maybe you get a much better opinion of what
- 22 the people in this city really think.
- 23 And I think that that's the one thing
- 24 we're really missing here is that we have to create an
- 25 atmosphere in this city where the residents can

- 1 succeed.
- 2 We've made a very serious error in
- 3 electing the gentleman that's mayor, mayor. And I
- 4 think that the residents of this city are starting to
- 5 really see that there's been serious errors made on
- 6 their part.
- 7 About a month ago the mayor decided

- 8 that he was going to chase me down and come after my 9 properties in violation of law.
- 10 I image that what's going to happen is
- 11 somebody's going to be sued. But did he have the power
- 12 to do what he wanted to do? Yes, he did, and he used
- 13 it. But was it proper? No, it wasn't.
- 14 And I think that he should have talked
- 15 to a couple of judges in the Lackawanna County
- 16 Courthouse before he decided to come after me, because
- 17 I've got judges in the courthouse that won't even pick
- 18 up their ink pen when I'm in their trial rooms.
- 19 And I think that the mayor has made so
- 20 many errors. Even when he was on Council, he was the
- 21 finance chair who moved the legislation through for the
- 22 Scranton Sewer Authority. That fiasco is still costing
- 23 us a ton of money. He also allowed somebody else to
- 24 run it. They ran all the equipment into the ground.
- 25 It's just been one bit of incompetence after another.

- 1 The pension fund was looted, the DPW
- 2 compound was borrowed against, South Side Sports
- 3 Complex was sold to the University of Scranton and the
- 4 money was dumped into Nay Aug Park.

5 It's been -- Huey Long would really be

6 proud of this gentleman, but this isn't Louisiana, so

7 -- and you see the fiasco they have going on there. I

8 mean, billions of dollars have been pumped into that

9 state and they still haven't straightened out New

10 Orleans.

11 And this mayor has just wasted money

12 time after time after time after time. That's why, you

13 know, that's why I bought this shirt today. And

14 tomorrow, these people here have this Legion of Doom

15 shirt on, but I think The Scranton Times has it

16 backwards, because the Legion of Doom is the mayor and

17 all the consultants and all the hang-on -- all the

18 people hanging on and the PEL and all these people that

19 say they represent us.

20 This city is in the worse shape that I

21 ever remember. We're all talking about illegal aliens.

22 You know something, that's not even the reason to have

23 a discussion here, okay?

24 The real issue here is incompetence.

25 We have got housing projects in this city that were

56

1 built years ago with no fire walls. This has been an

- 2 ongoing problem in this community for a very, very long
- 3 time.
- 4 Just go up to the top of Green Ridge
- 5 Street and look at that school. They had a problem on
- 6 the opposite side of the building. McDade came here
- 7 and offered money to bring that money up to code and
- 8 put it back on line in the Scranton School District.
- 9 The school board didn't want the money. The school
- 10 board wasted a ton of money.
- 11 The City of Scranton isn't the only
- 12 problem we have here. That's why recently they decided
- 13 to borrow \$60 million.
- 14 You know, it just comes to the point
- 15 that, you know, I was going to run for a seat on -- as
- 16 a county commissioner after what happened to my
- 17 daughter because the person they hired to run the
- 18 communication center wasn't qualified and she lost her
- 19 life.
- 20 But I think what's going to happen here
- 21 is in the next election I'll run for a Council seat and
- 22 we'll see if people will elect a person who only wears
- 23 a T-shirt to Council meetings or whether the only
- 24 people that are credible are the people with suits and
- 25 ties on.

1 Because you know what, we've had enough

2 of their crowd, and there's no more room for them. The

3 city has been looted. I think carpet baggers would be

4 very proud that this mayor is in office. Thank you.

5 MS. GATELLI: Thank you. Pedro

6 Gonzales.

7 MR. GONZALES: Good evening, Council,

8 Junior Council members, and all in attendance. My name

9 is Pedro Gonzales, South Side resident, taxpayer,

10 registered voter.

11 Since the very first time I took this

- 3 off baskets for them for the skate park project. That
- 4 is our contribution to the kids of this city, plus
- 5 other things as usual.
- 6 August 12 and 13, the inaugural
- 7 festival and parade for the Latin people. It went
- 8 down, it was nice, it was tremendous. A lot of people
- 9 in attendance and a lot of people to thank.
- 10 If I forget anyone tonight, please
- 11 forgive me, but I want to thank the newspapers, The
- 12 Times-Tribune, the Electric City, The Panorama
- 13 newspapers, TV stations, News 16, Channel 61.
- 14 The sponsors of the event, Latino, the
- 15 Latin Cultural Diversity Center, Gary DiBileo,
- 16 McDonald's.
- 17 Main, main sponsor was the Foley Law
- 18 Firm. Lori Agostini came out. She was their
- 19 spokesperson and their rep that day, a tremendous

- 20 woman. Thank you to Foley Law Firm.
- 21 We want to thank Natalie and Dr.
- 22 Katherine Cullens from the Lackawanna Valley Heritage
- 23 Authority.
- 24 People that came out in support, La
- 25 Senorita Gatelli, thank you so, so much, Senor

- 1 Courtright, thank you for coming out and supporting the
- 2 Latin people, Commissioner Mike Washo, Sid Prejean from
- 3 the Kiwanis, OECD Sara Hailstone was out there.
- 4 We want to thank the Parks and Rec.
- 5 Department for helping us with the show mobile and the
- 6 parks and all the tables and the garbage cans,
- 7 everything they provided for us. Thank you so much for
- 8 the Parks and Recreation Department.
- 9 All the workers in Nay Aug Park
- 10 shuffling around the show mobile and the tables and the
- 11 cans and things to that effect.
- 12 Ray Hayes, our Director of Public
- 13 Safety, Corporal Newcomb, the police department, all of
- 14 the Scranton Police Department, thank you all so, so
- 15 much. Very much appreciated. The fire department came
- 16 out, was in the parade.

- 17 The Lackawanna Library, the book
- 18 mobile, the Lupus Foundation, Migrant Educational
- 19 Workers, the Rose Mediator Center, Mike Tavern runs
- 20 that, if I'm not mistaken, the Boy Scouts, the Girl
- 21 Scouts, all the performers that came out that day that
- 22 did everything pro bono. Not one person got paid for
- 23 that. They all came out.
- 24 A lot of people from Scranton came out,
- 25 performers. We had people from Allentown, we had

- 1 people from Reading and Lancaster also that came out
- 2 and gave up their time.
- 3 And most we want to thank the Latin
- 4 people for coming out and showing support, and most of
- 5 all, all the people of the City of Scranton. Thank you

- 7 Again, my name is Pedro Gonzales, and
- 8 thank you for letting me express myself.
- 9 MS. GATELLI: Thank you, Pedro. Tom
- 10 Baux.
- 11 MR. BAUX: Good evening, Council. This
- 12 is my first time ever here, so I'm just going to wing
- 13 it. My story might not be as important as everybody

- 14 else's, but I have a concern about your liturgy and
- 15 your resolution to sell Sloan Little League to the
- 16 Scranton School District.
- 17 I've been involved with Sloan for 19
- 18 years. We've asked for funds from the city. Numerous
- 19 times we were turned down, turned down, where West Side
- 20 Little League got money, Lackawanna Little League got

- 22 So, three years ago we sat down with
- 23 Councilman Evans, Councilman Courtright and the school

- 1 We said, Fine, you can have the teener

- 3 went back and forth, and I guess the -- what do you
- 4 call them, the CEO, said, Oh, no, never mind. We're
- 5 not going to do it.
- 6 The problem I have right now, there's
- 7 three little leagues in the West Side of Scranton. Why
- 8 is Sloan put on -- I want to know why Sloan is on the
- 9 agenda.
- 10 It's just like out of the blue that

- 11 they're going to sell the field out from under us. Why
- 12 don't we get the chance to buy the field? I really
- 13 want to know that.
- 14 There's three little leagues in the
- 15 West Side, why weren't those other two picked on? I
- 16 wonder why we are. That's my problem. I want to know
- 17 who brought this resolution up to the Council?
- 18 MS. GATELLI: Are you asking me that
- 19 question?
- 20 MR. BAUX: Yes. I just want to know
- 21 why is Sloan picked of all the fields to be brought up?
- 22 MS. GATELLI: I don't know that answer.
- 23 I don't know why Sloan was picked.
- 24 MR. BAUX: Because I talked to Mr.
- 25 McTiernan just before this meeting, because I asked

- 1 him. We sat down, two council members, Mr. Courtright
- 2 and Mrs. Evans and Mrs. McGuigan the beginning of July
- 3 and we sat down and we talked about it. We talked and
- 4 hashed over what we felt.
- 5 She said, Well, she would have to go
- 6 back to the rest of the Council, talk to them, the
- 7 board, and they would get back to us. That was the

- 8 beginning of July.
- 9 They wanted to sit down and talk to us.
- 10 We've been waiting since July 27, was their next
- 11 meeting. It is now, what, September 7, 8, why is the
- 12 school board all of a sudden now in the forefront and
- 13 pushing Sloan Little League to the side? That's what I
- 14 want to know. I don't think it's fair to the kids.
- 15 I've put 19 hard years in it. We've
- 16 been willing to let the West Scranton use the field,
- 17 it's just that I can't understand why they want to buy
- 18 it and take it off us when we've been dong it for
- 19 40-odd years.
- 20 My question is why is Sloan on the list
- 21 of wondering whoever brought it up. I would like to
- 22 know that eventually.
- 23 MS. GATELLI: I don't know where the
- 24 idea ever originated. I don't know that answer.
- $25\ MR.\ BAUX:$  Do me a favor. Could you

- 1 find out for me so maybe I can find out? Because
- 2 there's other members -- because there's a couple
- 3 hundred parents that are wondering why. Because --
- 4 MS. GATELLI: I will find out for you.

5 MR. BAUX: Thank you.

6 MS. GATELLI: And I will not vote for

7 Sloan to be taken off you.

8 MR. BAUX: Thank you.

9 MS. GATELLI: Is there anyone else that

10 cares to speak tonight?

11 MR. HEALEY: Good evening, City

12 Council.

13 MS. GATELLI: Good evening.

14 MR. HEALEY: Now, I mean, I hate to be

15 a broken record, you, know --

16 MS. GATELLI: Please be quiet so we can

17 give the courtesy to the speakers, please.

1 that, you know, it is in my opinion that the city can

- 2 transfer its interest in this property to be acquired
- 3 in a treasurer's sale, so, therefore, you own it.
- 4 And since then, that was back in June I
- 5 came here and I said, this is what will happen. Now,
- 6 you know, I said, this is going to hit my house, you
- 7 know, well, my neighbor's house.
- 8 Unfortunately a very nice Hispanic
- 9 gentleman moved in. He bought the house next door to
- 10 me. The people sold it. Three months ago he bought a
- 11 house, and in three months, three trees slammed into
- 12 his house.
- 13 The first one, I got pictures, if you
- 14 want to look at them. Here's the pictures. That was a
- 15 bad one. That went through the back window of the
- 16 nursery, you know where the baby sleep, you know? And
- 17 the other one are on the wires, and, you know, there's
- 18 live wires on the ground.
- 19 As a matter of fact, the last time it
- 20 happened was on Labor Day weekend. I came home, I was
- 21 going in the backyard I saw -- I thought it was
- 22 fireflies, but it wasn't fire flies, it was sparks
- 23 flew, live wires, you know, in the wet grass.
- 24 I mean, I explained this is going to
- 25 happened, and this happened three times in three

- 1 months.
- 2 I mean, I feel bad for my neighbor, he
- 3 just bought a house in Scranton, now I'm going to be a
- 4 taxpayer and get all the benefits we get here, you
- 5 know, and here's what I got for it.
- 6 The city owns a property, they won't
- 7 fix it. Smashed my house three times, ripped the
- 8 siding off, you know? And --
- 9 MS. GATELLI: Could you please give all
- 10 that to Attorney Minora, and maybe he can contact --
- 11 MR. COURTRIGHT: Sir, didn't the city
- 12 come out there and take a look at that?
- 13 MR. HEALEY: Yeah. You know, they did
- 14 come out and the -- the first time they came out and
- 15 said, somebody on Council said, we don't own the
- 16 property. I showed them the letter. I think the
- 17 lawyer is lying, because he said you do.
- 18 So, then they came out again. They
- 19 scoped it out and said, Well, we have nothing to do to
- 20 solve this problem. We have no equipment that can
- 21 remove this stuff. We have nothing that can move it.
- 22 So, you know what, I got an idea. How

- 23 about if we put the bid up through somebody, like a
- 24 professional tree removal place that can actually do
- 25 the job and, you know --

•

- 1 MS. GATELLI: Well, somebody can clean
- 2 it. Either the city owns it and they have to clean it,
- 3 or --
- 4 MR. HEALEY: The city owns it.
- 5 MS. GATELLI: -- a person owns it and
- 6 they have to clean it. So, give your stuff to Attorney
- 7 Minora, and we'll have him call Attorney Farrell and
- 8 we'll see if we can get it straightened out.
- 9 MR. HEALEY: I've been telling this for
- 10 years now, okay, for years now. I mean, like, when is
- 11 it going to happen?
- 12 MS. GATELLI: Well, I don't know, but
- 13 please give it to --
- 14 MR. HEALEY: And my phone line got
- 15 knocked down, too, so and it takes 12 days to get that
- 16 fixed.
- 17 MS. GATELLI: Now, what's the address
- 18 of that property, that empty property?
- 19 MR. HEALEY: Rear 1320 Vine Street. Do

- 20 you want the numbers for the tax record, W17B37.
- 21 MS. GATELLI: And it's an empty lot?
- 22 MR. HEALEY: Yes.
- 23 MS. GATELLI: All right. Give all that
- 24 stuff to Attorney Minora, please, and we will see if we
- 25 can get you an answer.

- 1 MR. HEALEY: Now the guy -- see, before
- 2 it was just my house got smashed, but now you got
- 3 children playing in the yards and three trees have
- 4 fallen down in three months in the summer, and
- 5 electrical wires are still laying out there right now.
- 6 And here's the pictures here, if you want to look at
- 7 it.
- 8 MS. GATELLI: That's just not
- 9 acceptable.
- 10 MR. HEALEY: The future, I told you the
- 11 future. You didn't do nothing, it happened, you know?
- 12 MS. GATELLI: All right. You can give
- 13 it to Neil. He'll give it to Attorney Minora. Thank
- 14 you, Mr. Healey. Next speaker, please.
- 15 MR. HUBBARD: Good evening, Council.
- 16 Daniel Hubbard, Gardner Avenue, lower Green Ridge.

- 17 First I'd like to start by thanking
- 18 Mrs. Gatelli, Ms. Evans, Mr. Courtright for the effort
- 19 and the pressure you put on Mr. Parker to do his job
- 20 clearing the bridge. I appreciate that. It took
- 21 63 days, but it's done.
- 22 A couple of other concerns we have is
- 23 the full length of Gardner Avenue is still half dug up
- 24 from the sewer project. PW Washo's supposed to get
- 25 paved. We're still kind of waiting on that. There's

- 68
- 1 barriers everywhere, manholes 4 inches above the
- 2 street. It's hard to park. I would like to know when
- 3 we can get that paved. And we have ongoing sewer odor
- 4 problems.
- 5 MS. GATELLI: Speak into the
- 6 microphone. I'm having a hard time hearing you.
- 7 MR. HUBBARD: We have an ongoing sewer
- 8 odor problem with one of the catch basins. The odor
- 9 trapped in the catch basin was basically removed by the
- 10 flood.
- 11 MS. GATELLI: I already sent them over.
- 12 MR. HUBBARD: Yeah, the Sewer Authority
- 13 has been there. They've determined that it is not

- 14 their responsibility. It is the responsibility of the
- 15 DPW to put the odor trap in. Those call continue to
- 16 fall on deaf ears.
- 17 MS. GATELLI: And what corner was that?
- 18 MR. HUBBARD: It's on the corner of
- 19 Marion and Gardner. It's pretty obvious which catch
- 20 basin it is. The odor is very prevalent.
- 21 MS. GATELLI: Now, when I sent the
- 22 gentleman over, he said there was no odor.
- 23 MR. HUBBARD: It's there. It's
- 24 definitely there.
- 25 MS. GATELLI: All right. I'm just

- 1 telling you what they told me.
- 2 MR. HUBBARD: Yeah, it's unmistakable
- 3 for the length of the block. It's very noticeable,
- 4 especially when we get some rain, it's even more
- 5 noticeable. We just would like to get those two thing
- 6 cleared up.
- 7 The street getting paved, I'd like to
- 8 have the street -- at least see it get paved before the
- 9 snow falls. I mean, they're not going to be able to
- 10 plow the street with the manhole covers --

- 11 MS. GATELLI: And what street was that?
- 12 I'm sorry to be repeating it, but I can't hear you.
- 13 MR. COURTRIGHT: Neil --
- 14 MS. GATELLI: Neil, do you want to take
- 15 him outside, because I can't hear. I'm sorry.
- 16 MR. HUBBARD: Oh, it's okay. It's the
- 17 full length of Gardner Avenue, the 1400 and 1500 blocks
- 18 were dug up for the sewer project previous to the
- 19 flood, and it seemed like everything -- once the flood
- 20 hit, everything in that neighborhood just stopped, it
- 21 just completely stopped on all progress.
- 22 MS. GATELLI: It's funny, but I'm
- 23 putting Cedar Avenue --
- 24 MR. HUBBARD: No, it's Gardner.
- 25 MS. GATELLI: -- because Cedar Ave., I

- 1 know, has been ripped up for the last six months.
- 2 MR. HUBBARD: Yeah, we're feeling the
- 3 same as they are. One of the houses on Gardner Avenue
- 4 was bulldozed when they were working on the bridge.
- 5 That is -- we appreciate that.
- 6 MS. GATELLI: And that's the one that
- 7 was vacant.

- 8 MR. HUBBARD: There's still vacant
- 9 houses that are on the demolition list, one is on
- 10 Albright. It's the one that was burned out on the
- 11 second floor, and there's another. I don't know the
- 12 address on the one on Gardner. There's one more house
- 13 in the 1400 block of Gardner.
- 14 None of these houses have been touched
- 15 since Ivan, so there's two major floods where these
- 16 houses were filled with water, the water receded, and I
- 17 can only imagine what the mold is like in these tow.
- 18 You couldn't look into those two houses. They're
- 19 pretty tight.
- 20 MS. GATELLI: Could you call me with
- 21 those specific addresses, please?
- 22 MR. HUBBARD: I'll give you the
- 23 addresses, sure.
- 24 MS. GATELLI: Thanks.
- 25 MR. HUBBARD: It's nice to see stuff

- 1 getting done, I appreciate it, everything that you guys
- 2 did.
- 3 MS. GATELLI: I'm very happy to hear
- 4 that you started a neighborhood association.

5 MR. HUBBARD: We need to. We needed

6 to. We didn't have a choice this time.

7 MS. GATELLI: And if you -- did you

8 elect your officers already?

9 MR. HUBBARD: We're working on that

10 right now.

11 MS. GATELLI: Okay. As soon as you do,

12 make sure you tell Neil so we put it in the office and

13 also call zoning, because then you will be notified of

14 all the zoning --

15 MR. HUBBARD: -- any meetings or

16 anything like that.

17 MS. GATELLI: And you can call Mary

18 Alice Burke and ask her if you could be a part of the

19 council of neighborhoods.

20 MR. HUBBARD: Thank you. I appreciate

21 the information. And once again, I appreciate the

22 help. It was nice to finally see something get done in

23 the city.

24 MS. GATELLI: Thank you.

25 MS. SIMMONS: Good evening, Council.

1 Good evening, Youth Council. I welcome you back from

- 2 your vacation. We needed you three weeks ago, but
- 3 that's all right. We will forgive you for your
- 4 absence.
- 5 My name is Reverend Kathryn Simmons,
- 6 and I'm a lifelong Scranton resident. Thirty-eight
- 7 years ago my daughter and my husband and I were
- 8 promised if we allowed the city to bulldoze our
- 9 neighborhood, they would give us a better neighborhood,
- 10 a lifelong neighborhood, if we allowed them to come in
- 11 and demolish our heritage and our history, that we
- 12 would have another heritage and history to give to our
- 13 children.
- 14 Well, our children's heritage and
- 15 history are about to be torn down and leveled to the
- 16 ground. Now, to some I know it's just a project, and
- 17 what's a project? It's family.
- 18 I don't care if people don't like
- 19 families who live in projects, that's not my business.
- 20 My business is to surround those who do live in the
- 21 project, because they were promised a better life.
- 22 Thirty-seven years inspectors have been
- 23 coming in and out of that project, Scranton Housing
- 24 Authority have been sending inspectors in, HUD has been
- 25 sending inspectors in, and no one saw the flaws in

- 1 these codes. Well, I find that hard to believe, but
- 2 we'll save that for another day.
- 3 I've submitted to the mayor a request
- 4 from Florence Midtown Crime Watch that the city hire a
- 5 private inspector, because I don't believe any report
- 6 that comes from the city, that comes from SHA and that
- 7 even comes from HUD. Why would I, when they've been
- 8 giving us reports for 38 years? Why would I? They're
- 9 going to tell us whatever they think will calm us down
- 10 for the moment.
- 11 Someone asked me on the phone the other
- 12 day, they said, Where do you think the city will find
- 13 this money? You'll find it, if you need it. I don't
- 14 care where you find it at. You'll find the money to
- 15 tear those houses down, you'll find the money to move
- 16 those people out and throw them in the streets.
- 17 You found the money to go in there and
- 18 tell them that they no longer had homes. I'm sure you
- 19 can find the money to find a private inspector to get
- 20 in and find out if it's true what they're telling us
- 21 about the rest of these projects. I don't believe a
- 22 word that's in these reports.

- 23 I received a phone call today before I
- 24 came here. Someone called my home and told me in not
- 25 too nice words that I better not show my face here this

- 1 evening. Well, to them I say, I'll come wherever I
- 2 feel like coming, on whatever day I feel like coming,
- 3 because the light of God surrounds me, the love of God
- 4 enfolds me --
- 5 MS. GATELLI: Reverend Simmons --
- 6 MS. SIMMONS: -- the power of God

7 protects me.

- 8 MS. GATELLI: Reverend Simmons, before
- 9 you go on any further, please don't bring any religious
- 10 comments.
- 11 MS. SIMMONS: Well, it's not religious,
- 12 I'm just telling you who protects me and why I'm
- 13 standing here right now.
- 14 MS. GATELLI: One moment. One moment.
- 15 Attorney Minora, do you -- was that --
- 16 MR. MINORA: We'd like to just keep the
- 17 comments to city business.
- 18 MS. SIMMONS: Are you telling me that I
- 19 as a resident can't stand here and tell you who

- 20 protects me, but somebody can call me and tell me
- 21 whatever they want to?
- 22 MR. MINORA: Our rules require comment
- 23 to be limited to city --
- 24 MS. SIMMONS: In other words, what
- 25 you're telling me --

- 1 MR. MINORA: Can I finish?
- 2 MS. SIMMONS: You're not letting me
- 3 finish.
- 4 MR. MINORA: Finish then.
- 5 MS. SIMMONS: I was going to say Amen.
- 6 MR. MINORA: Fine.
- 7 MS. SIMMONS: I was done.
- 8 MR. MINORA: That's five minutes and
- 9 20 seconds.
- 10 MS. SIMMONS: So, what you're telling
- 11 me any more is I can't come to City Council and mention
- 12 God's name?
- 13 MS. GATELLI: No, it's not allowed in a
- 14 public forum. We stop other speakers and we have to
- 15 stop everyone --
- 16 MS. SIMMONS: Well, we will go to court

17 about this. Thank you. You have a good night.

18 MS. GATELLI: There is a separation of

19 church and state, and we must acknowledge that.

20 MS. SIMMONS: Well, we will go to court

21 about this. Thank you.

22 MS. GATELLI: Anyone else?

23 MR. BUDZINSKI: Fred Budzinski,

24 Scranton resident. Last two months I witnessed two

25 seniors that are women waiting for the bus and had to

76

1 take them to the hospital. One of them told me she

2 takes prescription pills and she gets dizzy and she was

3 about to fall over until somebody had to hold her up.

4 Up at this podium I heard about six or

5 seven people speak about benches for the seniors and

6 some Council members spoke about benches. Everything

7 looked good, now here, nothing.

8 And other issues, you're talking about

9 \$44 million which is going to cost \$84 million, and

10 over the last four or five years, the city has lost

11 arbitration, and at the beginning if they settled that

12 arbitrations, they probably wouldn't have to seek \$44

13 million now.

- 14 Also I read in the paper seven months
- 15 ago the city demolished over 400 properties. You see
- 16 these properties all over the city, they're vacant.
- 17 They took them off the tax base. Many of them homes
- 18 could have been saved, even if they gave them away to
- 19 responsible people and get them on the tax base.
- 20 That's another reason why we have to borrow \$44
- 21 million.
- 22 I read a lot of good reading in the
- 23 paper, city going bankrupt. Also I read about the
- 24 housing project, and there's another five other complex
- 25 no fire walls, this and that, and the Washington Plaza,

- 1 and the other ones are just as bad as them, and I can't
- 2 see how they can kick people out of there and the other
- 3 housing projects are just as bad.
- 4 Now, I live in the Jermyn, that was
- 5 remodeled about ten years ago, and that is a safe
- 6 apartment, there's fire doors on each side of the
- 7 elevator, I have five sprinklers in my apartment, and
- 8 in the hallway there's 16 sprinklers on every floor, so
- 9 I think that is a safe place. And all of these other
- 10 housing projects, I doubt if there's sprinklers, fire

- 11 doors and whatever. So, I don't see how they can kick
- 12 people out of Washington Plaza when the others are just
- 13 as bad. Thank you.
- 14 MS. GATELLI: Thank you very much.
- 15 MS. SHUMAKER: Good evening and welcome
- 16 back. Marie Shumaker. I originally didn't intend to
- 17 speak tonight, but there were a few things that were
- 18 not on the agenda that I expected, and one that I did
- 19 not expect.
- 20 So, item 5-F on your agenda tonight is
- 21 the capital budget, so I assume that's available in
- 22 Mrs. Garvey's office, is that -- if I come over
- 23 tomorrow, I can get a copy of that? Thank you.
- 24 I expected to see an ordinance
- 25 introduced tonight on pool maintenance. It's been

- 1 several months since I brought that here to give the
- 2 authority to Mr. Fiorini's people to go out when people
- 3 don't maintain their pools, except for his arbitrary
- 4 rule of some particular level at which mosquitoes can
- 5 breed. I think we need it. I brought some sample
- 6 ordinances, and I'd be happy to do more research.
- 7 MS. GATELLI: I'm not sure that we need

8 an ordinance for that, because I think that that would

9 be covered under the health code. I mean, I could be

10 wrong, but we emptied a lot of pools when I was there

11 because of health reasons. I mean, stagnant water is

12 not healthy. Forget the mosquitoes.

13 MS. SHUMAKER: No. But I called. I

14 was told no. I was asked what the level of water was

15 and that, and I was told that that was Mr. Fiorini's

16 justification for going out or not going out, and

17 that's what started this whole process of me coming and

18 asking.

19 So, I don't want to use up all my time,

20 so I hope to see a pool maintenance ordinance, because

21 that would give the required authority to that person

22 to go out and check these out when they're reported.

23 Also, before recess there was a

24 dialogue about the traffic existing the mini-mart at

25 Meadow and River, and nothing has been done. It's

79

1 still a stop and pray and hope you don't get killed

2 when you go around the corner.

3 There are no signs in that mini-mart

4 saying it's illegal to make a left turn. Mrs. Fanucci

5 said that she was sure that that was a requirement.

6 It's not there.

7 And now I'd like to move on to -- the

8 other night I was watching TV and some municipality

9 around here had just outlawed burn barrels. And I

10 thought, Hmm, I remember back when I was growing up in

11 South Side and almost everybody had a burn barrel, and

12 some would deteriorate and they'd get holes and then

13 the cracks and the sparks would fly out through the

14 cracks and you'd go and you'd stamp one out and, you

15 know, you could do that all the time.

16 And I look at this loan that the mayor

17 is asking for in the same way. You can keep stamping

18 out little fires all around or you can replace the burn

19 barrel and not have those little sparks flying out of

20 the holes.

21 There is absolutely nothing. The new

22 burn barrel is a balanced operating and capital budget

23 that is within the revenue of this city, and until that

24 is done, you're borrowing four more years at what cost?

25 Double the amount. You're going to pay

80

1 double the amount when you include the debt service,

- 2 and you're going to be in the same place, because your
- 3 operating budget at the end of the four years is still
- 4 going to be out of balance and you're still going to be
- 5 including capital projects that there's no revenue to
- 6 cover.
- 7 So, it's time to stop this slide, this
- 8 downhill slide. I hope you all -- I was here. I told
- 9 you I was the one who reported that I had read on the
- 10 Doherty Deceit website that a \$40 million loan was
- 11 going to be called, and you all went (UNTRANSCRIBABLE),
- 12 and here it is. Now it's \$44 or \$43, I don't remember.
- 13 But I ask you to think about it and I
- 14 certainly hope that you're going to require a
- 15 detailing, and I would hope that the budget would be
- 16 scrubbed and items would be cut and the hard choices
- 17 would be made now and not five years later on somebody
- 18 else's watch. Thank you very much.
- 19 MS. GATELLI: Thank you very much. The
- 20 next speaker.
- 21 MS. SUTTON: Hi. My name's Judy
- 22 Sutton, I'm a resident of South Side.
- 23 MS. GATELLI: Well, hello, Mrs. Sutton.
- 24 MS. SUTTON: Hello, Mrs. Gatelli. How
- 25 are you?

1 MS. GATELLI: I'm fine. How are you?

2 MS. SUTTON: Well, I've got a little

3 bit of a head of steam here. I live in South Side in

4 very close proximity to Mr. Morgan's property that he

5 spoke of before. I don't know about the other

6 properties, but I do know about the one on Stafford

7 Avenue.

8 He had tenants in there that made our

9 life unbearable. There was constant screaming,

10 fighting, cursing all hours of the day and night.

11 Mr. Morgan was approached and asked to

12 speak with his tenants. He said he would, but a few

13 days later, the police were called.

14 The police were called there on several

15 occasions, and on July 20, someone was taken out of

16 that building with a drug overdose.

17 There were also many, I won't say many,

18 there's several unregistered unlicensed vehicles on

19 that property, which I believe there is a city

20 ordinance against, plus another one was brought there

21 last week.

22 So, if anyone that knows me knows I am

- 23 not a fan of Mr. Doherty, and since Mr. Morgan said
- 24 Mr. Doherty is responsible for it, I say something to
- 25 Mr. Doherty that I didn't think I would ever say, thank

•

- 1 you. You restored peace and tranquility to our
- 2 neighborhood.
- 3 I have a couple other issues. On that,
- 4 ironically that building was shut down on August 1. On
- 5 August 2, I read an article in the paper about Forest
- 6 City publishing an ordinance, I don't know if the City
- 7 of Scranton has one, that if you have three disturbing
- 8 calls to a residence, the landlord must evict those
- 9 tenants. Do we have that ordinance in the City of
- 10 Scranton?
- 11 MS. GATELLI: We have an ordinance
- 12 similar to that, but I don't know that it's functioning
- 13 at its proper capacity at the present time.
- 14 MS. SUTTON: Well, I think we should
- 15 have that.
- 16 MS. GATELLI: I'm hoping that Mr.
- 17 Seitzinger will take that ordinance and --
- 18 MS. SUTTON: Because I'm sure this
- 19 incident on Stafford Avenue is not isolated. I'm sure

- 20 other parts of the city have, you know, the same
- 21 problem.
- 22 By the way, I was born and raised in
- 23 the City of Scranton. I've lived here all my life.
- 24 Well, a few years I lived out in the surrounding areas.
- 25 Also, I have a petition here that was

- 1 brought down in November and it was checked on in
- 2 January. We're looking to get a street light on --
- 3 another street light added to Old Log Road. Are you
- 4 familiar with Old Log Road? It's pretty dark. And
- 5 also, I have a photograph here. I have some other
- 6 photographs, too, of another issue I have.
- 7 But if we could get some trimming done
- 8 on Old Log Road, your vehicles, you by there. I have a
- 9 copy of that petition, also.
- 10 Now on a more personal issue. Adjacent
- 11 to our property there's a piece of a small parcel that
- 12 we believe is owned by the City of Scranton. There's
- 13 never been any maintenance done to that in 14 years
- 14 that we know of.
- 15 We are getting a new fence, we're doing
- 16 other work on our home, but we're getting a new fence,

17 and we wonder if we can get this cleaned up. Can I

18 show you the photos?

19 MS. GATELLI: Uh-huh.

20 MS. SUTTON: It's not a big piece of

21 property, but there's garbage on there and you can see

22 there's a drain.

23 MS. GATELLI: Oh, I see it, uh-huh.

24 MS. SUTTON: We had the stake there

25 last year, and they built up curbs, because we're

•

84

1 having water come into the front yard, and they said

2 that part of the property problem was that drain, so if

3 we can get that looked at and maybe get it cleaned up.

4 There's other areas around there that

5 our neighbors clean up, but I don't have the time and

6 Jim isn't capable of it, because he has back problems,

7 so if we could get that looked at, I would really

8 appreciate it.

9 MS. GATELLI: Do you know what the

10 address of this would be?

11 MS. SUTTON: No. It's right -- I wrote

12 ---

13 MS. GATELLI: I know you have adjacent

15 MS. SUTTON: It's right at the end of

16 our property. If you look there, you can see the

17 fence. That's our fence there.

18 MS. GATELLI: You're at 16 --

19 MS. SUTTON: Yeah, right. It's right

20 there at the end.

21 MS. GATELLI: So, would it be 14 or

22 would it be 18?

23 MS. SUTTON: I don't even know if it

24 has an address. It's just --

25 MS. GATELLI: But I mean, do you think

.

1 it would be a lower number or a higher number?

2 MS. SUTTON: No, it'd be higher. It

3 would be 18.

4 MS. GATELLI: A higher number, okay.

5 MS. SUTTON: And can you check on that

6 petition for me?

7 MS. GATELLI: Give the petition to

8 Neil. The street lights go to George Parker and MEM

9 investigates them.

10 MS. SUTTON: It was checked on in

- 11 January. We were told Mr. Parker would get to it when
- 12 he gets to it, and it's almost a year, okay? Thank you
- 13 very much.
- 14 MS. GATELLI: We'll forward it for you.
- 15 Thank you. Anyone else care to speak?
- 16 MR. TORRES: Hi. My name is William
- 17 Torres, West Side resident, taxpayer registered voter
- 18 here in Scranton, and I just want to continue where
- 19 Mr. Gonzales left off thanking people for the event we
- 20 had.
- 21 We would like to thank the Governor who
- 22 came down, although he had a tight schedule, but he
- 23 came down and spent a few hours with us, had a great
- 24 time having him here.
- 25 We also would like to thank the Mayor,

- 1 Chris Doherty, who also had other engagements, but he
- 2 took the time to come down spent a few hours with us,
- 3 enjoyed the day, also marched in the parade, the first
- 4 Latin parade, I should say, here in Scranton, and, of
- 5 course, City Council for being there for us, you know?
- 6 We brung this idea to you guys and you
- 7 guys just said, Let's go for it, and the support you

8 gave us gave us that extra push to go ahead and do this

9 work and create this historical weekend that we had,

10 this first Latin festival, first Latin parade here in

11 Scranton. We were proud of it, and I hope the City of

12 Scranton is proud of what we accomplished that weekend.

13 And, again, I just want to thank everyone who was

14 involved in any shame or form, and, again, City

15 Council, thank you.

16 MS. GATELLI: Thank you.

17 MR. DAVIS: I don't know what to say.

18 I always start off by saying Assalaam Alaikum, which is

19 peace and blessings of Allah be with you, but now I

20 can't even mention God. Allah is God to me. So, I'm

21 just wishing you the very best of everything. And if

22 you say we can't use that term, I don't know if my

23 greetings will even work.

24 But I have other problems that are even

25 more important than that. We have streets out here on

~ **-**

87

1 Washington Avenue where our senior citizens have a hard

2 time going from Gibson or going from Pine or Olive all

3 the way downtown because the lines are not there.

4 We had this problem before and we were

- 5 going to create some sort of a magic paste or magic
- 6 line that would last a little longer or something like
- 7 that, and for some reason or another it just went away.
- 8 We never kept up on it.
- 9 There's no follow-up in your systems.
- 10 And maybe I'm wrong, but the thing is, our adults, our
- 11 grandparents, our mothers, they can get hurt very
- 12 easily by just something as stupid as a line to guide
- 13 themselves across the street. Well, okay. I guess if
- 14 you drive them everywhere they go, then there's not a
- 15 problem.
- 16 MR. COURTRIGHT: Mr. Davis, would you
- 17 like me to answer that? I spoke to Mr. Parker, I
- 18 didn't speak to him, I sent him a letter and he sent me
- 19 one back, he -- because one of the people asked about
- 20 why on the highway do the lines last longer than they
- 21 do in the city.
- 22 Well, he's using the same paint that
- 23 they're using on the highway. He said it's just due to
- 24 the heavy traffic that we get, and he's saying they
- 25 keep on trying different paints, it's the best they can

1 find that meets the requirements, because they have to

- 2 meet environmental requirements.
- 3 So, I didn't ask him about the tape
- 4 that we heat down. I think that's a matter of cost. I
- 5 think that's really expensive. It lasts a long time.
- 6 MR. DAVIS: They do it down by Prep, it
- 7 works down there and it's right on Wyoming Avenue, you
- 8 know that.
- 9 MR. COURTRIGHT: Yeah, we got the
- 10 answer to why they did it by Prep. That was a long
- 11 time ago. Does anybody --
- 12 MR. DAVIS: Yeah, it's the same
- 13 problem.
- 14 MR. COURTRIGHT: Mrs. Gatelli said they
- 15 paid for it.
- 16 MR. DAVIS: Yeah, that's true.
- 17 MR. COURTRIGHT: It was way back when
- 18 Jay was here. I know I asked that question why they
- 19 got it down there. I can't recall the answer to be
- 20 honest with you.
- 21 MR. COURTRIGHT: Please stay at them.
- 22 It's important. It really is. I'm not asking it for
- 23 me. I could still see pretty good, but I'm saying that
- 24 it's important because I see too many people of age
- 25 trying to be independent and go from one place to

1 another.

2 MR. COURTRIGHT: I think the problem is

3 we need to add another person in that department,

4 because I don't think we have enough people in that

5 particular department.

6 MR. DAVIS: Take a kid from high

7 school, give him a job. Great. That's a great idea.

8 MR. COURTRIGHT: I'll suggest it. I

9 probably won't get too far with it.

10 MR. DAVIS: Thank you very much. This

11 has been a fantastic summer. I've watched the Latin

12 Alliance come to fruition, I've seen them celebrate

13 their holidays in the city that didn't even know they

14 existed two years ago. Beautiful crowd of people,

15 beautiful ambiance. It was just a warm pleasant thing

16 to actually have around us. I enjoyed it immensely.

17 Of course they're a minority group, so

18 I'm sort of that way, but the thing is, we can do that.

19 We have the ability to have all of our people

20 intertwined and we can respect them equally.

21 I know that we can do it, because our

22 parents did it before us. My father used to say to me,

- 23 Hey, look, when I come out of the coal mines, I look
- 24 like everybody else that comes out of that coal mine.
- 25 You don't have time to fear or be downtroddened by

- 1 anything that happens to me, because at that time a
- 2 coal miner was next to dirt, as I remember. But that's
- 3 beside the point. We've gone beyond that.
- 4 Now we have kids that are being treated
- 5 like dirt to me. And, Ms. Evans, of all the people
- 6 that I see up there on the stage and the people who are
- 7 trying to represent we, the residents, and I hear a lot
- 8 of people out there, and a lot of people have come to
- 9 me about, what are you guys going to do about
- 10 Washington Plaza, are you going to keep on fighting for
- 11 them or is it worth it?
- 12 And you know, you're the only one who
- 13 showed up to defend the people.
- 14 MS. EVANS: Thank you.
- 15 MR. DAVIS: And I really appreciate it.
- 16 I wanted to say that to you. I don't give a lot of
- 17 compliments out, but I compliment you on that.
- 18 MR. DAVIS: I never compliment you.
- 19 But on top of that --

20 MS. GATELLI: Finish up your thoughts,

21 Mr. Davis.

22 MR. DAVIS: Excuse me.

23 MS. GATELLI: Your time is up. Finish

24 up your thoughts.

25 MR. DAVIS: Thank you. The kids that

•

1 are in Washington Plaza are traumatized. We had a

2 party for them last Friday night after all this broke

3 out, and they were really traumatized to the point

4 where they didn't know what they wanted to do, they

5 didn't know where they wanted to go, and they need

6 help.

7 And it's really urgent that we do

8 something now to allay this problem and solve this

9 problem. Don't give us any more verbiage about what's

10 good and right.

11 I know when you come up over the hill

12 and all you see is the projects there, you don't want

13 to be bothered with them. But I'm telling you right

14 now, these kids are your future also. There's a lot of

15 success stories that come out of projects.

16 MS. GATELLI: Okay. Thank you,

- 17 Mr. Davis. Anyone else care to speak before Council?
- 18 MS. STOKER O'MALLEY: Good evening,
- 19 Council. How was your summer? I don't even know where
- 20 to begin. What can I say? You know why I'm here.
- 21 Hollow Avenue. How can you even justify this to me?
- 22 You can't, can you? Can anybody here justify that to
- 23 me?
- 24 MS. GATELLI: No.
- 25 MS. EVANS: No.

- 1 MS. STOKER O'MALLEY: All right. I am
- 2 here because I am paying taxes on land I cannot use,
- 3 and I've had it.
- 4 All right. The thing that bothers me
- 5 in the article that Stacy was very kind enough to write
- 6 for me, Mr. Farrell, the only thing I can say to you is
- 7 you should do your homework. This was once a street.
- 8 It was three-quarters of the way up.
- 9 Very simple answer to you, Mr. Farrell,
- 10 check the taxes. My family paid house taxes all
- 11 through the sixties until 1972, when the home was torn
- 12 down and then they paid lot taxes, and I'm still paying
- 13 the lot taxes.

- 14 So, don't tell me that this wasn't a
- 15 street and that they don't open new roads. Hollow
- 16 Avenue is a perfect example of it's who you know, and
- 17 I'm tired of it.
- 18 I don't know who to see, I don't know
- 19 what else to do. And there isn't one of you up there
- 20 that can't tell me that I am being unjustly paying
- 21 taxes, is there? Where do I go from here, without
- 22 rocking the boat too, too much, as I've already done?
- 23 What do I do? Where do I go? City
- 24 Council, what do I do now? Do any of you have an
- 25 answer for me?

- 1 MS. EVANS: I think we need to speak
- 2 with Mr. Parker. It was my hope that he would have
- 3 attending this evening's meeting.
- 4 However, perhaps during one of the
- 5 September meetings, he will attend, and we certainly do
- 6 need a discussion on the Hollow Avenue situation,
- 7 because unfortunately it has spiraled into Treegate.
- 8 MS. STOKER O'MALLEY: Yeah, I
- 9 understand. And I'm not trying to be here to cause
- 10 more problems. I was here long before that, and I'll

- 11 be here long after that until my problem is solved.
- 12 MR. COURTRIGHT: Sarine, we've gone
- 13 back and forth and back and forth for almost two years

14 now, right?

- 15 MS. STOKER O'MALLEY: More.
- 16 MR. COURTRIGHT: I mean with myself,
- 17 and we've talked to Mr. Parker, and on more than one
- 18 occasion I thought we had it settled, but it just never
- 19 seems to get -- I don't know what we're going to do

20 now.

- 21 MS. STOKER O'MALLEY: I mean no
- 22 disrespect, but isn't it a terrible death to be talked
- 23 to death?
- 24 MR. COURTRIGHT: Yeah.
- 25 MR. STOKER O'MALLEY: To be talked to

•

- 1 and promised and promised more times than anybody.
- 2 MR. COURTRIGHT: Did he or did he not
- 3 say at one time, I was almost positive, he said at one
- 4 time he was going to clear the road for you. Didn't he

5 say that?

- 6 MS. STOKER O'MALLEY: Yes.
- 7 MR. COURTRIGHT: And then what

- 8 happened?
- 9 MS. EVANS: Wasn't that during the
- 10 election?
- 11 MS. STOKER O'MALLEY: Probably,
- 12 probably.
- 13 MS. EVANS: I've spoken on two
- 14 different occasions over nearly the last three years to
- 15 Mr. Parker about your situation, and he indicated that
- 16 at one point the brush and trees would have been
- 17 trimmed on that property by the DPW; however, he did
- 18 reiterate that the city is not going to open a right of
- 19 way.
- 20 MS. STOKER O'MALLEY: Okay. On that I
- 21 want to say this, okay? Yeah, I can see it, but this
- 22 is a right of way that is paid by the State to the city
- 23 to maintain this, and they never bothered to do this.
- 24 MR. COURTRIGHT: Sarine, if he takes
- 25 the trees down, you have the right of way then, don't
- 95
- 1 you?
- 2 MS. STOKER O'MALLEY: No, I don't. I
- 3 have a trench.
- 4 MR. COURTRIGHT: That's the back part.

- 5 But I mean leading into there.
- 6 MS. STOKER O'MALLEY: Half way up,
- 7 Judy, right?
- 8 MS. GATELLI: There's almost like a
- 9 creek there.
- 10 MS. STOKER O'MALLEY: I have a trench
- 11 literally where people could jump in and, like, water
- 12 could run, you know, but, like --
- 13 MR. COURTRIGHT: Was the road opened
- 14 beyond that trench at one time?
- 15 MS. STOKER O'MALLEY: Yes, sir.
- 16 MR. COURTRIGHT: On the other side of
- 17 the trench?
- 18 MS. STOKER O'MALLEY: Yes, sir. Yes,
- 19 sir, they were. And this is --
- 20 MS. EVANS: But more importantly I
- 21 think two things, I don't know whether it's the policy
- 22 of the city to clear right of ways or not, but the fact
- 23 remains that now they have.
- 24 They've set the precedent, which, in my
- 25 opinion, requires that further right of ways be

1 cleared, unless such a policy is developed saying it

- 2 will never be done for anyone under any circumstances,
- 3 because as far as I'm concerned, what's good for one
- 4 person is good for another. It's either everyone gets
- 5 it or no one.
- 6 MS. STOKER O'MALLEY: Well, somebody
- 7 got it, but I didn't. Now, I was told by Mr. Parker
- 8 that this was supposed to -- after the Salvation Army
- 9 was done, I was next. They went right up to Hollow
- 10 Avenue. Hello. And, you know, honestly, that's the
- 11 sad fact.
- 12 MS. EVANS: Are you a committee person?
- 13 MS. STOKER O'MALLEY: Oh, no, I'm not,
- 14 and I never will be.
- 15 MS. EVANS: Are you a campaign
- 16 contributor?
- 17 MS. STOKER O'MALLEY: Absolutely not.
- 18 MS. EVANS: Well, that explains why you
- 19 got nothing.
- 20 MS. STOKER O'MALLEY: Yes, it is. Yes,
- 21 it is. It totally is. And, again, you know, I'm not
- 22 here to rock the boat or cause a problem. I was here
- 23 before Hollow Avenue, and I'm going to be back because
- 24 of Hollow Avenue.
- 25 MS. GATELLI: Yeah, I know.

1 MS. STOKER O'MALLEY: I was really

2 wondering -- hoping Mr. Parker was going to be here

3 tonight, because believe me, I have a lot that I'd like

4 to speak with Mr. Parker about.

5 The mayor will not see me, Mr. Farrell

6 will not see me. He's been on vacation for the last

7 two weeks, I want you to know. Because every time I've

8 called or faxed -- I did receive one phone call from

9 the secretary stating that he was on vacation. He

10 would return my call. I still haven't heard from him,

11 and this is two weeks now.

12 MS. GATELLI: Thank you.

13 MS. STOKER O'MALLEY: Thank you.

14 MS. GATELLI: I'll talk to you -- are

15 you going to stay after?

16 MS. STOKER O'MALLEY: Sure. Thank you.

17 MR. GERVASI: Good evening, City

18 Council. My name is Dave Gervasi. I'm the vice

19 president of the firefighters union.

20 From some comments that were made here

21 tonight and from repeated articles in the newspaper, it

22 seems that, once again, this \$43 million of borrowing

- 23 and the deficits they're going to try to blame on the
- 24 unions.
- 25 So, I just wanted to just make a few

- 1 statements here tonight and see if this Council
- 2 actually understands what's going on, and I know most
- 3 of you do.
- 4 Number one, when Mayor Doherty took
- 5 office, and you need to know this, when Mayor Doherty
- 6 took office, there was an operational budget surplus.
- 7 There was a surplus in 1999, 2000, 2001, 2002. 2003,
- 8 we haven't had the updated numbers and we didn't do a
- 9 financial analysis of it.
- 10 During our arbitration award, our big
- 11 contract arbitration award, the mayor, instead of using
- 12 Pennsylvania Economy League to bring the numbers, they
- 13 hired a firm for \$40,000 to come in to tell the
- 14 arbitrator the city was broke.
- 15 We sent him on his way, two of them,
- 16 sent them on their way because it was completely
- 17 contrary to what the independent audits of the city
- 18 said.
- 19 So, with that said, I'm very sure, you

- 20 don't have to believe me, but I'm very sure we had a
- 21 surplus since 1999, operational budget surplus. That
- 22 surplus was increasing every year up until 2002.
- 23 Now, now we're told we have to borrow
- 24 \$43 million because it's the unions' fault. Does
- 25 anybody up there know how much the city actually paid

- 1 in arbitration awards to the present day? Does anybody
- 2 know? I'll tell you what they paid, zero, because
- 3 they're not -- they're still in court.
- 4 How many of you people know how much
- 5 raises the police and firefighters got in the last five
- 6 years?
- 7 MS. EVANS: Nothing.
- 8 MR. GERVASI: Zero. Did you also know
- 9 that both departments, our overtime budget has
- 10 decreased in the last two years? We are now running
- 11 the police and fire department with less money than we
- 12 spent when Mayor Doherty took office.
- 13 Now, with all of that said, the
- 14 newspaper is going to continue to print without
- 15 actually verifying all this fraudulent information that
- 16 they're printing that this is all because of the police

- 17 and fire union because of arbitrations and the Recovery
- 18 Plan.
- 19 Number one, we have received nothing in
- 20 five years; number two, our budgets are actually less.
- 21 The only thing that's probably up is our health care
- 22 costs. And why is our health care costs up? Well,
- 23 let's see. I didn't chase 100 people out the door that
- 24 still have health care, I didn't hire \$3 million plus
- 25 employees to replace those people that are on health

- 100
- 1 care, I'm not the one or the unions aren't the one that
- 2 did no bid contracts. We didn't do any of that.
- 3 Am I correct to say that the unions do
- 4 not control the city budget, the unions cannot sign
- 5 checks or spend money; am I correct saying that?
- 6 MS. EVANS: Yes.
- 7 MR. GERVASI: Okay. So now that we
- 8 have cleared up, how can we possibly be guilty of the
- 9 mayor having to spend -- borrow \$43 million more, when
- 10 we received nothing?
- 11 Am I not correct that when the mayor
- 12 took office, the budget was approximately \$57 million?
- 13 Am I correct now that the future budget coming up with

- 14 preliminary numbers we've been hearing may hit \$72
- 15 million?
- 16 What did the police and firemen get?
- 17 Zero. Who's to blame for borrowing more money and
- 18 having a deficit? Is it the unions or is it the guy
- 19 who controls the checkbook? I didn't see anybody on
- 20 Council spending \$43 million or \$9 million or \$3
- 21 million.
- 22 There's one person who controls the
- 23 money in this town, and that's Mayor Chris Doherty.
- 24 And I don't care how many times the newspaper prints in
- 25 the paper that it's the union's fault, it's not true.

- 1 It's a lie and it's a fraud.
- 2 We have received nothing in five years,
- 3 zero, and our budget went up approximately \$14 million
- 4 in five years.
- 5 And now he wants to borrow \$43 million,
- 6 which, in fact, just so you know, when Mayor Connors
- 7 left office, there was a \$38 million deficit. I think
- 8 there was approximately \$70 million borrowed since
- 9 then. I think it's more than that.
- 10 And now \$43 million on top of that.

- 11 That's going to raise our annual debt payments by over
- 12 \$7 million a year for the next 28 years, and that
- 13 \$7 million could never be used again to clear trees or
- 14 pave streets or buy fire trucks or buy police cars for
- 15 the next 28 years.
- 16 We didn't do it. I can prove we did
- 17 not do it. It has nothing to do with the unions. So,
- 18 I hope enough people hear me tonight, and I'm telling
- 19 you the truth. We didn't write the checks, we didn't
- 20 spend the money. He did, not us. Thank you very much
- 21 for letting me speak.
- 22 MS. GATELLI: Thank you.
- 23 MR. GERVASI: And one more thing, not
- 24 only is the police and fire department going to pay for
- 25 the debt he put us in, now the people are going to pay,

- 1 because now they are going to have their taxes
- 2 increased.
- 3 And now you're not only going to pay
- 4 the same amount of taxes for lesser services when we
- 5 get 30 firemen laid off, you're going to pay more money
- 6 for less services so that he could continue to do his
- 7 pet projects.

- 8 MS. EVANS: And, Mr. Gervasi, just as a
- 9 footnote, if indeed this \$44 million passes, it will
- 10 increase our long-term debt to approximately
- 11 \$300 million
- 12 MR. GERVASI: And my question is where
- 13 ---
- 14 MS. EVANS: And never in the history of
- 15 this city has such figures ever been tossed about.
- 16 MR. GERVASI: Yes. Where is the state
- 17 and where is the PEL? Nowhere to be found. They've
- 18 been here 14 years and we're in a bigger hole now than
- 19 we were that made us distressed.
- 20 MS. EVANS: They enabled it.
- 21 MR. GERVASI: They enabled it.
- 22 MS. GATELLI: All right. Thank you
- 23 very much. Next speaker.
- 24 MR. COURTRIGHT: Yeah, knock it down a
- 25 little. Go ahead, Chris.

- 1 MR. SLEDZINSKI: Welcome back, Jude.
- 2 MS. GATELLI: Welcome back, Chris.
- 3 MR. SLEDZINSKI: Well, Jude, our
- 4 victory is in the books now, baby.

- 5 MS. GATELLI: Yep.
- 6 MR. SLEDZINSKI: Tomorrow night we got
- 7 Riverside tomorrow. Guys, good luck tomorrow. Thank 8 you.
- 9 MS. GATELLI: Thanks, Chris.
- 10 MR. BECK: Good evening, Council.
- 11 Wayne Beck, city resident and taxpayer. I wasn't going
- 12 to come over this evening, but I pulled out the agenda
- 13 for this evening and was just fascinated by 5-E, and I
- 14 don't have the legal mind that Attorney Minora has, so
- 15 I had to sit down and read it three times and then try
- 16 to put it in layman's terms, so I have a few questions,
- 17 because 5-E seems to set the stage for 5-F.
- 18 But as far as 5-E is concerned, it
- 19 appears from what I read that the city intends to lease
- 20 properties to the Redevelopment Authority and the
- 21 Redevelopment Authority will execute a lease agreement
- 22 that declares the guarantee of the SRA's lease revenue
- 23 bonds for a city project, that project being later on
- 24 this whole lease -- referred to as this whole lease
- 25 agreement, in which a lease rental debt will be

1 incurred, and that debt is not to exceed \$44 million,

- 2 which happens to be the amount of the increase or the
- 3 loan that the mayor is looking for.
- 4 The lease agreement will state the
- 5 realistic estimated useful life of the facilities
- 6 pledged as collateral for the bonds, so we have to have
- 7 some idea what properties he's talking about. That's
- 8 one of the questions I have. What are we looking at as
- 9 far as the collateral?
- 10 The lease rental debt -- I'm sorry. I
- 11 covered that. The city will then sublease the
- 12 facilities and guarantee the bonds through an agreement
- 13 made back with the SRA. The required debt statement,
- 14 which is required by a reporting law, from what I read
- 15 into it, the required debt statement will be filed with
- 16 OECD, thus authorizing the preparation of a debt
- 17 statement and borrowing based certificate.
- 18 This also concerns me. This action
- 19 will repeal inconsistent prior ordinances allowing for
- 20 the city to execute and deliver the previously
- 21 mentioned documents, which would be the lease
- 22 agreement, the sublease agreement and the guarantee
- 23 agreement, in order to allow the city to pursue the
- 24 project that is desirable for the health, safety and
- 25 welfare of the residents of the city.

1 I think there's a lot of -- a lot of

2 questions I have that need to be answered. Again, what

3 properties are we speaking of, why are all of these

4 legal steps to get the SRA involved, and then maybe an

5 explanation, but I'd like to know what it is, and what

6 existing ordinances might be in jeopardy and repealed

7 if this is passed?

8 Again, I'm not saying it's good or it's

9 bad, but I think it needs to be looked at. And one of

10 the reasons I think it needs to be looked at is -- as

11 you know, I used to come here quite a bit, and I have

12 quite a bit of notes and a lot of articles from The

13 Scranton Times-Tribune, and I have one from April the

14 22 of 2001.

15 Keep in mind the city's current debt

16 status. In there it says, A little more than a month

17 in office after a financial briefing by city business

18 administrator John Cawley, Mr. Doherty declared, We're

19 on death row.

20 By the end of that year, the city's

21 debt was more than \$6.7 million. If we were on death

22 row at \$6.7 million, where are we now? And I think

- 23 that needs to be considered when you're asking all of
- 24 these questions and trying to maybe cut some expenses
- 25 to reduce the amount of debt that we may have to go

•

- 1 into, if we have to go into any at all. And that's all
- 2 I ask is that you ask them and maybe provide the
- 3 answers to it.
- 4 And on a lighter note, I would like to
- 5 say that this past summer we went through one of the
- 6 heaviest -- well, the heaviest rainstorm that we've had
- 7 since East Mountain Project had been completed, and
- 8 there were absolutely no problems. It withstood
- 9 everything. The water was taken properly, drained
- 10 properly, no buckling or heaving of the East Mountain
- 11 Road, and I think that everyone involved with that
- 12 project should be commended. And I didn't see anything
- 13 downstream.
- 14 MR. COURTRIGHT: Wayne, maybe I might
- 15 be able to shed a little light. I think what they're
- 16 going to do is the same thing they did when they did
- 17 the DPW Complex.
- 18 I don't know for a fact. I think one
- 19 the properties they might use would be the police

- 20 station, which is probably worth \$3 to \$4 millin. I
- 21 don't know what else. Maybe they're going to use City
- 22 Hall. I don't know. But I think it's the same.
- 23 They're trying to do the same type of deal they did.
- 24 MR. BECK: I think the same questions
- 25 arose back then, though, because the funding for those

- 1 properties are already in prior budgets and supposed to
- 2 be paid for, you know?
- 3 And so, it just seems like it's an
- 4 ongoing thing, and it's got to stop somewhere.
- 5 MR. COURTRIGHT: I think it takes an
- 6 attorney to decipher it.
- 7 MR. BECK: Well, that's why I said I
- 8 had to put it in layman's terms, and I'm not so sure I
- 9 interpreted properly anyway. So, that's why Amil is --
- 10 MR. COURTRIGHT: You seem to do pretty
- 11 good to me.
- 12 MR. BECK: Thank you.
- 13 MS. GATELLI: Thank you.
- 14 MR. ANCHERANI: Good evening, Council.
- 15 I'm Nelson Ancherani, resident, taxpayer, financial
- 16 secretary of the FOP. I'm here to exercise my First

- 17 Amendment rights.
- 18 It's been three months since I've
- 19 attended a Council meting. I missed them, and after a
- 20 while it gets in your blood.
- 21 A lot has happened in those three
- 22 months. We went from having someone writing what we
- 23 saw at Council for us to the city possibly going
- 24 bankrupt.
- 25 First of all, I would like to say that

•

- 1 I write what I say here by myself. No one writes
- 2 anything for me and no one tells me what to say.
- 3 If someone did write my speeches, I
- 4 wouldn't have the mistakes and grammatical errors that
- 5 I have in them.
- 6 Over the last three months the daily
- 7 tabloid has been having a field day with the unions and
- 8 Council speakers. So far the Council speakers have
- 9 been called crazies, inane, malcontents, and that's
- 10 fairly new, Legion of Doom, Halloweeners and low-lifes.
- 11 As you can see, I chose the Legion of Doom, as some
- 12 other speakers here tonight did.
- 13 I never saw so much free advertisement

14 as this tabloid give these speakers. This makes me

15 think that these speakers have much to say about the

16 events of this city, so they say it.

17 It makes me think that the tabloid

18 doesn't want what the speakers have to say about a \$44

19 million loan that is about to be asked for, the

20 violation of the Recovery Plan by the city costing \$6

21 mill by the end of this year with new hires and raises,

22 the firing of the health care consultant costing the

23 city millions of dollars, forcing city employers out at

24 full medical insurance and replacing those employees

25 with the same coverage as the original ones that were

109

1 forced out.

2 Well, the speakers are back and they

3 are going to say what the tabloid won't. There's so

4 much to address, and we can only get five minutes to do

5 it, so we have to pick and choose what we say tonight.

6 At future Council meetings we will be

7 able to get everything in. One headline in the

8 tabloid, City Offered Help in Union Flap. PEL and DCED

9 showed up at a hearing at the courthouse on 8/24/06.

10 There were two attorneys there who argued before Judge

- 11 Munley that they should be allowed to be included in
- 12 the appeal for the arbitrator's award on the police
- 13 contract. They showed up in court three and a half
- 14 years late and 26 arbitration hearings later.
- 15 They now want to be included when they
- 16 refused to supply any records or information that the
- 17 unions subpoenaed. This is PEL, who has been
- 18 invisible, except for the time when the city was
- 19 sanctioned by the State under Mayor Connors.
- 20 I guess they feel it's time for them to
- 21 come out from under the rug before this city has to go
- 22 bankrupt, so they come out with a threat.
- 23 I have to ask, what has PEL done for
- 24 the city except get it sanctioned under Connors and
- 25 accept a pay check for doing nothing?

- 1 They should have been jumping up and
- 2 down standing on their heads raising the ceilings when
- 3 the mayor violated the Recovery Plan and put forth a
- 4 \$74 million budget for 2006, an approximate \$9 million
- 5 increase over 2005.
- 6 Where was PEL when the city put a
- 7 public safety director in the budget costing \$500,000

- 8 for the past five years and now hiring a deputy
- 9 director of public safety director and secretary at
- 10 approximately \$75 a year? Enough with PEL. They're a
- 11 failure getting paid for doing nothing.
- 12 As for the bankruptcy issue, the city
- 13 needs the \$44 million loan to stay afloat. We pay back
- 14 \$40 million in interest. That's almost a 50 percent
- 15 increase. \$84 million is what we pay back at \$3
- 16 million a year for 28 years.
- 17 Add that \$84 million to the \$240
- 18 million plus that the city owes over the next 28 years,
- 19 Wow, taxpayers. Just think, \$240 million plus \$84
- 20 million puts us around \$350 million for the next 28
- 21 years. Taxpayers' great, great grandchildren, get
- 22 ready.
- 23 In the tabloid article on 9/6/06,
- 24 Scranton seeks \$44 million to cover debt projects.
- 25 Both city business administrator Leonard Kresefski and

- 1 Mayor Doherty said there will be hire tax increases
- 2 next year. Told you so. We are going to pay and pay
- 3 dearly. You people up three have a big decision to
- 4 make. Me? I'd refuse the loan.

5 Mr. Moran mentioned that we could save

6 money by eliminating X amount of new hires and raises.

7 Think of this, if no raises and new hires weren't hired

8 in the last five years in violation of the Recovery

9 Plan, there would be no \$6 million deficit this year.

10 As I said before, the raises and new

11 hires total \$6 mill to the end of this year. Isn't it

12 ironic that the deficit is the \$6 mill in raises and

13 new hires in violation of the Recovery Plan by the

14 city? That's not our fault.

15 But I can see it down the road, the

16 unions will get the blame and the tabloid will pour it

17 on. Also, don't forget the legal fees for the

18 arbitrations that the city is paying. One thing, I

19 don't buy the paper, I read it for free. Thank you.

20 MS. GATELLI: Thanks.

21 MS. STULGIS: I'm Ann Marie Stulgis, a

22 city resident and president of the city police union.

23 I would just like to pick up where

24 Mr. Gervasi left off as far as wasteful spending and

25 excessive costs. We all know that the city is claiming

112

1 that the cost of health care is extraordinarily out of

- 2 control, but whose fault is that? Why are health care
- 3 costs out of control?
- 4 Before he came into office, we had a
- 5 health care consultant that was hired as the result of
- 6 a fire arbitration that was mandated by the unions to
- 7 come in and get health care costs under control, and we
- 8 did, and we saved the city \$7 million. So, what
- 9 happened? Mayor Doherty fired her. He fired her. She
- 10 saved the city \$7 million, and she was fired.
- 11 And then we went without a health care
- 12 consultant for a couple of years, had to go back to
- 13 arbitrators and see what we can do. And now we have
- 14 another health care consultant, thanks to Council, who
- 15 pushed the issue about two and a half years ago.
- 16 How much progress have we made in those
- 17 two and a half years? Do you know how much? None. We
- 18 still don't have the people listed as working in the
- 19 correct departments. We had one of our city inspectors
- 20 listed as retired firefighter.
- 21 Our human resource department evidently
- 22 doesn't have any idea who works where, so health care
- 23 cost are out of control. Because you know why? Mayor
- 24 Doherty doesn't have anybody watching the money.
- 25 There's no reason for health care costs

1 to be what they are, except nobody seems to care to get

- 2 a grip on the spending. We've tried.
- 3 We've spent our money to fight the city
- 4 to save the city money. The last time he asked for
- 5 money, I came here and I begged you, please don't do
- 6 it, please don't do it. The threat was we would go
- 7 payless paydays.
- 8 Well, what difference does it may?
- 9 We're just going to end up paying what little we make
- 10 now to pay this debt down anyway. I say, Don't do it.
- 11 The only way to force fiscal
- 12 responsibility is not to allow the money to be there,
- 13 then you force belts to be tightened.
- 14 If I can't afford steak, I don't go out
- 15 and take out a loan to buy it. I eat chicken. That's
- 16 what has to happen in this city. It really has to
- 17 happen, and it's up to you people. You're the only
- 18 hope we have, the five of you sitting there.
- 19 I'm telling you, we have hundreds of
- 20 city employees who are saying, bringing on the payless
- 21 paydays, if that's what it takes. Please don't put us
- 22 in any more debt than we already have. It's up to you.

- 23 Now, on another note, I'm sure you're
- 24 all aware it's on tonight's agenda about the police
- 25 officers who are buying police cars, and it's quite

•

- 1 controversial even among other police officers, because
- 2 the belief is that since the mailmen don't have to buy
- 3 their own mail delivery trucks and the UPS drivers
- 4 don't have to buy the UPS trucks, why are policemen
- 5 buying police cars?
- 6 I'll give you a perfect example. Just
- 7 last week our C-1 car was driving downtown. Thank God
- 8 he was in traffic and he was moving very slowly. He
- 9 had had the car in for repairs and there were repair
- 10 slips done on it and he was told nothing was wrong with
- 11 it three consecutive days.
- 12 And suddenly there was a loud noise and
- 13 the car stopped dead. The reason the car stopped dead,
- 14 is the mount that was holding the motor up fell out.
- 15 The motor dropped down. That's why policemen are
- 16 buying police cars.
- 17 Had he been doing 65 or 70 miles an
- 18 hour when that happened, the results would have been
- 19 catastrophic. They're buying police cars because they

- 20 want to go home after their shift and the city isn't
- 21 making that possible and probable, the condition of the
- 22 vehicles.
- 23 And I also would like to end by
- 24 commenting on the arbitration award that the
- 25 firefighters recently lost. The firefighters didn't

- 1 lose it, but the residents of the City of Scranton lost
- 2 it.
- 3 Because if I was a principal of a
- 4 school, had a nursing home, had an apartment building,
- 5 a college dorm where automatic alarms are used, do you
- 6 realize because of this arbitration award, now only one
- 7 truck responds and only two people.
- 8 And God forbid there's a fire in a dorm
- 9 or in a hospital, the soonest you're going to get more
- 10 firefighters there is five minutes. To save a couple
- 11 dollars in fuel, how much is a life worth? That's all
- 12 I have to say.
- 13 MS. GATELLI: Thank you very much.
- 14 Anyone else care to speak before Council?
- 15 MS. GARVEY: 5-A, motions.
- 16 MS. GATELLI: Mrs. Evans.

- 17 MS. EVANS: Good evening. I'm very
- 18 pleased that City Council is back in session and I look
- 19 forward to hearing your opinions and helping you solve
- 20 all of your problems.
- 21 To begin, I'd like to make the
- 22 following announcement. There will be a free rabies
- 23 clinic on Saturday, September 9 from one to 3 p.m. at
- 24 the Dunmore Pet Health Center located at 1317 East
- 25 Drinker Street, Dunmore. This free rabies clinic is

- 116
- 1 sponsored by the Scranton Animal Association.
- 2 I'd like to recognize the wonderful
- 3 work performed by the DPW last Thursday and Friday.
- 4 Not only was the debris cleaned from beneath the
- 5 Albright Avenue bridge, but the riverbank was built up
- 6 several feet along the old Laminations building.
- 7 Friday afternoon I watched the DPW
- 8 trucks deliver one load of dirt after another and I
- 9 watched as a bulldozer solidly leveled those walls.
- 10 And I say, Excellent job to the DPW.
- 11 I'm also elated to see the medallions
- 12 that we fought so hard to preserve will be part of the
- 13 Medallion Garage facade once again. Thank you

- 14 particularly to the Architectural Heritage Association
- 15 we worked with in 2005.
- 16 I would also like to announce that
- 17 Mr. Fiorini any contacted Daron Northeast on August 2
- 18 about watering down the street to prevent unhealthy air
- 19 quality in the air. If problems persist, please call
- 20 Mr. Fiorini or myself through City Council's office.
- 21 Also notable, the streetlight on Henry
- 22 Street was finally installed in August, and thankfully
- 23 after three years of talking, badgering, Kane Street
- 24 will be paved.
- 25 I have some new requests, first of all,

- 1 a letter to Mark Seitzinger, 1015 Mount Vernon Avenue
- 2 residents complain of a condemned house which is an
- 3 overgrown eyesore.
- 4 Next, speed limit or school signs are
- 5 needed on Wyoming Avenue in the block of Scranton Prep.
- 6 Construction is exacerbating the traffic speeding and
- 7 road rage, and the crossing guard has been requesting
- 8 these signs for years without success.
- 9 A letter to Mr. Wintermantle and the
- 10 SPA, city businesses complain that downtown employees

- 11 are using metered parking spaces in front of their
- 12 businesses thereby prohibiting customers from parking
- 13 and patronizing their establishments.
- 14 These workers appear every two hours to
- 15 refill the meters and remain in the parking spots
- 16 throughout the working day. Can you develop a policy
- 17 to remedy this situation?
- 18 In other cities tires are marked with
- 19 chalk after a set number of hours remaining in one
- 20 space and the owners of the vehicles are ticketed.
- 21 Surely two new parking garages can accommodate some
- 22 downtown employees.
- 23 I have several complaints about houses
- 24 and properties on Prospect Avenue, which I would like
- 25 forwarded to Mr. Fiorini.

- 1 A letter to Chief Elliott, residents of
- 2 Grove Street report that despite signs that prohibit
- 3 truck traffic, 18 wheelers from Topps Bubble Gum and
- 4 the soda building frequently travel Grove Street. They
- 5 come dangerously close to parked vehicles and sometimes
- 6 drive over residents' properties. Further, the curbs
- 7 on Albright Avenue are being destroyed. Please, can

- 8 you enforce the signs?
- 9 Next, city residents request pedestrian
- 10 walking lines at Nay Aug Park in the area of the mine
- 11 and parking lots. One reports that he nearly was
- 12 struck by a car this summer and a cyclist was injured
- 13 trying to avoid a car.
- 14 Next, a letter to Ms. Hailstone, why
- 15 have the benches in the downtown not been installed as
- 16 promised, and when will they be installed?
- 17 Next, pave the entire length of Gardner
- 18 Avenue. Paint the traffic lanes at Franklin Avenue and
- 19 Spruce Street and the entrance to the Steamtown Mall on
- 20 Lackawanna Avenue and paint the crosswalks once again
- 21 at Pine and North Washington and Gibson and North
- 22 Washington.
- 23 Also, I received a response from
- 24 Mr. Seitzinger, a very timely response, regarding
- $25\ 913\mbox{-}915$  Green Ridge Street, however, the request I made

- 1 was not properly addressed.
- 2 I do understand that the property is in
- 3 a blighted condition and that it is not city owned
- 4 property, rather, it is owned by a bank.

- 5 My question was, would he please
- 6 facilitate the purchase of such property by a neighbor
- 7 who wishes to renovate. I believe it's Mr.
- 8 Seitzinger's intention to demolish the structure, when,
- 9 in fact, there are citizens who are more than willing
- 10 to rehabilitate this Victorian.
- 11 Lastly, we had a notice tonight about a
- 12 sad cave-in that needs black top in the 1000-block of
- 13 Mohawk Street, and they appear to have called about
- 14 this problem all summer long, and Council has received
- 15 a picture of that huge depression, which is also
- 16 flooded.
- 17 I also wanted to bring Council's
- 18 attention to a letter we received in our mail this
- 19 evening from a young man, Brian Kusick from Troop 16 of
- 20 the Boy Scouts, who's working on an Eagle Scout
- 21 project. This was discussed, I believe, almost a year
- 22 ago. Do you recall, Mr. Courtright?
- 23 MR. COURTRIGHT: Yes.
- 24 MS. EVANS: And he would like to
- 25 install a flag pole at the East Mountain Fire House.

1 He chose this project to honor the people in public and

- 2 military service, including his very own brother and
- 3 father who recently returned from Iraq and Afghanistan,
- 4 as well as all other civil servants.
- 5 He needs \$900 to complete the project,
- 6 and I would move that City Council should donate \$200
- 7 from Council's budget to Brian Kusick's Eagle Scout
- 8 project to erect a flag pole at the East Mountain
- 9 Firehouse.
- 10 MR. COURTRIGHT: I'll second it.
- 11 MS. GATELLI: On the question? All in
- 12 favor.
- 13 MS. EVANS: Aye.
- 14 MS. NEALON FANUCCI: Aye.
- 15 MR. MCTIERNAN: Aye.
- 16 MR. COURTRIGHT: Aye.
- 17 MS. GATELLI: Aye. Opposed? The ayes
- 18 have it and so moved.
- 19 MS. EVANS: Thank you. Kay, did I
- 20 receive a response from Ms. Hailstone regarding the
- 21 loan information I requested by September 6?
- 22 MS. GARVEY: No.
- 23 MS. EVANS: Please contact her tomorrow
- 24 and remind her that I'm waiting.
- 25 Also, I require her written response to

- 1 the letter of July 6 requesting answers for Mr.
- 2 Sbaraglia and identifying the party ultimately
- 3 responsible for loan repayment when a business closes.
- 4 And while we're on the topic of OECD,
- 5 I've noticed that NDC, the newest consultant, is hiring
- 6 Scranton Tomorrow at a fee of \$3000 to serve as their
- 7 consultant on economic development, thus, the
- 8 consultants who do the work of the city employees will
- 9 now also have a consultant.
- 10 Also, I have yet to receive the
- 11 independent audit which was due by law in May 2006.
- 12 But none of these occurrences should surprise us after
- 13 the highly eventful weeks of August and September.
- 14 Since Council recessed, we have
- 15 witnessed the following, The city tried to take a
- 16 business through condemnation, the city tried to evict
- 17 low income residents of an SHA housing project, the
- 18 city submitted a two-page incomplete capital budget,
- 19 and to no one's surprise, the Doherty debt is rising by
- 20 another \$84 million in long-term debt. He's pointing
- 21 the finger of blame at everyone but himself, and he
- 22 wants Council to clean up his mess.

- 23 Now, I ask you, if your house is a
- 24 filthy mess, can you call up your neighbors and ask
- 25 them to clean it for you?

- 1 And if you set your house on fire, can
- 2 you call up your neighbors and ask them to rebuild it
- 3 for you? And isn't this the guy who said he was going
- 4 to reduce our taxes when he first ran for mayor?
- 5 But now he claims he said all along
- 6 that he would increase taxes. He wants to borrow \$44
- 7 million to cover projected deficits. So, in other
- 8 words, he's asking us to okay his never having to
- 9 balance a budget.
- 10 In the meantime, while taxpayers are
- 11 told to pay all the Doherty debt, 23 percent of this
- 12 city lives in poverty, and the region's unemployment
- 13 rate is up over five percent. How can we pay these
- 14 bills? How can our senior citizens pay these bills?
- 15 In November and December 2004, together
- 16 with Mr. DiBileo and Mr. Courtright, I created a budget
- 17 that would have saved this city \$4 million. We had a
- 18 plan, a good viable plan, so that the mayor would not
- 19 have to borrow any money. He vetoed that budget and

- 20 borrowed the \$4 million.
- 21 My fellow Scrantonians, I ask you, as
- 22 to alternatives, when has this mayor ever taken the
- 23 advice of City Council?
- 24 Mr. Doherty is not interested in
- 25 alternatives, so the public relations team better dream

- 1 up a better line for the next newspaper article.
- 2 The bottom line is, now you're all
- 3 strapped with a tax increase and many, many more to
- 4 come, which I have been predicting for the last three
- 5 years. The more money we give this fellow, the longer
- 6 and greater the tax increases will slap us in the face.
- 7 And since when is accumulating over
- 8 \$300 million in long-term debt considered, quote, going
- 9 in the right direction? That's it.
- 10 MS. GATELLI: Thank you. Mrs. Fanucci.
- 11 MS. NEALON FANUCCI: Well, it's really
- 12 fun to be back. I want to thank everybody for coming
- 13 out, all my friends.
- 14 I just want to say a few things. This
- 15 has been an actually a pretty productive meeting, I
- 16 think. I feel that we are starting to communicate on a

- 17 better level, which is great.
- 18 One thing I want to tell Mrs. Evans,
- 19 the Parking Authority, I had the same complaint about
- 20 meter feeding and all that. They are looking into new
- 21 meters and some way of stopping that. I'm not sure
- 22 exactly what they were, but I know that they had told
- 23 me that they were looking into some new meters.
- 24 MS. EVANS: Thank you.
- 25 MS. NEALON FANUCCI: Okay. But also I

- 124
- 1 want to talk about Mark Seitzinger. I'm very big on
- 2 believing in this program. Blight in the city is
- 3 definitely something that I have been an advocate in
- 4 getting rid of, and I know Judy, as well as everyone
- 5 else, feels that this is something to help us.
- 6 When we are paying our taxes and doing
- 7 what we can to keep our properties up and there is a
- 8 property next door that may be is decreasing your
- 9 property value, I don't think that is something that we
- 10 should just let go.
- 11 And unfortunately we do not have the
- 12 manpower to do that. So, I am happy that this is
- 13 happening, and I do believe in the longrun this will

- 14 help bring in more tax base and keep people in the city
- 15 for a longer period of time.
- 16 On the bankruptcy issue, I believe that
- 17 my words were very -- I'm going to stand by what I said
- 18 about being bankrupt.
- 19 From what I have read and who I've
- 20 talked to in the State, we will not be able to file
- 21 bankruptcy under any circumstances, this is what they
- 22 tell me, that the judge will not let us file bankruptcy
- 23 until we up implement some plan.
- 24 Now, whether or not it is with this PEL
- 25 or someone else who comes in, the judge will throw it

- 1 back. They said the reason for that is because if we
- 2 do not implement a plan, everyone else in all of
- 3 Pennsylvania will just file bankruptcy, that it would
- 4 be the easy way out.
- 5 This is what I've been told. Now, I'm
- 6 sure that next week we'll have a lot of dispute on
- 7 that, but this is what the explanation was to me, that
- 8 bankruptcy was not an issue for us at this time. That
- 9 was something that someone had said tonight, so that
- 10 was the only reason.

- 11 As far as the \$44 million, this is
- 12 probably the most difficult decision I think that any
- 13 of us will have to even ponder for the next few weeks.
- 14 I am doing my best to sit down and educate myself on
- 15 this.
- 16 I've heard a lot of comments about the
- 17 \$44 million. I, myself, am not inclined to give out
- 18 that kind of money right now. I am not sure that I
- 19 have enough information to make my decision
- 20 100 percent. I am definitely going to vote it in
- 21 tonight so that I could take time to figure out what we
- 22 have to figure out.
- 23 And I would like to sit down with
- 24 everyone and see if we can come up with some
- 25 money-saving alternatives.

- 1 And I know that Mrs. Evans said that
- 2 she had done that years ago with the last Council.
- 3 Maybe that is something we need to do. I know that it
- 4 should not be on our lap, but I feel like it is.
- 5 And as far as I am concerned, I believe
- 6 that it is our job to at least try to save something or
- 7 some money or do something that we can be proud of at

8 the end of all this. And that is all I have tonight.

9 Thank you.

10 MS. GATELLI: Thank you.

11 Mr. McTiernan.

12 MR. MCTIERNAN: Thank you,

13 Mrs. Gatelli. Just two items. First of all I'd like

14 to thank the Scranton School District maintenance

15 department for taking the initiative to paint the

16 crosswalks around the schools in the city for the

17 safety of the students as school begins this past --

18 beginning of September.

19 And also, Kay, if you would send a

20 letter or Neil to Mr. Parker. I made a verbal request

21 last time we had a meeting regarding a sinkhole that is

22 developing along Forest Glen Drive and now it's

23 obstructed by trees overhanging and that is getting

24 larger and dangerous. It is in an area that there

25 aren't houses, so I don't know of an address.

1 MS. GARVEY: Okay.

2 MR. MCTIERNAN: If they could take a

3 look at it. And that's all, Mrs. Gatelli. Thank you.

4 MS. GATELLI: Mr. Courtright.

5 MR. COURTRIGHT: Yes. I had a taxpayer

6 send me a letter asking about the CRF loan and what

7 project had been funded from the CRF money, and they

8 asked if I would read it off here, and I certainly will

9 do that.

10 One was D & S Auto Sales, they got

11 \$50,000, and two jobs were created. They need to

12 create one job for every \$35,000 that they receive.

13 The second one Edmund and Chris Pisano

14 Partnership, \$250,000, and that's eight jobs. The

15 third is Scranton Dunlap, Incorporated, and that's

16 \$200,000, seven jobs.

17 The next one is National Pastry Bake

18 Shop, Mr. Bill Fox, \$250,00, eight jobs, and the latest

19 one I have, I don't know if there's -- no, I believe

20 there isn't any more, we haven't voted on them, is

21 Denise's Salon, LLC, \$75,000, three jobs.

22 The one thing that I would say is this

23 is that these are loans, they're not grants, they're

24 loans, and none of this money could be given unless

25 Council votes on it, and every single one of the ones I

128

1 just read were unanimously approved by everybody on

- 2 this Council. Nobody voted no on any of these, so I
- 3 think we all felt they were good projects.
- 4 And I'll ask to keep updated on whether
- 5 projects come through. But for your own information,
- 6 you'll see us voting on them, because they can't get
- 7 the money without us voting on them.
- 8 And on a note that I think is a happy
- 9 note, I started working on something a while back with
- 10 Mr. McTiernan, and this -- approximately two Fridays
- 11 ago I met with Congressman Kanjorski, Chris Doherty,
- 12 Karen Feather, who is Congressman Kanjorski's Chief of
- 13 Staff, Tom Williams, who is the District Project
- 14 Director for Congressman Kanjorski, and we went up on
- 15 Main Avenue and took a look at a project that we wanted
- 16 to do, and that project is from Jackson Street to
- 17 Luzerne Street curbs, sidewalks, lights, trees and
- 18 possibly underground utilities.
- 19 And Congressman Kanjorski came up there
- 20 to take a look at it. He seemed to be excited about it
- 21 and he said he would certainly help us fund this.
- 22 So, I asked Kay if this week if she
- 23 could send out a letter to -- you did that today maybe,
- 24 Kay, to the mayor?
- 25 MS. GARVEY: No, it didn't go out yet.

1 MR. COURTRIGHT: Okay. So, if we can

2 send it tomorrow morning possibly asking him to get us

3 an estimate on this project so that we can get it

4 moving.

5 I know the people in West Scranton are

6 really looking forward to this, and I want to do

7 everything I could to speed it up. And I just want to

8 thank all concerned for considering this project, and

9 hopefully it will get done.

10 I understand and I've explained to the

11 people in West Scranton that it takes a long time

12 before you're going to actually see it completed, but

13 at least we've got the ball rolling, and I'm really

14 hoping that it takes hold. So, I'd just like to thank

15 everybody concerned.

16 The Sewer Authority has asked us,

17 correct me, Kay, if I state this wrong, that if we have

18 a problem with anything to do with the Sewer Authority

19 that we call this specific number and they'll handle it

20 that way; is that correct?

21 MS. GARVEY: That was the first

22 response that I had gotten from Mr. Scopelliti, he

- 23 called and said regarding any of these requests that
- 24 are coming in, there's no need to send the letters,
- 25 they can just call this dispatch number or that we

- 1 could call it for them if we got those requests, but
- 2 then two weeks after having gotten that message from
- 3 him, Gene Barrett from the Sewer Authority called me to
- 4 tell me that a certain catch basin had been taken care
- 5 of, and I told him of Mr. Scopelliti's phone call, and
- 6 he said, no, that he would prefer that the letters
- 7 continue. He would rather have them in writing. So,
- 8 I'm --
- 9 MR. COURTRIGHT: Okay. All right. I know
- 10 that letter is in our box, I just didn't read it. I
- 11 saw it tonight. Okay.
- 12 Well, anyway, Neil, I know I had Neil
- 13 call about this one to that particular number, it was
- 14 947 Euclid. The road has been torn up for quite a
- 15 while, and I don't know. I haven't gotten -- I
- 16 apologize to the person that lives at 947 Euclid, I
- 17 lost your number.
- 18 I had several conversations back and
- 19 forth with this individual, and the last time I spoke

- 20 to them, the road wasn't paved. So, maybe we need to
- 21 send a letter then, I guess, the phone call is gone to
- 22 the wayside, okay.
- 23 All right. So, if we can send a letter
- 24 asking about 947 Euclid, that entire road there that
- 25 they tore up, if they could take a look at that.

- 1 And just probably down the street a
- 2 little bit from where Mr. McTiernan talked about, there
- 3 is a house in front of this. It's 33 Forest Glen.
- 4 There has been a depression across the road there for a
- 5 long time, and I've asked at least three or four times
- 6 if the DPW can go up there and take a look at it,
- 7 because winter will be here faster than we want it to
- 8 be, and then for sure we're not going to get it done.
- 9 And one last thing, with the
- 10 \$44 million, I asked Kay if she could contact PEL, and
- 11 she did that for me, we did it both on the phone and I
- 12 believe E-mail, and a gentleman by the name of Jerry
- 13 Cross called me today.
- 14 And my question was this, Does PEL
- 15 agree with borrowing \$44 million? And he couldn't
- 16 answer me. He said that what he needed to do was they

17 get their direction from the State before he can give

18 me any answer and that he would -- he called me early

19 this afternoon and he said he would try to have that

20 answer to me before the meeting, if not, he would have

21 it for me for next week.

22 And so, all I asked was a simple

1 It does not set forth the estimated

2 annual costs of operations and maintaining of

3 facilities that are constructed or will be acquired in

5 In fact, this budget is a disgrace. In

6 its present form the 2007, capital budget does not

7 merit comment on any of its entries, either on the

8 revenue side or the expenditure side.

9 Because as it was submitted to City

10 Council, I cannot inquire into the necessity or

- 11 validity of any entry. I cannot determine if it's good
- 12 for the people. This is yet another attempt to
- 13 diminish the oversight authority of Council.
- 14 MS. GATELLI: Mrs. Evans, do you have a

17 it's violating the Home Rule Charter, and tell him if

18 he sends it down in the proper fashion, that we will

19 put it on the agenda again.

20 MS. EVANS: Did you notice the length

21 of the budget, a two-page capital budget?

22 MR. COURTRIGHT: Mr. Minora, can I ask

23 you a question? As long as one of us has voted in the

24 negative, we can reintroduce it if we get the

25 information that we need, correct?

152

1 MR. MINORA: Yes.

2 MR. COURTRIGHT: But it has to be one

3 of us that voted in the negative; is that correct?

4 MR. MINORA: Yes.

5 MR. COURTRIGHT: Okay.

6 MS. GATELLI: And besides, I think it

7 would be different. If it had the proper information,

8 it would be different, and I don't think we'd even have

9 to reintroduce it. If it's different than the first

10 case --

11 MS. NEALON FANUCCI: Right, because

12 it'd be a different piece of legislation.

13 MR. MINORA: Either way I think it

14 would work.

15 MS. GATELLI: Okay. Fine.

16 MS. GARVEY: 5-G, FOR INTRODUCTION - AN

17 ORDINANCE - AUTHORIZING THE TRANSFER OF CITY-OWNED LAND

18 SUBJECT TO ALL NECESSARY APPROVALS, SPECIFICALLY THE

21 MS. GATELLI: At this time I'll

22 entertain a motion that 5-G be introduced.

23 MR. COURTRIGHT: So moved.

24 MR. MCTIERNAN: Second.

25 MS. GATELLI: On the question?

1 MS. EVANS: Yes. Mr. Baux raised a

2 number of very important questions tonight, one of

3 which I don't think was answered as yet, how this

4 particular item came to be on this evening's agenda at

5 all.

6 But that being said, I have a few

7 questions I'd like to pose, first, in the event of such

8 a transfer, who would reimburse Sloan Little League for

9 the fence and bleachers they paid for for the teener

10 league?

11 And despite the lack of approval of a

12 new lease, legally speaking, it appears that the lease

13 would continue day to day, and, therefore, I think that

14 it would include all of the city's athletic fields,

15 therefore, if you were to pass this, you've broken a

16 lease, and I wouldn't be surprised that Sloan can and

17 would sue the city.

18 Also, as Mr. Baux indicated, there has

19 been no formal contact between the Scranton School

20 District and Sloan Little League in many, many, many

21 months, other than an informal meeting that was

22 conducted in July, at which time a school director

- 23 promised to contact Sloan with the school board's
- 24 decision and failed to do so.
- 25 I really believe this legislation puts

- 1 the cart before the horse. Let the two entities sit
- 2 down, negotiate and come up with their own solution and
- 3 then let City Council pass that legislation.
- 4 MS. GATELLI: Anyone else on the
- 5 question? I'd just like to say that I didn't know it
- 6 was coming either, but I put it on here so that maybe
- 7 the interested parties could finally get together and
- 8 solve this, because it just keeps going back and forth.
- 9 If there's a possibility of putting
- 10 Sloan into that mix, I'm not sure, but I would like
- 11 Sloan -- if this is going to happen, and I'm in favor
- 12 of this happening, because I'd like to see the kids
- 13 over there on the teener field, but I also would like
- 14 Sloan to be part of it, so maybe we can table this or
- 15 add an amendment to it or something that Sloan would be
- 16 a sublessee --
- 17 MR. MINORA: I don't know that we can
- 18 do that, because you're binding the school board, who's
- 19 not really party to our legislation. The school board

- 20 is going to have to sit down and be part of the
- 21 solution.
- 22 MR. BAUX: That's all we're asking.
- 23 MR. MINORA: Right now they don't seem
- 24 to be.
- 25 MR. BAUX: That's all we're asking.

- 1 MS. GATELLI: All right.
- 2 MR. MCTIERNAN: Before we vote any
- 3 further, Mrs. Gatelli, I had raised some concerns based
- 4 on the concerns of the folks who were involved with the
- 5 Sloan Little League, and they were concerned about
- 6 retention of access and control over the little league.
- 7 I would vote yes for this legislation,
- 8 but I will personally contact some folks at the school
- 9 district to find out if we can add provisions to
- 10 maintain accessibility for the little league.
- 11 As I said in remarks several months
- 12 ago, I don't believe the school district has any use
- 13 for the little league field due to its physical
- 14 constraints and the requirements of the PIAA regarding
- 15 high school athletics. So, I'll make that contact
- 16 tomorrow and then I can bring that information

- 17 back.
- 18 MS. EVANS: I like what you're doing,
- 19 Mr. McTiernan, opening the lines of communication, but
- 20 I still feel adamantly about Sloan sitting down with
- 21 the school district, rather than intermediaries. I
- 22 believe the two entities involved need to iron this out
- 23 to both of their satisfaction.
- 24 MS. GATELLI: I do, too, but I don't
- 25 think there should be any other parties involved

- 1 because other people put their spin on it and somehow
- 2 it becomes not what it's supposed to be. It's supposed
- 3 to be West Side, Sloan.
- 4 The same kids that play at Sloan are
- 5 going to go to West Intermediate and they're going to
- 6 go to West Side High School, and we're all talking
- 7 about the same kids. We just can't get to the point we
- 8 need to get at.
- 9 MS. EVANS: So, why doesn't City
- 10 Council then keep its hands off it until they finish?
- 11 Well, actually until they start and finish their
- 12 negotiations?
- 13 MR. COURTRIGHT: Mrs. Evans, as you

- 14 recall, we met at Sloan Little League. I said to Mrs.
- 15 McGuigan that I didn't want to know anything about
- 16 this, I didn't want to see anything come before me
- 17 about this --
- 18 MS. EVANS: Yes, you did.
- 19 MR. COURTRIGHT: -- until what time
- 20 Sloan and the school district had some kind of an
- 21 agreement. I don't know how this falls on us. I mean,
- 22 I understand it's city property, but they're the two
- 23 groups that have to decide this. I don't think it's up
- 24 to us, I really don't.
- 25 MS. EVANS: Because as I raised other
- 157
- 1 issues beyond the use of fields outside the teener
- 2 field, there are other issues at stake, because these
- 3 people have been maintaining those fields and have been
- 4 fundraising independently for years, and every
- 5 improvement that was made has come out of their pockets
- 6 and off the sweat of their brows and they deserve the
- 7 consideration, monetary consideration, I believe, from
- 8 the school district.
- 9 MR. COURTRIGHT: I don't know. I just
- 10 thought after we met that night, that they were going

- 11 to come back to the Sloan Little League, that was my
- 12 understanding --
- 13 MS. EVANS: They didn't.
- 14 MR. COURTRIGHT: -- and then we
- 15 wouldn't see anything until those two had some kind of
- 16 an agreement. That's what I thought we had agreed on
- 17 that night, but evidently that didn't happen.
- 18 MS. EVANS: I agree with you.
- 19 MS. MCTIERNAN: Mrs. Gatelli, one
- 20 additional thing. You're looking at information from
- 21 the school district. In our backup packet there is a
- 22 copy of a resolution that passed 8-0 on May 15 by the
- 23 Scranton School Board, and I'll just read the paragraph
- 24 that I think is pertinent here, Whereas, the School
- 25 District of the City of Scranton recognizes that such

- 1 entities, including but not limited to the Sloan Little
- 2 League Association, have an interest in continuing to
- 3 utilize the field for their purposes and it is not
- 4 therefore the intention of the district to preclude the
- 5 Sloan Little League Association from use of the
- 6 premises or any other groups so long as it is not
- 7 inconsistent with the needs of the district.

- 8 So, there is some discussion and there
- 9 is some official notation of the district's desire to
- 10 work with Sloan Little League, and that passed 8-0 on
- 11 May 15.
- 12 MS. EVANS: I think that, you know,
- 13 that's commendable, although I don't feel that the
- 14 language particularly protects Sloan Little League,
- 15 however, I'd be willing to gamble that Sloan Little
- 16 League didn't even know about that. They didn't.
- 17 MS. GATELLI: Well, why don't we --
- 18 we'll vote on it as it is right now, and we will have
- 19 Mr. McTiernan bring those ideas back to the school
