- 25 police officers and Chief Elliott said that

- 1 to check with Miss Hailstone and was
- 2 informed that a cap was on public service
- 3 money and we reached our maximum funding, so
- 4 what I would like to do is find out what
- 5 other projects are public service projects
- 6 that maybe we can cut back on them instead
- 7 of on these. I know that in west side Jill
- 8 Foley and Melissa Forsett. In Greenridge
- 9 Jason Christiano and Pat Cavanaugh. South
- 10 Scranton has Chad Doherty. North Scranton,
- 11 Officer Ken James and Tim Charles and in the
- 12 hill section there is no assignment, so
- 13 there are none in the hill and there is only
- 14 one in south side and we always had two
- 15 there, so I don't understand why we have
- 16 less than more and this council appropriated

17 that --

18 MR. COURTRIGHT: I can tell you.

19 MS. GATELLI: Go ahead.

20 MR. COURTRIGHT: They need to hire

21 more officers. When the officers go from

22 out of the order of rank 140 they take them

23 from the COM-E officers, so they move them

24 from the COM-E into the rank of 140 so

25 actually they're being giving a test this

1 summer, I believe it's next month, for the

2 police officers that we hired more officers

3 so the bottom line is we don't have anybody

4 to fill those slots, so we got to hurry up

5 and get tested and get these guys out here.

6 MS. GATELLI: That doesn't help us

7 all summer.

8 MR. COURTRIGHT: Right.

9 MS. GATELLI: That's very

10 unfortunate. Then they'll have to go for

11 training, then they won't be there until

12 Christmas.

13 MR. COURTRIGHT: Right. Absolutely.

- 14 MS. GATELLI: I wanted to bring your
- 15 attention that there are some street paving
- 16 going on and it's K-Routes that are being
- 17 paved. Boulevard Avenue from Electric to
- 18 Parker Street, Monroe from Mulberry to
- 19 Popular, South Webster from Birch to Main,
- 20 and Genet to Duncan. West Popular, Grove,
- 21 Court and Albright from Wyoming to
- 22 Providence. Birch from Washington to South
- 23 Webster. River from East Mountain Road to
- 24 Stafford, Rockwell, Charles and Marvin from
- 25 West Market to North Main. These are all

- 1 K-Roads and they are paved with 80 percent
- 2 federal funds. So that's a little bit of
- 3 good news.
- 4 Next, I just received this tonight,
- 5 it's for first Friday that's held in the
- 6 downtown and they would like you to stop by
- 7 B's Floral Design at 131 Penn Avenue
- 8 tomorrow from 6 to 9 and one of the artists,
- 9 Kevin Carey, was hit by a dump truck coming
- 10 home from work after visiting a child at

- 11 home for their school studies. Kevin is a
- 12 special ed teacher and the accident left him
- 13 with several disabilities. If you would
- 14 take a moment and visit and support him his
- 15 art will be displayed there tomorrow
- 16 evening.
- 17 I'd also like to give a report,
- 18 although I wasn't here last week I was out
- 19 sick, and I wanted to tell you that the day
- 20 after the last meeting, which would have
- 21 been May 18, I did call the Department of
- 22 Environmental Protection concerning Daron
- 23 Industries and I filed a complaint on behalf
- 24 of City Council. They did send me -- I
- 25 talked to Mary Beth Nestor, she recalled

- 1 when we had this problem in my neighborhood
- 2 and she was so kind as to send me all of the
- 3 reports that they had written when they
- 4 check there on complaints. They have 14
- 5 complaints since 2004. So, if anyone -- I
- 6 will share these with my fellow council
- 7 members and we will proceed from there, but

- 8 they are aware of the situation and I did
- 9 file a complaint.
- 10 I'd also like to make a motion
- 11 tonight to prepare -- have Amil prepare an
- 12 ordinance or Rob Farrell, whoever has to do
- 13 it, to ban truck traffic in the 1700 block
- 14 of Dickson. This is only one small thing
- 15 that we can do to help the situation that's
- 16 happening there. I don't know if it will
- 17 abate all of the problems, but it will be
- 18 one small step into making it better there
- 19 and all of council I'm sure is interested in
- 20 this, we have all discussed this, and I
- 21 think that banning the truck traffic would
- 22 be one step --
- 23 MS. EVANS: Second.
- 24 MS. GATELLI: -- so I make that
- 25 motion. Anyone on the question?

- 1 MS. EVANS: Yes. I went down to
- 2 visit the area this week and I noticed that
- 3 their usual entrance had now been closed
- 4 down and great piles of cinder blocks now

- 5 prevent any view of the property from the
- 6 Dickson Avenue side. I also know that
- 7 despite the fact that the manager,
- 8 Mr. Lewis, indicates that all truck traffic
- 9 is confined to the hours of 7 a.m. through
- 10 7 p.m. the neighbors report that trucks are
- 11 idling outside Daron Northeast as early as
- 12 5:30 a.m. and so I, too, feel, very strongly
- 13 the only solution to this is to close that
- 14 street down the 1700 block for the benefit
- 15 of the residents to all truck traffic.
- 16 MS. GATELLI: Does anyone else have
- 17 anything? All in favor?
- 18 MS. EVANS: Aye.
- 19 MS. FANUCCI: Aye.
- 20 MR. MCGOFF: Aye.
- 21 MR. COURTRIGHT: Aye.
- 22 MS. GATELLI: Aye. Opposed? The
- 23 ayes have it and so moved. Does anyone else
- 24 have any announcements to make? Mrs.
- 25 Garvey? Mrs. Evans?

1 MS. EVANS: Good evening. I ask you

- 2 to remember in your prayers a young man who
- 3 was my student and a National Honor Society
- 4 member of which I'm the moderator, Matthew
- 5 Grendel. His devoted parents, Dennis and
- 6 Patti, and his siblings, Jane and Pat also
- 7 ask that you pray for them.
- 8 In the last two weeks William Fox,
- 9 Jr., a retired teacher at West Scranton High
- 10 School, and Charles Benzel, a retired
- 11 Scranton police officer passed away. Please
- 12 keep both men and their families in your
- 13 prayers as well.
- 14 I wish to thank Gerry Knight for her
- 15 contribution to the Kids Swim Free Fund.
- 16 I'll be sure Mr. Jackowitz has it in his
- 17 hands tonight.
- 18 The pave cut inspector,
- 19 Mr. Hazzouri, reported that the paving
- 20 project was put out to bid on May 24, 2007,
- 21 and Diamond Avenue was placed on the list.
- 22 It should be paved by the end of June or the
- 23 beginning of July. I hope to hear soon from
- 24 the inspector that the block of Wheeler
- 25 Avenue council discussed at it's last

1 meeting will also be added to the paving

2 list. And if my colleagues agree, can we

3 schedule a public caucus with Mr. Gene

4 Barrett, executive director of the Scranton

5 Sewer Authority for the June 14 meeting.

6 I'd like to discuss the 56 percent rate

7 increase and the lease back agreements.

8 MS. GATELLI: We'll schedule that.

9 MS. EVANS: Thank you. I am more

10 than a bit concerned that the sales manager

11 of Daron Northeast wishes only to meet

12 privately with council to discuss the

13 problems at this business rather than

14 publically. He also indicates he can meet

15 with us separately or as a group, obviously,

16 he is not acquainted with the Sunshine Law

17 and any meeting that would involve the five

18 members of council must be a public meeting,

19 but such arrangements, such private back

20 door arrangements, raise a red flag. If

21 you're in compliance with DEP and OSHA, if

22 you have not harassed the neighbors, and if

- 23 you want to be a good neighbor why are you
- 24 afraid to meet with the taxpayers? I will
- 25 not meet with Daron unless five neighbors

•

- 1 are present at the private conference to
- 2 represent the affected areas of Scranton.
- 3 Also, I move that Parks and
- 4 Recreation director will provide council
- 5 with an itemized list of costs for the dog
- 6 park and a copy of the rules drafted for
- 7 entrance therein.
- 8 MR. COURTRIGHT: Second.
- 9 MS. GATELLI: On the question?
- 10 MS. EVANS: I know that I had sent a
- 11 letter requesting these itemized costs
- 12 before, however, I did not make that in the
- 13 form of a motion I thought perhaps that
- 14 might hold it up and so I'll follow the
- 15 proper procedures and hopefully we will have
- 16 that answer for the public as soon as
- 17 possible.
- 18 MS. GATELLI: Anyone else on the
- 19 question? All in favor?

- 20 MS. EVANS: Aye.
- 21 MS. FANUCCI: Aye.
- 22 MR. MCGOFF: Aye.
- 23 MR. COURTRIGHT: Aye.
- 24 MS. GATELLI: Aye. Opposed? The
- 25 ayes have it and so moved. If you like we

- 1 can have Tom McLane come in, he designed it,
- 2 if you would like to see it.
- 3 MS. EVANS: Well, I think --
- 4 MS. GATELLI: We can do that, too.
- 5 MS. EVANS: I think --
- 6 MS. GATELLI: He will probably do
- 7 the specs and put it out to bid. That might
- 8 be a good idea.
- 9 MS. EVANS: I'm just curious about
- 10 the costs because I know from several
- 11 residents who contacted me who have
- 12 performed their own research on the Internet
- 13 they are saying that costs for similar dog
- 14 parks seem to be coming in at approximately
- 15 \$100,000, so that's why I'm looking for
- 16 exactly, you know, where that is coming

- 17 from.
- 18 Because of the cost discrepancy for
- 19 the beautiful tree house reported by
- 20 Mr. Scopelliti for \$300,000 and a local
- 21 television news station for \$650,000 I move
- 22 that the Parks and Recreation director
- 23 provide a cost breakdown in total for this
- 24 project since several citizens asked me to
- 25 do so.

•

- 1 MR. COURTRIGHT: Second.
- 2 MS. GATELLI: On the question? All
- 3 in favor?
- 4 MS. EVANS: Aye.
- 5 MS. FANUCCI: Aye.
- 6 MR. MCGOFF: Aye.
- 7 MR. COURTRIGHT: Aye.
- 8 MS. GATELLI: Aye. Opposed? The
- 9 ayes have it and so moved.
- 10 MS. EVANS: I further move that the
- 11 city -- the Office of City Controller
- 12 provide invoices for all capital projects
- 13 from 2002 through 2007.

- 14 MR. COURTRIGHT: I'm sorry, can you
- 15 repeat the motion, I was writing. I don't
- 16 want to second something I didn't hear.
- 17 MS. EVANS: I move that the Office
- 18 of the City Controller provide invoices for
- 19 all capital projects for 2002 through 2007.
- 20 MR. COURTRIGHT: I'll second the
- 21 motion, but could I -- I'll wait for on the
- 22 question.
- 23 MS. GATELLI: On the question?
- 24 MR. COURTRIGHT: On the question, I
- 25 think some of the information we have asked

- 1 for in the recent past Mrs. Novembrino, and
- 2 I'm not going to speak for Mrs. Novembrino,
- 3 but feels that it's available to us and we
- 4 didn't need to go at it as far as a motion,
- 5 so I don't know if this is one of those
- 6 items or not.
- 7 MS. FANUCCI: It is.
- 8 MS. EVANS: If I might jump in, I'm
- 9 looking for information with regard to the
- 10 capital budget and we all know the capital

- 11 budget is very minute document that in no
- 12 way explains or itemizes according to the
- 13 requirements of the Home Rule Charter, so
- 14 I'm simply trying to get the specifics of
- 15 the general statements made within that
- 16 budget.
- 17 MR. COURTRIGHT: Okay. I just
- 18 didn't know if this would all fall under one
- 19 of things that she thinks are already
- 20 supplied to us and we can easily go over and
- 21 pick up. I don't want to put any undue
- 22 burden on her, but I'll second that.
- 23 MS. GATELLI: Anyone else on the
- 24 question?
- 25 MR. MCGOFF: Why back to 2002?

- 1 MS. EVANS: Because there has been no
- 2 real explanation all these years. It's been
- 3 a five-year plan, a capital budget covers a
- 4 five-year span, a new one, in fact, should
- 5 be in the process of development as we
- 6 speak, but even with regard to the prior
- 7 plan there were no annual updates explaining

- 8 the dollar figures provided in every
- 9 category and according to the Home Rule
- 10 Charter the administration is to provide
- 11 that information, nevertheless, they have
- 12 failed to do so throughout the years and as
- 13 a result city council has not passed the
- 14 capital budget in at least the last two
- 15 years. Unfortunately, even without approval
- 16 of city council the capital budget
- 17 automatically passes.
- 18 MS. GATELLI: Anyone else? All in
- 19 favor?
- 20 MS. EVANS: Aye.
- 21 MS. FANUCCI: Aye.
- 22 MR. MCGOFF: Aye.
- 23 MR. COURTRIGHT: Aye.
- 24 MS. GATELLI: Aye. Opposed? The
- 25 ayes have it and so moved.

- 1 MS. EVANS: Next, I did receive a
- 2 response from Mrs. Novembrino, city
- 3 controller, regarding consultant invoices,
- 4 however, I received but few because the

5 remainder are in storage. I would like a

6 letter sent to Mrs. Novembrino requesting

7 that the Controller's Office locate all

8 consultant invoices dating back to January

9 2002, as per council's motion.

10 I also have citizen's request for

11 the week. 1326 Penn Avenue, cut high grass

12 and clear this vacant city-owned lot. A

13 letter to Mr. Brazil, Director of Parks and

14 Recreation, please purchase a new flag for

15 the large flag pole just beyond the Everhart

16 Museum. The current flag is noticeably torn

17 and ragged in appearance. Replace this as

18 soon as possible since Veterans reported

19 this substandard display, in fact, this past

20 Memorial Day, Monday.

21 Also, citizens have requested that

22 no dogs should be allowed in the new tree

23 house. Problems have already occurred for

24 several visitors.

25 1101 Cedar Avenue remains an eyesore

24

1 for the surrounding area. Residents wish to

- 2 know when this property will be addressed.
- 3 Please provide a written response on or
- 4 before June 6.
- 5 Residents of south side request a
- 6 clean-up of Connell Park for use by children
- 7 in summer. They ask that perhaps the junior
- 8 council would address this problem as they
- 9 have demonstrated such fine work at the
- 10 Doherty Street playground.
- 11 A memo to Mr. Parker, when is the
- 12 street sweeper scheduled for street cleaning
- 13 in the plot section of Scranton.
- 14 A letter to Chief Elliott, was a
- 15 study or observation conducted of the
- 16 speeding and failure to obey a stop sign at
- 17 the intersection of 16th Avenue and Division
- 18 Street. Neighbors continue to report these
- 19 hazardous conditions and fear for the safety
- 20 of children playing in the vicinity.
- 21 A letter over to Mr. Setizinger
- 22 regarding 2931 Birney Avenue. This house
- 23 was scheduled for demolition by the owner in
- 24 September 2006. The plywood has been torn
- 25 down and neighbors report that people are

- 1 observed frequently entering and existing
- 2 the structure.
- 3 Also, south side residents report
- 4 abandoned vehicles in their area. They have
- 5 asked if an inspector is assigned to south
- 6 side.
- 7 To my friend with the tax refund
- 8 problem, I will visit the tax office in
- 9 person for you and report the results.
- 10 One more thing, I would ask that a
- 11 letter be sent to Chief Elliott regarding
- 12 illegal parking and traffic enforcement
- 13 thereof on Dickson Avenue and he, once
- 14 again, responded promptly. He sent out a
- 15 directive to Captain Carl Graziano stating,
- 16 "I have recently received complaints of
- 17 illegal parking on sidewalks and truck
- 18 traffic exceeding the speed limits in the
- 19 area of Dickson Avenue. Please have the
- 20 patrol officers pay special attention to
- 21 this area and enforce any and all
- 22 violations. Please let me know the results

- 23 of this investigation."
- 24 So, I thank Chief Elliott for his
- 25 timely attention to that matter, and that's

•

- 1 it.
- 2 MS. GATELLI: Thank you. Mrs.
- 3 Fanucci?
- 4 MR. FANUCCI: Let me see if Mr. Quinn
- 5 is here. Last week Mr. Ozzie Quinn got up
- 6 and had a suggestion about rehabbing median
- 7 homes and helping people who are having
- 8 trouble getting loans within the city. What
- 9 I did was I checked on that and it seems
- 10 like OECD will not approve of any projects
- 11 that do not go to moderate or low income.
- 12 There is nothing for anyone else. That is
- 13 the only -- their only requirement and that
- 14 is their only specification for any of their
- 15 projects for moderate to low income people.
- 16 So, unfortunately, that is not something
- 17 that they can do within the city.
- 18 Also, we tonight had -- or today
- 19 during the day at 3:00 the representatives

- 20 Mr. Shimkus, Mr. Smith, and I believe three
- 21 others came in and spoke about the
- 22 nonsmoking ordinances that they are thinking
- 23 about enacting for the State of
- 24 Pennsylvania. They had the Department --
- 25 the head of the Department of Health came

- 1 and a lot of the same people, the students
- 2 and others, came into testify and I have to
- 3 say that the meeting I thought went very,
- 4 very well, unfortunately, I couldn't stay
- 5 for the whole entire thing, but it went very
- 6 well and it seems that this is definitely
- 7 something that they are on and hopefully
- 8 will pass within, you know, the near future,
- 9 I have to say. And we are very -- they did
- 10 praise us actually for being courageous
- 11 enough to step up and to do what we are
- 12 doing in the City of Scranton. They also
- 13 placed the high school students who were
- 14 very instrumental in bringing this stuff
- 15 forward and making sure that we knew exactly
- 16 what their reasoning was.

- 17 I have to say I got lots of phone
- 18 calls this week from people in businesses
- 19 who are still keeping nonsmoking within the
- 20 business and I thank you for that and thank
- 21 you for sticking with clean air, and that is
- 22 all I have. I just wanted to say thank you.
- 23 MS. GATELLI: Thank you.
- 24 Mr. McGoff?
- 25 MR. MCGOFF: Nothing. Thank you.

- 1 MS. GATELLI: Mr. Courtright?
- 2 MR. COURTRIGHT: Yes. Kay, I know we

6 MS. EVANS: Mrs. Gatelli, before you

7 take the proper steps to move that along,

8 I'd like to make a motion to table 4-C.

9 Since we last met I believe each of us

10 received written communication from another

11 company, Expand. If I can have a moment

12 here, I believe it's in the best interest of

13 the taxpayers of Scranton to ensure that

14 this transaction or such contract would be

15 put out to bid. It's my full understanding

16 that this contract had never been put out to

17 bid but rather was hand selected by the

18 mayor and it is very possible that through

19 the bidding process the taxpayers of

20 Scranton could realize an even greater sum

21 of money for the sale of our tax

22 delinquencies and I'd just like to read the

23 letter that we received from Expand: "In

24 late April of I was alerted to a newspaper

25 article outlining the proposal to sell

1 Scranton real property taxes.

- 2 "Expand, a part of the respected
- 3 investment banking firm Baer-Sterns, is the
- 4 nations preeminent tax lien purchaser and
- 5 servicer. We would welcome the opportunity
- 6 to show you how much our company would be
- 7 willing to pay for Scranton's delinquent
- 8 property taxes. Expand hopes that Scranton
- 9 will consider soliciting competing bids for
- 10 the purchase of it's delinquencies. The
- 11 competitive bidding process encourages
- 12 potential purchasers to aggressively price
- 13 the city's delinquencies and, consequently,
- 14 helps ensure that Scranton will generate the
- 15 maximum revenue benefit from such a
- 16 transaction. Other municipalities in
- 17 Pennsylvania have solicited competing bids
- 18 for their property tax delinquencies and
- 19 there is a market of qualified purchasers.
- 20 Our Pennsylvania clients include the City of
- 21 Erie, the City of Chester, Montgomery County
- 22 and several school districts," and it is
- 23 signed Charles R. Smith.
- 24 And I believe, as I said a moment
- 25 ago, it is in the best interest of the city

1 and the people of this city that this

2 contract be put out to bid.

3 MR. COURTRIGHT: I'll second that,

4 but I want to speak on the question.

5 MS. GATELLI: On the question.

6 MR. COURTRIGHT: I'd like to say

7 this, I understand not everything,

8 especially professional services need to be

9 put out to bid, but I think in this

10 particular case that it if we got a recent

11 RFP I'm sure there are several companies

12 that would like to, you know, put their name

13 in for this. It's probably lucrative for

14 them and maybe, just maybe, we can get a

15 little bit more money for the city, and I

16 think we all know we need it. So, I would

17 like to see at least a RFP process. I agree

18 to a certain extent with the selling of them

19 because we are going to get the money up

20 front and we certainly need it, but, you

21 know, I hate to use the term best bang for

22 our buck, I use that a lot here, but I think

- 23 it's that's what we need, so I'll second
- 24 that motion.
- 25 MS. GATELLI: Anyone else on the

- 1 question.
- 2 MS. EVANS: Yes, in terms of added
- 3 justification the sale to MRS will leave
- 4 a -- well, actually, an over \$900,000 gap in
- 5 the operating budget expenditures. I
- 6 believe by putting this out to bid we can
- 7 well makeup part of that loss, if not all of
- 8 that loss. If you recall 3.6 million was
- 9 plugged in as revenue in 2007 from this sale
- 10 and now we learn that in actuality what will
- 11 come into this city is closer to 2.7
- 12 million.
- 13 MR. MCGOFF: Do we jeopardize losing
- 14 the opportunity to gain this revenue by
- 15 prolonging this process? We can put this
- 16 out to bid and by the time we would vote on
- 17 this and approve a company for the sale of
- 18 these tax liens do we jeopardize losing the
- 19 revenue for 2007?

- 20 MS. EVANS: Well, it appears that at
- 21 least from the caucus we had with MRS they
- 22 were arranging, for example, a contract that
- 23 would have begun or they were going to back
- 24 date it to February 2007 through February
- 25 2008 at which time the contract would be

•

- 1 considered for renewal, so I would imagine
- 2 that any firm, any reputable firm can
- 3 certainly do the same thing, or begin the
- 4 process at such time as the contract is
- 5 signed, which I'm sure will be within 2007.
- 6 MS. FANUCCI: Attorney Minora, is
- 7 there anything in the legislation saying
- 8 time constraints? Are we under any time --
- 9 MR. MINORA: I hadn't read it to look
- 10 for that particular thing and it was just
- 11 raised I opened it up to look at it and see
- 12 what the term of it is and without some time
- 13 to review it I don't think I can answer that
- 14 right off the bat.
- 15 MR. COURTRIGHT: Mrs. Gatelli, can I
- 16 say one thing more?

17 MS. GATELLI: Sure.

18 MR. COURTRIGHT: This particular

19 piece of legislation because I didn't

20 believe I was up to speed on it, I went and

21 I sought out somebody that's involved and

22 has been involved in this type of

23 transaction before and he thought it was a

24 good deal for the city because I questioned,

25 you know, could we have done this in-house

•

1 and should we have been doing this in-house,

2 three years gone by, and maybe we should

3 have but we didn't, so now we are at the

4 point where we are and his recommendation to

5 me, and he had no stake in this one way or

6 the other and that's why I sought him out,

7 he felt it would be good deal for the city

8 and also a good deal for the company. He

9 said if he had a company of this nature he

10 would really like to get these contract and

11 that's why I think, you know, an RFP, if not

12 we'll bid. If there's an RFP I think that

13 can move along really quick. I certainly

14 don't want to loose it. There is going to a

15 gap. I mean, there is a gap anyway even if

16 we sold. It's 2.8 and it was a budgeted at

17 3.2, is that?

18 MS. EVANS: It's budgeted at 3.6

19 and--

20 MR. COURTRIGHT: 3.6.

21 MS. EVANS: And after all of the

22 costs involved we are going to bring in 2.7.

23 MR. COURTRIGHT: So there is going to

24 be a little built of a short fall and --

25 MS. EVANS: Well, it's almost a

1 million dollar shortfall.

2 MR. COURTRIGHT: I'm trying to be

3 kind.

4 MS. FANUCCI: We are going to incur

5 those costs regardless, I think, no matter

6 who is representing us and my theory is that

7 the reason that this firm was chosen was

8 because they represented the Scranton School

9 District and they did a wonderful job and

10 they were extremely happy with the progress

- 11 that they made over there and what their
- 12 return was, so I don't feel that we will be
- 13 getting a bad deal.
- 14 MR. COURTRIGHT: I don't question
- 15 that they are a good company, I don't
- 16 question that at all because I did speak
- 17 with some school directors and --
- 18 MS. FANUCCI: Yeah, they were
- 19 thrilled.
- 20 MR. COURTRIGHT: -- and they were
- 21 very happy with the company. I'm just
- 22 thinking if there is another company out
- 23 there that's just as reputable that's
- 24 willing to give us more money, let's take
- 25 it. You know, I have nothing against this

- 1 company, I have only met those gentlemen
- 2 that night they were here, I'm just looking
- 3 to try to get the most money for this city
- 4 that we could.
- 5 MS. EVANS: And, if I might add, I
- 6 had read the Erie newspaper, it was not the
- 7 Scranton School District actually who

- 8 recommended MRS to Mayor Doherty, rather
- 9 Mayor Doherty was visiting Erie and Mayor
- 10 Doherty struck this deal himself with this
- 11 company and the article indicated, as did
- 12 the Scranton Times, that this was never put
- 13 out for bid.
- 14 MS. FANUCCI: I thought that those
- 15 people wrote a letter representing Erie?
- 16 MS. EVANS: No, they don't -- I asked
- 17 them that evening, "Do you represent the
- 18 city in which your headquarters are
- 19 located," and their answer was, "No."
- 20 It appears that Expand represents
- 21 their city.
- 22 MS. GATELLI: Anyone else on the
- 23 question? The motion is to table 4-C and
- 24 5-A; correct?
- 25 MR. COURTRIGHT: No, just 4-C. It

- 1 would actually make 5-A moot if we table
- 2 4-C.
- 3 MS. FANUCCI: No, the problem --
- 4 regardless of whether or not we --

5 MR. MINORA: The motion is just for

6 4-c.

7 MS. FANUCCI: But, regardless of

8 whether or not we go with the legislation we

9 still are going to need to have our --

10 MS. GATELLI: Fees in place.

11 MS. FANUCCI: Fees in place and still

12 be able to pursue what we are pursuing which

13 is to be able to put the loans on the

14 properties and be able to do that. That

15 is more imperative now than anything, that

16 we have our legislation in place so we can

17 do our jobs in the city. You know, we

18 cannot put these liens on these properties

19 if we do not agree to the legislation for

20 them to do it, so that is definitely going

21 to be a problem.

13 DELINQUENT REAL ESTATE TAXES.

14 MS. GATELLI: You have heard Reading

15 by Title of Item 5-A, what is your pleasure?

16 MR. MCGOFF: I move that Item 5-A

17 pass Reading by Title.

18 MS. FANUCCI: Second.

19 MS. GATELLI: On the question?

20 MS. EVANS: I believe that a portion

21 of what this legislation contains is already

22 pursued and required by law. Beyond that, I

23 believe that it inflicts Draconian measures

24 on delinquent taxpayers and I would believe

25 the object is to collect the delinquent tax,

- 1 not to triple the amount such that the
- 2 delinquent taxpayer will never have the
- 3 ability to pay that tax and will wind up
- 4 losing his or her home.
- 5 MS. GATELLI: Anyone else on the
- 6 question?
- 7 MR. COURTRIGHT: Yes, Mrs. Gatelli.
- 8 Several weeks back I know we spoke about
- 9 this in caucus and Mr. Minora give us his
- 10 explanation and then tonight at the caucus I
- 11 found out about a different explanation, I'm
- 12 not voting for it this week anyway because
- 13 I'm just not comfortable. I'm just not
- 14 comfortable that I understand and then
- 15 that's my fault and I apologize, but before
- 16 I vote, yes, for this I want to be
- 17 comfortable, so I'm going to sit down one on
- 18 one and speak with Mr. Minora and this week
- 19 and see if he can't make me more comfortable
- 20 with it. I think I understand what he was
- 21 trying to tell me in caucus there, but I'm
- 22 fearful that possibly what Mrs. Evans just

- 23 said could be true, and if that is true then
- 24 I would vote, no. If what he explains to me
- 25 contradicts then I will vote in the

- 1 affirmative, but I -- just I'm just not
- 2 comfortable voting, yes, at this time.
- 3 MS. GATELLI: From what I understand
- 4 the fees will be going to the city.
- 5 MR. COURTRIGHT: Right, I understand
- 6 that.
- 7 MS. GATELLI: Go ahead, Mr. McGoff?
- 8 MR. MCGOFF: I was going to say the
- 9 same thing, these are not fees that are
- 10 being taken by the collection agency, these
- 11 are fees that will be incurred by the city
- 12 and placing the liens against property and
- 13 not every -- not every one of these would be
- 14 assessed, it is a progressive policy that
- 15 when one stage is not met then it proceeds
- 16 to the next stage and so that not every one
- 17 of these fees would be incurred by everyone
- 18 who was delinquent on their taxes. In fact,
- 19 it would probably be a very, very rare

- 20 occasion that all of these fees would be
- 21 assessed to anyone. It is my understanding
- 22 that in most cases the fees rarely go beyond
- 23 the first stage, and with that said, I think
- 24 that we need to place fees on the delinquent
- 25 taxpayers because by not doing that I think

- 1 we place a greater burden on the taxpayer,
- 2 on the person who does pay their taxes, a
- 3 person that pays their taxes is now paying
- 4 for not only themselves, but they are paying
- 5 an additional tax for the people who won't
- 6 pay and without any means of forcing them to
- 7 pay taxes, pay their delinquent taxes, they
- 8 may not and so I feel that these are
- 9 justifiable and I would vote, yes.
- 10 MS. GATELLI: Anyone else on the
- 11 question?
- 12 MS. EVANS: Yes. I would ask council
- 13 to keep in mind that with regard to
- 14 delinquent tax collection a fee of
- 15 25 percent is already attached above and
- 16 beyond the delinquency. That, of course,

17 goes to NCC not to the city and I in no way
18 wish to suggest that I'm opposed to the
19 collection of delinquencies, however, I do
20 know when I believe it was approximately 27
21 additional costs, fines, penalties and fees
22 are attached to a delinquency it's going to
23 make it virtually impossible to collect your
24 delinquent tax. Now, that can place a
25 greater burden on the taxpayer. At the same

44

1 time, however, you are going to have a home
2 then, one that a family previously lived in.
3 I don't see, frankly, that we have a great
4 influx of people moving into the City of
5 Scranton particularly since we have such
6 oppressive taxes. Whether we are talking
7 about the wage tax, the increases in the
8 school district taxes, the increase levied
9 by the City of Scranton, the Lackawanna
10 County tax increase, people generally are
11 not fighting and screaming to move into this
12 city at this point in time because we don't
13 have a handle on our taxes. So what happens

14 to property then, more blighted property,

15 more of the value of our homes plummeting.

16 I think the wise thing is certainly, and we

17 would all agree to this, is to collect the

18 delinquency, but let's make it possible to

19 collect the delinquency.

20 MS. FANUCCI: All of those fees are

21 not imposed on every delinquent tax. It's

22 not part of the system. It is there for

23 backup just in case. One thing is to place

24 a lien, if that does not work the others are

25 there, so there is not 30 separate issues

45

1 that are placed on every lien and every

2 home. And, also, maybe possibly it will

3 bring someone in who maybe willing to pay

4 the taxes. A lot of our problem, too, is we

5 have wonderful taxpaying citizens and also

6 we have a lot of absentee landlords and

7 other people who are not paying their share

8 in this city and that is a major problem for

9 us. The absentee landlord is a huge problem

10 for the citizens.

- 11 Now, do I feel that we should not
- 12 collect taxes from them? No. I think we
- 13 need to do whatever we need to do to get the
- 14 money this is owed to us in the city. Now,
- 15 whether or not it's a friendly or a
- 16 political good move or not doesn't matter.
- 17 We need to get the money that is owed to us
- 18 and maybe we wouldn't have to tax the rest
- 19 of the citizens so much if everyone was
- 20 paying their share in the city. So that's
- 21 my feeling.
- 22 MS. EVANS: And I'm very glad that
- 23 you did bring up absentee landlords because
- 24 I do notice that they are, indeed, the
- 25 individuals who are purchasing the

- 1 properties within this city, but I think it
- 2 would be advantageous for the city to pursue
- 3 the individuals who have for whatever reason
- 4 gotten away without paying taxes for a long,
- 5 long, long time because of whom they are and
- 6 we all know that this goes on and we all
- 7 know there are people in Scranton with two

8 addresses, one here and one out of town and

9 I don't see -- I also know of wealthy

10 business owners who haven't made payments to

11 the city in quite a long time and yet I

12 don't see the administration pursuing them

13 either yet we are very, very willing here to

14 take the little guy and hold him over the

15 fire. I just want his taxes, I don't want

16 to burn him at the stake.

17 MS. GATELLI: Anyone else on the

18 question?

19 MR. MCGOFF: Two last things:

20 First, many of these fees are things that

21 are already set and that the cost is

22 incurred by the city and so going through

23 the process of trying to collect those taxes

24 is costing the city money. What this is

25 doing is turning that cost back to the

. _

47

1 person that owes the taxes.

2 Second, I don't think that without

3 some type of punitive system that people

4 will be encouraged that those who are, let's

5 say, reluctant to pay their taxes will

6 continue to be reluctant if there is no

7 punitive measures to force them to pay.

8 MS. EVANS: The 25 percent is not

9 punitive?

10 MR. MCGOFF: Yes, it is and the more

11 punitive --

12 (Whereupon comments were made from

13 the audience.)

14 MS. GATELLI: Excuse me.

15 MS. EVANS: I agree with you, there

16 are many parts of this that are a natural

17 part of this process that council, frankly,

18 doesn't even need to consider, but what goes

19 above and beyond here I think is going to

20 cause more people to lose their homes than

21 it's going to cause people to be able to pay

22 their delinquencies.

23 MS. FANUCCI: They didn't lose

24 anything when the school board did this

 $25\ process.$ Nobody left, packed up and left

1 town because the school board was placing

- 2 liens and they had placed liens, also.
- 3 MS. EVANS: The school board cannot
- 4 place liens against a property.
- 5 MS. FANUCCI: You had to have a
- 6 personal guarantee, the same thing as an
- 7 EOCD loan to personally guarantee or
- 8 whatever it was that they were -- but it was
- 9 the same amount of money. People didn't
- 10 just pack up and leave. It's a process and
- 11 I do believe that the taxpayers deserve to
- 12 know that we are here and making sure that
- 13 we are not only watching and being the guard
- 14 dog, but a lot of times when you are the
- 15 guard dog you are barking at everyone who
- 16 comes down the street it doesn't matter if
- 17 they are good or bad, you are so busy
- 18 barking you are not seeing a good thing and
- 19 I believe that the money that we can get
- 20 from the taxes that are owed to us is a good
- 21 thing and regardless of who or what we need
- 22 the money. It is our money that's owed to
- 23 us. This is not looking for extortion.
- 24 This is money of people choosing not to pay.

- 22 the sale of the loans. What is this SRA
- 23 thing? It's just something for the minutes,
- 24 the Doherty administration to not live up to
- 25 the responsibilities that he is supposed to

- 2 those stupid board members are gulping it
- 3 up, they are captive, and I hate to see
- 4 people who are captive.
