- 1 freedom. He happens to be the son of a
- 2 friend of mine who I worked with as a nurse
- 3 at Moses Taylor Hospital. She still works
- 4 at Moses Taylor and I have spoken to her and
- 5 I told her that I was going to announce
- 6 tonight where to send any money that you
- 7 would like to commemorate in her son's name
- 8 to her grandson's fund, who his name is
- 9 Jakub, J-A-K-U-B, Prorock, and they are
- 10 accepting donations to the Jakub Fund, PNC
- 11 Bank, 533 Main Street, Peckville, PA, 18452,
- 12 and I would just like to say that this
- 13 council is very, very proud of Jan Argonish,
- 14 very proud of him for defending us and his
- 15 country and his mom told me that he believed
- 16 in the war, he really believed that they
- 17 were there and having an impact and doing
- 18 the right thing, so that made me feel
- 19 better, not too much better because I don't

20 think the war is necessary, that's only my

21 personal opinion, but I think that we should

22 honor Jan for dying for his country, a nice

23 young man and left a grandson, so let's just

2 MS. GATELLI: Thank you. Just one

3 more thing, it has come to my attention

4 there are several times in the past year

5 that the zoning board has voted against a

6 particular project and it seems that when

7 the people appeal the project it goes down

8 to the courthouse and a judge hears the case

9 and sometimes the case is overturned, and I

10 have heard that sometimes they are

11 overturning the cases because no one came to

12 the zoning board to object even though maybe

13 it was wrong and the zoning board absolutely

14 did the correct thing, they are taking it, I

15 don't know if they are doing it legally, you

16 know, on legal issues or hardship issues,

17 but I am continuing to get complaints about

18 one specific case and I have gone there and

19 the place is a mess. The neighbors are

20 complaining and I just would like to see if

21 we can't send a letter to the judge, I think

22 the President judge is Chester Harhut, on

23 behalf of council if everyone would agree.

24 I don't find it necessary that we do a

25 motion, but if everyone would agree that

2 zoning board is appointed by council, they

3 do represent the people, I think that they

4 are all doing a fine job on the zoning

5 board, I think it's one of the best zoning

6 boards we have had in years. Illegal

7 apartment conversions aren't happening

8 anymore and illegal businesses, and I think

9 that it hurts them and it hurts their cause

10 when right down the street they are being

11 overturned.

12 So I would like you to send that

13 letter, Kay, and if they want to meet with

14 us that would be fine. Maybe there are
15 reasons that this is happening, but then
16 it's coming back to council and we are
17 getting the complaints about the properties,
18 so I would also like to make the judges
19 aware of that, that it's not going away and
20 we are continuing to get the complaints, so
21 I just want to have that on. Does anyone
22 else have any announcements? Mr. McGoff?
23 MR. MCGOFF: I would just like to
24 commend the county commissioners on the
25 ceremony that was conducted this morning at .

- 1 McDade Park as a memorial ceremony for 9/11.
- 2 It was well attended by members of the fire

- 3 and police departments of Scranton and local
- 4 communities. A number of elected officials
- 5 were also present. The ceremony was
- 6 conducted by Mr. Charles Spano and I think
- 7 the most moving part of the commemoration
- 8 was the bell ceremony, the traditional
- 9 firemen's bell ceremony that was conducted
- 10 by the, and I hope I get the title, it was

- 11 conducted by lieutenant Dave Gervasi of the
- 12 Scranton Fire Department, and the
- 13 commemoration was very nice even though it
- 14 was in a driving rainstorm, but they had
- 15 planted two trees that are to symbolize,
- 16 they had been planted last year I believe,
- 17 to symbolize the twin tours and the wreath
- 18 was going to be placed there to commemorate
- 19 another year of the anniversary of 9/11.
- 20 That's all.

- 3 our city fire department and some of our
- 4 police officers our involved in this, it is
- 5 truly a lovely ceremony, and I'm very sorry
- 6 to miss it tonight, but I'm hoping that many
- 7 of our citizens not only from Scranton but

- 8 all surrounding areas would attend this
- 9 lovely memorial service.
- 10 MS. GATELLI: Anything else? Thank
- 11 you for being so kind while we made our
- 12 announcements. The agenda items is Giovanni
- 13 Piccolino.
- 14 MR. PICCOLINO: Good evening, city
- 15 council, and fellow Scrantonians, my name is
- 16 Giovanni Piccolino, and I'm a partner in
- 17 Buono Pizza, Incorporated, located 504
- 18 Lackawanna Avenue and here we go again with
- 19 "Q" here. They are asking for you guys to
- 20 pass some legislation about it, and
- 21 excluding us and Coney Island, two
- 22 businesses well over 100 years combined
- 23 together, and both of us have tried time and
- 24 time again to be included in this and,
- 25 again, we are excluded and I just don't

- 1 understand it. They are actually in the
- 2 thought process of wanting to put sidewalks
- 3 starting past 504 and 506 Lackawanna Avenue,
- 4 so the beginning of the block will have the

5 old sidewalks and then all the way until the

6 end until Coney Island will have new ones,

7 then at Coney Island there will be old

8 sidewalks, so what I'm saying to you what

9 about safety concerns of the citizens with

10 like lopsided sidewalks here, we're going to

11 have old ones, new ones, old ones and they

12 constantly, constantly exclude us.

13 I'm still actually waiting for that

14 letter that Doherty supposedly sent us

15 months and months ago about being included

16 in this, and I just don't get it. I think,

17 Stacy, you wrote that article, I don't know,

18 did you get a letter? We didn't and our

19 attorney didn't and this is ridiculous now.

20 These are two businesses, we have been here

21 forever and it's constantly, constantly

22 being excluded and, you know, the whole

23 times you guys have been saying you'll take

24 our side and I hope when this comes up that

25 you won't pass it. Thank you very much.

1 MS. GATELLI: Thank you. Andy

- 2 Sbaraglia
- 3 MR. SBARAGLIA: Andy Sbaraglia,
- 4 citizen of Scranton, taxpayer. Fellow
- 5 Scrantonians, a little play on words here,
- 6 on 5-R, approving Section 147 (F) of the
- 7 Internal Revenue Code, as so on and so
- 8 forth, it is desired for the health, safety
- 9 and welfare of the people of the City of
- 10 Scranton-Lackawanna Health and Welfare
- 11 Authority to undertake a project for the
- 12 attorney to undertake a projects for the
- 13 University of Scranton. They are building a
- 14 dorm, okay? How you can classify that under
- 15 that article is beyond me. You would be
- 16 better off building neighborhoods for the 30
- 17 million then the University to build them a
- 18 dorm, but they are not. You are not really
- 19 building them a dorm, all you are doing is
- 20 being a conduit for the money, but it's
- 21 where the conduit is coming from. It
- 22 shouldn't be from there. It should have
- 23 been some kind of an industrial because
- 24 that's exactly what it is. They have
- 25 nothing to do with the health and welfare of

- 1 the City of Scranton.
- 2 Okay, let's go down to "T", okay
- 3 5-T, this project to fix up this building.
- 4 Okay, we are going to give them \$250,000
- 5 bucks to lend them, okay, they are going to
- 6 hire eight people, but only four has to be
- 7 low and medium income, that means the other
- 8 four could be the top in the world. Why
- 9 somebody would lend that kind of money for
- 10 only -- for a low and moderate income and
- 11 leave the other people come from wherever
- 12 class they come from or the income they did,
- 13 in other words, the bosses are going to be
- 14 making money and the peons are going to be
- 15 the peons.
- 16 MS. FANUCCI: Andy, actually we are
- 17 going to table that tonight because they
- 18 have changed some of the wordage and some of
- 19 the legislation, so it could be there are
- 20 more people coming and, again, so, that
- 21 won't be on the agenda tonight, I'm just --
- 22 MR. SBARAGLIA: Well, if it's not

- 23 going to be there then I can always speak on
- 24 it later.
- 25 MS. GATELLI: Thank you. Ozzie

- 1 Quinn.
- 2 MR. QUINN: Ozzie Quinn, President of
- 3 the Scranton and Lackawanna County
- 4 Taxpayers' Association, Incorporated. I
- 5 want to on the agenda there is an
- 6 introduction of an ordinance approving
- 7 accepting the City of Scranton's capital
- 8 budget for the Year 2008, Section 20.904.
- 9 You can't really approve that because there
- 10 has to be a public hearing.
- 11 MS. GATELLI: We are going to
- 12 schedule that tonight.
- 13 MR. QUINN: So, I'm just wondering
- 14 about that. The other thing is on 5-C, an
- 15 introduction for an ordinance authorizing a
- 16 parcel of land to be acquired and sold which
- 17 is part of the flood project. When I worked
- 18 on the flood project for Nay Aug Avenue the
- 19 PEMA told us that that land had to remain

- 20 vacant in continuity. I feel bad for the
- 21 Garden Path, but I would look into that
- 22 because you might be just transferring land
- 23 that can't be transferred according to the
- 24 regulations of FEMA.
- 25 And, again, and I have nothing

- 1 against the people who are buying this land,
- 2 but you have introductions of several sale
- 3 of properties, are these properties through
- 4 Act -- through the Vacant Property View
- 5 Committee or are they through the Pittsburgh
- 6 Plan, were they advertised and what is going
- 7 to go on these lots, do you have any idea
- 8 about that? Before you introduce something
- 9 you should really know that stuff.
- 10 MS. GATELLI: No, but they're
- 11 purchasing the property and it's been
- 12 appraised.
- 13 MR. QUINN: That doesn't mean
- 14 anything. You should know what's going on
- 15 there.
- 16 MS. GATELLI: No, we understand --

17 MR. QUINN: If she is commenting I

18 don't want to lose my time.

19 MS. GATELLI: All right, I won't

20 comment.

21 MR. QUINN: I'm just saying we should

22 know what's going on here before you go

23 introducing this because once it's

24 introduced it's gone and I have nothing

25 against the people. Do it right.

1 The other one is the resolution for

2 the loan as Andy just spoke about. What's

3 the use of that land? What's the use of

4 that money?

5 MS. GATELLI: Thank you. Les

6 Spindler.

7 MR. SPINDLER: Good evening,

8 Council, Les Spindler, city resident. I

9 also want to talk about 5-R, the University

10 wants to borrow \$30 million. Mayor Doherty

11 said in the paper that the city is not

12 liable for that. Well, why does it have to

13 go through city council? Can someone answer

14 that question?

15 MS. EVANS: It's part of the IRS

16 regulations. It's a mere formality.

17 MR. SPINDLER: It doesn't smell

18 right, I smell a rat. Why don't they go

19 through a bank like any other person would

20 do. If the city is not liable why does it

21 have to go through city council? That's all

22 I have. Thank you.

23 MS. GATELLI: Mr. McCloe.

24 MR. MCCLOE: I'm sorry, I'm going to

25 pass on this one. Thank you.

1 MS. GATELLI: Mrs. Shumaker.

2 MS. SHUMAKER: Good evening and

3 welcome back from your six-week vacation.

4 First, I'd like to request you table the

5 capital budget until the caucus has been

6 held with the mayor and the business

7 administrator so they may answer questions

8 among which are: One, where are the

9 following missing projects. The police

10 headquarters lot paving. Only the binder

- 11 was in the construction contract. The
- 12 finishing layer was left out so the money
- 13 could be put into the building. I seriously
- 14 doubt that the binder will not deteriorate
- 15 after seven years and certainly that
- 16 finishing coat should be in the capital
- 17 budget.
- 18 Robinson Park, any Scranton little
- 19 league improvements where the mayor promised
- 20 to invest about a quarter of a million
- 21 dollars from the 72 million dollar bond
- 22 issue in his first term. Shingles are
- 23 missing from the building at Robinson Park,
- 24 nothing in the budget.
- 25 The light at softball field to

- 1 replace the Schmidt Field, where is that?
- 2 The Nay Aug greenhouse that OECD told
- 3 HUD had been restored, where is that? Nay
- 4 Aug playground area for the handicap that
- 5 held up the junior council's swing set,
- 6 where is that? The Nay Aug pool house
- 7 improvements, where are they?

- 8 The East Elm storm water project
- 9 between Derby and Blucher Avenue that the
- 10 mayor promised prior to the 2005 election.
- 11 Where is that?
- 12 Funding for the out years also
- 13 depends appears dependent on more long-term
- 14 debt, 16 1/3 million dollars planned for
- 15 2009. Can we really afford that much more
- 16 debt?
- 17 Three, what is the justification for
- 18 the acquisition of new property and
- 19 construction of the new library?
- 20 And then on F-E and F, I think
- 21 parking meters have been placed at hospitals
- 22 so I believe it is excessive to give the
- 23 University no parking for two blocks on
- 24 Mulberry Street. Thank you.
- 25 MS. GATELLI: Anyone else care to

- 1 speak on agenda items? Mr. Morgan?
- 2 MR. MORGAN: My question is rather
- 3 brief here today and I would like council to
- 4 explain 5-T, what kind of corporations, what

- 5 kind of corporation this is and what
- 6 benefits this has for the city, and the
- 7 other thing I had is, you know, I really
- 8 would like to agree with Marie because she
- 9 is right on the money and the tax group is
- 10 really informed and we are really troubled
- 11 by the legislation that this council is
- 12 trying to ram through on such a small amount
- 13 of time for the residents to speak about
- 14 them and we find it very troubling and a
- 15 representative of government to have that
- 16 happen. Thank you.
- 17 MS. GATELLI: Thank you. Anyone
- 18 else?
- 19 MR. HUBBARD: Good evening, Council,
- 20 Daniel Hubbard, Scranton resident. I have a
- 21 question on 5-Q, didn't council unanimously
- 22 pass a motion saying that you would not
- 23 entertain a look at anything that had to do
- 24 with the 500 block of Lackawanna Avenue?
- 25 MS. EVANS: Yes.

1 MR. HUBBARD: Then why is it on the

- 2 agenda?
- 3 MS. FANUCCI: We actually said that
- 4 we would not look or anything or introduce
- 5 anything until we knew that Mr. Giovanni was
- 6 spoken to and was included in the
- 7 agreements.
- 8 MR. HUBBARD: And you actually know
- 9 that he -- -
- 10 MS. FANUCCI: He actually opted out.
- 11 MR. PICCOLINO: We never opted out.
- 12 MS. FANUCCI: He actually opted out.
- 13 MR. HUBBARD: Well, that's obviously
- 14 between Mr. Giovanni and the city, but until
- 15 you have some clarification on that and not
- 16 just your side of the clarification, his
- 17 side as well from his attorney then it still
- 18 applies.
- 19 MS. FANUCCI: I actually passed the
- 20 legislation on just his opinion and his side
- 21 of it, but as far as I'm concerned this is
- 22 legislation that we did pass, this is
- 23 something that needs to take place for the
- 24 project to go forward and that's very
- 25 important now. Everyone was included and

1 asked to come. Whether or not he doesn't

2 want to do that, that has nothing to with me

3 as a city council person.

4 MR. PICCOLINO: We were never --

5 MS. FANUCCI: And that's all I can

6 say.

7 MR. HUBBARD: I'm not going to get

8 involved with Mr. Giovanni, I just wanted

9 some clarification on that. Also, again,

10 the Rejuven Essence Management Services,

11 that's a salon; correct?

12 MS. FANUCCI: Yes.

13 MR. HUBBARD: Is that an atypical

14 figure \$250,000 for salons, it that what we

15 are doing now? It's the same amount as

16 Alexander's.

17 MS. FANUCCI: Actually, they are

18 putting \$770,000 into the salon themselves.

19 MR. HUBBARD: Where are they located

20 at, they are located at the Ice Box;

21 correct?

22 MS. FANUCCI: Correct.

- 23 MR. HUBBARD: Where is this money
- 24 going to be spent, in their facility there?
- 25 MS. FANUCCI: No. No. This is for a

- 1 different facility, but also this
- 2 legislation has been tabled, we are going to
- 3 table this tonight because this is not the
- 4 correct legislation from what we are being
- 5 told.
- 6 MR. HUBBARD: We are removing
- 7 parking meters on Mulberry Street as well,
- 8 so not only are we just giving the
- 9 University land like there is no tomorrow we
- 10 are going to let them take away our parking
- 11 meters as well so they we lose money on that
- 12 as well?
- 13 MS. EVANS: I do believe though,
- 14 Mr. Hubbard, that I have read communication
- 15 from the university to the administration
- 16 that they make five annual payments to the
- 17 city for the removal of parking meters that
- 18 they have caused and, also, from what I have
- 19 read those monies that are giving by the

- 20 University of Scranton to the City of
- 21 Scranton are then placed in the Parks and
- 22 Recreation Fund.
- 23 MR. HUBBARD: That's awfully generous
- 24 for them to pay for the parking meters, at
- 25 least they could pay for the land.

- 1 MS. GATELLI: Anyone else on the
- 2 agenda items?
- 3 MR. DAVIS: Salaam aleikam. My first
- 4 question is for "L," 5-L, can you look
- 5 Judge, an ordinance for sale of tax
- 6 delinquent property at the corner of Linden

- 6 Scranton. I wasn't going to speak tonight,

8 tonight is very important night, the first 9 night back from city council after the 10 vacation and a vote was taken five to 11 nothing and I think we need to hear both 12 sides of this 500 block of Lackawanna Avenue 13 development. I think into Buona Pizza's 14 side and Coney Island's side plus the 15 mayor's side and Rinaldi's side should be 16 heard before this voted on. You guys voted 17 five to nothing not to vote on it, I am not 18 convinced that things are up and aboard on 19 this and I really think another week is not 20 going to hurt. Hold it back a weak and 21 let's hear from both sides. Let's give the 22 attorneys on both sides an opportunity. 23 Let's make it public. This is very 24 important to the City of Scranton, very 25 important to businesses and to citizens, to

1 residents and we don't need to do like we
2 did with other things like a smoking ban and
3 everything else, shoot from the hip and
4 shoot crooked. We need to shoot straight,

5 so let's take some time, let's cool our

6 heels people, let's take another week, let's

7 take another two weeks if we have to. It's

8 not going to delay the project. Let's just

9 wait and make sure that you hear from Boyd,

10 the attorney and someone and make sure we

11 did it right for once. Let's do something

12 right in the City of Scranton. Thank you.

13 MS. GATELLI: Thank you. Anyone

14 else? Anyone else on agenda items? Mrs.

15 Evans?

16 MS. EVANS: Good evening, glad to be

17 back. During our summer recess, the 2006

18 independent audit became an issue in our

19 local newspaper with the administration

20 pointing the finger of blame at council,

21 however, the only responsibility we can

22 accept is for working to save the people of

23 this city money. Further, if this

24 particular audit followed the annual

25 tradition it would just reach this desk now

32

1 in September 2007. The work of the auditors

- 2 was delayed by a few months because of
- 3 council's successful efforts to obtain a
- 4 fair price and to save \$100,000 which should
- 5 be spent on upgrading our roads or paying
- 6 necessary salaries.
- 7 On the other hand, it is the fault
- 8 of this administration that the audit is not
- 9 progressing successfully and quickly. There
- 10 are six areas of information that were
- 11 requested by the CPA's dating back to
- 12 6-18-07 to which the administration failed
- 13 to respond. Nevertheless, both Mr. Armoni
- 14 and Mr. Grassi, CPA's, will update me on a
- 15 weekly basis on any progress or lack
- 16 thereof. They cannot complete -- or they
- 17 cannot predict a completion date at this
- 18 point in time, only more timely responses
- 19 from the administration will hasten the
- 20 process.
- 21 I also have concerns regarding a
- 22 \$3.4 million hole in the 2007 operating
- 23 budget. Mr. Doherty plugged in this figure
- 24 as revenue to be received from the sale of
- 25 delinquent property taxes. He struck a deal

- 1 with an Erie firm without benefit of
- 2 bidding. Consequently, another firm,
- 3 Expand, offered to make a competitive
- 4 proposal to the city as well. The
- 5 administration agreed to review the expand
- 6 proposal, but has failed to reach a decision
- 7 and to present any legislation to council,
- 8 hence, the \$3.4 million hole in this year's
- 9 budget. It would behoove the mayor and Mr.
- 10 Krushefski to address these two crucial
- 11 issues. First, provide information to the
- 12 auditors; and, second, explain how you will
- 13 cover a \$3.4 million budget hole.
- 14 I also have two responses, two
- 15 requests that were made at our last council
- 16 meeting of July 26, 2007, Mr. Wintermantel
- 17 responds that no spots are sets aside for
- 18 county workers in any of the Scranton
- 19 Parking Authority garages. Any worker for
- 20 the county would be asked to pay the \$75 per
- 21 month fee. Also, Chief Elliott states that
- 22 regarding the traffic around Bridget Court

- 23 and 14th Avenue, he has notified the traffic
- 24 division to monitor the situation.
- 25 In addition, however, I have

- 1 received no answer from Mr. Baker of the
- 2 Scranton Housing Authority regarding the
- 3 potholes at Park Gardens. And I do have a
- 4 few citizens' requests. A letter to
- 5 Mr. Brazil, please clean the lot at the
- 6 corner of River Side Drive and Depot Street,
- 7 this is the second request. Residents
- 8 report that overgrown trees at the corner of
- 9 Sanderson Avenue and Delaware Street
- 10 obstruct a stop sign, please trim trees.
- 11 Fill potholes in the 1500 block of Von
- 12 Storch Avenue. Although, numerous streets
- 13 in need of repair have been addresses this
- 14 summer, some appear to have been more recent
- 15 requests. Neighbors are very upset. This
- 16 is the third request ongoing since
- 17 March 2007.
- 18 Also, residents report sightings of
- 19 snakes and mice in an abandoned lot adjacent

- 20 to 608 Hampton Street. These creatures have
- 21 infiltrated neighbors' properties. Please
- 22 address immediately due to health and safety
- 23 concerns.
- 24 A memo to Chief Elliott, residents
- 25 report the vehicles continue to speed on

- 1 Shawnee Avenue ignoring stop signs. A
- 2 letter to Mr. Seitzinger, 1158 Hampton
- 3 Street residents continue to complain that
- 4 the property has been blighted for over
- 5 15 years. The front porch roof is falling
- 6 down and despite prior notification this eye
- 7 sore remained untouched all summer. It is
- 8 the second request, the first was made in
- 9 June 2007. Also, for Mr. Seitzinger, a
- 10 house at 1917 Prospect Avenue was condemned
- 11 twice since December 2006. It was gutted
- 12 six years ago. The property is an overgrown
- 13 eyesore nestled between two well-kept
- 14 properties. Neighbors have endured this
- 15 blight for over six years. Update council
- 16 as soon as possible with a demolition date.

- 17 1909 Prospect Avenue, a house was also
- 18 condemned and boarded up. The property is
- 19 an overgrown mess. Update council as soon
- 20 as possible with a demolition date because
- 21 of the conditions of both of these
- 22 properties, rats have been observed by
- 23 neighbors. And I also have, Kay, quite a
- 24 number of excellent photos of both of the
- 25 locations on the Prospect Avenue that I

- 1 would like Mr. Seitzinger to see, and that's
- 2 it.
- 3 MS. GATELLI: Mrs. Fanucci.
- 4 MS. FANUCCI: I only have a few
- 5 things. First of all, I would like to thank
- 6 Jeff Brazil, I'm sure as well as the rest of
- 7 us, have been keeping him extremely busy on
- 8 our six-week vacation with all of the
- 9 matters that he needed to attend to. Also,
- 10 Mark Seitzinger has done so much for me and
- 11 I want to bring up a situation that we had,
- 12 in fact, I believe this was sent to you,
- 13 Janet, and then I don't know how it got in

- 14 there, but it was put to all council people,
- 15 but this one went on because it had a big
- 16 issue and there a problem, this elderly
- 17 women who is living in a home, renting in a
- 18 home and that was deplorable. She had
- 19 e-mailed us with the conditions of this
- 20 house.
- 21 Now, her fear was and being up in
- 22 age that if we did condemn her home that she
- 23 was renting that she would not have anywhere
- 24 to go, so she was torn between actually even
- 25 sending us the e-mail. She didn't even want

- 1 us to really go and check it out because of
- 2 her fear of not having anywhere to go when
- 3 we went and condemned this home. When Mark
- 4 had responded very quickly, thank God, the
- 5 home was in terrible condition. There were
- 6 electrical wires hanging that were live.
- 7 There were walls ripped out. This woman was
- 8 living in probably just a terrible
- 9 condition, but I want to thank Mark because
- 10 what he did was he relocated her the same

- 11 day when he condemned the home. He made
 12 sure that she was safe and in a good place
 13 that she wanted to be, and for anybody who
 14 is out there if there is your situation and
 15 you are renting off of someone and paying
 16 them money and you are living in a place
 17 that is just not liveable because it really
 18 would be condemned or hazardous to your
 19 health or dangerous do not fear that when we
 20 do, you know, send our inspectors in they
 21 will make sure that you are okay. My heart
- 23 between torn actually wanting to do the

22 went out to this because I can't imagine

- 24 right thing and still paying for it and then
- 25 not being serviced from the city, but I want

- 1 to thank him for that response because she

8 I also would like to speak on the

9 fact that they capital budget, the capital

10 budget seems to be an issue every time it

11 comes before us. It's just a wish list.

12 It's nothing more, it's nothing less, and

13 it's like Christmas time, you know, you say

14 you want everything in the world, does it

15 mean you are going to get it? No. That's

16 all it is. It's just projects that in a

17 deep, you know, say we had a windfall of

18 money this is what we want. It doesn't mean

19 that's what the money were are spending. It

20 doesn't mean that it's even part of a budget

21 or will be included, it's just what we wish

22 for. As far as citizens we'd all want it if

23 we can get it, but obviously that won't

24 happen, so I have no problem with the

25 capital budget. It's pretty much a

1 formality. They have to send it down, we

- 2 have to read it and approve it and send it
- 3 back and maybe you want to put more things
- 4 on the wish list, I guess, we can probably
- 5 go on for the next 20 years and figure out
- 6 things to put on it, so I will be voting in

- 8 that to be problem.
- 9 As far as the Giovanni Piccolino

- 14 This is always in litigation and I don't
- 15 know why you would want to be involved over
- 16 something that's in litigation, so I just
- 17 wanted to clarify my thoughts on that. I'm
- 18 certainly not going to sit up here and act
- 19 like any of these decisions are very easy,
- 20 and one way or another there is always
- 21 someone upset, so that's just what I had to
- 22 say.

- 23 And I do want to say that it's nice
- 24 being back, it's hard to believe, but it is
- 25 very nice being back. We spent six weeks

•

- 1 working probably just as hard, actually,
- 2 doing more things because in the summer
- 3 months there seems to be a lot more that
- 4 needs to be attended to, and that's all I
- 5 have. Thank you.
- 6 MS. GATELLI: Thank you. Mr. McGoff?
- 7 MR. MCGOFF: Thank you. Just a few
- 8 brief things, a day in August where the
- 9 temperatures were somewhere in the high 80's
- 10 or 90's, the snow removal committee met,
- 11 that's somewhat ironic. Mr. Hayes,
- 12 Mr. Brazil, Mr. Tom Gallagher from the
- 13 Scranton school district, and myself,
- 14 Mr. Courtright was unavailable that day, but
- 15 we met and we talked about the problems that
- 16 occurred last year with the snow removal.
- 17 What we did was we looked at the prior plan,
- 18 made some suggestions for revisions, also,
- 19 some maybe additions to the plan.

20 Suggestions came from, you know, everybody

21 that was at the meeting and such things as

22 one of the things that came up with was the

23 possibility of a medical emergency number.

24 I know during that storm in February there

25 was some concern over people needing to get

43

1 to doctor's appointments, hospitals, and

2 etcetera, and so the thought was that maybe

3 one of the things we need to include is some

4 type of medical emergency number so that

5 people can either be plowed out of there

6 their homes or possibilities of some type of

7 action taken to get them to their, you know,

8 whatever the emergency condition may be.

9 And the other thing that was

10 prominently mentioned was that once the plan

11 is completed that it be published on the

12 website, on the city website so that people

13 can see the nature of the snow removal plan

14 and how it could be conducted and hopefully

15 it will alleviate some of the questions

16 that, you know, maybe people have about why

17 certain streets are plowed and what order18 they are plowed. We are going to meet again19 at the end of September and hopefully that20 will be in place before the first snow

21 storm.

22 Second thing I would like to make

23 mention of, there was a condition at

24 Cloverfield in West Scranton concerning a

25 young girl that stepped on top of what

1 appeared to be a sewer drain or something

2 and was harmed, she was hurt, and her father

3 did call and we looked into it and the

4 nature of the problem was actually not a

5 sewer, but it was kind of a water basin that

6 was put in with the water meter for a

7 building that was placed at Cloverfield for

8 the West Side Jet's football team. That the

9 problems were addressed, the DPW and the

10 West Side Jet's, kind of the custodians of

11 Cloverfield, met and took care of some of

12 the problems that lead to this unfortunate

13 accident and some of the issues at

- 14 Cloverfield are continuing to be addressed,
- 15 the fencing, putting up new fences, removal
- 16 of I think the dug outs and some other
- 17 things that are taking place to make it a
- 18 more safer environment for the children that
- 19 participate in events at this field.
- 20 And the last think I'd like to
- 21 mention is I'd like to commend Mrs. Gatelli
- 22 and the South Side Neighborhood Association
- 23 for their action taken to address the
- 24 serious blight conditions that existed in
- 25 the lower part of south side. I know that

- 1 the neighbors when the plans were announced
- 2 by the mayor for what was going to take
- 3 place, I realize that there was some
- 4 objections to what was possibly being done,
- 5 but I do know that the residents of lower
- 6 south side, the areas around Cedar Avenue
- 7 where these properties were located were
- 8 elated what was going to take place and it
- 9 will be a definite improvement for the
- 10 neighborhoods that are affected, and that's

11 is all. Thank you.

12 MS. GATELLI: Thank you, Mr. McGoff.

16 quick items, may I?

- 4 MS. GATELLI: On the question?

- 9 that I find it comforting to know that this
- 10 is a wish list because, indeed, that's how

- 13 capital budget. This does not resemble a
- 14 true budget. Another great concern I have,
- 15 and I should back pedal here, I guess my
- 16 greatest objection in all sincerity is that
- 17 absolutely no costs have been broken down.
- 18 This is in nothing but glitter and
- 19 generalities.

- 20 Now, what concerns me more so is the
- 21 fact that while \$10 million has been
- 22 allocated to six city parks over the next
- 23 five years, merely \$3 million has been
- 24 allocated to infrastructure, specifically,
- 25 our roads, our curbing and our bridges.

- 1 Now, personally, if this may well be a wish
- 2 list, but I think Mr. Doherty has it
- 3 backwards, I think the ten million needs to
- 4 go toward or streets and our curbing and our
- 5 bridges and the three million toward the
- 6 parks. I know myself, I visited the parks
- 7 perhaps three times in the last year, but
- 8 I'm driving these city streets every day and
- 9 I'm listening to the people of Scranton's
- 10 complaints about our roads and bridges
- 11 nearly everyday and so as for the fact that
- 12 there is really no connection between the
- 13 SIP and the operating budget there, indeed
- 14 is, in fact, I will quote from the document,
- 15 "Resources for the SIP generally come from
- 16 the issuance of bonds or notes, grants,

- 17 contributions from the city's operating
- 18 budget," that is the general fund, "or other
- 19 one-time financial sources."
- 20 Further along, "Traditionally the
- 21 greatest part of the city's capital
- 22 improvement projects has been funded through
- 23 the issuance of tax supported general
- 24 obligation bonds and notes," and that,
- 25 indeed, means, you, the taxpayer. I will be

1 voting, no.

- 2 MS. GATELLI: Anyone else on the
- 3 question.
- 4 MR. MCGOFF: Yes. I would like to
- 5 clarify as well. First of all, there is
- 6 absolutely no money allocated. There is no
- 7 money to allocate to a capital budget,
- 8 again, and there is absolutely nothing
- 9 binding about a capital budget. The reason
- 10 that there are no specific amounts there in
- 11 a capital budget is that none of these
- 12 projects have actually been bid or anything
- 13 else. They are, as has been said, just

14 things that the city would like to see done
15 if, in fact, it gets a grant or, you know, a
16 bond or whatever and it has money. And
17 there is also whatever order they are in is
18 not binding. And, in fact, if there were
19 money allocated for something it doesn't
20 even have to be for something that's listed
21 within the capital budget. Any needy
22 project could be entertained, and so the
23 capital budget is really just a piece of
24 paper that itemizes a few things that could
25 be done if, in fact, there is money

1 available, but there is nothing binding
2 about it, and there is no money allocated to
3 it and so voting for it is to me just a
4 formality saying that, yes, this is a nice
5 wish list and nothing more.
6 MS. EVANS: Then that must, indeed,
7 be the attitude or the response of the
8 administration in that annually they will
9 not present their capital budget in
10 compliance with Section 904 of the Home Rule

- 11 Charter, so now I better understand what
- 12 they are doing. They feel that it's a

1 the owners, the city, and the developer and

2 there are, indeed, two sides to a story.

3 When I give my word I keep my word, and I

4 will be voting against this. And as

5 Mr. Piccolino mentioned earlier, I find it

6 absolutely foolish that you would put new

7 sidewalks, curbing and lighting in the

8 middle of the street to have absolutely

9 nothing done on each end. That will look

10 ridiculous. I don't see any point in

11 pursuing that, and I believe I had spoken to

12 the mayor personally about this long ago, he

13 made myself and Mr. Piccolino a number of

14 promises and never kept those promises. As

15 I said, no.

16 MS. GATELLI: Anyone else on the

17 question?

18 MR. MCGOFF: Yes. I would like to

19 say that I think that we have fulfilled our

20 obligation from our vote. Again, my

21 understanding that the matter of involvement

22 for Buono Pizza and Mr. Piccolino is in

23 litigation. If it weren't in litigation

24 then an offer of some sort must have been

25 made and he must have been included in some

•

1 nominal way and I feel that Mr. Piccolino is

- 2 attempting to use council as a means of
- 3 leverage in the Court case, and I think his
- 4 inclusion in the project is going to be
- 5 settled not here, but through litigation and
- 6 through the Court case that he is now
- 7 pursuing and that I will vote, yes, to move
- 8 this forward and let the Court's decide the
- 9 nature of Mr. Piccolino's inclusion in the
- 10 project.
- 11 MS. EVANS: I just wanted to add to
- 12 that though, as such time as I made the
- 13 motion and it was approved by this council
- 14 Mr. Piccolino was involved in litigation
- 15 with the city, that had not developed
- 16 afterwards, that was part and parcel of what
- 17 was occurring, so to now use that as an
- 18 excuse really doesn't hold water.
- 19 MS. GATELLI: Anyone else? I do
- 20 agree with you Mrs. Evans and I would like
- 21 Mrs. Garvey to pull that motion out and see
- 22 exactly what we voted on, for next week.
- 23 I'm not sure that this HARB approval is a
- 24 monetary approval, you know, approval of any
- 25 sort. We are not approving any money for

- 1 the project, it's just to approve that it is
- 2 a historical district. I will have more
- 3 information next week and I will have them
- 4 here if we request it and Attorney Minora
- 5 will accompany me to the meeting and we will
- 6 have more to say. I am going to vote to
- 7 push this forward to next week. That
- 8 doesn't necessarily mean that if I get
- 9 information that we would violate that
- 10 motion in any way that I won't vote, no,
- 11 when it comes up for final passage. This
- 12 does not mean that I am agreeing with it,
- 13 I'm just moving it forward to the next level
- 14 because I do agree with Mrs. Evans on that
- 15 issue.
- 16 We need to all be on the same page
- 17 and, you know, maybe the eminent domain will
- 18 come, I can't say that, but if we can get
- 19 around it and settle it another way it's
- 20 much easier than eminent domain, trust me,
- 21 because we have been there. I don't want to
- 22 not have the project because the 500 block

23 of Lackawanna County Avenue is deplorable

24 and is the only part of Lackawanna County

25 that's not being addressed and it really

1 needs some work on that particular block.

2 The other side where the bridge is and the

3 restaurant and the intermodal transportation

4 that money is also in place so we will have

5 all of Lackawanna County complete, so I

6 don't really want to lose the whole project,

7 but I do feel for Mr. Piccolino and, like I

8 said before, we are going to do everything

9 we can to make sure that we as a counsel can

10 do whatever we can legally to see that he is

11 treated fairly.

12 MS. EVANS: I do agree with what you

13 said, that block is absolutely in need of

14 rehab and no one wants to see that stop, but

15 I don't believe it was ever Mr. Moran's or

16 Mr. Piccolino's intention to stop progress.

17 They simply wanted to be included and

18 treated fairly and honestly and that hasn't

19 happened. So, you know, as I said, I am not

- 20 going to be voting to approve this, but I
- 21 also would ask council if you have a
- 22 questions about that motion you should very
- 23 likely pose them to me, not to our attorney,
- 24 it doesn't need interpretation because the
- 25 mover sits with you, and I can tell you

- 1 precisely what I meant when I made that
- 2 motion.
- 3 MS. FANUCCI: Well, my feeling, and
- 4 I said before, I'm going to introduce is and
- 5 that does not mean that I'm going to pass it
- 6 through. We are going to take a look at it
- 7 and see next week what my feeling is on it.
- 8 I'm not one way or another right now, I'm
- 9 sort of in-between trying to figure out what
- 10 we should do. I certainly don't want to
- 11 stop a project and I certainly don't want to
- 12 see anything happen like what happened with
- 13 the mall. I don't want to see the taxpayers
- 14 paying way to much money for a project or
- 15 for businesses that aren't worth it. I want
- 16 to see it be fair. Fair is all I think we

- 17 need to be focused on here. So if, indeed,
- 18 he has not offered or was not communicated
- 19 with then we will deal with that
- 20 accordingly.
- 21 MS. GATELLI: Anyone else? All
- 22 those in favor?
- 23 MS. FANUCCI: Aye.
- 24 MR. MCGOFF: Aye.
- 25 MS. GATELLI: Aye. Opposed?

1 of the significant impact on municipal

2 revenue by University Community networks.

3 The study was conducted by the Pennsylvania

4 Economy League and I'd like to quote from

5 it: "It was expected that the study would

6 find that the expenses were significantly

7 higher for host municipalities.

8 Interestingly, the findings indicate

9 that it is revenue that is significantly

10 lower in host municipalities than in their

- 11 municipal counterparts. College host
- 12 municipalities consistently collect less
- 13 revenue per capita in earned income tax,
- 14 real estate tax, and total taxes than the
- 15 controlled municipalities. These findings
- 16 indicate that while institutions of higher
- 17 education bring an undisputed economic boon
- 18 to a region or state, they may also
- 19 adversely affect a municipalities fiscal
- 20 resources.
- 21 Why is this the case? Higher
- 22 learning institutions do not contribute
- 23 property tax due to their tax exempt status,
- 24 but they typically owe a significant amount
- 25 of property in a municipality. Higher

- 1 education institutions that have prominence
- 2 in the municipality tend to own significant
- 3 amounts of property lowering the level of
- 4 real estate taxes collected by the
- 5 municipality. These circumstances lead to
- 6 less revenue for college host municipalities
- 7 than municipalities that are comparable in

8 median family income and percentage of 9 renters."

- 10 Now, as I examined this agreement
- 11 presented to us, I noticed that in an
- 12 Exhibit A we have listed the description of
- 13 the project of the \$30 million will be used
- 14 to finance and one of those uses is
- 15 financing of other miscellaneous capital
- 16 expenditures including expansion. Now, what
- 17 they mean by other miscellaneous is in
- 18 addition to the campus dormitory they are
- 19 currently erecting, so it's evident that
- 20 they have plans of further expansion and/or
- 21 renovation of the existing facilities on the
- 22 university campus and etcetera, then they
- 23 proceed to define the university's campus
- 24 and included in that definition is an
- 25 additional athletic complex located on both

__

- 1 sides of Broadway Street between Third and
- 2 Lackawanna River in the City of Scranton.
- 3 So, is it does appear that will be
- 4 great expansion. Now, I don't believe that

5 anyone can afford this. One point -- or

6 excuse me, one in six people in Scranton

7 still live in poverty. The University of

8 Scranton should be building up, not out, and

9 by agreeing to this arrangement we are in,

10 in fact, agreeing to a allow them to expand

11 further and place additional financial

12 burden on the taxpayers of Scranton, so I

13 cannot approve this.

14 MS. GATELLI: Anyone else on the

15 question?

16 MR. MCGOFF: Yes. As I read it, the

17 expansion that you are speaking of is to

18 properties that that they already own that

19 they are not purchasing additional property.

20 The properties on O'Hara Road and the

21 properties between Third and Lackawanna

22 River are properties that are already in the

23 possession of the University of Scranton.

24 MS. EVANS: Well, that's certainly

25 very interesting, but I think we all know

1 the history of the University of Scranton

- 2 which is almost an annual expansion to the
- 3 point where our citizens are suffering from
- 4 the amount of tax producing properties that
- 5 have been devoured by the University of
- 6 Scranton and removed from the tax rolls.
- 7 MR. MCGOFF: But, none of those --
- 8 they are not going to acquire any new
- 9 properties so that that's --
- 10 MS. FANUCCI: They are building on
- 11 their own land.
- 12 MS. GATELLI: We are still on the
- 13 question. Just for the record, I spoke to
- 14 Bob Nevrosky, who is a member the
- 15 association and is directly affected by the
- 16 neighboring University of Scranton, and he
- 17 said that the Hill Neighborhood is in total
- 18 agreement with this expansion project, and
- 19 they are thrilled that the homes are gone
- 20 and that the students will be housed in
- 21 dormitories. It makes for a much more
- 22 pleasant neighborhood when the children are
- 23 not crowding into homes where landlords are
- 24 making excessive amounts of money and he,
- 25 indeed, is in favor of this project so I

1 would be voting, yes, in agreement with the

- 2 Hill Neighborhood Association.
- 3 MS. EVANS: Well, I can certainly
- 4 respect that and I do understand the
- 5 position of the neighbors of the Hill quite
- 6 well and their issues over these many years.
- 7 I can understand that they would, of course,
- 8 favor the construction of dormitories over
- 9 off-campus housing, but unless I see within
- 10 their newly produced policy that they will
- 11 not permit any student freshman through
- 12 senior year or graduate students to reside
- 13 off campus, I don't think they can give you
- 14 this guarantee. In fact, the University I
- 15 believe this year has the great honor of
- 16 hosting it's largest freshman class in
- 17 history. They are an excellent, excellent
- 18 post-secondary institution. They have
- 19 earned their superior academic reputation
- 20 and as such more and more students wish to
- 21 attend the University of Scranton, and I
- 22 don't believe that you are going to see all

- 23 of their student population encompassed in
- 24 dormitory residents. There will still be
- 25 off-campus housing whether we like it or

•

- 1 not, particularly in light of their recent
- 2 growth, and I expect that will only
- 3 continue, as I said, because they are an
- 4 outstanding institution.
- 5 MS. GATELLI: We could belabor this
- 6 for the next hour. The permit fees alone on
- 7 those projects are \$891,000 so we are
- 8 getting almost a million dollars in permit
- 9 fees. This new project is going to house
- 10 all of the sophomores, so now we all have
- 11 all the freshman and all of the sophomores
- 12 on campus.
- 13 I think that the new president of
- 14 the University is a very cognizant of the
- 15 neighborhood and trying to move forward with
- 16 getting more things done on campus and I
- 17 think you will see in the future more
- 18 dormitories built to keep more of the
- 19 students on campus.

- 20 I have been in negotiation with the
- 21 University of Scranton during my tax, in
- 22 lieu of taxes meetings, and within the next
- 23 several weeks I will be making an
- 24 announcement, we are very close to an
- 25 agreement on them doing a substantial

- 1 project for the City of Scranton, so I will
- 2 keep you posted on that, and just for the
- 3 record, they are not donating -- not
- 4 donating, paying \$891,000 in permit fees for
- 5 this project.
- 6 So, I think whether you like it or
- 7 not the University is here, Marywood is
- 8 here, we are educating children, they are
- 9 contributing to the restaurant, the bars,
- 10 the stores and, you know, I don't know how
- 11 you can measure that. I do agree with you,
- 12 I don't like the tax exempt either, and we
- 13 have to try to get what we can from tax
- 14 exempts as we got from the Housing
- 15 Authority, the \$900,000 which they have
- 16 never done before. And so, you know, we

- 17 have to keep on plugging and just hope than
- 18 when it's time for them to come up to the
- 19 plate that they come up to the plate for us,
- 20 and I do think it's going to help the Hill
- 21 Section. Your points are well taken.
- 22 MS. EVANS: And I did just want to
- 23 add I think it is splendid of the Scranton
- 24 Housing Authority to make a \$900,000 payment
- 25 in lieu of taxes to the City of Scranton.

- 1 MS. GATELLI: And the board members
- 2 don't get paid, by the way. They had a
- 3 misprint in today's paper. I know we are
- 4 going off the topic, but there was an
- 5 article in there that the board members got
- 6 paid.
- 7 MS. EVANS: I saw that, yes.
- 8 MS. GATELLI: That is not true. The
- 9 board members do not, Mr. Brown, up in the
- 10 balcony, you need to make a correction, the
- 11 board members do not get paid, and it is a
- 12 nice contribution, but it needs to fill the
- 13 potholes.

14 MS. EVANS: Yes, he does.

15 MS. GATELLI: And I'll call Marie

16 tomorrow, I thought that would be the next

17 thing you were going to say.

18 MS. EVANS: No, but I thank you.

19 Actually, as I said, I am very impressed and

20 very grateful, certainly that is most

21 beneficial and necessary, but it seems if

22 the Scranton Housing Authority can afford

23 something of that nature, is it not

24 embarrassing that we have postsecondary

25 institutions that contribute nothing to this

2 MS. GATELLI: Yes.

3 MS. EVANS: And others who are

4 extraordinarily financially solvent to say

5 the least who have contributed a mere

6 \$110,000 for many years, so --

- 17 to the public tonight that the swing set has
- 18 arrived and was installed at Nay Aug Park on
- 19 Saturday by Dunmore Evergreen Landscaping,
- 20 Incorporated, lead by Mr. George Dunbar. I
- 21 thank Mr. Dunbar for donating his time and
- 22 service to install our swing set. We
- 23 greatly appreciate all he has done to help
- 24 us.
- 25 Tomorrow, at 10 a.m. Junior Council

1 will hold a ribbon cutting ceremony at Nay

- 2 Aug Park for the completion of our
- 3 children's handicapped accessible swing set
- 4 project and on behalf of the Junior Council
- 5 I invite city council and the citizens of
- 6 Scranton to attend. Thank you to all those
- 7 who made this day possible. We are very
- 8 proud that we are able to give this gift to
- 9 so many residents all across our community.
- 10 For the 2007-2008 school year the
- 11 Scranton Junior City Council has five seats
- 12 available for any interested high school
- 13 students. Applications are available at
- 14 West Scranton High School and Scranton High
- 15 School. Students will be required to answer
- 16 an essay question and receive a written
- 17 recommendation from the teacher. All
- 18 applications are due by Monday,

- 9 in our infrastructure, attracting new
- 10 businesses and supporting our existing ones.
- 11 It's a plan to build our future today so we

- 14 That's a quote by our present mayor.
- 15 I'd like to break it down. "We are building

- 19 That's out of Money magazine.

- 20 "We are investing in our
- 21 infrastructure." Everybody knows how our
- 22 roads are.
- 23 "Attracting new businesses. "The
- 24 only businesses we attract are the ones that
- 25 we gave handouts and KOZ's to, and,

- 1 "Supporting our existing ones." They don't
- 2 support us or Coney Island.
- 3 "It's a plan to build our future
- 4 today so we are ready for the challenges
- 5 that tomorrow may bring." Basically it's
- 6 saying, let's borrow, borrow, borrow, and
- 7 worry about what happens in the future.
- 8 These are some population numbers
- 9 for Scranton: July '01, 75,222; July of
- 10 '02, 74,505; July '03, 73,905; July '04, 73,
- 11 555; July '05, 73,154; July of '06, 72,861.
- 12 All of this present administration had done
- 13 for us has raised the taxes and has
- 14 population decrease and no job growth at

- 1 that to fix up our South Side complex. Does
- 2 anybody know where that ball field is now

- 4 I don't even want to get into it, it's not
- 5 that important because I know it's not there
- 6 and probably never will be there. This man
- 7 constantly makes promises that he can't
- 8 keep. I wouldn't call him a liar, but, damn

- 10 Let's look at the Sewer Authority.
- 11 Is that increase legal? You have a lawyer,

1 MR. SBARAGLIA: And we are stuck with

2 this increase. And anybody with common

3 sense remembers that the reason why we

4 bought back our Sewer Authority was because

5 they were going to give us a 42 percent

6 increase instead of what do we got now, 53

7 or 56 percent increase and God knows where

8 it's going to end. There is no supervision

9 at all over the Sewer Authority if they

10 become autonomous. The Taxpayers'

- 11 Association's contacted PUC, they in turn
- 12 said if the Sewer Authority extends out
- 13 beyond Scranton it would probably come under
- 14 the PUC and it's good chance, we are in
- 15 litigation with them now. The other thing
- 16 is if not then we have to go to the Courts
- 17 and the Court would then supervise the Sewer
- 18 Authority. You can't have a Sewer Authority
- 19 without any kind of a checks and balances,
- 20 it doesn't work that way. It's got to be
- 21 done and it's got to be done quick. I don't
- 22 know why you would let anybody usurp your
- 23 powers. It doesn't make sense. It doesn't
- 24 make any kind of a sense. You are there to
- 25 protect the people from the mayor. You

- 1 don't do a good job of it. You probably
- 2 never will do a good job of it. You are
- 3 hand-in-hand with something that's pushing
- 4 the city beyond it's financial feasibility.
- 5 We're BP rated, that's junk bond. We are
- 6 going to go lower and lower and lower.
- 7 Nobody asks how much money from the sinking

8 fund when the Scranton Recreation -- the 9 Scranton Redevelopment Authority built a 10 garage. They had a sinking fund to pay off 11 some of the bonds. Now, in turn, probably 12 that fund was gone and the reason that 13 garage was sold is to get another sinking 14 fund, that's the only reason. Thank you. 15 MS. EVANS: Mr. Sbaraglia, I did 16 address on the issue at the time that the 17 \$8 million was paid to American Water 18 Services on behalf of the City by the 19 Scranton Sewer Authority and appeared at 20 that time that the only, let us say, power 21 the city retained after that transaction was 22 the ability of the mayor it appoint members 23 to the Scranton Sewer Authority Board, so, 24 as I said, I did bring up the issue that I 25 thought it was outrageous that the rate

1 increases would no longer come before2 Scranton City Council and why had that3 ability, that right, be taken away from us4 in order to protect the people, but it is

- 5 gone and how that transpired I do not know
- 6 because I was not privy to any of those
- 7 negotiations or deals that were made.
- 8 MR. SBARAGLIA: That's why you have
- 9 a lawyer.
- 10 MS. GATELLI: Ozzie Quinn.
- 11 Mr. Sbargalia, we will try to get that
- 12 answer for you.
- 13 MR. QUINN: Ozzie Quinn, Taxpayers'
- 14 Association. Janet, Mrs. Evans, you are
- 15 right about that CPI and, Mr. McGoff, you
- 16 are wrong. They are definitely has to be
- 17 the funding sources, be it a grant, CDBG
- 18 funds, taxes or whatever, and has to say the
- 19 amount, okay? This is not a wish list, this
- 20 is something in regard to the whole budget
- 21 and we are being hoodwinked again by Mayor
- 22 Doherty. We owe -- it's crunch time, we owe
- 23 \$300 million, that's principal and long-term
- 24 interest. And don't let anybody tell you
- 25 that the authorities are not -- that we're

1 not responsible for what the authorities

- 2 default. Read the ordinance of July when
- 3 you passed that \$35 million bond for the
- 4 Scranton Parking Authority. You know what,

- 8 it, enough is enough. How are we going to

2 MR. QUINN: That's my assumption is

3 right because I study the books, you don't,

5 fact that we are down there in Daron

6 Industries and what's happening down there

7 is a shame, there are two people on

8 respirators down there. One is in intensive

9 care right now in the hospital, okay, for

10 the last two weeks. It's a shame, it's a

11 crying shame. Miss Fanucci, you know, you

12 passed that for to be an industrial zone and

13 a month later your relative, Keating,

14 approved that, sent the land development

15 plan into the city, SRA, that was approved.

17 like Judy did tonight or says, "I want to

18 abstain because of the fact that I know my

19 daughter goes over there."

20 Well, if you were a relative you

21 should abstain to, but, no, you like before

22 when you were arguing about who is going to

- 23 pay for this -- don't giggle, Miss Giggles.
- 24 Everybody loves your giggle. The fact is

- 1 MS. FANUCCI: He is not my relative,
- 2 Ozzie, I don't know how many times I have to
- 3 tell you. God Bless you.
- 4 MR. OZZIE: He is a relative. He can
- 5 argue this for the day, he is your relative.
- 6 MS. FANUCCI: You find a blood link
- 7 and I'll believe it.
- 8 MR. QUINN: He is your relative, I
- 9 know, I went into the family tree. Mrs.
- 10 Evans, there is no doubt about it with the
- 11 Sewer Authority it's politics as usually.
- 12 The people are getting --
- 13 MS. FANUCCI: This is so sad.
- 14 MR. QUINN: -- upside down. It's
- 15 politics. The people just got their water
- 16 bills, they can't afford it.
- 17 MS. GATELLI: Thank you, Mr. Quinn.
- 18 MR. QUINN: Come on, let's go, you
- 19 people. Do something.

- 20 MS. GATELLI: Jim Stucker.
- 21 MR. STUCKER: The city, the bar at
- 22 Brass Pendant told me top tell you that was
- 23 the law. He told once again on Virginia
- 24 tonight. I live in John Doherty's building
- 25 so that's right next to East Street Park and

- 1 I live right around the back of it. I feel
- 2 better there and my buddy, Pat, told me to
- 3 tell you there is some people watching on TV
- 4 tonight with me. Our garbage hasn't been
- 5 picked up. I want to know what you can do
- 6 about Parrot Avenue, again. There is holes
- 7 up there by the school, I went about 5 or
- 8 10 -- five or six times about. I complain

- 13 McGoff violate the Home Rule Charter, so if
- 14 you want the citizens to obey the rules set
- 15 a good example, do it yourself.
- 16 MS. FANUCCI: How do I do that, Mr.
- 17 Spindler?
- 18 MR. SPINDLER: With citizens'
- 19 participates.
- 20 MS. FANUCCI: I don't think so, Les.
- 21 MR. SPINDLER: I know so.
- 22 MS. FANUCCI: Oh, okay.
- 23 MR. SPINDLER: Also, at the July 26
- 24 meeting, Mrs. Fanucci, you said you do what
- 25 the taxpayers want you to do, again, I don't

- 1 think so. You voted for a 25 percent tax
- 2 hike. I don't think the citizens wanted you
- 3 to do that. You also voted for that
- 4 ridiculous delinquent tax legislation which
- 5 would cause people who fall on hard times to
- 6 lose their houses. I don't think the
- 7 citizens of the city want that either.

- 8 And something else, you said at one
- 9 of the last meetings you made a bunch of
- 10 phone calls and most cities around here have
- 11 three minutes of public speaking. Don't
- 12 know you who you called, I did make some
- 13 phone calls, I got in touch with nine cities
- 14 and boroughs, the only one that's three
- 15 minutes is Hazleton. Wilkes-Barre and
- 16 Dunmore are ten minutes. Olyphant,
- 17 Plymouth, Kingston, Nanticoke and Moosic are
- 18 all unlimited. So, I think this council is
- 19 very unfair to us; and, lastly,
- 20 Mrs. Fanucci, you can't drive to Guam. Your
- 21 former teachers must be very proud of you.
- 22 MS. FANUCCI: You have to be kidding
- 23 me. You can't drive to Guam? I didn't know
- 24 that.
- 25 MR. SPINDLER: You are wasting my

- 1 time, please wait.
- 2 MS. FANUCCI: You are wasting my
- 3 time quite frankly.
- 4 MR. SPINDLER: Mr. McGoff, you said

5 something tonight, you were wrong and I

6 think you should get the facts before you

7 speak, you said Buono Pizza is in litigation

8 so an offer must have been made to them,

9 that's wrong. They are in litigation to

10 stop the -- I lost my train of thought, stop

11 the eminent domain proceedings, that's why

12 it's in litigation. They were never made an

13 offer.

14 Lastly, I think this council should

15 look into what West Pittston just did and

16 passing a ban on all minors smoking on

17 public property. I think it's a health

18 issue and I think it's a real good idea if

19 West Pittston did it I think that's

20 something we should also do. Thank you.

21 MS. GATELLI: Thank you. Reverend

22 Simmons.

23 MS. SIMMONS: Reverend Katherine

24 Simmons, Scranton resident. Good evening,

25 council, Junior Council. I came here

1 tonight to talk about three issues, but I'm

- 2 going to put all of them aside until next
- 3 week and speak about those who are not being
- 4 spoken for in the City of Scranton, the
- 5 needy, the poor, people who are only earning
- 6 enough to get themselves through a week.
- 7 The poor were insulted today. They were
- 8 insulted this morning and they were insulted
- 9 this evening. Any ministry or any nonprofit
- 10 group that deals with homeless families or
- 11 hidden families was insulted today and I
- 12 thought coming to council tonight there
- 13 would be some support here, but,
- 14 Mrs. Fanucci, you showed that you have
- 15 absolutely no regard for homeless families,
- 16 families that have been evicted from
- 17 condemned buildings because there is no one
- 18 in the City of Scranton that helps us find
- 19 housing for these people. I have been
- 20 involved with these people for 18 years and
- 21 not one time has anybody from a city
- 22 administration come forward to help me find
- 23 housing for these people. So, where you get
- 24 this idea from that --
- 25 MS. FANUCCI: In the instance I was

1 speaking of she did get relocated and she --

2 MS. SIMMONS: Well, bless her heart.

3 MS. FANUCCI: So personally --

4 MS. SIMMONS: One out of 18 years,

5 isn't that wonderful.

6 MS. FANUCCI: Well, that was the

7 incident I was speaking of.

8 MS. SIMMONS: Well, at the end you

9 said, you made the statement --

10 MS. FANUCCI: Yes, I did.

11 MS. SIMMONS: That anybody shouldn't

12 be afraid to turn their house over to have

13 it condemned or --

14 MS. FANUCCI: Their apartment. Their

15 apartment if they are renting from someone.

16 MS. SIMMONS: To them it's a house,

17 Dear, okay, they live in it.

18 MS. FANUCCI: But, you have to be

19 clear because I didn't say a home. I said

20 an apartment.

21 MS. SIMMONS: Well, I was sitting

22 right there, I heard it and everybody that

- 23 was in the front row heard it.
- 24 MS. FANUCCI: I said if they were
- 25 renting, this woman was a renter.

- 2 it make? It's their house.
- 3 MS. GATELLI: Excuse me, I don't
- 4 want to take your time, but we do have a
- 5 program in the city to assist people when
- 6 they are in --

- 8 MS. GATELLI: It's the United
- 9 Neighborhood Centers.
- 10 MS. SIMMONS: They haven't helped us.
- 11 MS. FANUCCI: United Neighborhood

- 15 MS. GATELLI: It's in block grant

16 money.

- 17 MS. SIMMONS: Where is it? Where is
- 18 it?
- 19 MS. GATELLI: I'll have Mike Hanley

- 20 call you.
- 21 MS. SIMMONS: I don't need Mike
- 22 Hanley call me, I had a meeting with him
- 23 this morning. Where is this program at? We
- 24 are out here every single day, 365 days a
- 25 out of the year trying to find housing for

- 1 people who have been either evicted from
- 2 apartments, is that a better word you want
- 3 me to use, or condemned buildings.
- 4 MS. GATELLI: If there is -- there is
- 5 no evictions --if they are evicted from
- 6 condemned buildings there is money. Well,
- 7 I'm telling you there is. It's been there
- 8 since --
- 9 MS. SIMMONS: Well, I'm asking you
- 10 where? Where?
- 11 MS. GATELLI: Where? Mike Hanley.
- 12 You call me tomorrow and I'll tell you where
- 13 the money is.
- 14 MS. SIMMONS: Well, you better tell
- 15 him because it was his group that met this
- 16 morning and we have a mundane amount of

17 problems.

18 MS. GATELLI: Well, I'll call Mike

19 Hanley tomorrow.

20 MS. SIMMONS: Well, you do that. You

21 do that.

22 MS. GATELLI: It's there. I'm

23 telling you, it's there.

24 MR. MCCLOE: Good evening. My name

25 is Brett McCloe, Scranton taxpayer. Over

1 the course of the past two months, I did

2 some light research into the nature of those

3 3-2 votes and those 4-1 votes and the more I

4 studied it the less it became important. I

5 realized it really didn't matter how, why or

6 how those votes fell or why they go the way

7 they do, or who will adversely affected as

8 long as only 30 percent of this city's

9 voting age participates in the proces. It's

10 not rocket science to figure out that the

11 upcoming tax hikes are geared towards those

12 who best absorb the increases, those who own

13 homes with household incomes of \$50,000 or

14 above. Households that don't make that kind
15 of money may not be able to absorb the
16 increases and will suffer due to a survival
17 of the fittest, survival of the financially
18 fittest's mindset. This can also be
19 problematic when it comes to households in
20 the lower middle class to working poor where
21 most rent rather than own their own homes.
22 Higher taxes mean higher rents, higher rents
23 with no corresponding increase in income may
24 cause household budgets to become untenable
25 with the credible expectations that there

1 may be a recession looming in the horizon.

2 In my opinion it would be irresponsible for

3 this city to do anymore borrowing or lending

4 without first reading the fine print and

5 telling the citizens the obvious, with every

6 dollar borrowed and lent out by this city

7 major tax increases and penalties will

8 follow. The people need to be told this,

9 the people need to be told this by you, it

10 can't be just something that happens to

- 11 them.
- 12 New tax legislation will probably
- 13 not get to the agenda until after the
- 14 November elections, and that's not hard to
- 15 figure out. I think it would be a smart
- 16 idea for in council to read the front page
- 17 of yesterday's newspaper and recognize the
- 18 realities of what could be the next
- 19 important voting block. Thank you.
- 20 MS. GATELLI: Thank you. Mr.
- 21 Jackowitz.
- 22 MR. JACKOWITZ: Bill Jackowitz,
- 23 South Scranton resident. Mrs. Gatelli,
- 24 there may be money available but the only
- 25 people that get that money are the Doherty

- 1 real people and the Fanucci my people.
- 2 Scranton Taxpayers' Lackawanna County
- 3 Citizens' Group, Incorporated, we had our
- 4 free swim program this year, we had a total
- 5 of five free swims at Nay Aug Park for a
- 6 total cost of \$3,034. One-thousand
- 7 one-hundred six kids swam for free. Some

8 this was the first time they ever swam at

9 Nay Aug Park. He we had five events, we had

10 six events that was scheduled for 2nd of

11 September, but it was cancelled due to the

12 fact that no life guards were available.

13 Labor Day weekends, no lifeguards, too bad.

14 If you are torn or undecided you should

15 table until you are 100 percent in favor of

16 or against the vote that you are making.

17 That's all that I'm asking for. You should

18 know more about that vote that you are

19 voting on because you are affecting every

20 citizen in the City of Scranton, than you

21 should know about your own family tree. You

22 should know everything that you need to know

23 about that vote. Legion of Doom stands for

24 fair, honest and open government and that's

25 all I'm asking for is fair, honest and open

1 government. Let's start getting it. Let's

2 make sure we know what we are voting on.

3 You should be able to answer any and every

4 question that is brought here to your

5 attention by a citizen or by a fellow 6 councilman or anybody. You should know the 7 answers. If you don't know the answers, be 8 man enough or woman enough to say, "I don't 9 know the answer, but I'll find the answer 10 and I'm not going to vote on it until I know 11 the answer," because it's a shame that the 12 taxpayers and the taxpayer group knows more 13 about what's going on in this city and this 14 county than our elected officials. 15 You guys were elected by us to 16 support us and to work for us, not to 17 support the people who voted for you, and 18 vote against the people who voted against 19 you. You are here to support every citizen 20 of the City of Scranton and it's damn -- you 21 better damn start doing it. It's as simple 22 as that. It's not being done. If you lose 23 your election, too bad. If you win your 24 election, great, but don't do it off the 25 backs of the citizens of this city. The

1 city cannot tolerate it any longer. We just

- 2 can't. People are broke. There is not too
- 3 many of us who make over \$50,000 a year.
- 4 Thank God I happen to be one of them, but
- 5 guess what, I'm in the minority because most
- 6 of the people in this city are making
- 7 between \$18,000 and \$22,000 to \$24,000 a
- 8 year. Think about it. Think about it when
- 9 you pass that vote. If the budget comes up,
- 10 think about it, know that budget, know that
- 11 budget inside and outside. Think about that
- 12 person who is making \$12,000 that single
- 13 mother. Think about it. That's all I ask.
- 14 MS. GATELLI: I think there is one
- 15 more on the list, Mrs. Shumaker.
- 16 MS. SHUMAKER: Marie Shumaker,
- 17 citizen and member of the Taxpayers'
- 18 Association. I have four brief items
- 19 tonight. First of all, Mrs. Gatelli, I'd
- 20 like to say I was very disappointed that you
- 21 decided to close the budget meetings after
- 22 you had announced that there would be three
- 23 meetings on the 9th, the 16th and the 23rd
- 24 between 11 and 1, that was very
- 25 disappointing.

- 1 Second, I would like to ask that you
- 2 reinstate an ordinance that was brought here
- 3 in December of 1993 to require all new homes

- 8 time, those of us who have persons in
- 9 wheelchairs, women in strollers that are
- 10 forced on the streets, it's just creating
- 11 needless -- the time to do it is when the
- 12 home is being built and new homes and I
- 13 would suggest you have Mrs. Garvey bring
- 14 that legislation back for passage.
- 15 Third, I'd like to ask Mrs. Gatelli,
- 16 several months ago you said you are going to
- 17 have the solicitor research the liens where
- 18 the city has demolished buildings and done
- 19 work for private individuals and I'd really
- 20 like to know what the result was of that. I
- 21 understand there has been another on Market
- 22 Street that was done for a private

- 23 individual and, I don't know, I didn't go
- 24 down and check to see if there is a lien on
- 25 that property, but the city can't be

- 1 affording those kinds of gifts I don't
- 2 believe.
- 3 And then, finally, I'd like to say
- 4 that the two minutes to address agenda items
- 5 is insufficient. Tonight there were 19
- 6 agenda items, I would like to have to spoken
- 7 to more than I did, but I was restricted and
- 8 I think two minutes is certainly
- 9 insufficient when you have that large of a
- 10 quantity. Thank you.
- 11 MS. GATELLI: Thank you.
- 12 MS. RICKARD: High. My name is Wanda
- 13 Rickard, and I live in the Tripp Park
- 14 Development, most of you know me. The
- 15 reason why I'm here tonight is because I
- 16 have a dangerous safety issue that I'm
- 17 dealing with living within our new
- 18 development. I'm one the first homes that
- 19 was built there, and my mother-in-law lives

- 20 with me and last year I had an ambulance
- 21 come to my home two times and the ambulance
- 22 could not find my home because my treat is
- 23 unmarked. This year my -- I had to call an
- 24 ambulance in two weeks four times and, also,
- 25 we had trouble, the ambulance had to call me

- 1 to give them directions because my street
- 2 wasn't marked.
- 3 Now, generally, what I do is I send
- 4 them over Euchlid Avenue, I know you are
- 5 familiar with the development, and I'll tell
- 6 them to take Hawthorne, but presently right
- 7 know there are trees that are really
- 8 overgrown and you can't even acknowledge let
- 9 alone read the Hawthorne sign, so they go
- 10 way past my house and they are on the other
- 11 end of the development and trying to wiggle
- 12 their way through and so the response time
- 13 is not good for me; and right now I'm
- 14 dealing with an ambulance, police, you don't
- 15 know who you are going to need, so it's a
- 16 concern of mine.

- 17 And one other thing I'd like to
- 18 bring attention to is the fact that I had
- 19 brought this issue up before, I am living in
- 20 my home it's going to be six years, like,
- 21 back two years ago with Mr. Fiorini and he
- 22 assured me that that matter would be taken
- 23 care of. At that time I didn't need, I
- 24 wasn't projecting that I would need an
- 25 ambulance, so it was, do you know what I

- 1 mean, but now it's an issue because no one
- 2 can find us. And I have home health coming
- 3 to the home and also I have nursing, private
- 4 duty nursing staff coming to my home. I
- 5 have a job so I am waiting for them and I
- 6 end up driving to a street three or

- 8 them to bring them to my home and that's
- 9 unnecessary when all I need is a sign to

- 11 MS. GATELLI: If you would leave your
- 12 name with Neil I'll have Mr. Brazil call you
- 13 tomorrow.

- 14 MS. RICKARD: Okay, and that's all,
- 15 you know I don't know who to talk to or --
- 16 MS. EVANS: Would you mention to him
- 17 too, though, about trimming the trees as
- 18 well?
- 19 MS. GATELLI: That's a good idea.
- 20 MS. RICKARD: I almost did it myself.
- 21 MS. EVANS: I'm sure he will take
- 22 care of these things.
- 23 MS. RICKARD: Thank you for your
- 24 time, I just didn't know who to talk to.
- 25 MS. GATELLI: Tell Neil, and Mr.
- 117
- 1 Brazil will call you tomorrow.
- 2 MR. GONZALEZ: Good evening,
- 3 Council, Junior Council, and all in
- 4 attendance. My name is Pedro Gonzalez,
- 5 south side resident, taxpayer and a
- 6 representative of the Latin Culture
- 7 Diversity Center Group and I'm here as usual
- 8 to announce certain events that have are up
- 9 and coming. One, the first one is at
- 10 Scranton University, this coming Saturday,

6 inspector's position. I don't want to

8 record straight and say and mention some of

9 the things the health inspector is

10 responsible for. The mold issue was

- 11 mentioned before, to my knowledge there is
- 12 no city, county or state authority that
- 13 deals with mold at all.
- 14 You also mentioned about -- it was
- 15 also mentioned about the bars and
- 16 restaurants. The health inspector, and
- 17 there is one health inspector for the City
- 18 of Scranton. She is responsible for over
- 19 400 bars and restaurants along with
- 20 approximately 60 vendors for one weekend of
- 21 the Italian festival, which she does along.
- 22 She also condemns -- along with posting stop
- 23 works order she also condemns for no heat,
- 24 no electricity, no water, no hot water,
- 25 infestation, unsanitary conditions, feces

- 1 and sewage backup.
- 2 The condemning officer, which would
- 3 be me, for all of those reasons are also
- 4 responsible to notify the owner if necessary
- 5 about the combination, also to setup for
- 6 temporary housing for the person who has
- 7 been condemned out and pull the power if

8 necessary, if that needs to come up. A

9 condemning officer is responsible to setup

10 the file and carry the file. I also issue

11 citations, attend hearings and issue

12 licenses.

13 I have been moved physically to the

14 first floor yet I'm expected to issue

15 licenses out of the fourth floor and

16 maintain files on the fourth floor. Last

17 year while this council voted in their

18 budget not to give our office another health

19 inspector, this council also voted to give

20 me the responsibility of the smoking ban and

21 all of the waivers because I guess I didn't

22 have enough to do.

23 And just one more thing, I'm also

24 the lowest paid inspector in the officer.

25 MS. GATELLI: Thank you.

2 I'd also like to mention that that was

3 Patti, our health inspector, and just

4 recently we had quite a scare for Patti and

5 animal control officer, they were both

- 23 employee and financial secretary of the FOP.
- 24 I'd like to thank Ms. Gatelli, Ms. Fanucci
- 25 and Mr. McGoff, for stifling two minutes

- 1 from our free speech. They have voted to
- 2 change the amount of minutes so often I
- 3 forgot how much time we would have. Let's
- 4 see what we should talk about. How about
- 5 the budget.
- 6 On Tuesday, November 13, which is
- 7 nine weeks away, the mayor has to present
- 8 his budget to council. I bet it's a record
- 9 budget, over 77 million, I bet he is going
- 10 to ask for a multi-million dollar loan and I
- 11 bet he is going to tie in another 25 percent
- 12 tax increase because he will need them to
- 13 cover the deficit that he will say we have
- 14 and then blame the unions for it.
- 15 Oh, can't forget the TANS, we will
