1 MS. GATELLI: I'd like to call the

2 public hearing to order. Roll call.

3 MR. COOLICAN: Mrs. Evans?

4 MS. EVANS: Here.

5 MR. COOLICAN: Ms. Fanucci?

6 MS. FANUCCI: Here.

7 MR. COOLICAN: Mr. McGoff?

8 MR. McGOFF: Here.

9 MR. COOLICAN: Mr. Courtright?

10 MR. COURTRIGHT: Here.

11 MR. COOLICAN: Mrs. Gatelli?

12 MS. GATELLI: Here. The purpose of

13 the public hearing is to hear testimony and

14 discuss the following:

15 FILE OF COUNCIL NO. 110, 2007 -

16 ESTABLISHING PERMIT PARKING ON THE NORTH SIDE

17 OF THE 700 BLOCK OF EAST GIBSON STREET FROM

18 MOIR COURT EAST FOR NINETY SEVEN FEET.

19 Is there anyone that cares to

- 20 address council on this particular issue? Let
- 21 the record reflect there are no residents here.
- 22 (No public comment.)
- 23 MS. GATELLI: I now declare this
- 24 public hearing closed. Now we have to wait
- 25 until 6:15 for the next one in case anyone else

- 1 wants to come. So we have about ten minutes.
- 2 Thank you.
- 3 (The public meeting concluded at
- 4 this time.)
- 5 MS. GATELLI: I would like to call
- 6 the public hearing to order. Roll call.
- 7 MR. COOLICAN: Mrs. Evans?
- 8 MS. EVANS: Here.
- 9 MR. COOLICAN: Ms. Fanucci?
- 10 MS. FANUCCI: Here.
- 11 MR. COOLICAN: Mr. McGoff?
- 12 MR. McGOFF: Here.
- 13 MR. COOLICAN: Mr. Courtright?
- 14 MR. COURTRIGHT: Here.
- 15 MR. COOLICAN: Mrs. Gatelli?
- 16 MS. GATELLI: Here. The purpose of

- 17 this public hearing is hear testimony and
- 18 discuss the following: FILE OF COUNCIL NO.
- 19 113, 2007 DESIGNATING THE 3200 BLOCK OF CEDAR
- 20 AVENUE AS A ONE WAY STREET ALLOWING TRAFFIC TO
- 21 FLOW IN A NORTHERLY DIRECTION AND PROHIBITING
- 22 TRAFFIC FROM FLOWING IN A SOUTHERLY DIRECTION.
- 23 And the first speaker is Patrick Hefron.
- 24 MR. HEFRON: Good evening, ladies
- 25 and gentlemen. My name is Patrick Hefron. I

- 1 am a resident in the 3200 block of Cedar Avenue
- 2 in Scranton. My wife and I purchased a home in
- 3 the 3200 block of Cedar Avenue in August of
- 4 2005. Shortly thereafter, basically from
- 5 conversations with neighbors, several of whom
- 6 expressed various safety issues with regards to
- 7 two way traffic in this particular block of
- 8 Cedar Avenue. Specifically, I point to my
- 9 neighbor, Patrick Paddon, who also a resident
- 10 of this particular block, various safety
- 11 concerns included cars proceeding in a
- 12 southerly direction down Cedar Avenue in a very
- 13 high rate of speed.

- 14 If you're familiar with this
- 15 particular block, it's very narrow and a lot of
- 16 times what we see happening is cars and traffic
- 17 attempting bypass the light at the intersection
- 18 of Birney Avenue and Davis Street, and this
- 19 provides an easy route down past Birney Avenue
- 20 through the light because Cedar Avenue is the
- 21 one block parallel to Birney Avenue. So
- 22 there's a direct right of access via left turn
- 23 from Davis Street to get onto Cedar Avenue.
- 24 Another concern expressed by several
- 25 residents on this block many of whom have very

- 5
- 1 young children expressed significant concerns
- 2 about the cars proceeding down this block.
- 3 It's very lengthy. Again, if you're familiar
- 4 with it, it's a very lengthy block. Speed --
- 5 just simply posting a speed sign will not do
- 6 it. There's very little to do in terms of
- 7 enforcement in terms of pulling any car over
- 8 that might be speeding on this road. And also
- 9 it has -- several vehicles that have been
- 10 parked the on this street have been hit again

- 11 by vehicles proceeding in a southerly direction
- 12 down Cedar.
- 13 Myself and Mr. Paddon took it
- 14 amongst ourselves roughly two years ago to
- 15 contact city hall to see if there was anything
- 16 we can do to address this issue. I myself
- 17 contacted city hall and was advised that the
- 18 petition procedure would be the proper format
- 19 in terms of trying to get something to
- 20 challenge this or to change this into a one way
- 21 proceeding into a northerly direction. And I
- 22 am sure if you have a petition in front of you,
- 23 the signatures they very much speak to
- 24 themselves.
- 25 The overwhelming residents on Cedar

- 1 Avenue have signed this petition.
- 2 Specifically, I point to -- I will not name
- 3 names. There is an active Scranton police
- 4 officer on the street who signed the petition
- 5 and agreed with the safety concerns that I have
- 6 expressed before you here tonight.
- 7 It has taken us, I assume, roughly

8 two years to get this before council tonight.

9 And it's also my understanding through the

10 rumor mill that the city engineer's office

11 agrees with our position that this should be a

12 one way street as it's very narrow. And

13 considering the safety issues, which I

14 expressed, an overwhelming number of signatures

15 on this petition, I request that Cedar Avenue

16 in the 3200 specifically be changed to a one

17 way in a northerly direction. Thank you.

18 MS. GATELLI: Anyone else that wants

19 to address the issue? I now declare the public

20 hearing closed.

21 (The public meeting concluded at

22 this time).

16 MS. GATELLI: Are there any

17 comments? If not, received and filed.

18 MS. GARVEY: That's all there is in

19 third order.

20 MS. GATELLI: Before we get to the

21 agenda items, I have a few announcements. We'd

22 like to congratulate our former stenographer,

23 Lisa Graff -- if you all remember her -- she

24 had a baby boy this week. So we'd like to

25 congratulate her on her baby boy.

1 And I was speaking to the Downtown

- 2 Scranton Business Alliance, and they asked that
- 3 I make an announcement that all of the downtown
- 4 shops, restaurants and boutiques will remain
- 5 open until 7:00 on Thursdays to better
- 6 accommodate shoppers' schedules and to create a
- 7 festive atmosphere in the downtown.
- 8 The Scranton Business Alliance is
- 9 vibrant and energetic of more than 200
- 10 representatives from business and industry
- 11 throughout the downtown. They represent
- 12 restaurants, specialty clothes and jewelry
- 13 boutiques, historic and tourist attractions,
- 14 hotel services, professionals and corporations.
- 15 Downtown Scranton is their livelihood, and they
- 16 are its future. And we wish the Downtown
- 17 Business Alliance a lot of luck with opening
- 18 their restaurants and stores until 7 on
- 19 Thursday.
- 20 When most of us were children who
- 21 are sitting up here, Thursdays they were open
- 22 until nine. So we are glad to see they are
- 23 going to open again on Thursday evening. Try
- 24 to patronize some of our downtown stores and
- 25 restaurants. I'm just happy to see in our box

- 1 tonight -- I know I announced last week -- but
- 2 now the check is really here. We've received
- 3 our \$900,000 check from the Scranton Housing
- 4 Authority, and we're very pleased about that.
- 5 And I did speak to Mr. Baker about
- 6 the potholes. He said he would have them
- 7 repaired. So you can let us know if that's
- 8 accomplished.
- 9 MS. EVANS: I will be driving by.
- 10 MS. GATELLI: Does anyone else have
- 11 an announcement to make?
- 12 MS. EVANS: Yes. Light the Way, a
- 13 candle light gathering for friends and families
- 14 of loved ones who have been lost to suicide
- 15 will be conducted on Wednesday, September 19th,
- 16 2007 -- that would be tomorrow -- at 6 p.m. at
- 17 the gazebo by the Everhart Museum at Nay Aug
- 18 Park. Everyone is invited. The event is free.
- 19 And for more information, call Cathy Wallace at
- 20 the Advocacy Alliance, 207-9199.
- 21 MS. GATELLI: That's it? Anyone
- 22 else? The first speaker is Andy Sparaglia.

- 23 MR. SBARAGLIA: Andy Sparaglia,
- 24 fellow Scrantonian, also a taxpayer. I want to
- 25 talk about 7 B., the university. We're about

- 1 the save them probably millions and millions of
- 2 dollars of interest if this loan goes through.
- 3 I would love to know how many million we are
- 4 going to save them. But we are going to save
- 5 them millions of dollars in interest.
- 6 We are going to lose meters, parking
- 7 meters. That means we are going to lose
- 8 parking revenue that's going to be lost. And I
- 9 don't see how we can compensate that part of
- 10 it. I mean, we're saving them millions, and
- 11 they are costing us money. Does that make
- 12 sense? No, it don't.
- 13 Then the gall of it is they want to
- 14 use some of that and fix up our park that they
- 15 so graciously acquired from the S. R. A., which
- 16 they were supposed to maintain down in the
- 17 South Side Complex. How much gall can you
- 18 have? Not only do they get down there through
- 19 some shameless deal, which you might call a

- 20 shameless deal, their -- I don't want to get
- 21 into it. But it's still part of the same thing
- 22 because the fact is we're taking this loan out
- 23 in their name for them to fix up that park so
- 24 that brings the park back into it again. I
- 25 don't want to bring it up at this time.

- 1 But it's ridiculous. We couldn't --
- 2 and the wort part of is we don't have that park
- 3 they promised us. Where is the other ball
- 4 field they were supposed to replace that one
- 5 with? All these things are going on, but
- 6 nobody really cares about the citizens of
- 7 Scranton.
- 8 It's obvious by what is happening.
- 9 You were elected to represent us. You spend
- 10 more time representing the university than you
- 11 do us. We're going to take a hit on this
- 12 project, not financially because you know darn
- 13 well that we are not responsible for the debt.
- 14 So we are not going to take it that way. We
- 15 will lose parking revenue. That is a hit on
- 16 us. I don't know how many blocks of parking

17 meters.

18 Who will pay to remove them? Who

19 will pay to have them to be reinstalled

20 somewhere if they are going to be reinstalled?

21 Who will make up for lost revenue?

22 MS. GATELLI: Thank you.

23 MR. COURTRIGHT: If I may, I got a

24 little information. We're going to be losing

25 five meters. That's what we are going to be

•

1 losing. The Scranton Parking Authority is

2 telling me that when they put those five meters

3 in they were aware of the fact this project was

4 taking place and they were aware of the fact

5 when the project took place that parking meters

6 would be removed. The approximate -- the

7 approximate cost I believe -- Kay, was it \$20

8 per day?

9 MS. GARVEY: It was \$4 per day per

10 meter approximately.

11 MR. COURTRIGHT: That's what they

12 said they are going to lose. Just a bit of

13 information for you.

14 MS. GATELLI: Mr. Quinn.

15 MR. QUINN: Ozzie Quinn, president

16 of the Scranton and Lackawanna County taxpayers

17 and citizen's taxpayers associated

18 incorporated. I want to speak on the agenda in

19 regards to the city's home rule charter and the

20 capital budget. Last week you introduced

21 capital budget without any figures. You

22 published it in the local paper without any

23 figures without any summary.

24 That's violating two sections of the

25 home rule charter. Thirdly, you are violating

13

1 article ten of the charter, fiscal. You failed

2 to send us -- the mayor failed to send this --

3 maybe he did -- to the planning commission for

4 their review in June.

5 Does anybody know if it was sent to

6 the planning commission? You violated the home

7 rule charter. What would happen if congress

8 kept on violating the Constitution, which the

9 home rule charter is for the City of Scranton?

10 It would be chaos. That's what it is in

- 11 Scranton, chaos. What we are doing is putting
- 12 up with this, hoodwinking this mayor with the
- 13 \$21 million. That's why he's not coming across
- 14 with this figure. We can't afford it. What
- 15 can we do to go to a public hearing if we
- 16 cannot address and prioritize what's going on
- 17 until after all these are introduced?
- 18 Shame on you people with the
- 19 exception of two. Also I want to ask a
- 20 question in regards to the ordinance for the
- 21 flood control parcel. Did you find anything
- 22 about that? Yes?
- 23 MS. FANUCCI: Uh-huh.
- 24 MR. QUINN: Tell me after I speak.
- 25 Thank you. Also I would like to know on the

- 1 agenda, the property at Cedar Avenue and Locust
- 2 Street they sold for \$28,000 to a Mr.
- 3 Brozzetti. What is going on in that property?
- 4 \$28,000 is probably the highest I ever seen for
- 5 a vacant property coming. Do you know what's
- 6 going on with that? Don't know what's going on
- 7 it, and you're going approve it tonight?

8 MS. GATELLI: No, I am going table

9 it tonight, Mr. Quinn.

10 MR. QUINN: Okay. Can you tell me

11 what happened on that?

12 MS. FANUCCI: I will do it in my

13 motions.

14 MS. GATELLI: Bill Jacowicz.

15 MS. GARVEY: Can I respond to

16 something Ozzie said?

17 MS. GATELLI: Yes.

18 MS. GARVEY: As far as the paper, it

19 was advertised on Monday, I believe, of this

20 week. It was in the paper in the legal

21 section. So a summary was advertised in there.

22 MR. QUINN: No, I looked at it.

23 There is no summary. It's just explaining a

24 public hearing, and you can go look at your

25 office. A summary means that you put the

. **.**

1 projects down --

2 MS. GARVEY: The entire thing is in

3 there. I took up about four columns. I don't

4 think they put it in the same section as the

- 5 legals were. It was beyond that maybe two
- 6 pages.
- 7 MR. QUINN: Did they put it in the
- 8 comics?
- 9 MS. GARVEY: I can't control where
- 10 the Times puts it. I only get it to them to
- 11 put in the paper. And I think it is also on
- 12 the agenda of the planning commission as well.
- 13 MS. GATELLI: Mr. Jacowicz.
- 14 MR. JACOWICZ: Bill Jacowicz, south
- 15 Scranton resident. I want to speak on 5 C. and
- 16 5 D. It appears we are moving some money,
- 17 \$239,000 and also \$10,000 from two different
- 18 accounts. One of the accounts for clearing the
- 19 banks and streams. Does that have anything to
- 20 do with lower Green Ridge, and also who is
- 21 getting this money? What business will be
- 22 getting this money? Hopefully I can get an
- 23 answer for that when I'm done.
- 24 Also on 5 D. again we have \$250,000
- 25 going Rejuven Essence Management Services. Can

1 you please tell me who they are and what they

- 2 do and how this will benefit the citizens of
- 3 Scranton? Also on 7 A. on the 500 block of
- 4 Lackawanna Avenue, can you please tell me
- 5 exactly what they are doing down there? Is
- 6 this a sidewalk project and if so do you know
- 7 what type of sidewalks are they going to put in
- 8 and does it make any sense to eliminate two
- 9 bookends, Bouna Pizza and Coney Island if
- 10 that's what this project is because I thought
- 11 this project was to beautify the downtown and
- 12 make the 500 block of Lackawanna Avenue look
- 13 better and more attractive to visitors and to
- 14 citizens.
- 15 If we just eliminate two businesses
- 16 -- they've been in business for over 100 years
- 17 combined. You talk with visitors who come to
- 18 Scranton, family members, relatives and they
- 19 know who coney island is and they know who
- 20 Bouna Pizza is. I think council needs to exert
- 21 whatever you can exert, and let's do this
- 22 right. Seriously. We talk how much we want to
- 23 beautify the downtown and make it look better,
- 24 we want to tract people and attract businesses.
- 25 Yet we are going to eliminate two businesses

1 who have over 100 years in this city. Think

- 2 about it.
- 3 MS. GATELLI: Thank you. Ron
- 4 Ellman.
- 5 MR. ELLMAN: Hello, council. I am
- 6 Ronnie Ellman, homeowner and a member of the
- 7 taxpayers' association. I didn't show up last
- 8 week because I just get so tired beating my
- 9 head on the wall, you know, just the same thing
- 10 every week, same people talking. It just seems
- 11 like a waste of time. And all these people out
- 12 here, they just want what's best for the city.
- 13 They are not after things for themselves, but
- 14 you know, all five of you just -- you let --
- 15 you let --
- 16 MS. GATELLI: Excuse me for one
- 17 minute, but this is on agenda items only.
- 18 MR. ELLMAN: I'm sorry. I thought
- 19 -- I was outside. I thought they called me for
- 20 -- can I asking you something quick? It's not
- 21 on the agenda. I tried to talk to you about
- 22 getting this -- the Smith house torn down. You

- 23 talked about taking them down in south side.
- 24 Can you put it on a list or something?
- 25 MS. GATELLI: Yes. I will find out

•

- 1 for you.
- 2 MR. ELLMAN: I signed the wrong
- 3 sheet.
- 4 MS. GATELLI: Do you want me to put
- 5 your name on the other sheet?
- 6 MR. ELLMAN: Yeah, that's fine.
- 7 Thank you.
- 8 MS. GATELLI: David Dobson.
- 9 MR. DOBSON: Good evening, council,
- 10 Dave Dobson, taxpayers' association associate.
- 11 On 7 A. I'd also like to comment on that. That
- 12 was my main purpose for signing up at this
- 13 time. I would like the citizens of the city --
- 14 that completely wrapped around to the court and
- 15 be totally rejuvenated. I see no sense in a
- 16 patch work situation where certain places are
- 17 ignored and other ones are -- if these
- 18 businesses are supposed to kick in their fair
- 19 share maybe they should be granted an

- 20 opportunity to separate that part of the
- 21 project from the main project and put their
- 22 fair share into the sidewalks because that's
- 23 going to look terrible and it will be a
- 24 monument to the lack of cooperation in the city
- 25 for the next 30 years. That's all I have to

- 1 say on the matter. Thank you.
- 2 MS. GATELLI: Thank you. Pat
- 3 Calpin.
- 4 MR. CALPIN: Good evening. My name
- 5 is Pat Calpin. I'm from Minooka. I'm here to
- 6 oppose 6 F. the making of 3200 block of Cedar
- 7 Avenue into one way. I did sign that petition
- 8 about two years ago, but since then I've
- 9 learned that that would not be the answer to
- 10 our problem back there. And I don't know if
- 11 these two gentlemen that came with the petition
- 12 had any other agenda as to what they would like
- 13 to see down there. But I'm very badly opposed
- 14 -- very importantly opposed to turning it into
- 15 a one way.
- 16 I lived there for 55 years. And you

17 just go around the block. But you would have

18 to go around five blocks if you make it one

19 way. It is not going to help the problem. We

20 had a problem there with drug runners coming

21 from the Birney Plaza, and they would head

22 straight towards the city on Cedar Avenue and

23 it would zoom, zoom one after the other car,

24 ten cars at least in one section, one clump at

25 a time. I don't think that's the answer.

•

1 And I would like to be on the books

2 as getting my name off that petition and

3 opposed to this. Thank you.

4 MS. GATELLI: Thank you. Mr.

5 Piccolino.

6 MR. PICCOLINO: Giovanni Piccolino,

7 partner of Bouna Pizza. I just want to comment

8 on 5 C. and D. You guys give money left and

9 right to businesses in Scranton that aren't

10 guaranteed to make it, but then on 7 A., you

11 know, again you guys are living two businesses

12 that have been in the city forever that pay

13 their taxes that do stuff for the community

- 14 that really don't ask for anything but to be
- 15 included in a project -- and again I'm sure you
- 16 guys will pass it on through tonight and
- 17 exclude us as usual. But you guys give money
- 18 left and right to these businesses that aren't
- 19 guaranteed to make it, K. O. Z.s, loans, this
- 20 and that.
- 21 You have two businesses that have
- 22 been landmarks in the city forever. And for
- 23 some reason you guys continually ignore us.
- 24 Thank you.
- 25 MS. GATELLI: Dan Hubbard.
- 21
- 1 MR. HUBBARD: Good evening, Daniel
- 2 Hubbard, lower Green Ridge. I have a few
- 3 questions basically directed towards 5 C. Does
- 4 council feel that the maintenance of flood
- 5 control systems in the city is important? Does
- 6 council feel business development in the city
- 7 is important? Okay. What's more important,
- 8 protection of property or business loans? What
- 9 is council's priority? You know, you look at
- 10 the banks of Leggets Creek at Hallow Avenue and

- 11 Main Avenue are collapsing. There's a house on
- 12 Main Avenue right there against Leggets Creek
- 13 where the entire side of the bank has collapsed
- 14 and their foundation is being exposed to the
- 15 bank -- to the creek.
- 16 You look at the river banks of lower
- 17 Green Ridge that have yet to be repaired, yet
- 18 to be updated, have no corrections done to them
- 19 since the last two floods, and you're going to
- 20 pull \$239,000 from a project designated for the
- 21 clearing of river banks and streams and you're
- 22 going to give it to a hair salon that has a
- 23 state tax lien on it right now that we have no
- 24 guarantee that we will see that. It seems
- 25 council's priorities are fairly mixed up.

- 1 Yes, we like to see business
- 2 development in the city, of course. But don't
- 3 you think that the protection of the residents
- 4 of this city should be the priority of council?
- 5 To pull that exorbitant the amount money from a
- 6 project that is basically there to maintain the
- 7 river banks and streams within the boundaries

8 of city, you got to know Scranton does have its

9 flooding issues and you're going to take money

10 from a project that can help Keyser Valley,

11 east mountain, lower Green Ridge, residents

12 along Leggets Creek and you're going to give it

13 to another hair salon. It's right here. It's

14 \$239,000 being pulled from rivers -- river

15 banks and streams to be consolidated with

16 \$10,000 from a computerized mapping program so

17 that Rejuven Essence can have a \$250,000 loan

18 from the city. What is council's priority? Is

19 it another hair salon or protection of

20 property?

21 MS. GATELLI: Thank you. Is there

22 anyone else that wants to speak on the agenda?

23 MR. SPINDLER: Good evening,

24 council, Les Spindler, Scranton resident. This

25 will sound repetitive. As everyone knows, this

1 council voted five zero not to locate any

2 legislation that excludes Bouna Pizza from the

3 500 block of the Lackawanna Avenue project.

4 Now, last week was passed through -- I forget

5 three to one vote, whatever. This legislation

6 should not be passed if you people will stick

7 to your words. I just want to say, let's see

8 if you have the back bone tonight to stick to

9 your words and not pass this legislation.

10 Thank you.

11 MS. GATELLI: Anyone else?

12 MR. PATILLA: Good evening, Ms.

13 Evans. You need to excuse me. I'm a working

14 man. Excuse the dirt. I have -- I need a

15 little information from you. I need

16 information regarding the home program and the

17 E. S. G. program, and I need that information

18 because on the agenda here I see that a lot of

19 money is being taken that can help poor people

20 to, as Mr. Hubbard stated, fund another hair

21 salon. I might need one, not \$250,000 worth.

22 It doesn't make any sense.

23 This agenda -- the items on this

24 agenda shows that this administration is not

25 for the citizens, it's not for the taxpayers.

1 We went through this with Alexander's. We went

- 2 through with the coffee shop. You give our
- 3 money to places that don't benefit the average
- 4 taxpayer. You give our money to places that
- 5 don't benefit the City of Scranton. You know,
- 6 it's one little small circle, one little small
- 7 click that's surviving on our backs. We're
- 8 tired if it. If you want to give them
- 9 \$250,000, give them some of your money. We
- 10 want our money to go to educate ours kid. We
- 11 want the emergency shelter money there for
- 12 people whose houses catch on fire who need that
- 13 money. We want the home program. We want that
- 14 money there for people who want to buy their
- 15 first home.
- 16 We don't want our money being given
- 17 to cronyism or businesses that serve no purpose
- 18 other than to line the pockets of a certain
- 19 few, you know. I'm tired of it. I'm fed up
- 20 with this because this does make any sense.
- 21 It's not right. Every week we come here. You
- 22 ignore the citizens' pleas. You ignore the
- 23 facts and figures. You can't run from them.
- 24 Those are the truth. The city is almost a half
- 25 billion dollars in debt now. This man is

1 continually borrowing or asking to borrow and

2 using our money in a way that is not beneficial

3 to the citizens of this city. Can I get --

4 MS. EVANS: I couldn't hear you.

5 MR. PATILLA: -- information

6 regarding the home and E. S. G. program because

7 they are taking money from poor people. I need

8 to know what those programs are.

9 MS. EVANS: I will do my best to get

10 that for you, and actually there's quite an

11 amount of money being allocated through

12 community development block grants to these

13 programs that we will be voting on tonight, so

14 I think you might be very interested to see

15 what those allocations are.

16 MR. PATILLA: Thank you.

17 MS. GATELLI: Anyone else?

18 MR. DAVIS: Salaam aleikam. My name

19 is Jim Davis. I'm back again with the 6 J. --

20 I have a question -- not 6 J., I'm sorry. This

21 was the one about Monroe Avenue. I can't find

22 it here. There are three initials afterwards

- 23 it was L. L. C. I was wondering if someone on
- 24 the panel could --
- 25 MR. COURTRIGHT: You lost me. Which

- 1 one are you on?
- 2 MR. DAVIS: I thought it was 5.
- 3 MS. FANUCCI: I think it's K.
- 4 MR. COURTRIGHT: 6 K.
- 5 MR. DAVIS: Linden Street and --
- 6 MS. GATELLI: Taylor Avenue.
- 7 Those are corporate initials I
- 8 believe, L. L. C.?
- 9 MR. DAVIS: Right, K., 6 K. excuse

10 me.

- 11 MR. MINORA: That means limited
- 12 liability corporation, L. L. C.
- 13 MR. DAVIS: You have a legal opinion
- 14 of that, sir? L. L. C -- L. L. C. what does
- 15 that mean?
- 16 MR. MINORA: Limited liability
- 17 corporation. They are authorized by the
- 18 Pennsylvania Corporation Code.
- 19 MR. DAVIS: By the corporation?

- 20 That's a name of a person, James Howells? Does
- 21 that mean he's not responsible?
- 22 MR. MINORA: It is a corporation.
- 23 L. L. C. is a corporation.
- 24 MS. GATELLI: Anyone else?
- 25 MS. EVANS: We have several pressing

- 1 issues on the council's agenda, first community
- 2 block grant allocations. Although I agreed
- 3 with most awards, I would like to see a few
- 4 alterations, some of which are an increase to
- 5 the police department for neighborhood police
- 6 patrols from 200,000 to at least 300,000. I
- 7 would also like the West Scranton Little League
- 8 to receive at least \$80,000 to complete perhaps
- 9 one half of their project description, and
- 10 North Scranton Little League to receive the
- 11 requested \$25,000. In addition, I believe
- 12 Meals on Wheels should receive \$55,000 for home
- 13 delivery meal production.
- 14 Also the Women's Resource Center
- 15 should be increased by at least \$100,000 in
- 16 light of the fact their federal funding has

- 17 been significantly cut under the current
- 18 administration. I am pleased that the
- 19 Community Intervention Center received an
- 20 increase over prior years and that Gordon
- 21 Avenue and Olive Street will receive \$25,000
- 22 for a flood protection project.
- 23 However, I believe there are items
- 24 whose funding should be cut. For example,
- 25 O.E.C.D contingency of \$100,000 when O. E. C.

- 28
- 1 D. is already allocated \$900,000. And I had
- 2 assessed additional areas for cuts, which I'm
- 3 not going to enumerate tonight.
- 4 Mrs. Gatelli has indicated each of
- 5 us on council should submit to her our requests
- 6 for allocations as well as those for omissions
- 7 or deductions. Secondly, the capital budget
- 8 remains in violation of the home rule charter
- 9 according to Section 904 numbers two through
- 10 five. If I might just quote from that, this
- 11 regards a five-year capital improvement budget
- 12 plan.
- 13 No. 2, list of all capital

- 14 improvements which are proposed to be
- 15 undertaken during the five fiscal years ensuing
- 16 with appropriate supporting information as to
- 17 the necessity for such improvements. Three,
- 18 cost estimated method of financing and
- 19 recommended time schedule for such
- 20 improvements.
- 21 Four, estimated annual cost of
- 22 operating and maintaining the facilities to be
- 23 constructed or acquired, and, fifth, inventory
- 24 replacement schedule for purchase and
- 25 replacement of major equipment. Now, nowhere

- 29
- 1 does the charter refer to the capital
- 2 improvement budget as a wish list. If the
- 3 mayor, however, presents this document as a
- 4 wish list, he better give it to Santa Claus and
- 5 hope he's been a very good boy. Until he can
- 6 adhere to the charter and demonstrate he can
- 7 balance budgets over consecutive years without
- 8 borrowing and tax increases, he should be keep
- 9 this capital budget and refrain from pursuing
- 10 non-specific projects.

- 11 Third, I wish to present an update
- 12 on the independent audit. Only two items have
- 13 been received by the auditors since my last
- 14 report, those being taxes receivable and access
- 15 insurance coverage in the workers' comp fund.
- 16 Six items still have not been forwarded by this
- 17 administration. Fourth, designating the 3200
- 18 block of Cedar Avenue as a one-way street,
- 19 since last week's meeting, I have received
- 20 several phone calls from residents of Oak
- 21 Avenue and Birney Avenue who oppose this
- 22 legislation.
- 23 I learned that no traffic study was
- 24 performed and that a petition, as was noted
- 25 tonight by a speaker during the public hearing,

- 1 a petition was circulated approximately two
- 2 years ago to address speeding on Cedar Avenue.
- 3 Therefore, I believe this item should be tabled
- 4 until such time as PennDOT can conduct an
- 5 independent objective traffic study of the 3200
- 6 block of Cedar Avenue, of Corey street, 3200
- 7 block of Oak Street and the applicable stretch

- 8 of Birney Avenue. Also Moosic Borough who
- 9 maintains Corey Street should be notified since
- 10 this change in direction will certainly be
- 11 effecting motorists and Corey Street.
- 12 Fifth, regarding the acceptance of
- 13 the certificate of appropriateness for the 500
- 14 block of Lackawanna Avenue development company,
- 15 this legislation should be tabled or declined
- 16 when council agreed not to entertain any
- 17 legislation -- any legislation pertaining to
- 18 the 500 block of Lackawanna Avenue, that failed
- 19 to include Bouna Pizza. Bouna Pizza was
- 20 already in litigation with the City of
- 21 Scranton.
- 22 Further, council is not being used
- 23 by either Coney Island or Bouna Pizza. These
- 24 two anchor businesses who are excluded from the
- 25 street scape project, rather I believe

- 1 adamantly it is the job of city council to
- 2 protect existing businesses that have operated
- 3 for decades and supported our city through
- 4 their annual tax dollars.

- 5 This street scape project will
- 6 jeopardize possibly the health, welfare and
- 7 safety of our citizens by failing to include
- 8 Bouna Pizza and Coney Island whose sidewalks
- 9 may collapse as others are dug beside them.
- 10 And one speaker tonight, I wanted to add, made
- 11 I thought a most appropriate comment. I am
- 12 just going to rephrase here what will be the
- 13 legacy or what picture does that leave in the
- 14 minds of people and visitors to the City of
- 15 Scranton that they would observe such a block
- 16 beautiful in the middle and bookends allowed to
- 17 deteriorate. It's acts of vindictiveness,
- 18 nothing more, nothing less.
- 19 No. 6, approving a plan of financing
- 20 for the authority on the University of Scranton
- 21 I believe is unwise at this time. In addition
- 22 to the published Pennsylvania Economy League's
- 23 study I reported on 9/11/07, I add that neither
- 24 the university or the city has provided the
- 25 replacement fields for the South Side Complex

- 2 and promised to the city by 2005.
- 3 Kay, I would also like a letter to
- 4 Mr. Peter Arvonio, C. P. A., one of our
- 5 auditors, requesting a copy of the documents
- 6 pertaining to the excess insurance coverage
- 7 workers' comp fund. Also I would like to see a
- 8 copy of the deed for the children's library and
- 9 the Albright library. Finally, I have but two
- 10 citizens' requests, a letter to Mr. Brazil,
- 11 please pave the court behind the 1400 block of
- 12 Sloan Street between Watson, Sloan off Parrot
- 13 Avenue. This is an extension of Smith Place.
- 14 It is a dirt court and littered with
- 15 holes. Residents complain they have a
- 16 difficult time getting out of their garages
- 17 particularly in winter months. And a letter to
- 18 Mr. Dougher, can swings be placed on the swing
- 19 set at Clover Field? Residents of West
- 20 Scranton would like their young children to
- 21 enjoy a swing set while the older siblings play
- 22 midget football. And that's it.
- 23 MS. GATELLI: Thank you. Mrs.
- 24 Fanucci?
- 25 MS. FANUCCI: I'm going to be long

- 1 tonight. I'm sorry, but I have a lot to report
- 2 on. I'm going to start with the clearing banks
- 3 and streams money that was allocated in the
- 4 year of 1995.
- 5 This money was not allocated for
- 6 clearing bank and streams, but under that title
- 7 it was designated for property acquisition and
- 8 reconstruction in a certain project. It was
- 9 not used for that project. This money could
- 10 not got to lower Green Ridge or any project
- 11 with the flood in the flood project because the
- 12 army corps is there and army corps is in charge
- 13 of that project.
- 14 It is unfortunate that we cannot put

- 13 are three partners one which is out of state.
- 14 This is a huge business and a huge endeavor for

- 16 It's going to be in south side. The
- 17 reason a wellness center is important and I'm
- 18 -- this is something we can all relate to. As
- 19 part of a small business or big business when

- 20 you paid your health care insurance and you
- 21 promise that you people will take part in a
- 22 wellness program, your insurance premiums go
- 23 down.
- 24 This is the nature of this business
- 25 to help you, small business, and the big

- 1 business help your insurance premiums to go
- 2 down. The state does this right now. They
- 3 really. We all have to take part in that to
- 4 keep our insurance premiums down. They are
- 5 putting in 14 new positions. They will already
- 6 been exceeding what they were asked in the
- 7 first few months of business.
- 8 This project is not just about
- 9 beauty and -- it's about health. This is where
- 10 we're going in the future. I do think this is
- 11 wonderful, and it's also going in south side,
- 12 which to me is absolutely wonderful because
- 13 south side does need businesses.
- 14 I also want to talk about -- the
- 15 owners themselves are financing 55 percent of
- 16 this business. They are not saying we want you

17 to pay for our business. They are saying we

18 are putting in 55 percent of the money up front

19 and they are asking us to loan them the

20 250,000. This is how much money they are

21 investing. This is not just about what this

22 business can do for our city. We can go to

23 there, what can this do for us. There are many

24 high end jobs this will bring. A lot of jobs

25 which we probably aren't seeing this kind of --

1 this kind of salaries in our city, which is

2 what we want.

3 I understand that a lot of times we

4 don't realize, but they did whole -- they did a

5 whole study of benefits and what they would do

6 to create their jobs and how they are going to

7 go into the schools and help the schools and

8 the children of the schools and educate them

9 and also go to the teachers so that the

10 teachers can then have their health care

11 lowered so, therefore, saving the taxpayers

12 money in that respect.

13 It's a wonderful idea and a

14 wonderful concept. I didn't want this to be
15 miscommunicated. This is not a hair salon. It

2 takers on it, now Coney Island is trying to opt

3 back into the project and the developers aren't

4 willing to perhaps entertain the amounts of

5 money that Coney Island is looking for to get

8 interests of Coney Island at the expense of a

9 project that will benefit the city. With Bouna

10 Pizza, also it is my understanding offers were

- 8 from what they said that it's because the
- 9 project is ready to go, the money needs to go
- 10 somewhere right now and that project is ready

- 15 applying for their loan and whatever money has

- 10 MS. SHUMAKER: Has it been done or
- 11 not been done?
- 12 MS. GARVEY: That hasn't been
- 13 rehabilitated yet.
- 14 MS. GATELLI: But it has gone
- 15 through all of the engineering and all that,
- 16 no?
- 17 MS. FANUCCI: This is the evaluation
- 18 money. This was not the physical --
- 19 MS. GATELLI: Right. This was
- 20 engineering money. That's been done for
- 21 Rockwell Avenue from what I know. And the
- 22 Parker Street bridge I think got it, too, on
- 23 the bridge report. So I think it really needs
- 24 to be done for the safety of the residents in
- 25 that neighborhood.

- 1 MS. SHUMAKER: But couldn't it be
- 2 taken from something other than the -- than
- 3 another bridge project that's also very needy?
- 4 MS. GATELLI: If it's not needed in
- 5 that bridge project, why would you keep it
- 6 there?
- 7 MS. SHUMAKER: I am not convinced
- 8 it's not needed. There's no proof it's not
- 9 needed as far as I can tell. So I hope we're
- 10 not coming back looking for money for Rockwell
- 11 Avenue bridge shortly. Thank you.

2 steal property. Anybody that looks at it any

8 fine on them of over \$3,000 if they don't pay

- 1 Association supports the police K. 9 drug bomb
- 2 sniffing dog. Dear friend, the Hill
- 3 Neighborhood Association is running a fund

- 6 They wish to purchase a bomb
- 7 sniffing slash drug dog. All support is
- 8 appreciated. Remember all contributions may be
- 9 made tax deductible. No amount would be too
- 10 small. Make checks payable to the H. N. A.
- 11 Scranton police K. 9 fund and mailed to the
- 12 Hill Neighborhood Association, 419 Prescott
- 13 Avenue. Cash donations may be dropped off the
- 14 hill office between 9 and 2. I got this letter
- 15 today from Chief Elliott, an unsigned letter.
- 16 So I called the chief's office to
- 17 see it had come from him. It was not signed.

- 3 different topic, did you ever get your C. D. B.
- 4 G. allocations?
- 5 MR. NEVEROSKI: No.
- 6 MS. EVANS: Here we are still giving

- 8 MR. NEVEROSKI: There's \$60,000
- 9 floating out here in limbo land that we're not
- 10 entitled to, but let's see if we are.

- 11 MS. EVANS: I'd like to see you get

14 whatever or make any accusations to that. But

15 to me the sidewalks are public domain. If I

16 went into Mr. Piccolino's business, their sign

17 clearly is stating no smoking, he could ask me

18 to leave.

19 I can smoke all the cigarettes I

20 want until I die of cancer on the curb out in

21 front of his place. So the point being that

22 what I would like to see as a taxpayer and I'm

23 sure the residents of the city might agree,

24 many of them, we don't need to have a project

25 come in lackluster.

1 MS. GATELLI: Thank you. Mr.

- 2 Piccolino.
- 3 MR. McGOFF: I'm sorry. Just wait
- 4 one second. I just want to respond to one
- 5 thing. On the snow removal item, that
- 6 committee did meet again -- just very quickly,
- 7 we were discussing the possibility of snow
- 8 emergency routes which would need to be done
- 9 with the cooperation of PennDOT since many of
- 10 those roads are state roads and we're -- we
- 11 also talked about emergency numbers and also
- 12 dedicate a vehicle for medical assistance and
- 13 medical emergencies. So it is being discussed.
- 14 MR. DOBSON: On the bus service --
- 15 bus service was cancelled. It lost the county
- 16 money, and a lot of people in my neighborhood
- 17 were homebound because they didn't -- they
- 18 didn't have busses going past their house. It
- 19 would also be a good answer to people coming
- 20 downtown getting stuck and causing a problem
- 21 and maybe getting into an accident. They can
- 22 use the bus one or two days a year even. Thank
- 23 you.
- 24 MR. PICCOLINO: Giovanni Piccolino
- 25 resident. Good evening council and fellow

- 1 Scrantonians. I had a question. Who do you
- 2 think that these decline penalties and fees for
- 3 the taxes affect the most? It's not the youth
- 4 because the youth are packing up and leaving
- 5 the city like there's a plague going on here
- 6 and that plague is our current elected
- 7 officials. It's not the elderly. With the
- 8 cost of water, sewer, gas, medication and
- 9 everything going up, your loyalty to them with
- 10 these rediculas penalties and fees, not mention
- 11 a 25 percent tax increase, followed by another
- 12 one that's almost guaranteed with a three to
- 13 two vote as usual.
- 14 I mean, where does it end? These
- 15 people are paying taxes, 20, 25 years. That's
- 16 loyalty to them? It shouldn't be that way at
- 17 all. You, Mr. McGoff, when you were talking
- 18 about the pizza shop -- to be included into
- 19 something, isn't an offer for your real estate.
- 20 It would be an offer to stay and do something.
- 21 That's not an inclusion in project. An offer
- 22 to leave is -- that's not included in a

- 23 project. I've never been offered to be
- 24 included at all.
- 25 Just like -- I really enjoyed that

- 1 commercial you did with Mayor Doherty walking
- 2 side by side just. Like you did with the first
- 3 tax increase, are you going to do it with a
- 4 second tax increase, too?
- 5 MS. GATELLI: Dan Hubbard.
- 6 MR. HUBBARD: Good evening, council,
- 7 Daniel Hubbard, lower Green Ridge. Mr.
- 8 Courtright, have we made any progress from the
- 9 response from zoning?
- 10 MR. COURTRIGHT: I have to
- 11 apologize, Mr. Hubbard. I -- they did tell us
- 12 in the meeting that you would have answers to
- 13 each and every one of those questions. We
- 14 haven't gotten them. I sent two letters out.
- 15 I don't know what else to do.
- 16 MR. HUBBARD: I just wanted to ask.
- 17 I have some questions for council in general.
- 18 There's three of them. I don't need any
- 19 response tonight, but I would like a response

- 20 to these questions.
- 21 Does Scranton have environmental
- 22 protection statutes in place? Do you feel as
- 23 council they are adequate? Do you -- do they
- 24 measure up to state and federal laws? I don't
- 25 want a response tonight, but I want a response

- 1 to those three questions.
- 2 Now, tonight -- when a business or
- 3 entity receives funding, does the funding stay
- 4 with the business or the property? In other
- 5 words, if you give a business money to renovate
- 6 a property and they leave, does that funding --
- 7 in other words, if somebody else comes into the
- 8 property, is the funding for the property or
- 9 the business?
- 10 MR. COURTRIGHT: Business.
- 11 MR. HUBBARD: Are you aware that the
- 12 Scranton Lace building was sold last year? No,
- 13 okay. Where is the \$500,000 that was given to
- 14 Lackawanna Junior College to renovate the
- 15 Scranton Lace building in 2004 because
- 16 Lackawanna Junior College no longer owns the

- 17 Scranton Lace building?
- 18 It was donated to them by the former
- 19 owners. They couldn't pull the project off
- 20 after the flood in 2004. Then it was sold to
- 21 Scranton Lace Partnership, L. L. C. When you
- 22 told me during the summer that \$500,000 was in
- 23 play, is it in play with the facility, or is it
- 24 in play with Lackawanna Junior College because
- 25 it was given to them to renovate --

.

- 1 specifically renovate the Scranton Lace
- 2 building.
- 3 So where is that half a million
- 4 dollars because they no longer own the
- 5 building. Based on the newspaper articles that
- 6 came out last week, there is going to be a
- 7 green scape project for art studios and
- 8 artisans and their families for loft
- 9 apartments, not a recreational field, not a
- 10 field house and nothing that has to do with
- 11 Lackawanna Junior College. If that half
- 12 million is still in play with Lackawanna Junior
- 13 College, why is it still in play with them?

- 14 They were given it to renovate to lace works.
- 15 They no longer own the lace works. Where's the
- 16 money? Why were they given the money and the
- 17 money was not taken back, or why was it did not
- 18 anybody question the sale of that building and
- 19 where a half a million dollars of city funds is
- 20 because it was sold in 2006? It was purchased
- 21 by Scranton Lace Affiliates, L. L. P., so it is
- 22 no longer owned by Lackawanna Junior College.
- 23 And Mayor Doherty did give them half a million
- 24 so they can demolish the old Scranton Lace
- 25 Works to make way for a new \$9 million project

- 1 including fields and houses.
- 2 So that building did change hands,
- 3 and the money either was never given to them
- 4 and I would like to know if it was or wasn't
- 5 and if it was why was it not returned.
- 6 MS. FANUCCI: Okay.
- 7 MR. HUBBARD: Thank you.
- 8 MS. GATELLI: Thank you. Liz
- 9 Hubbard.
- 10 MS. HUBBARD: Good evening, council.

- 11 Liz Hubbard, city resident and taxpayer. I
- 12 just have a couple questions. Maybe they
- 13 should be directed at Amil. Is the City of
- 14 Scranton involved in any litigation -- city
- 15 council, city itself, zoning with Daron
- 16 Company?
- 17 MR. MINORA: The City of Scranton,
- 18 not that I'm aware of.
- 19 MR. HUBBARD: Not that you're aware
- 20 of. Last week when Mr. Hubbard asked some
- 21 questions regarding the questions that you
- 22 referred to, Mr. Courtright, that zoning
- 23 doesn't seem to be answering, Mrs. Gatelli made
- 24 a comment and so did you that you couldn't
- 25 answer that because it's in litigation. You're

- 1 not in litigation with them. What I want to
- 2 know --
- 3 MR. MINORA: What I said is they are
- 4 in litigation. There's neighbors suing Daron.
- 5 According to the papers there's someone suing
- 6 Daniel all over the Daron situation. It is --
- 7 what I suggested to council was that it's

- 8 improper to take a side in litigation that's
- 9 going to be decided by a judge or a jury.
- 10 MR. HUBBARD: No, I don't think by
- 11 council demanding answers to questions asked by
- 12 a taxpayer and a citizen has anything to do
- 13 with the litigation. Those questions were
- 14 asked weeks ago.
- 15 MR. COURTRIGHT: Hold her time for a
- 16 second. Does this litigation prevent the
- 17 people from answering the questions that I gave
- 18 to them? And if you don't know the answer --
- 19 MR. MINORA: I am not sure of the
- 20 question.
- 21 MR. COURTRIGHT: You weren't here
- 22 that evening. Your brother was filling in for
- 23 you. I gave them a list of questions that Mr.
- 24 Hubbard had been bringing up each week. They
- 25 told me they would answer each one of those
- 119
- 1 questions to the best of their ability. Mr.
- 2 Hubbard gave my the questions. We turned them
- 3 over. I sent letters. Is there a reason they
- 4 are not answering? Do you know that --

- 5 MR. MINORA: Administration?
- 6 MR. COURTRIGHT: It was butler. Mr.
- 7 Wallace --
- 8 MR. MINORA: I'm not sure.
- 9 MS. EVANS: Mr. Wallace works for
- 10 the city. Attorney Butler is a part-time
- 11 solicitor for the City of Scranton, so you
- 12 posed questions to the employees of the city
- 13 Scranton for answers about Daron. Since the
- 14 city is not involved in litigation with Daron,
- 15 I can't see any reason why the city can't
- 16 provide the answers to city council.
- 17 MR. MINORA: I suspect that Attorney
- 18 butler is giving them the same advice I'm
- 19 giving you.
- 20 MR. COURTRIGHT: Would you ask
- 21 Attorney Butler why he wouldn't answer my
- 22 questions -- we will have an answer at least.
- 23 MR. HUBBARD: My question is these
- 24 questions that Daniel presented had to do with
- 25 zoning issues, environmental buffer zones,

1 things like that. What does the fact that

- 2 Daron is suing Daniel have to do with them not
- 3 answering the questions? That's all I want to
- 4 know.
- 5 MR. COURTRIGHT: I don't know. I
- 6 don't know the answer to that.
- 7 MS. HUBBARD: Is the city in cahoots
- 8 with Daron?
- 9 MR. COURTRIGHT: I hope not. Mr.
- 10 Minora will ask Mr. Butler why they are not
- 11 answering the questions I posed to them.
- 12 Hopefully we will have an answer in a week to
- 13 why they are not answering questions. They did
- 14 -- there's no two ways about it. They told me
- 15 they would answer the questions.
- 16 MR. HUBBARD: If they were presented
- 17 in writing, they would answer.
- 18 MR. COURTRIGHT: Everything was done
- 19 properly.
- 20 MR. HUBBARD: Still no answer.
- 21 MR. COURTRIGHT: We have no answers.
- 22 MR. HUBBARD: Okay. Thank you.
- 23 MR. COURTRIGHT: Thank you. Ron
- 24 Ellman.
- 25 MR. ELLMAN: I'll try to get it

- 1 right this time. Mr. McGoff, I got a quick
- 2 question. Do you intend to keep this three
- 3 minutes during your tenure?
- 4 MR. McGOFF: For the time being, I
- 5 guess this is what we're doing, yes.
- 6 MR. ELLMAN: I think -- I will

- 22 MR. COURTRIGHT: It is
- 23 inappropriate. I will not let you to say that.
- 24 MR. ELLMAN: They took our money and
- 25 squandered it.

- 1 MR. COURTRIGHT: That's your
- 2 opinion. That's your opinion. You cannot --
- 3 MR. ELLMAN: That's my opinion is
- 4 right.
- 5 MR. COURTRIGHT: You have no proof.
- 6 MR. ELLMAN: It's the opinion of
- 7 thousands of people in this city also.
- 8 MR. COURTRIGHT: They are entitled
- 9 today do. I will not allow you to say that.
- 10 MR. ELLMAN: It is said. Nothing
- 11 could be done about it. Something ought to be
- 12 done about them though. And before I leave,
- 13 Mr. Minora, in May you said that you were going
- 14 to have an opinion on the sewer rates, and
- 15 we've talked about it. You never gave it I
- 16 don't believe.

17 MR. MINORA: You have to refresh my

18 recollection. I'm not sure from the spring

19 what you're talking about.

20 MR. ELLMAN: Back in May when the

21 sewer authority was raising their rates and

22 all, you said you were going to give an opinion

23 on it. That silence is your answer?

24 MR. MINORA: That silence is your

25 time is up.

16 other questions. And as I say, I don't get any

25 I continue for a few more?

- 24 struggling just to pay for prescription drugs
- 25 and heating bills. They must pay an extra 25

1 percent just to stay in their homes? No senior

2 should be faced with the decision whether to

3 buy life saving prescription drugs or to pay

4 the taxes that allow them to stay in their

5 homes.

6 I know the city can not do much to

7 help with the cost of prescription drugs. We

8 can provide tax relief for all of Scranton

9 residents including seniors. The city of

10 Scranton currently spends far too much money on

11 lawyers and consultants which do very little to

12 improve the lives of Scranton's residents. As

13 a younger Scrantonian, it's heartbreaking for

14 me to see senior citizens such a tough

15 situation. Many of these seniors I am speaking

16 of are neighbors and relatives of mine.

17 The time too make things right is

18 now. It is not too late to change course. All

19 the spending in the City of Scranton must come

20 to an end, and property taxes must be reduced.

21 Once this is accomplished, Scranton can truly

22 begin to recover from the mistakes of the past.
