1 announcement. On next Monday, October 8th from

2 5 to 7:30 my parish, Saint Francis of Asissi is

3 having their annual pasta dinner, homemade

4 meatballs, salad and canolis. And the sauce is

5 truly the best.

6 So please try to make it over. It's

7 on Monday and Wednesday from 5 to 7:30. And on

9 I'm sure everyone up here has been --

- 18 from 12 until 5. Takeouts are available from

- 22 MS. GATELLI: Anyone else? I just
- 23 have some information also if anyone would care
- 24 to look at it. I got a letter from Mike Hanley
- 25 from United Neighbor Centers, and he watches

- 1 the meetings, and he sees a lot of things being
- 2 discussed like housing and different projects
- 3 that people address here at the podium.

5 MR. SBARAGLIA: Andy Sbaraglia,

6 citizen of Scranton. Fellow Scrantonians, 7 A.

7 for consideration for the committee for

8 community development for adoption -- in there

9 there's a little article by transferring

10 \$239,156.45 from clearing banks and streams to

11 the commercial loan program. Now, Mr. Lasky

12 came before you, oh, maybe about two months ago

13 and was discussing some stream work he wanted

14 done.

15 Now, here is money that can be used

16 since it's no longer used for this project.

17 Maybe it could be used for his project. I

18 mean, to take it and put it into another loan I

19 don't think we need another bake shop or

20 another beauty parlor or another place to trim

21 the dogs. But we need things that -- flooding.

22 I remember one man. I hope something was done

23 about it. I think he used to get flooded and

24 everything else. I guess it was behind his

25 backyard, but there's quite a lot of people

- 2 to fix up the streams beyond their homes.
- 3 Surely you should look into it before you
- 4 transfer it instead of doing it carte blanche.
- 5 Let's go to the 5 I., authorizing the mayor and
- 6 other appropriate city officials to enter a
- 7 lease agreement with First Source Bank for the
- 8 purchase of the -- the backhoes I guess they
- 9 are, little vehicles.
- 10 Anybody know a little something
- 11 about it, what it's going to cost to lease
- 12 these vehicles and the length of the lease?
- 13 You know, these -- them are garbage trucks I
- 14 believe. In fact, I think the bank I think
- 15 gave us some or leasing from a different bank.
- 16 MS. GATELLI: I did get a call from
- 17 the union president down there. He encouraged
- 18 us to pass that. They need some new pack
- 19 masters. Mr. Quinn. It's a five-year period,
- 20 Mr. Sbaraglia.
- 21 MR. QUINN: I want to know about 6
- 22 A., \$28,000 for the sale of the land to --
- 23 what's that going to be used for? Is it going
- 24 to be taxable?
- 25 MS. GATELLI: Yes, it's a private

1 person that's buying tax delinquent properties,

2 very large parcel on the corner of Cedar and

3 Locust.

4 MR. QUINN: Is that across from the

5 Creedon's flower shop -- or McCarthy flower

6 shop?

7 MR. COURTRIGHT: No, it's --

8 MS. GATELLI: A block down from

9 Smith's Restaurant.

10 MR. QUINN: That was one sold for

11 another developer, right? It was sold for a

12 developer who was supposed to put a parking

13 lot?

14 MS. GATELLI: The other one?

15 MR. QUINN: Yeah.

16 MS. GATELLI: I don't know.

17 MR. QUINN: I'm pretty sure.

18 MS. GATELLI: This one will be

19 businesses. It is a big parcel, Ozzie.

20 MR. QUINN: Transferring -- 6 B.

21 that's transferring property over on Tripps

22 Park to the school district. Does that mean

- 23 that you support an \$80 million school? Does
- 24 that --
- 25 MS. GATELLI: I don't know it would

- 1 mean that.
- 2 MR. QUINN: It's going to cost \$80
- 3 million. They already owe \$200 million.
- 4 MS. GATELLI: You need to go to the
- 5 school board to address that.
- 6 MR. QUINN: You're giving the land
- 7 to them. Are you giving it to them?
- 8 MS. GATELLI: If we vote for it,
- 9 yes.
- 10 MR. QUINN: If you vote for it, then
- 11 obviously you're supporting a \$80 million
- 12 program the taxpayers can't afford. Think
- 13 about that. Think deep about what you're
- 14 doing. Also the consideration on community
- 15 development for \$70,000 -- you know, that's a
- 16 mega million dollar corporation. What are we
- 17 looking for \$70,000 for?
- 18 MS. GATELLI: Thank you.
- 19 MR. QUINN: That's -- that's weird.

- 20 Something is wrong someplace.
- 21 MS. GATELLI: Mr. Jacowitz.
- 22 MR. QUINN: Did you count my time
- 23 that she talked?
- 24 MS. GATELLI: You wanted the answer.
- 25 It's part of your time, Mr. Quinn.

- 1 MR. MINORA: Read the rules. It's
- 2 part of your time.
- 3 MR. QUINN: Are you kidding me?
- 4 You're calling the next person?
- 5 MS. GATELLI: Yes, I am.
- 6 MR. QUINN: Boy, oh, boy.
- 7 MS. GATELLI: Everyone does it every
- 8 week. They ask if you want the answer. Then
- 9 you're at the end of your time. That's nothing

10 new.

- 11 MR. JACOWITZ: Bill Jacowitz, south
- 12 side. I want to talk about the secure county
- 13 communication compliance archive services, 7 B.
- 14 I gave you a handout. This is going up for
- 15 final vote today. E-mail -- it's an e-mail
- 16 compliance archive system to fulfill legal

- 17 requirements for the archiving of electronic
- 18 mail. I did some research on page two.
- 19 You will see that it's not a member
- 20 of the business -- better business bureau for
- 21 New York. On Page 3 it is also not a member of
- 22 the better business bureau for the national. I
- 23 found that a little surprising. May 7th, 2007
- 24 it was announced that they were building a
- 25 center in Scranton. We are pleased to formally

- 1 announce our presence in Pennsylvania and our
- 2 plans to locate a data operation center in the
- 3 City of Scranton. That was from the president
- 4 Daniel Summa. April 23, 2007, it was also
- 5 announced that they made their decision and
- 6 that Scranton had gotten a deal -- Page 9 --
- 7 it's -- it's Wall Street West gets Scranton
- 8 center, again this goes back to April and May
- 9 of 2007.
- 10 On Page 1 we have some job
- 11 announcements from the company for their
- 12 Manhattan office. As you can see, they are
- 13 full-time positions. Look at the salary,

- 14 commensurate with experience. For an admin
- 15 position, commensurate with experience. We
- 16 know what that means, entry level positions.
- 17 Financial sales, look at the salary, draw, plus
- 18 commission. That's on Page 13, draw plus
- 19 commission. And on page 15 you will see a
- 20 picture of Mayor Doherty and Austin Burke
- 21 presenting his company with a check.
- 22 This was in June of 2007. So why is
- 23 it coming up to council in September with a
- 24 final vote in October? They were given the
- 25 check in October 2007. Look at the picture on

- 1 Page 15.
- 2 MS. GATELLI: Thank you.
- 3 MR. HUBBARD: Good evening, Daniel
- 4 Hubbard. A couple quick things on SECAS, you
- 5 know, they are not actually part of the Wall
- 6 Street West Initiate. The Wall Street West
- 7 Initiative is stopping in Stroudsburg and
- 8 Easton. It will not it to make Scranton. We
- 9 do not have the fiber optic capabilities in
- 10 this area. We won't for many, many years

- 11 possibly 2012 but nothing beforehand.
- 12 Right now the cables that are strung
- 13 between New York and eastern Pennsylvania are
- 14 at their maximum for data transfer for real
- 15 time data transfer. Also this company is not
- 16 necessarily dealing with financial data. The
- 17 office in Scranton is actually going to be
- 18 there to save corporate client e-mails and
- 19 instant messages in case the client company is
- 20 sued.
- 21 So basically it's just a data
- 22 transfer facility like Cigna, Prudential have
- 23 up on Montage with only employing ten people.
- 24 For the ten people we're going to give them
- 25 \$70,000. So we are paying them \$70,000 to give

- 1 us ten jobs which we're not guaranteed because
- 2 let's face it, if they take a hit, they will
- 3 lay people off like every other company in the
- 4 area has. It's been said -- this is an article
- 5 from the Scranton Times actually August 5th of
- 6 this year that these facilities are hard to lay
- 7 out cash but does not generate return for the

- 8 company.
- 9 So they are really not too quick to
- 10 make the decisions to expand these companies.
- 11 The Wall Street West Initiative, it's not
- 12 coming here. That's not hearsay. That's a
- 13 fact. We don't have the speed capabilities for
- 14 fiberoptic to transfer the data as quick as
- 15 Wall Street would like it. So it's not
- 16 happening here.
- 17 This is directly from the director
- 18 of the Wall Street West Initiative where she
- 19 says that the -- the work will begin soon to
- 20 lay faster fiberoptic connections from New York
- 21 City and Pennsylvania but those improvements
- 22 end in Stroudsburg and Easton. Scranton is not
- 23 what we will -- we will be considered second
- 24 rung for companies who need direct data
- 25 transfer centers similar to what we have on

- 1 Montage. Regardless of what they are telling
- 2 you, the capabilities of this company aren't
- 3 there for high speed data backup. This office
- 4 in Scranton is really only going to be a

5 glorified Diversified records keeping e-mails

6 and instant messages for lawsuits.

7 MS. GATELLI: Thank you. Anyone

8 else?

9 MS. KRAKE: I would like to talk

10 about the composite pension board, which is

11 part of the agenda in the meeting and reading

12 of the minutes. At the composite pension board

13 meeting, I'm sure if you read your minutes, you

14 will see the city is going to not have to pay

15 \$1.1 million next year. It's a savings in the

16 budget. I know council I'm sure is working on

17 the budget now, so they've already seen that.

18 The reason it went down from the firemen is

19 because they haven't had a raise in five years.

20 They've also had 18 deaths. The

21 police cost will go down \$520,000. They also

22 have not had a raise in five years and also had

23 18 deaths. This is an extremely sad thing that

24 happens when you're part of Act 47 for 15 years

25 and especially under this administration.

16

1 We haven't had a raise in five years

- 2 either but we have middle management in our
- 3 union. So they base our actuary on loaded
- 4 salaries from people that do not even collect a
- 5 pension in the end.
- 6 They also -- this administration and
- 7 not through my negotiations passed a double
- 8 pension. They gave a whole group of people who
- 9 went out the door a double pension that was not
- 10 negotiated by the union president. Thank you.
- 11 MS. GATELLI: Anyone else?
- 12 MR. MORGAN: Good evening, my is
- 13 name Lee Morgan. The first thing I will talk
- 14 to is 7 A. I would like to say that Mr.
- 15 Sbaraglia is absolutely correct about 7 A., and
- 16 I think that that should be tabled. Taking
- 17 \$239,000 and diverting it anywhere else other
- 18 than cleaning out the streams or doing work on
- 19 the streams is definitely wrong.
- 20 I mean, I don't know why we did all
- 21 these flood prevention projects if we're going
- 22 to loot this fund. The other thing is -- on 5
- 23 I., don't we have an agreement with the
- 24 landfill -- DeNaples landfill they will give us
- 25 \$100,000 a year when we did the tipping fee

1 /

1 with them? If that's so, where is that money 2 going to? Didn't the mayor say that money was 3 going to be implemented to buy pack masters. I 4 am wondering why are we considering this in 5 light of that agreement? The other thing is 5 6 B., we're going to -- we're going to -- how are 7 we going to determine if it's an abandoned or a 8 junk vehicle? Are we going to tell people they 9 can't take their car off the road and park it 10 on their own private property? 11 I would like council to really look 12 at that and explain to all the people in the 13 city -- I mean, the questions that I've asked. 14 The other one I have is 6 B., when you look at 15 what the school district wants to do and that 16 council will give them 3.7 acres, the McKissick 17 report has already been undermined because now 18 we find out that contributions for the 19 campaigns to candidates was mingled in and they 20 were promised contracts and all kinds of 21 things. That report is seriously flawed due to 22 political corruption inside the city, and I

- 23 don't think in my own opinion that the city
- 24 should vote to give them any land to build any
- 25 project because the study itself is flawed.

- 1 Until we have a realistic study
- 2 without graph tied to it and without school
- 3 board members taking money, I think we've got a
- 4 serious problem.
- 5 MS. GATELLI: Mr. Morgan, please
- 6 refrain from saying those comments unless you

7 ---

- 8 MR. MORGAN: They acknowledged they
- 9 took money against ethical codes. That's their
- 10 own acknowledgment.
- 11 MS. GATELLI: Go to the school board
- 12 with that. This is city council.
- 13 MR. MORGAN: You're voting on that
- 14 and you're empowering them to build schools
- 15 even though they used a flawed design to come
- 16 up with the things they want. And the --
- 17 MS. GATELLI: Your time is up, Mr.
- 18 Morgan. Thank you. Anyone else?
- 19 MR. DOBSON: Dave Dobson, resident

20 of Scranton. On 5 B. I would tend to agree. I

21 would be concerned about getting those fines

- 22 excessive because all you -- unless somebody
- 23 scoffs at the situation and refuses to move an
- 24 absolutely ridiculous vehicle.
- 25 However, I've been noticing that

- 1 there's a lot of residences in this town
- 2 lacking adequate garbage buckets or trash
- 3 barrels. A few weeks ago somebody mentioned
- 4 about skunks. Whenever I take my dog out in
- 5 the yard in the evening I am using a flashlight
- 6 nowadays, and I see -- I walk him through the
- 7 courts, and I do see quite a few people that
- 8 are just depositing bags on Wednesday night or
- 9 whatever. And Thursday morning is trash pickup
- 10 or Friday -- I think it's -- yeah, Friday. And
- 11 here these bags are sitting for two days. It's
- 12 a skunk restaurant. It's a skunk restaurant.
- 13 They just -- it just attracts them. So if we
- 14 are going to have a staunch cleanup, let's
- 15 start with some regulation trash barrels and so
- 16 forth so these animals can't get in there.

- 17 If they can't get the food, they
- 18 will find somewhere else to go. They will go
- 19 back up in the woods where they belong. Thank
- 20 you, and have a good night.
- 21 MS. GATELLI: Anyone else?
- 22 MS. EVANS: Good evening. Last
- 23 Tuesday, September 25th, each council member
- 24 received a packet of documents pertaining to
- 25 the 500 block of Lackawanna Avenue project.

- 20
- 1 Having reviewed this information, particularly
- 2 the cooperation agreement, I can state
- 3 unequivocally that if I were the owner of Coney
- 4 Island, I, too, would refuse to sign.
- 5 This document in my opinion
- 6 significantly benefits and protects the
- 7 developer, not the business owners. The
- 8 apparent secrecy and dishonesty with which this
- 9 project has proceeded is shameful. I do
- 10 believe that our council solicitor is going to
- 11 attempt to speak to the parties involved and
- 12 bring that information back to council. And at
- 13 that point I am hoping very much that a meeting

14 among all the parties, city council, O. E. C.

15 D., developer, business owners and respective

16 attorneys will take place because I do believe

17 it is the job of an elected official to protect

18 businesses in this city, especially those that

19 have existed for decades and have supported

20 this city without question.

21 It is, indeed, unfortunate that the

22 -- in Scranton is blinded by mayors and its own

23 grandiose vision. Scranton is not a college

24 town, and the University of Scranton is not the

25 biggest economic engine in our city. Rather,

21

1 it's the taxpayers and business owners who are

2 the biggest economic engine by means of the

3 oppressive taxes that we're all forced to pay.

4 I believe there's only one test, one question,

5 in fact, to determine the benefit of the

6 university six block street scape project for

7 their campus.

8 Does it make your life easier or

9 better? Put it this way. Let's say you live

10 in North Scranton and your paycheck isn't

- 11 keeping pace with your mortgage and your bills
- 12 and your taxes any longer. Across down in
- 13 south Scranton your friend puts in new
- 14 sidewalks and new landscaping at his house.
- 15 Does that pay your bills? Does that save your
- 16 home from foreclosure? I think not. It's a
- 17 wonderful improvement for your friend and his
- 18 neighbors in the block. But your friend can
- 19 afford it, and it is his property. But what
- 20 does it do for you and your financial jeopardy?
- 21 Zero.
- 22 I also have the latest report on the
- 23 independent audit. The auditors still need
- 24 responses to the following memos, again a
- 25 general fund bank reconciliation from June,

- 1 special city's cash accounts, FEMA flood
- 2 protection, summer and November 2006 flooding,
- 3 special city's east mountain road, special
- 4 city's receivables and payables, special city's
- 5 journal entries. And once again as of last
- 6 week they do not have a copy of the Scranton
- 7 Parking Authority's 2006 audit report. And,

8 No. 3, they are still awaiting responses from

9 three confirmation letters from attorneys, so

10 it appears there's been very little progress

11 since last week on the financial front as well.

12 The 2007 Commonwealth allocation of

13 general municipal pension systems state paid in

14 the amount of 2,760,702.73 was received on

15 September 27th, 2007, by the city treasurer.

16 Finally, the officers of Channel 61 have been

17 asking for a meeting with council since we

18 reconvened on September 11th.

19 Meanwhile I'm sure we all are aware

20 that Comcast has significantly increased our

21 rates and should be coming up for a contract

22 renewal sometime in the future. I had asked my

23 honorable colleagues to consider allocating any

24 excess above what is listed in the 2007

25 operating budget for cable T.V. revenue to

23

1 Channel 61 last spring. I am going to ask them

2 to consider this again and to meet with channel

3 61 officers to hear their suggestions for

4 possible funding.

5 And I do have a report on the moneys

6 received from Comcast and formerly Adelphia for

7 2006 and 2007. We're still awaiting the

8 payment for 7/1/07 through 9/30/07, and their

9 final payment for calender year or budget year

10 is not received until the first financial

11 quarter of the following year.

12 So that's available for anyone to

13 take a look at. And that's it.

14 MS. GATELLI: Thank you. Mrs.

15 Fanucci?

16 MS. FANUCCI: Last week there was

17 some conversation on the Sloan field not

18 getting block grant funding. I did want to

19 check on that. The reason they did not receive

20 the money is they did not qualify for low to

21 moderate income. I believe their percentage

22 was 46 percent, which is the figures they sent

23 to O. E. C. D. That's not what we do. They

24 send that in and submit it. You need to be 52

25 percent to qualify for the money. That's why

24

1 they didn't receive the money.

- .

- 2 So I'm -- I just wanted to say that,
- 3 you know, it wasn't that it was being kept
- 4 somewhere, it was they did not qualify. Also,
- 5 I want to -- I had a phone call from a business
- 6 owner downtown -- misinformation was put out in
- 7 this forum -- Poochie is the -- the owner of
- 8 the business downtown. They are open, and they
- 9 are going to stay open. They are not closing.
- 10 They were a little upset because from here
- 11 someone --a regular speaker had gotten up and
- 12 said they were closing their doors. And they
- 13 had lot of fashion shows and things like that
- 14 set up, and people were calling very upset. I
- 15 do want to say go down to Poochie and get
- 16 yourself -- if you have a dog or cat -- get
- 17 some fun and functional stuff. Go down there
- 18 and support our businesses downtown. I'm sorry
- 19 that has happened from this forum. That's all
- 20 I have. Thank you.
- 21 MS. GATELLI: Thank you. Mr.
- 22 McGoff?
- 23 MR. McGOFF: I would like to mention
- 24 this Sunday is the Steamtown Marathon. There
- 25 is still time to register if anyone would like

1 to participate, and they are also willing to

2 take volunteers. It's the -- a really good

3 day. I do want to respond to Mr. Jacowitz who

4 asked me two questions last week, one

5 pertaining to an asphalt machine and one to a

6 pothole machine.

7 I'm assuming that the asphalt

8 machine that was a paving machine you were

9 asking about. And I was told that, yes, it is

10 -- it is used and it is in the possession of

11 the D. P. W. and the pothole machine is also in

13 Works and it is used infrequently I'm told

14 simply because of some issues they have with

15 it.

16 But both machines are still in --

- 4 sitting just a block or two away -- a cat and
- 5 mouse game. They are trying to get more teeth
- 6 to the police department to get their job done
- 7 for those of you questioning about that.
- 8 On a very good note -- a couple

- 10 gentleman whose family members from south
- 11 Scranton -- there are two senior citizens who
- 12 lost their German Shepard, and that dog -- they

- 2 That's easy enough to check. You
- 3 know what low to moderate. I don't think
- 4 there's any section of the city, namely the
- 5 upper hill that may fall out of that category.
- 6 But I think the whole other part of the city
- 7 definitely is low to moderate income. That
- 8 means all the money that they have been wasting
- 9 for investing in the different projects could
- 10 have been used for the infrastructure of the

- 11 city.
- 12 That's what's wrong with the city.
- 13 We need parks. We also need roads and
- 14 sidewalks. We need a lot of the infrastructure
- 15 to fix. Our bridges are falling apart.
- 16 Everything is falling apart. But still we're
- 17 committing to these few jobs, and now like you
- 18 say a gift. And through -- Mr. Courtright is
- 19 right that people can be in New York. They can
- 20 live in New York. They can commute here once a
- 21 week, and really you're not going to get any
- 22 wage tax. You will get the \$52. Is that worth
- 23 70,000? God knows how long it will take us to
- 24 get back to that 70,000. You don't look at
- 25 payback. You got to look at payback. If you

- 1 ever want to get out of the hole, you can't
- 2 figure on projects that will go 20 years into
- 3 the future. They just don't help us at the
- 4 point of time we're in now. We're in deep
- 5 financial trouble.
- 6 We're getting deeper and deeper and
- 7 deeper. Mr. McGoff, you weren't here. But

- 8 part of the pack masters that were used were
- 9 leased from the P.N.C. bank. That was done.
- 10 Now we're going to lease more equipment. Do
- 11 you realize how much equipment in the city we
- 12 have to lease now?
- 13 We can't afford to buy any more.
- 14 You will have the firemen bring in their own
- 15 fire engine, you know what, because the
- 16 policeman have their cars. The firemen may be
- 17 to buy their fire engines. We can move this
- 18 thing forward. But this is what is going on.
- 19 We're not using the money -- the money that
- 20 could have been used for equipment and
- 21 infrastructure is being -- is put away on
- 22 different projects, same with this thing about
- 23 the banks.
- 24 I wish Mr. Lasky was here and
- 25 realized that the money he cried for -- it was

. \_

- 1 available. Thank you.
- 2 MS. GATELLI: Thank you Mr. Quinn.
- 3 MR. QUINN: Ozzie Quinn, taxpayer.
- 4 Again, I want to emphasize the fact that what

5 you're doing with the conveying the land for

6 the Scranton School District to build an \$80

7 million school, which obviously would be near

8 almost \$200 million with the interest, you are

9 hurting the taxpayers of the City of Scranton.

10 Look into this, please.

11 I just want to mention that the

12 Times did a big thing on what happens with the

13 school board. I just hope the Scranton Times

14 will look at something in regards to the \$400

15 million indebtedness that we owe in the City of

16 Scranton. We have a B. B. rating, 25 percent

17 tax increase last year. Mr. McGoff will raise

18 it again this year. We have police and fire

19 that haven't been paid for five years, and we

20 just have a big fiasco that's going on with

21 cronyism, okay. I want to read this letter to

22 Mr. Rossi -- Robert Rossi and company about the

23 City of Scranton 2006 audit.

24 Dear Mr. Rossi, I am writing you

25 concerning the 2006 audit of the City of

1 Scranton that the Rossi and Company CPA firm is

- 2 presently performing on the contract using city
- 3 administration funds, i.e., taxpayers' money.
- 4 As you are aware, state and municipal law
- 5 permits the taxpayers to ask the city auditor
- 6 to investigate or impose a surcharge on public
- 7 officials or employees. The taxpayers
- 8 association mission is to be watchdog of local
- 9 government spending under the municipal law.
- 10 Therefore, if the annual audit is
- 11 considered a crucial event. Audit is a power
- 12 tool to insure the accountability of elected or
- 13 appointed municipal personnel. We the
- 14 taxpayers must rely on the audit to protect the
- 15 public coffers to carry out the taxpayers
- 16 association mission. The public officials have
- 17 to go into their pockets whenever they are
- 18 responsible for a financial loss suffered by
- 19 the municipality, adds an essential level of
- 20 accountability to the City of Scranton's
- 21 government.
- 22 Typically whether an official or
- 23 employee wilfully or intentionally caused an
- 24 unlawful loss to the city is -- is not
- 25 determined -- chief inquiry is whether the City

- 1 of Scranton suffered a financial loss as a
- 2 result of this -- the conduct or mismanagement
- 3 of any official or employee.
- 4 Also the financial loss by the city
- 5 need not have been one that benefitted. The
- 6 official the bottom line is the city may have a
- 7 financial loss to the extent that it exceeds
- 8 the cost that would have occurred had the
- 9 proper procedures been followed. Therefore, a
- 10 loss of taxpayers money is provided to run
- 11 government officially and with integrity. In
- 12 conclusion, the taxpayers association by
- 13 municipal law requests -- may I continue to
- 14 finish this paragraph?
- 15 MS. GATELLI: Continue your
- 16 sentence.
- 17 MR. QUINN: -- to request the Rossi
- 18 firm to investigate and impose the surcharge if
- 19 the completed audit -- audit indicates
- 20 mismanagement or lacking accountability of
- 21 taxpayers money.
- 22 It is our professional -- it is your

- 23 professional opinion if you determine that all
- 24 is well in Scranton government, so be it on
- 25 your behalf. Also Scranton officials allege

•

- 1 that municipal authorities indebtedness is not
- 2 the responsibility of the city administration,
- 3 the taxpayers. The same officials indicate
- 4 that principle should not be calculated along
- 5 with the indebtedness not -- not the interest,
- 6 okay.
- 7 We would like your firm's opinion
- 8 regarding the debt being incurred by city
- 9 authorities and commissions including the long
- 10 term interest. Ultimately it's the city
- 11 taxpayers responsible for any debt incurred by
- 12 the city administration or authorities. It is
- 13 common ground that when an individual or entity
- 14 borrows money they should be considered foolish
- 15 to calculate their repayments by principle
- 16 only.
- 17 The recipient of the loan will be
- 18 deceiving himself and the taxpayers. Also if
- 19 an individual or entity uses one credit card to

- 20 balance -- to pay off the balance of a second
- 21 credit card, they are deceiving themselves and
- 22 their taxpayers.
- 23 MS. GATELLI: Thank you.
- 24 MR. QUINN: -- tantamount to what
- 25 city administration is doing with the bonds and

- 1 loan indebtedness.
- 2 MS. GATELLI: Thank you.
- 3 MR. QUINN: We got to stop this. It
- 4 is too much down the road. Thank you.
- 5 MS. GATELLI: Mr. Spindler.
- 6 MR. SPINDLER: Good evening,
- 7 council, Les Spindler. Mrs. Fanucci, last week
- 8 you told me to say something productive. Week
- 9 after week people come to this podium and say
- 10 productive things and it goes in one ear and
- 11 out the other with you and your fellow rubber
- 12 stamps. Two weeks ago I gave two good ideas
- 13 here and nobody said a word. I said the
- 14 council should consider a public smoking ban
- 15 for minors in public places I mean and also to
- 16 ban cell phones while driving a vehicle.

- 17 Nobody said a word about that.
- 18 One is a safety issue. One is a
- 19 health issue. Those are productive things.
- 20 Nobody said a word about them. Why should we
- 21 waste our time? On talk radio, Mrs. Fanucci,
- 22 you said that people lie on the web site. Talk
- 23 about the pot calling the kettle black. You
- 24 lied about the 500 block of Lackawanna Avenue
- 25 when you voted to pass it without Bouna Pizza

- 1 being involved in it. That's funny.
- 2 The gentleman on the radio this
- 3 morning had a great idea that the elected
- 4 officials have to sign a waiver that they
- 5 understand and read all the legislation that
- 6 comes before them before they vote on it. I
- 7 firmly believe that's true because people on
- 8 city council don't even know what they are
- 9 voting on when they vote such as Mr. McGoff
- 10 voting for the 500 block of Lackawanna Avenue
- 11 project when he knew nothing about it, didn't
- 12 know who paid for the sidewalks, didn't know
- 13 what offer was made to Bouna Pizza. People

- 14 just vote because Chris Doherty wants them to
- 15 vote that way.
- 16 Lastly, I read in the paper last
- 17 week, Mrs. Gatelli, that you had a mental
- 18 breakdown and you're on medication. If this is
- 19 true, I don't think you should be up there
- 20 serving the people. You make decisions that
- 21 can cost the taxpayers thousands of dollars. I
- 22 think you should step down immediately.
- 23 MS. GATELLI: Thank you, Mr.
- 24 Spindler.
- 25 MS. FANUCCI: I think you should try

- 1 that medication.
- 2 MS. GATELLI: Reverend Simmons.
- 3 MS. SIMMONS: Reverend Kathryn
- 4 Simmons, Florence Midtown Crime Watch. I come
- 5 here this evening to take you on a little tour
- 6 of history. Ten years ago, Esther Phillips and
- 7 myself as part of Downtown Crime Watch and
- 8 Florence Midtown Crime Watch started to talk
- 9 about gangs in the city and in the area.
- 10 Of course, no one listened to us.

- 11 And it was just we were told on many occasions
- 12 that we were just middle aged housewives who
- 13 should go home and find something better for
- 14 ourselves to do.
- 15 As of today, there are 76 gangs in
- 16 this area. I don't know how you rectify that
- 17 with we didn't know what we were talking about.
- 18 We're not going to give up what we're doing
- 19 because we're not going to see any more of your
- 20 children lost. On October 18th at 3:00 at
- 21 Bethel A. M. E. church we are bringing in the
- 22 Exodus Tour. They come out of Philadelphia,
- 23 and they're coming in to talk to the citizens
- 24 of Scranton about gangs and gang activity, gang
- 25 identification and what we can do to help our

- 1 children to avoid the problems that they are
- 2 now facing.
- 3 I hope -- this is open to the public
- 4 -- and I hope that they will get a good turnout
- 5 that day because our children need to know that
- 6 mom and dad are concerned. Now, on to 9/11, on
- 7 9/11 we heard all around the city where there

8 were prayer vigils and people were remembering

9 what happened so many years ago. But the

10 people that they don't seem to remember are the

11 firemen and the policeman. They taught us that

12 day the need for these heroic men and women.

13 I don't know why we won't give them

14 a raise. I don't know -- I don't understand

15 the specifics, but I do know that if anyone

16 should be given a raise in this city it should

17 be firemen and policemen. We have General

18 Dynamics located in the middle of central city.

19 If someone should ever decide to do something

20 to that plant, who would be looking to save our

21 souls but our firemen and our policemen. Thank

22 you.

23 MS. GATELLI: Thank you. Lee

Thank you. Let

24 Morgan.

25 MR. MORGAN: Good evening, council.

1 The first thing I have here is Mrs. Gatelli

2 talked about United Neighborhood Centers, and

3 there has been some discussion here in the last

4 two weeks about help for the poor in the city

5 and what programs actually exist. We are

6 talking about supposed programs that really

7 exist here, and I just like to say that you

8 know, I -- I took a person to a lot of these

9 places for help this week. Friends of the Poor

10 gave this individual a small bag of food.

11 Catholic Social Services gave this person \$36.

12 United Neighborhood Centers gave this person a

13 small bag of food. There was no real help for

14 utilities, no real help for rent, no real

15 infrastructure to help everybody. It's time

16 for council to realize the kind of pain the

17 city is in and stop living in a mirage that you

19 I had the opportunity to talk to a

22 penalize him for paying his property taxes

23 late. He said, Lee, I took a mortgage against

24 my house so I won't get penalized \$2,600.

25 That's not the only person that spoke to me

1 about that. There have been quite a few. I

- 2 think it's time to realize this city has been
- 3 thoroughly looted by this mayor, and it has to
- 4 stop and this council has to stop it. You're
- 5 not -- you're not supposed to be politicians in
- 6 those seats. We aren't playing games. We're
- 7 passing legislation that's important for the
- 8 people.
- 9 I think 6 B. really brings it home
- 10 because, you know, during the election for
- 11 council Mr. Hartman said this was a circus.
- 12 He's on the school board. This is really a

- 19 bringing in 1,300 on high end jobs with an
- 20 average salary of \$50,000. Where? Smithfield
- 21 Township, Monroe County. Who is bringing in
- 22 these jobs? Wall Street West. Projects will

- 23 be built on 14.6 acres of land, could lead to
- 24 more than \$400 million a year in local revenue.
- 25 Smith Field Township stands to benefit \$400

- 1 million dollars, Scranton city, \$400 million in
- 2 long term debt. So I ask Mr. Austin Burke,
- 3 Mayor Doherty and councilwoman Fanucci -- I
- 4 will tell you they are concentrating on low
- 5 paying jobs and giving loans to their friends
- 6 and contributors while the citizens of Scranton
- 7 suffer.
- 8 Example, metro jobless rate
- 9 climbing, unemployment rate of Scranton has
- 10 marched steadily upward currently 5.1 percent,
- 11 still one of the highest in the state. It

- 13 worry. Help is on the way, ten high paying
- 14 jobs coming from Wall street West, only 1,290
- 15 jobs short of the Smithfield Township program.
- 16 Scranton has shown an income -- increase in
- 17 food and drink establishments, approximately 8
- 18 hundred more workers, \$2.85 an hour. Also back
- 19 to -- back to school jobs and holiday jobs will

- 20 help temporarily. Way to go, Mayor Doherty and
- 21 Mr. Austin Burke, build some more parks. The
- 22 unemployed and underpaid need somewhere to go
- 23 since they have no money.
- 24 The national unemployment rate, 4.6
- 25 percent, Pennsylvania rate 4.5 percent,

- 1 Scranton rate 5.1 percent, population decrease
- 2 to 60,500 residents, higher unemployment rates
- 3 indicate a stagnant economy with little
- 4 pressure to hire workers or rais their pay.
- 5 Thirty-fours years with high unemployment, high
- 6 unemployment in Scranton, Mr. Burke, 27 years
- 7 ass chamber -- on chamber of commerce. Good
- 8 luck with the new book store. They will need
- 9 it in downtown Scranton. And, Mr. Courtright,
- 10 again on page 14 of the handout I gave you,
- 11 financial sales jobs from SECAS, full-time
- 12 position, salary draw plus commission. Do you
- 13 think they are going to pay 60,000 or 65,000 in
- 14 Scranton when they are not even paying that in
- 15 Manhattan?
- 16 When you ask the administration for

17 an answer, it's like asking O.J. Simpson for

18 marital advice.

19 MR. McCLOE: My name is Bret McCloe,

20 Scranton taxpayer, homeowner. Last week I had

21 questioned why the City of Scranton neglected

22 to buy properties along the northern side of

23 Mulberry Street to build city owned dorms and

24 used them as a revenue generating asset for the

25 city. Then it occurred to me that decision

1 would have had to have been made 13 years ago.

2 I began to do some simple math. If in 1994 the

3 city limited the expansion of the university,

4 built its own dorms, charged rents comparable

5 or less than what they pay through tuition or

9 \$300,000 and \$3 million a year to pay off those

- 2 that creative class cities are chronic under
- 3 performers. It's a shame effected officials,

- 8 every diversity celebration and roof top party.
- 9 Beware of those who lead the way

- 8 that's probably a really good place to start.
- 9 We're paying money for space we don't need in
- 10 the Scranton Life building. Two weeks ago I
- 11 asked you guys three questions involving the
- 12 environmental protection statutes in the city.
- 13 Any chance you have answers for me on that? Do

14 we have them in place? Do you feel they are

15 adequate, and do you feel they measure up to

16 the state and federal laws? I gave you two

17 weeks. I asked for one. I gave you two. Come

18 on.

19 MS. FANUCCI: I'm not going to

20 answer that question because I really feel

21 where you're going with that is something I'm

22 certainly not going to get involved in whether

23 I believe the state is adequate or not

24 adequate. That's not -- that's not something I

25 think as a city council person I can legislate

•

1 my way through.

2 MR. HUBBARD: You are introducing an

3 ordinance for the health, safety and welfare,

4 protection of the environment of and for the

5 residents and property owners of the City of

6 Scranton.

7 So obviously, if you're introducing

8 an ordinance tonight that involves the

9 environmental protection of the property in the

10 city with junk cars, then I would hope you

- 11 would be aware of the environmental statutes in
- 12 the city.
- 13 MS. FANUCCI: I am certainly aware,
- 14 but I think it's a stretch you're going where
- 15 you're going.
- 16 MR. HUBBARD: It's a stretch?
- 17 MS. FANUCCI: Yes.
- 18 MR. HUBBARD: Do you feel our
- 19 environmental ordinances in the city are
- 20 adequate? Yes or no. It's a simple question,
- 21 yes or no. Do you feel that the ordinances is
- 22 in this city are adequate?
- 23 MS. FANUCCI: I said I'm not going
- 24 to answer.
- 25 MR. HUBBARD: Your silence speaks

- 1 volumes. I mean, you feel that --
- 2 MS. FANUCCI: I said I'm not
- 3 answering. I am not silent. I said I refused
- 4 to answer.
- 5 MR. HUBBARD: Everybody else's
- 6 silence speaks volumes. In regards to Daron
- 7 Industries the -- the Department of

- 8 Environmental Protection found it within their
- 9 authority to cite them for dust for leaving
- 10 their property. So obviously if the D. E. P.
- 11 felt that they should cite this company, don't
- 12 you think our own zoning should have in --
- 13 right along with the D. E. P. followed their
- 14 own rules? It's a simple question about the
- 15 ordinance. You're introducing an ordinance
- 16 tonight that seriously involves for the
- 17 property -- the environmental protection of the
- 18 property of the residents the City of Scranton
- 19 for junk cars.
- 20 So, you know, if the -- the city
- 21 police department stickers a car on the street,
- 22 they have 45 days to get it off there, 30 days
- 23 for the state law and usually about two weeks
- 24 of paperwork after that, and yet you're going
- 25 to pass an ordinance that gives licensing and

- 1 inspections the authority to tell somebody they
- 2 have to remove their own personal property
- 3 within 48 hours.
- 4 MS. GATELLI: Thank you.

5 MS. EVANS: Mr. Hubbard, I wanted to

6 respond to a few issues. The location of O. E.

7 C. D., that was something that council had

8 examined a year ago in the hopes saving that

9 money as you mentioned. However, O. E. C. D.

10 renewed their lease agreement without the

11 knowledge or consent of city council, I

12 believe, that would have been the summer of

13 June of 2006 -- either 2005 or 2006.

14 And in addition to that, the new

15 lease includes language for an increase in the

16 monthly rent that O. E. C. D. is paying. So

17 obviously the only way out of that situation is

18 to break the lease and that, of course, would

19 involve ourselves in yet another lawsuit. But

20 again I emphasize the fact this was done

21 without the knowledge or consent of city

22 council.

23 In addition, when you asked about

24 environmental ordinances, I am aware that D. E.

25 P. has cited Daron Northeast on more than one

1 occasion. I am aware that we have ordinances

- 2 within the city pertaining to a variety of
- 3 environmental issues. The key to those would
- 4 be enforcement -- effective enforcement, and I
- 5 think you can compose, draft, all of the
- 6 ordinances that cover just about every
- 7 situation that is detrimental to the people of
- 8 this city. But if you don't have individuals
- 9 who are willing to objectively enforce those,
- 10 then I really don't know where you're going.
- 11 So I guess my point is simply this.
- 12 You can have it on paper, but you have to have
- 13 the people who are going to follow the law
- 14 rather than follow the orders of a person above
- 15 them to keep hands off this situation or that
- 16 situation where zoning is concerned or an
- 17 environmental issue is concerned, and I think
- 18 we all know much of that goes on in this city
- 19 unfortunately.
- 20 MS. GATELLI: Mrs. Hubbard.
- 21 MS. HUBBARD: Good evening, council.
- 22 Liz Hubbard, Scranton resident, taxpayer,
- 23 whatever. I would like to know if council or
- 24 their solicitor has the answer to my question
- 25 of two weeks ago regarding why zoning is not

1 answering the questions that they said -- told

2 Mr. Hubbard to give him in writing and they

3 would answer. And I believe Mr. Minora was

4 going to speak with Mr. Butler to find out why

5 they are not answering them.

6 MR. MINORA: Haven't been able to

7 speak with them yet.

8 MS. HUBBARD: In two weeks?

9 MR. MINORA: In two weeks.

10 MS. HUBBARD: Okay. Well,

11 hypothetically speaking, don't you think that

12 if Mr. Hubbard was wrong with the questions

13 that he posed to them that they would have

14 answered them immediately? When do you tend to

15 get Mr. Butler? I would really like an answer

16 to that question.

17 MR. MINORA: I'm sorry? Were you

18 directing that question to me. I thought you

19 were directing it to council. What was the

20 question?

21 MS. HUBBARD: I want to know when

22 you are going to get a hold of Mr. Butler

- 23 because I would really like an answer to any
- 24 question s. They are --
- 25 MR. MINORA: I can't -- if I can

•

- 1 predict when somebody -- when I can get to
- 2 somebody, I would tell you, but I can't
- 3 possibly predict that. People have other jobs
- 4 and other commitments, and we haven't talked.
- 5 So you're asking me for something I can't
- 6 possibly --
- 7 MS. HUBBARD: Can you put it on your
- 8 to do list for this week maybe?
- 9 MR. MINORA: I will put it on my to
- 10 do list again.
- 11 MS. HUBBARD: Thanks, council.
- 12 That's about it for now.
- 13 MS. HUMPHREY: Good evening, all of
- 14 council. The Diocese of Scranton is having for
- 15 the bishops appeal, so I would ask everybody to
- 16 support his appeal and --
- 17 MR. COURTRIGHT: Can I interrupt you
- 18 for one second, please? In the past we asked
- 19 people not to wear any political -- just turn

- 20 it around or something just -- just people were
- 21 coming up supporting --
- 22 MS. HUMPHREY: Isn't it freedom of
- 23 expression. I'll put it here in my Dolly
- 24 Parton's treasures. I want to say hello to all
- 25 my military in the United States and all over

- 1 the world. We in the City of Scranton and the
- 2 Diocese of Scranton -- we love you. We're
- 3 proud of you, and we truly would love you to be
- 4 home with us. But due to the circumstances and
- 5 our president, he is doing the best that he
- 6 could. His mission is for justice, liberty and
- 7 freedom to all who are battered, beaten,
- 8 abused, burnt, beheaded, you name it, in other
- 9 countries. But also in our country we need
- 10 help.
- 11 We need help in the City of
- 12 Scranton. This is truly not a ghost town. We
- 13 are good people. We have our
- 14 misunderstandings. My Father said to me if you
- 15 have something to say, do not say it in public,
- 16 try as being peacemaker to get them in a huddle

17 and talk to them. And I really want to talk

18 not for you to hear with your hearts. I love

19 everyone of you's very much even in your

20 mistakes and all. We are all human. I want to

21 make this a better town. I have a holy statue

22 that's going to be put in front of the White

23 House, and there's four flags that last week

24 when I came here -- I know you cannot

25 comprehend when I says as a -- being dignified

1 being a diplomat we have to extend our hands to

2 everyone.

3 MR. COURTRIGHT: Thank you, Phyllis.

4 MS. HUMPHREY: That's all I have to

5 say. God bless you. May you all have a

6 peaceful weekend. Work things out and try to

7 do the best, but I got this. We'll be back.

8 MR. COURTRIGHT: All right. Anyone

9 else? Come on up, Mr. Davis.

10 MR. DAVIS: Salaam aleikam. My name

11 is Jim Davis. Congratulations. I met this

12 young lady ten years ago at Chick's Diner, and

13 now she's a stenographer. Congratulations.

- 14 Scranton as a lot of good success stories. I
- 15 am afraid that bypassed minorities and bypassed
- 16 the poor people and it doesn't seem like it's
- 17 ever going to go that way again from the way
- 18 we've been passing bills and the way we've been
- 19 passing jobs around here. I haven't seen where
- 20 the employment rate for non-whites has
- 21 decreased itself in Lackawanna County one iota.
- 22 As a matter of fact, it increased to 14
- 23 percent.
- 24 But if you -- again, these are all
- 25 statistics right there in Pennsylvania. I am

- 1 saying to you like this, we have been bypassed
- 2 in a lot of ways. I think maybe this election
- 3 -- maybe all minorities and all the poor people
- 4 maybe we shouldn't vote. That's an idea. If
- 5 we don't vote perhaps we can get some things
- 6 changed like on your registration form, your
- 7 race no longer optional, put down your race so
- 8 you can be counted for.
- 9 That's the only way we can plan for
- 10 the future, and that -- that is -- that's my

- 11 main thing I wanted to say tonight, yeah, let's
- 12 not vote. This election -- let's not vote and
- 13 we'll find out just what difference that makes.
- 14 You say we don't vote. You say we're not
- 15 participatory. I agree with you.
- 16 I can look at this crowd here and

- 18 Jim, why do you keep going down there and
- 19 talking to them? Why do you keep asking them

11 MR. COURTRIGHT: Thank you. Anyone

12 else?

13 MR. ROGAN: Pat Rogan, West Scranton

14 resident. Each day I watch the 5:00 news and

15 see more and more stories about crime. A large

16 percentage of these stories are coming from

17 Wilkes-Barre. Although crime has been on the

18 rise in Scranton, we've not been affected by

19 the problems as much as Wilkes-Barre has.

20 Crime in the region is on the rise and the time

21 to deal with the growing problem is now before

22 it gets out of control. The city of Scranton

23 needs to increase beat and bicycle police in

24 our neighborhoods. These neighborhood patrols

25 will not only make residents feel safer, they

79

1 will prevent crime. Criminals are less likely

2 to commit a crime if they know there will be a

3 police officer in the neighborhood.

4 This is just common sense. One

- 5 reason why residents have stayed in Scranton is
- 6 because we have relatively safe neighborhoods.
- 7 As Scranton crime rate continues to rise, many
- 8 more people will pack their bags and ship out
- 9 of town. Currently we're not spending enough
- 10 money, time or effort to keeping our city safe.
- 11 Public safety is not something that
- 12 should be taken for granted. We must be
- 13 proactive by staying ahead of the criminals.
- 14 If we continue to skirt public safety, drug
- 15 dealers and gang members will replace law
- 16 abiding tax paying residents.
- 17 Once again, I hope that council will
- 18 consider bringing back more bike and -- more
- 19 bike patrols and more beat cops. Thank you.
- 20 MR. COURTRIGHT: Thank you. Anyone
- 21 else?
- 22 MR. SLEDENZSKI: Janet, this is a
- 23 big one this week, honey. We're going to beat
- 24 him badly this week, right, Billy?
- 25 MR. COURTRIGHT: Yeah. Thank you.

1 MR. DOBSON: In the past few weeks

- 3 MR. COURTRIGHT: State your name for
- 4 the record.
- 5 MR. DOBSON: Dave Dobson, Scranton

- 20 MS. GATELLI: Thank you. Anyone
  - LEET. Thank you. Thiyon
- 21 else? Ms. Schumaker.
- 22 MS. SCHUMACHER: Marie Schumacher,
- 23 resident. First I would like to start by
- 24 saying how disappointed I was in the three --
- 25 and I am not sure which three because I had to

1 leave last week early -- that voted in favor of

- 2 the capital budget.
- 3 It's one thing to vote against the
- 4 capital budget or vote for the capital budget
- 5 when you are aware of deficiencies. But I
- 6 certainly made you aware of serious
- 7 deficiencies in that budget, not just Section
- 8 904 of crossing and Ts and dotting the I.s but
- 9 serious things that were left out of that
- 10 budget. And to vote for that I will never,
- 11 ever -- once I find out who the three of you
- 12 are will never trust you again.
- 13 I a couple weeks ago -- or maybe it
- 14 was last week -- I asked and I will ask you
- 15 again tonight -- I will wait for an answer.
- 16 Who is the city engineer?
- 17 MS. EVANS: I can answer that. At
- 18 this time the city has no engineer in its
- 19 employ. It was put out to bid. I really don't
- 20 know what happened with that bid. I do know
- 21 that there was at least one response to it and
- 22 that was quite a while back now, but we still

- 23 have not officially hired anyone. I hear that
- 24 we're in the process. Meanwhile, I've been
- 25 told that Mr. Parker is continuing to serve the

- 1 city on as needed basis and that he's providing
- 2 those services at no charge.
- 3 MS. SCHUMACHER: Thank you. But
- 4 nobody from that office returns phone calls I
- 5 can tell you. The mayor said he runs the city
- 6 like a business. I never seen a business that
- 7 didn't have a short range plan and a long range
- 8 plan. But what our mayor does is sort of
- 9 sticks his stockholders who were the taxpayers
- 10 in the eye with a sharp stick. He makes
- 11 promises in all of the capital budget. I again
- 12 -- I gave you a litany of promises the mayor
- 13 made going back to 2002, and those promises are
- 14 not in his capital budget, therefore, they are
- 15 not being fulfilled.
- 16 Businesses usually pay their debts.
- 17 I read in the paper this week of the Scranton
- 18 Abington Planning Association Scranton has not
- 19 paid \$11,603 in member fees the city owes the

- 20 association for 2007. He says the city has
- 21 owed the money since August. The city is out
- 22 soliciting for sand and all kind of things for
- 23 the coming winter. In the paper today there's
- 24 a -- there was a picture of the county -- roads
- 25 and bridges department -- did Mrs. Evans' time

•

- 1 go against me?
- 2 MS. GATELLI: Yes.
- 3 MS. EVANS: I apologize.
- 4 MS. SCHUMACHER: I'll be back next
- 5 week. I will learn.
- 6 MS. GATELLI: Do you have a lot
- 7 more? If you can finish up in a minute, I will
- 8 let you finish it up.
- 9 MS. SCHUMACHER: Well, the city
- 10 again -- the city was not -- did not
- 11 participate in this. Apparently we're too
- 12 proud to go and get something from the county.
- 13 I don't know why these taxpayers have to pay.
- 14 It may only be a small amount but it's still
- 15 something we wouldn't have to pay for. Again
- 16 another clipping, Carbondale -- I don't know,

- 17 Mrs. Gatelli. You were going to have Mr.
- 18 Minora investigate liens. Let me read to you
- 19 what another entity does.
- 20 It's a disaster, a criminal charge
- 21 can get people's attention. The city can also
- 22 place a lien on the property. This was a
- 23 condemned property. An action normally taken
- 24 to secure payment of a debt or satisfying an
- 25 obligation -- a similar situation occurred

- 1 early last month when a former owner of the
- 2 Masonic lodge was sentenced to six months in
- 3 Lackawanna County Prison for violating a Court
- 4 order. He was to apply for permits and begin
- 5 demolition of the properties condemned, and it
- 6 gives the date. What does Scranton do? We go
- 7 out and do it for them and give it to them.
- 8 Who pays? Our poor old folks who are on fixed
- 9 incomes and having their houses taken away.
- 10 MS. GATELLI: Thank you. Anyone

- 1 questioned whether the 2006 audit results had
- 2 to be used to secure the 35 million loan for
- 3 the Scranton Parking Authority.
- 4 If it had to be used and it wasn't,
- 5 why wasn't it? The audit could possibly have
- 6 been negative toward obtaining the loan. As of
- 7 August 28th, 2007, according to the Times by
- 8 Stacy Brown, staff writer, in the article the
- 9 city is still awaiting the annual audit reads a
- 10 long overdue audit is preventing Scranton from

- 11 receiving a new bond rating and has placed
- 12 potential borrowing plans by two city
- 13 authorities in jeopardy officials said Monday.
- 14 Without the audit which was due in
- 15 May, the insurance rates may also rise because
- 16 companies cannot ascertain an accurate
- 17 financial picture of the city business
- 18 administrator Leonard Kresefski said. While
- 19 the city doesn't plan to borrow money to
- 20 balance the 2008 budget, it does plan to use
- 21 tax anticipation notes for the operating
- 22 expenses at the beginning of 2008 and that
- 23 yearly practice also requires banks to view
- 24 financial records. By the way, that's one of
- 25 my predictions, the tax anticipation notes.

- 1 Without the audit, the city's credit rating can
- 2 suffer. Plans by the sewer and parking
- 3 authorities can be jeopardized. So did we get
- 4 the loan without the audit?
- 5 We must remember it is the taxpayers
- 6 who are going to be stuck with the bill if the
- 7 Scranton Parking Authority defaults on the

8 loan. How good could the Scranton Parking

9 Authority be doing if the city had to give them

10 \$725,000 this year? Shouldn't they be paying

11 their own bills and not relying on the city? I

12 said last week that the population of the city

13 is 70,000. I stand corrected, 60,500. That

14 means that the taxpayers who are paying the

15 bills have to make up the taxes for the ten

16 thousand less people.

17 Thanks again, Ms. Gatelli, Ms.

18 Fanucci and Mr. McGoff for the first 25 percent

19 tax increase, and at least two more coming. If

20 -- what about our soldiers that served in Iraq?

21 Isn't it a shame that we treat those protectors

22 of America the way we do? Thank you.

23 MS. GATELLI: Can I have a motion to

24 adjourn?

25 MS. EVANS: Motion to adjourn.
