21 MS. GARVEY: That's all there is in

22 third order. 4 A - MOTIONS.

23 MS. GATELLI: We will have our usual

24 announcements before we have our citizen's

25 participation. Today we'd like to say happy

- 1 birthday to one of our clerks in our office,
- 2 Sue Magnotta. Neil said she's 50, but I don't
- 3 think she is. He's just teasing. On Saturday,
- 4 November 3rd from 4 to 7 at the Elm Park Church
- 5 the Youth Group is having their spaghetti
- 6 dinner. It's \$6 for adults and \$3 for
- 7 children. Also in Saturday from 6 to 10 at the
- 8 Melting Pot on Washburn Street Francis Willard
- 9 PTA is having a silent auction. It's \$10 in
- 10 advance and \$15 at the door. Street light

- 11 problems, someone e-mailed me this week about
- 12 streetlights. If you have a streetlight that
- 13 is out, you can call 1-877-207-3861. Or on
- 14 your computer you can punch in www.slout.com.
- 15 The SL stands for streetlight.
- 16 When you do that they are going to
- 17 ask you for the numbers on the pole where the
- 18 light is out. There is two rows of numbers on
- 19 aluminum plates. Copy those numbers down
- 20 before you make a call or enter it into a
- 21 computer. They are usually there within 48
- 22 hours. Maybe we can ask that they put that on
- 23 the channel 61 where they have the line of
- 24 potholes and blight. Maybe we can put this on,
- 25 Kay.

- 1 Scranton High Drama Club is having a
- 2 play this Saturday. There will be a
- 3 performance at 2 and a performance at 7. It is
- 4 a family comedy called, Wooing Wed Whitinghood.
- 5 It's \$3 for all tickets. The Doitch Institute
- 6 is having their celebrity luncheon November
- 7 11th at St. Mary's Center from 9 to 1. We'd

- 8 like to thank Lutherwood. Once again they have
- 9 stepped up to the plate and gave a contribution
- 10 to the city in the amount of \$6,000. So we are
- 11 very happy, and we'd like to publically thank
- 12 Lutherwood for their contributions every year.
- 13 They are one of the very few that gives us
- 14 money in lieu of taxes.
- 15 I spoke to Linda Abley this week
- 16 about Mr. Neveroski's problem with his money in
- 17 the hill section. So she is reviewing the
- 18 file. I talked to Bob, Ozzie, and we are going
- 19 to set up a meeting to see what's up with the
- 20 money. The friendship house -- Mr. Sbaraglia
- 21 asked a question. That money is being
- 22 transferred from a Friendship House account for
- 23 a different purpose into one for heating and
- 24 new steel doors, et cetera. So it's Friendship
- 25 House money just being used in a different

/

- 1 manner. I was also told that they had three
- 2 hundred and \$2,000 I believe, and it's been
- 3 several years and they hadn't used the money.
- 4 So I asked if they could get an accounting for

5 us projects that haven't gone forward because 6 in two to three years, the projects should be 7 moving and if they haven't, we can possibly use 8 the money. And if these projects move forward 9 at a later time, they can always reapply for

10 the money. So they are going to get me a list

11 of how much money there is in old projects, and

12 I told them that we are very interested in

13 paving. So when I get that, I will share it

14 with the rest of council, and we can decide and

15 hopefully by the spring have a nice paving

16 project for the low to moderate income

17 neighborhoods.

18 I spoke to Michael Wallace this

19 week. This is an empty plant on the corner of

20 Pittston Avenue and Warner Street, and they are

21 trying to open a recycling center in there. So

22 Michael has already cited them so that the

23 people back there know that the problem is

24 being addressed.

25 1013 South Webster Avenue, I talked

1 to the contractor to, Mr. Sparrow. And he said

- 2 he would be there within the next two weeks.
- 3 It is being demolished by the owner. And it's
- 4 been a long time that the place has been
- 5 abandoned. And he said he already has the
- 6 permits and within two weeks the property
- 7 should be coming down. Mr. Wallace also went
- 8 to the south side shopping center and sent them
- 9 a letter to cease and desist.
- 10 They are always having cars for sale
- 11 in the south side shopping center. I am sure
- 12 if any of you go by you see them. When he
- 13 calls them, they get rid of them and in three
- 14 days they are back. So I told Michael that I
- 15 think we need to cite them. They are out of
- 16 town. They don't have a manager in town, and
- 17 they are creating a lot of blight. It's rather
- 18 nice down there now, and I don't like to see
- 19 that happening.
- 20 Then it also hurts the people that
- 21 are trying to sell cars legitimately. Also he
- 22 sent a letter to Paul's Auto up on Jackson
- 23 Street on October 17th, and he's giving them
- 24 ten days to get the trucks off the road. And I
- 25 think there might have been one more. They are

1 all for Paul's Auto. I did talk to Paul's Auto

2 several times. I talked to him today on the

3 phone, and he said that he would cooperate and

4 keep the cars off the road.

5 So he seems like he's going to try

6 to be a nice neighbor. Does anyone else have

7 any announcements?

8 MR. McGOFF: I would like to

9 announce again the Turkey Chase Race five K.

3 such and such contingency to account there -- a

6 they -- you can do that, but if it falls

7 through, I would gladly loan 61 that 13,000

8 with no interest. If it falls through and they

9 don't need it, fine. But if they do need it,

10 the importance of this channel to this city is

11 paramount and it should be. Anything we can do

12 to keep it going, we should do. I am having

13 canisters made up for donations.

14 Let's move on to your 6 A. The

15 question I asked on 6 A. was what was account

16 number -- from project No. 05-154 originally

17 for.

18 MS. GATELLI: A new residence.

19 MR. SBARAGLIA: That's what it was

- 20 for. They were going to build something?

- 24 the funding.

- 3 shelter grant, such and such and thus. How
- 4 much are they asking -- how many are they
- 5 trying to get this grant for? It's 7 A. You
- 6 are voting on it today for adoption. So the
- 7 dollar amount --
- 8 MS. FANUCCI: I didn't hear the
- 9 question.
- 10 MR. SBARAGLIA: What is the dollar
- 11 amount?
- 12 MS. FANUCCI: What is the dollar
- 13 amount because --
- 14 MS. GATELLI: It's for the block
- 15 grant for this coming year. I don't remember
- 16 how much it was.

17 MR. SBARAGLIA: Because --

18 MS. GATELLI: It was in the original

19 amount --

20 MR. SBARAGLIA: This thing is sort

21 of like a slush fund because I notice through

22 the year now they will be drawing money out of

23 this fund and transferring it to other things.

24 And it could be for any kind of a thing, and if

25 you -- if you look through your legislature,

2 MS. GATELLI: Mr. Quinn.

3 MR. QUINN: Ozzie Quinn, Scranton

4 taxpayer. Judy, thanks for following up for on

5 that hill neighborhood association problem and

6 also for following up on the money that's

7 collecting dust in O. E. C. D. for a number of

8 years. I want to know about 7 A. Wasn't that

9 approved?

10 MS. FANUCCI: It's up for tonight.

11 MS. GATELLI: The 30-day waiting

12 period.

13 MR. QUINN: Are any of the projects

14 in there? Nobody knows what the projects are.

15 MS. FANUCCI: They are going to be

16 making their amendments tonight.

17 MR. QUINN: Thank you so much.

18 MS. GATELLI: You're welcome. Mr.

19 Piccolino.

20 MR. PICCOLINO: Giovanni Piccolino.

21 I would like to comment on 5 B. also. I really

22 hope also that that money goes through and

23 doesn't get lost like the other 25,000 that was

24 promised. Channel 61 is a very, very good

25 thing for the City of Scranton. And as Mr.

1 Sbaraglia did -- if that somehow falls by the

2 wayside I would like to offer any kind of help

3 I can help to channel 61 also.

4 On 7 A., I kind of agreed with Mr.

5 Sbaraglia again, you don't even have any dollar

6 amounts or anything. Do you go and buy a home

7 and look at three or four rooms and purchase

8 the whole home? You guys vote on things and

9 don't know the exact dollar amounts of things.

10 These decisions are affecting thousands and

- 11 thousands of people on a daily basis. You
- 12 should have all the information before you
- 13 consider things. Thank you.
- 14 MS. GATELLI: Thank you. Go ahead.
- 15 MS. FANUCCI: Mr. Piccolino, I am
- 16 not sure you understand what this legislation
- 17 is. I am going to help you out a little bit.
- 18 This is individual projects. The money -- we
- 19 do know how much money each project is
- 20 receiving.
- 21 That was not the questions he was
- 22 asking. What he was asking was the final
- 23 amount of the projects. So we do have a list
- 24 with all of the projects, what the projects are
- 25 and how much money they will be receiving. I

- 1 don't know why you don't have the list. You
- 2 will be hearing it tonight. I'm not sure why
- 3 you didn't receive one.
- 4 MS. GATELLI: Mr. Dobson.
- 5 MS. GARVEY: Mrs. Gatelli, as far as
- 6 the block grant issue goes, it was introduced
- 7 approximately a month ago because we had the

- 8 30-day wait period. At that time it was on the
- 9 agenda in its full and it showed all of the
- 10 projects that were proposed to be funded until
- 11 tonight when you're going to be making whatever
- 12 amendments you have to make to that. So that
- 13 was available to everyone at that time about a
- 14 month ago.
- 15 MS. GATELLI: Some of them in that
- 16 one section is shelter grant money.
- 17 MS. GARVEY: Yes -- right, right.
- 18 MS. GATELLI: Although it's separate
- 19 money.
- 20 MS. GARVEY: Yes.
- 21 MS. GATELLI: Homeless money and
- 22 things of that nature?
- 23 MS. GARVEY: Right.
- 24 MS. GATELLI: Is Mr. Dobson here?
- 25 Pass, okay. Mr. Porter. Is Mr. Porter here?

- 1 How about Mrs. Schumacher?
- 2 MS. SCHUMACHER: Marie Schumacher.
- 3 I would like to also hope that you would vote
- 4 in favor of 5 B. and that the insufficient

- 5 quantity to over ride the mayor's assumed veto.
- 6 I would also like to speak to 7 B. Could
- 7 somebody tell me where that is in the capital
- 8 budget? We received the capital budget just
- 9 slightly over 60 days ago, and I don't know how
- 10 this popped out of the woodwork since then. I
- 11 can't find it in the capital budget. I would
- 12 also like to know why 7 C. is authorizing a
- 13 grant program for one pool, that being the -- I
- 14 believe this one is the Novembrino pool in the
- 15 mayor's capital budget.
- 16 There are similar requirements at
- 17 Weston Field, Weston Park, Connell Park,
- 18 Capouse Avenue, Nay Aug Park and Novembrino.
- 19 Why is there not a -- if there's grant money
- 20 available, why is there not a grant for each of
- 21 those?
- 22 MS. GATELLI: I did see one for
- 23 Connell Park, too.
- 24 MS. SCHUMACHER: I didn't.
- 25 MS. GATELLI: I did. They don't

1 necessarily have to be all done at once. And

- 2 what did she ask about 7 A? That's the Crisp
- 3 Avenue culvert. That's a flood project. The
- 4 flood --
- 5 MS. SCHUMACHER: It's not a capital
- 6 budget?
- 7 MS. GATELLI: No, I believe FEMA
- 8 will be paying for that. That will be state
- 9 and federal money. We might have a small
- 10 match, but that's -- that's a flood project
- 11 through FEMA.
- 12 MS. SCHUMACHER: Why do you have to
- 13 approve it if --
- 14 MS. GATELLI: We have to approve any
- 15 money that comes through the city, federal or
- 16 state has to go through the municipality.
- 17 MS. SCHUMACHER: No answer on 7 C.,
- 18 huh?
- 19 MS. GATELLI: Let's see.
- 20 MR. PORTER: Good evening, city
- 21 council. My name is Andrew Porter. I've been
- 22 a resident of Scranton for seven and a half
- 23 years. I've been coming to these meetings
- 24 approximately five years.
- 25 MS. GATELLI: Mr. Porter, excuse me

1 for a moment. But are you speaking on agenda

2 items or regular business?

3 MR. PORTER: Business and agenda.

4 MS. GATELLI: This is agenda only.

5 This portion of public comment is --

6 MR. PORTER: Agenda, okay. Okay. I

7 will reserve.

8 MS. GATELLI: Okay, thank you.

9 Anyone else for items on the agenda?

10 MS. HUBBARD: Elizabeth Hubbard,

11 Scranton resident. I just have a question.

12 Where is Sturgis Park?

13 MS. GATELLI: I believe it's on

14 Electric Street.

15 MS. HUBBARD: Would that be Pretzel

16 Park?

17 MS. EVANS: Pretzel Park.

18 MS. HUBBARD: How you come they are

19 spending more money to improve that than they

20 are the Novembrino Swimming Complex. Pretzel

21 Park looks pretty good to me. I don't know

22 what kind of basic improvements it needs. I

- 23 just wondered. Anybody have an answer to that?
- 24 MS. GATELLI: I think receptacles
- 25 and benches, things of that nature. It's a

- 1 grant.
- 2 MS. HUBBARD: I know, but ten
- 3 thousand dollars.
- 4 MS. GATELLI: Ten thousand dollars
- 5 isn't much at all. We have a dog park for
- 6 \$300,000.
- 7 MS. HUBBARD: You can probably
- 8 repave a block somewhere. There isn't any
- 9 there now? Now they are going to do more?
- 10 MR. COURTRIGHT: It said lights,
- 11 garbage cans, benches.
- 12 MS. HUBBARD: It must be nice.
- 13 That's right across from the mayor's house,
- 14 isn't it? Nice. Thank you.
- 15 MS. GATELLI: Mr. Morgan.
- 16 MR. MORGAN: Good afternoon,
- 17 council. I would like to state that I hope
- 18 that 5 B. passes council unanimously so there's
- 19 no chance for a mayor's veto. I have question

- 20 here on 7 B. Did council just say that that's
- 21 federal moneys and that's why there's no dollar
- 22 figure listed on that service?
- 23 MS. FANUCCI: Uh-huh.
- 24 MS. GATELLI: I believe it was put
- 25 out to bid. Is that the culvert that he's

- 1 talking about again?
- 2 MR. MORGAN: That was federal? Was
- 3 that federal money?
- 4 MS. GATELLI: FEMA money and
- 5 probably PEMA. But it was put to bid because I
- 6 saw the bids in our mailbox. The bids were

7 open.

- 8 MR. MORGAN: I just think it's
- 9 really important -- I'm not picking a position
- 10 for council. I'm just saying that no matter
- 11 whose funding any project, I think it's
- 12 important that the money is wisely spent no
- 13 matter who furnishes the dollars to the city.
- 14 MS. GATELLI: The culvert is washed
- 15 out. There is no -- those people can't get
- 16 across that mountain.

- 17 MR. MORGAN: I am not debating that
- 18 issue. What I am saying to you is we should
- 19 pay attention to the dollars and cents no
- 20 matter where the revenues --
- 21 MS. GATELLI: It was bid. That's
- 22 the only recourse we have to is bid something.
- 23 MR. MORGAN: Absolutely.
- 24 MS. GATELLI: So it was bid.
- 25 MR. MORGAN: That's why I asked --

- 1 MS. GATELLI: You have to bid
- 2 federal projects.
- 3 MR. MORGAN: That's why I asked for
- 4 clarification. I thought that council had said
- 5 in unison that it was federal money. So --
- 6 MS. GATELLI: It's probably federal
- 7 and state. We may have to put in some. I'm
- 8 not sure.
- 9 MR. MORGAN: I think that we should
- 10 pay attention to the money no matter where it
- 11 comes from and safeguard the money and make
- 12 sure it's wisely spent no matter what --
- 13 MS. GATELLI: I'm telling you it's

14 been bid. I mean, I don't know what else --

15 MR. MORGAN: It's not whether or not

16 it's been bid or not. The debate is wither

17 council is watching the dollars and cents no

18 matter where the revenue comes from. It's not

19 important whether the project's been bid. What

20 is important is, are you paying attention to

21 the -- to the money even regardless of what the

22 revenue stream is? That's my point. You

23 understand that, right?

24 MS. GATELLI: No, I really don't.

25 All I know is the people on the west mountain

•

21

1 can't get from one side to the other. So it

2 was bid, you know. There were sealed bids so

3 -- I don't know what else you can do besides

4 bidding it out, and the federal government

5 requires that. Kay, I think we do have copies

6 of the bids. I think they have been opened.

7 So if anybody wants to see the bids -- or

8 Roseanne would have them. I know I saw them.

9 I can't recall what they were.

10 MR. HIBBARD: Daniel Hubbard. In

- 11 regards to the upgrades for Sturgis Park,
- 12 didn't that park just receive new sidewalks all
- 13 around it?
- 14 MS. GATELLI: Yes.
- 15 MR. HUBBARD: And the police
- 16 department pretty much chases the kids out of
- 17 that park every single night at dark. So why
- 18 are we putting lights? And does it have
- 19 anything to do with the park being right across
- 20 the street from the mayor's house?
- 21 MS. FANUCCI: Maybe he wants to hang
- 22 out there more, Daniel.
- 23 MR. HUBBARD: They chase the kids
- 24 every night at dark. I don't see any reason
- 25 why we need to approve it. I think

- 1 specifically --
- 2 MS. FANUCCI: Safety for the
- 3 children it would be nice to have lighting
- 4 regardless if they are being -- I mean, I
- 5 wouldn't want to walk around that corner at
- 6 dark anyway or have my daughter walk around in
- 7 that corner in the dark.

- 8 MR. HUBBARD: It's been dark for as
- 9 long as I can remember.
- 10 MS. GATELLI: That was where that
- 11 kid was beat up.
- 12 MR. HUBBARD: It was dark as long as
- 13 I can remember.
- 14 MS. FANUCCI: Maybe your children
- 15 won't say the same. That will be good.
- 16 MS. GATELLI: Anyone else? Mrs.
- 17 Evans?
- 18 MS. EVANS: Good evening. Please
- 19 remember Patricia Kowalik who passed away last
- 20 week in your prayers. She was a great lady,
- 21 active in a leadership position in numerous
- 22 community activities, most notably past
- 23 president of the ladies auxiliary to the
- 24 Scranton chapter of Fraternal Order of Police.
- 25 She is missed but never forgotten by her

- 1 devoted family and friends.
- 2 She did reside across the street
- 3 from Daron Northeast. Since last week's
- 4 council meeting, I spoke with the majority

5 commissioners, and they have very generously

6 agreed to donate funds to cover costs incurred

7 by channel 61 in both the short and long-term.

8 Our gratitude to Mr. Cordaro and Mr. Munchak

9 for continued live coverage of open government.

10 These funds would be in addition to those

11 distributed by city council on tonight's agenda

12 thereby hopefully providing an approximate

13 total of \$25,000 that was promised previously

14 by council.

15 Regarding city's conflict with the

16 municipal unions, I never suggested the city

17 settle contracts on the union's terms. Rather,

18 I believed then as now that all workers -- all

19 workers are entitled to a fair living wage.

20 Our city workers have had no raise in six years

21 while gasoline prices, utility bills and taxes

22 have increased.

23 I think all people would agree that

24 all workers both union and management deserve

25 fair treatment and decent wages. Finally, I

24

1 stated at last week's meeting that the city's

- 2 elected officials should eject the Pennsylvania
- 3 Economy League and resume control of city
- 4 finances. Now, we're told only PEL can amend
- 5 the recovery plan. Thus, it seems that the
- 6 city ultimately is not in control. Rather, it
- 7 is PEL who cooperates with Mr. Doherty in
- 8 violating the recovery plan through job
- 9 creations and exceeding the financial
- 10 projections of the 2002 recovery plan.
- 11 Mr. Doherty has out borrowed and
- 12 outspent every mayor in the history of Scranton
- 13 with PEL's blessing. Who is really in control,
- 14 PEL or the mayor? Both are poor financial
- 15 managers. Lastly, I do have citizen's requests
- 16 for the week.
- 17 Memo to Mr. Brazil, please direct D.
- 18 P. W. workers to collect the garbage from the
- 19 four houses in the blocked off area of Green
- 20 Ridge Street and Capouse Avenue. Garbage and
- 21 recyclables were not picked up on Wednesday,
- 22 October 24th. Also for Mr. Brazil, please
- 23 repair the following potholes, corner of the
- 24 1100 block of Hampton Street and South Main at
- 25 the Hampton Street side, the 500 block of 12th

- 1 Avenue, the bottom of 12th Avenue just past the
- 2 stop sign on the corner as one turns up 12th
- 3 near the top of the hill parallel to the West
- 4 Scranton softball field, cluster of potholes
- 5 that vehicles try to avoid by driving into the
- 6 oncoming lane need to be filled as soon as
- 7 possible.
- 8 Also we received -- each of my
- 9 colleagues and myself -- a packet of requests
- 10 from the neighbors of Sloan and Wattson Streets
- 11 regarding problems in Smith Place. This report
- 12 includes a number of photographs of all of the
- 13 problems that have been enumerated in the
- 14 report, and I'm going to give you, Kay, my

- 16 Brazil. And please send a letter to the

- 21 And one last thing, we did receive
- 22 the latest report on the independent audit of

- 23 council. Matters remain fairly stationary with
- 24 the exception of the information for the flood

25 project.

- 1 Partial information has been
- 2 received, and the remaining information
- 3 obviously will be forthcoming from Mr. Luciani.
- 4 There have been a number of meetings
- 5 rescheduled, but it's my hope that by the next
- 6 time council meets we will hear that at least
- 7 the FEMA flood protection summer and November
- 8 flooding documentation will have been received
- 9 by Robert Rossi and Company. That's it.

9 city working with the Little Sisters of the

10 Poor and especially has for years been an

11 advocate of the Doitch Institute. The

12 scholarship is for students working in the

13 special needs area.

14 It's going to be given to a student

15 at the University of Scranton. I am told that

16 contributions are still being accepted, that if

- 17 anyone would like to help honor Mr. Gerrity
- 18 through this scholarship that they can contact
- 19 the University of Scranton. Thank you.
- 20 MS. GATELLI: Excuse me. But does
- 21 anybody know what that is noise is? Is it the
- 22 microphone? Thank you. Mr. Courtright.
- 23 MR. COURTRIGHT: Just two items.
- 24 Scranton is losing two more police officers.
- 25 Somebody might have read about Sergeant Guy

- 1 Salerno. He's leaving. Guy was a terrific
- 2 officer sergeant. He was on the job for maybe
- 3 -- I think approximately eight years as a bomb
- 4 specialist. So we are losing a good officer,
- 5 and we are also losing Corporal Casey Newcomb,
- 6 another good officer. I hate to see them
- 7 leave, and that's why I would like to see these
- 8 contracts get settled.
- 9 One other thing, I was notified of
- 10 paving being done off Keyser Avenue. And I
- 11 went back and took a look, and there's a -- I
- 12 don't know if there's a name to the road. I'm
- 13 not quite sure, but in it's between, which was

- 14 a Mobile station -- I forget the name of it now
- 15 -- and a car wash right off Keyser Avenue close
- 16 to my home.
- 17 And I don't think people are
- 18 complaining because the road is being paved. I
- 19 think they are complaining because there's many
- 20 roads that need to be paved, and they asked how
- 21 do we chose that one particular road when
- 22 there's not a great deal of traffic on it.
- 23 There are no homes on it. So I will -- I will
- 24 send an e-mail to Mr. Brazil and ask him how we
- 25 choose that one particular road because it was
- •
- 29
- 1 our DPW paving the road. I will ask him what
- 2 the criteria is forgetting roads paved because
- 3 it's offended some people. That's all I have.
- 4 MS. FANUCCI: I have the same
- 5 question this week, and I called. What they
- 6 told me was that every seven years they can
- 7 only pave a road that is in a low to moderate
- 8 income, so the problem is that -- you can't
- 9 pave a road if you were not paved seven years
- 10 before. I didn't know that. I thought you can

- 11 pave a road anytime you wanted. That's not the
- 12 case if it's being paid for by, like, CDBG or
- 13 whatever funds. So it might depend on the --
- 14 MR. COURTRIGHT: That's not low to
- 15 moderate there.
- 16 MS. FANUCCI: I am wondering if it's
- 17 the funding.
- 18 MR. COURTRIGHT: It was our DPW
- 19 doing the paving. We will ask Mr. Brazil.
- 20 MS. EVANS: Mr. Courtright, I just
- 21 wanted to piggyback on something you said about
- 22 the officers we are losing.
- 23 I am not going to name any names,
- 24 but I have had in the last few months private
- 25 conversations with two gentlemen on the police

- 1 force who are going to be leaving. And I can
- 2 tell you it's the last thing they want to do.
- 3 They love Scranton, and they want to stay here
- 4 more than anything. It was always their
- 5 greatest hope to serve in their hometown. But
- 6 they have no choice left but to take a
- 7 different position because, as I said earlier,

- 8 they hadn't had a raise in six years and they
- 9 have families and they need to be able to
- 10 support their families.
- 11 They are not anxious to move
- 12 elsewhere or put themselves on the road far
- 13 away from home for a number of years. But this
- 14 is what the situation has deteriorated into.
- 15 And not only are these officers losing, but
- 16 this is a tremendous loss for all the people of
- 17 the city. It's not just -- I don't mean to
- 18 minimize this. It is not just their personal
- 19 loss. We're all losing in this situation.
- 20 MR. COURTRIGHT: These are
- 21 experienced officers. I think you will see
- 22 another four go within the next six months.
- 23 MS. GATELLI: Hopefully we will have
- 24 a contract by then. Jeez, I hope the mayor
- 25 would sit down now with the unions and try to

- 1 work something out. It behooves everyone for a
- 2 settlement to occur.
- 3 MS. EVANS: I agree. I would love
- 4 to see that happen. But again, negotiations

5 mean give and take on two sides.

6 MS. GATELLI: Absolutely.

7 MS. EVANS: Not one side telling one

8 side take it or leave it.

9 MS. GATELLI: We know. We will be

10 having ours pretty soon, too.

11 MS. EVANS: There should be fairness

12 and respect in those negotiations, fairness for

13 all the taxpayers and fairness for all of the

14 city workers and -- I think if they would just

15 keep that in mind, I can't imagine any

16 reasonable adult not wanting to sit down and

17 iron that out.

18 MS. GATELLI: Yes. I agree. I have

19 to say though I was pleased about an article I

20 read where they are reaching out to the

21 minorities to be police officers. I read that

22 in the paper this week we have no Hispanic

23 police officers, and I believe we only have one

24 African-American. And they were doing an

25 outreach program, and it is time that they are

1 on the force.

- 2 So I was glad to see that the city
- 3 is moving in that direction. It will help
- 4 because there are a lot of Hispanics in this
- 5 community.
- 6 MS. EVANS: I am wondering though
- 7 where the city going to get the money to
- 8 educate all the officers when the city has not
- 9 got enough money to pays the officers.
- 10 MR. COURTRIGHT: What happened was
- 11 Scranton did it a little while back. I don't
- 12 know why they stopped. Wilkes-Barre does it
- 13 all the time. I happen to teach the police
- 14 academy. They -- they are paid maybe 80 some
- 15 percent, if not more, by a government agency.
- 16 So if they send a police officer there, they
- 17 get reimbursed for it. I believe they have to
- 18 pass though.
- 19 If they fail two classes, two tests,
- 20 in the police academy, they are out. So I
- 21 don't know what happened -- I know what happens
- 22 if they send somebody and fails -- it the
- 23 burden is on that person to pay for it. I'm
- 24 not sure what happens there.
- 25 MS. EVANS: It would appear just

- 1 from what we read -- you have to read with
- 2 caution -- that the city is going to be
- 3 responsible.

- 5 will people intelligent enough to pass.

- 8 of two years. I wouldn't dispute that if,
- 9 indeed, that's the case. However, the money
- 10 was withheld for so long against the requests
- 11 of Sloan.
- 12 It seems the onus would fall on the
- 13 shoulders of OECD. So I am hoping like the
- 14 Hill Neighborhood Association this can be
- 15 another matter that is satisfactorily cleared

16 up.

17 MS. FANUCCI: The only problem was

18 that Sloan was the one who filled out the

- 19 forms. They sent forms home to all the
- 20 families of the children who were participating
- 21 there. They or the people who filled out what
- 22 their income was, how many people in a median
- 23 household, all of the information -- when that
- 24 came back to OECD and they sent it out, they
- 25 did not meet the qualifications. So the

- 1 paperwork that was done -- I know you want to
- 2 say it was a cat and mouse -- it was not a cat
- 3 and mouse because it was provided by the
- 4 families of Sloan.
- 5 Maybe now things have changed which
- 6 means reapply and go through the whole routing
- 7 system again. That's the only way it can
- 8 happen because the information -- I saw the
- 9 paperwork from each family. They didn't
- 10 qualify. And, unfortunately, these situations
- 11 are overlooked not just by the city but by the
- 12 state. And there are so many rules, and they
- 13 did miss it. And I believe it was by 6 points

14 or 6 percentage points of -- to be a low mod.

15 MS. EVANS: I won't dispute that.

16 That would have been the most current figures.

17 That money was awarded years ago.

18 MS. FANUCCI: This was the for the

19 file of that money. This file was from then,

20 yeah. We can get you a copy.

21 MS. GATELLI: Do you want me to get

22 the file?

23 MS. EVANS: Yes, because in the

24 meantime --

25 MS. GATELLI: We used to do ones

1 like that for street paving. If you thought

2 your neighborhood was low to mod, sometimes it

3 doesn't come up on the census map because that

4 is 10 years old and things change in 10 years.

5 If you do an income survey in your neighborhood

6 -- I know Joan Malino used to do them al the

7 time. And if 51 percent of the block is low

8 mod, then you can get your street paved. You

9 have to do the foot work.

10 MS. EVANS: They have been working

- 11 on that over the last at least two years. I
- 12 think Mr. Courtright knows -- and, in fact,
- 13 they met with Mr. D'Angelo who had told them
- 14 they were to go and get estimates and so bids
- 15 so the work can again. So they've actually
- 16 been led to believe on more than one occasion
- 17 by that office that the money was forthcoming
- 18 and then, ironically in the last, say, six
- 19 months, they received a visit from a city
- 20 department head and inquiring to see the
- 21 insurance that they have on this field. And
- 22 they were told that all leagues, all fields
- 23 would be visited but, in fact, no others were
- 24 just them.
- 25 MS. GATELLI: I just want to piggy

- 1 back on that for a minute. All the little --
- 2 all of the little leagues are supposed to
- 3 provide insurance every year with the leases.
- 4 MS. EVANS: They had, yes.

- 6 saying there are some that aren't, they are
- 7 supposed to.

8 MS. EVANS: I am not saying there

9 are any who aren't. I know they must.

13 saying is that, you know, it just seemed a bit

14 unusual to have someone coming out and checking

15 on only one field and saying all fields would

16 be checked when, in fact, no others were. So,

- 24 after the poor people who are on a fixed
- 25 income, and they are trying to grab their

- 1 properties at a steal. You helped them. You
- 2 voted for that piece of legislation that nobody
- 3 had any kind of a heart or any feeling from the

- 6 that was really pro Doherty -- would ever vote

13 making too much money to get this or that

14 because they are not low enough income.

- 6 we're wasting a lot of money as Dennis
- 7 Yemblosky who is the secretary for economic
- 8 development for the state noted in a associated
- 9 press survey last week -- the associated press
- 10 -- I am quoting -- review records for 56
- 11 businesses that were awarded a total of 44
- 12 million in incentives in 2003 and 2004 that
- 13 were subject to state compliance audits. Only
- 14 25 or fewer than half had hired the number of
- 15 workers they promised.
- 16 I ask you as I did back in January
- 17 which I got a spin on the questions that I
- 18 asked that Kay sent over -- audit please those
- 19 people who are getting this money from our
- 20 OECD. You said earlier you can use this money
- 21 maybe in some projects that might help people
- 22 if they are not doing what they promised and
- 23 get them the heck out of there and get that
- 24 money back from them.
- 25 Also the -- from Yamblonski's

- 1 economists and academics questioned whether
- 2 such spending does much to bolster economic
- 3 growth, benefit taxpayers or revive the
- 4 depressed areas. Business executives and
- 5 development sector officials say companies
- 6 decide where to typically put more weight on
- 7 factors like the quality of the work force and
- 8 access to customers or supply chains rather
- 9 than incentives. I think these incentives
- 10 we're giving these people and they don't need

- 16 I am getting a \$21 raise. Now, is politics in

- 18 in Scranton. You people pay no attention to
- 19 what is going on to the people -- real people

20 out there. I would love to see you get off

- 21 your duff and get out and communicate with the
- 22 people in my position who need help.
- 23 There are a lot of people out here
- 24 who are property owners. They pay through the

- 16 people who are addressing real needs. I hope

- 17 that this council will have a moratorium on

- 19 will of the people and the people who really
- 20 need your help. Thank you.

- 23 Ms. Evans for showing some uncommon leadership
- 24 on this issue.
- 25 We need uncommon leaders who value

- 1 free speech and freedom of expressions more
- 2 than their political careers. The bottom line
- 3 is it's mind over matter. Without channel 61,
- 4 without voter participation, without people
- 5 actually being able to say what they want to
- 6 say responsibly, of course, most in power will
- 7 pay you no mind. And after election day you
- 8 will no longer matter. So please everyone who
- 9 -- next Tuesday get out there and vote, and do
- 10 more than just go out and vote. Speak up and

- 11 say your mind.
- 12 Everything rides on what comes out
- 13 of your mouth more than the button you push or
- 14 the -- the hole you poke in the elector. Thank
- 15 you.
- 16 MS. GATELLI: Mike Dudek.
- 17 MR. DUDEK: Mike Dudek, 608 Depot
- 18 Street, Scranton, I live in the plot. Two
- 19 quick things I will bring attention to city
- 20 council. The last time I suggested a piece of
- 21 legislation at this microphone you passed it.
- 22 That was the apartment inspection law that we
- 23 now have in the city.
- 24 I will give you two more no brainers
- 25 to pass. Given the plight of our city firemen,

- 1 city policemen and also given that rather
- 2 onerous law that says anybody who is a fireman
- 3 or policeman has to live in the City of
- 4 Scranton period, I would like to see you pass a
- 5 law suspending the real estate property tax --
- 6 the R. E. I. T. for any person who becomes a
- 7 city fireman or policeman who buys a house in

- 8 the City of Scranton.
- 9 That I think would be a help to
- 10 them. That's a no brainer. You can have that
- 11 done -- cranked out by Thanksgiving. Any
- 12 person becoming a cop or fireman in the city
- 13 who buys a house in the city wouldn't have to
- 14 pay the real estate transfer tax.
- 15 That's the first one I would like
- 16 you consider, pass, have it done by
- 17 Thanksgiving. The second one would take a
- 18 little bit longer. If you saw the booklet that
- 19 everybody got who participated in the Office,
- 20 okay, I got an idea from that booklet. Have
- 21 somebody in the OECD approach every person who
- 22 takes a job in the City of Scranton -- for
- 23 instance, from the University of Scranton or
- 24 the Scranton Times or Marywood or the hospitals
- 25 or whatever anybody that those -- that is hired

- 1 in this city, whether it's a law firm or bank
- 2 firm who has to move here who is considering
- 3 buying, say, in Clarks Summit or Dunmore or
- 4 Throop or whatever, have the OECD give them a

5 book showing all of the real estate available

6 in the city, have special coupons in that book

7 giving them free meals in the better

8 restaurants in the city, put other little

9 things in that book but severely limit the

10 number of books. Only give out a book to a

11 person who moves into the city or buys a house

12 in this city.

13 And also give them a three-year wage

14 tax -- wage tax freeze. Now, the Scranton

15 Times just hired a man. He moved his family to

16 616 Depot Street. He is an editor -- economics

17 editor. They hired him from St. Louis. It's

18 people like this who come to this city who buy

19 a house in the city who should get a three year

20 suspension of paying the wage taxes to -- to

21 encourage them to come to the city. When

22 you're buying a house, you are going to have a

23 lot of other expenses. They are going to have

24 moving expenses and whatever it's going to take

25 for him to move his family from St. Louis to

1 here.

- 2 I think people like this should get
- 3 that kind of a break, okay. And as for one
- 4 other little item, I did a walk like Mrs.
- 5 Fanucci did last week. I went down Spruce
- 6 Street and went down Washington. I found nine
- 7 other vacant store fronts. There are four
- 8 vacant store fronts on Spruce Street. There
- 9 are directly across the street from the city
- 10 administration building -- long red building
- 11 four of them right in a row all vacant. And on
- 12 North Washington Avenue the 100 block -- 119,
- 13 121, 123, 125 and 127, store fronts for rent.
- 14 MS. GATELLI: Thank you. Mr.
- 15 Piccolino.
- 16 MR. PICCOLINO: Giovanni Piccolino.
- 17 I would like to thank you, Ms. Fanucci, for yet
- 18 another unprofessional and off colored remark
- 19 you made to a citizen again which just so
- 20 happened to be me tonight. I do understand
- 21 what I talk about.
- 22 Personally, I don't think you
- 23 understand any of the legislation that is
- 24 placed in front of you. And regardless if you
- 25 did or didn't, you'd vote yes as long as mayor

- 1 Doherty told you to. I also understand --
- 2 MS. FANUCCI: I don't get you a lot
- 3 of votes, Pic. Good luck on that one.
- 4 MR. PICCOLINO: I would also -- I
- 5 understand you made the comment there are no
- 6 empty store fronts in Scranton. How about
- 7 Creedon's Floral and Abe's Deli on Wyoming
- 8 Avenue? How about Bunches on Spruce Street in
- 9 the life building? How about the whole Connell
- 10 Building on North Washington Avenue? How about
- 11 Bewitching? How about the three buildings next
- 12 to Bewitching? How about the former Kentucky
- 13 Fried Chicken building? How about the former
- 14 Rite Aide and the South Side Complex down
- 15 there?
- 16 I also understand how difficult your
- 17 constant yes votes makes it to be a businessman
- 18 in the City of Scranton. There's a few
- 19 examples, the Price Chopper on Luzerne Street
- 20 moved to Taylor because of our ridiculous taxes
- 21 that basically you and your other two comrades
- 22 up there with your yes votes? How about the

- 23 Shoppes at Montage? Half of those were in the
- 24 Steamtown Mall. They moved up there for
- 25 greener pastures and cheaper taxes.

- 1 Now our two newest ones moving out
- 2 of the city the McCann School of Business and
- 3 Geisinger Lake Scranton moving right out of
- 4 town because of you, Mrs. Gatelli and Mr.
- 5 McGoff, yes, yes, yes votes and our constant
- 6 raise in taxes. Thank you.
- 7 MS. FANUCCI: I will dually note Mr.
- 8 Piccolino has a wonderful outview on our city.
- 9 I hope all the citizen are there hoping to have
- 10 that wonderful, wonderful aspect and hope for
- 11 our city as he does. That's all.
- 12 Also I would like to say one more
- 13 thing. He was absolutely incorrect about me
- 14 stating -- you did not understand what you were
- 15 speaking of, or you made a mistake. Maybe you
- 16 should replay the tape. That might help you
- 17 out also.
- 18 MS. GATELLI: Mr. Dobson.
- 19 MR. DOBSON: Good evening, council.

- 20 This week I would like to talk about the issues
- 21 with our sewer authority. And to repeat,
- 22 Senator Kanjorski secured 20 million for
- 23 overflow prevention projects. Scranton needs
- 24 150 million for the same type of project.
- 25 And this was applauded by

- 1 organizations and agencies involved all the way
- 2 to the Chesapeake Bay as they gave it a thumbs
- 3 up, but 20 million doesn't cut it for us
- 4 unfortunately.
- 5 And in addition to sewer storm water
- 6 mix, \$4,600 miles of P. A. streams are
- 7 contaminated with acid mine water and very
- 8 little concern from the federal government in
- 9 spite of the fact that -- of the mining
- 10 reclamation act which taxes coal at \$1 a ton.
- 11 Very little of this being spent in P. A. I'm
- 12 asking everyone to please contact state and
- 13 federal congress people to provide funds.
- 14 \$150 million can cripple our city
- 15 with huge sewer fees. Another Times article,
- 16 in addition, too, estimates that 51 percent of

- 17 P. A. municipal sewers are in violation of this
- 18 act. So it's pretty much everybody or -- a
- 19 very large portion of it. So once again I'm
- 20 asking to please -- you people start from the
- 21 grass roots. That's where everything starts --
- 22 start contacting congress and try to get us
- 23 something for this because it's -- \$150 million
- 24 is -- if you put the long term value on that
- 25 you're probably talking \$300 million. And to

- 1 the voters, please get out and vote on Tuesday.
- 2 Thank you.
- 3 MS. GATELLI: Thank you. Mr.
- 4 Porter.
- 5 MR. PORTER: Good evening again,
- 6 Andrew Porter, citizen of Scranton, veteran. I
- 7 got to make it here more often because only one
- 8 list out there when I was here last and now
- 9 there's two. I am here mainly -- I've been
- 10 coming here for five years. The city will
- 11 never be as great as you say it is to be as
- 12 we'd like it to be unless it's inclusive of all
- 13 people.

- 14 Bill talked briefly about grants. I
- 15 went through that grant process thing to find
- 16 out that when grants were initially written for
- 17 -- the idea of a grant has gone 360 degrees.
- 18 Actually I am pretty upset and I ask God to
- 19 just step in here because of what had
- 20 transpired with me this weekend. I am trying
- 21 to open up a restaurant Momma's Soul Food
- 22 Restaurant. I am registered with the state
- 23 license and have an employee tax number as well
- 24 as a number of other things from the state.
- 25 Now, it rained Friday all just about

- 1 and then on Saturday continued to rain. And I
- 2 had to set up -- this Office Convention was one
- 3 that I was at -- everybody knows Al Roker. I
- 4 think you would know him not to come to the
- 5 convention not just to see him because he's
- 6 black but because he is a well known prominent
- 7 American citizen.
- 8 I would like to be known to be a
- 9 well known prominent citizen of Scranton as
- 10 well as this country also, but I'm trying to

- 11 put a business if place and moneys I thought
- 12 was available to me was not available to me.
- 13 So I have tried every way that I can to raise
- 14 money to start this business.
- 15 This business will create jobs for
- 16 the City of Scranton as well. Everyone knows
- 17 that I am cleaner than Mr. Clean and that I am
- 18 a very organized person as well. Now, it
- 19 rained hard. It took us -- took me quite some
- 20 time -- I only had the assistance of a member
- 21 of my church help me to bring things over there
- 22 to the downtown area. We were set up well. I
- 23 had my pop there.
- 24 He counted the money and stuff like
- 25 that, but I wasn't set up as we was supposed to

- 1 be set up at ten. I wasn't set up until about
- 2 12:00. Now, the position where I was located I
- 3 mean, you know, I was on Spruce Street where
- 4 most of the action took place around Linden
- 5 Street. I was pretty much a block away from
- 6 everything. I am sure Al Roker didn't know he
- 7 had some soul food there, but if he would have

- 8 like other people, maybe they would have come 9 over and had. But the persons that did have it 10 enjoyed it.
- 11 I have a problem with the city
- 12 inspector. I will tell you I was at the Unity
- 13 Festival that -- it required -- you can check
- 14 on it for me -- the city inspector to be there
- 15 to inspect food, so on and so forth. I was
- 16 also at Scranton night out and a few other
- 17 things. The bottom line is what happened to me
- 18 was that she came over to my stand. When
- 19 finally people came over after the rain had
- 20 dissipated and asked me a lot of questions, and
- 21 she was very rude and ran people away from me.
- 22 She actually said, I've been looking for you as
- 23 if I was on the F.B.I.'s most wanted list. And
- 24 I asked for I. D. She didn't have I. D.
- 25 That's my question to you. Would a city

- 1 employee like that -- should they have I. D?
- 2 MS. GATELLI: Absolutely.
- 3 MR. PORTER: That person did not
- 4 have I. D., as a matter of fact continued

- 5 harassing me by coming over to my house
- 6 yesterday. I told her I was on a business
- 7 call. Now, I have -- she said she's been
- 8 looking for me because she seen menus and
- 9 announcements -- and I know that I am over the
- 10 limit. It's very important I read this.
- 11 Momma's Soul Food Restaurant will specialize in
- 12 providing a unique blend of southern style
- 13 cooking but this restaurant is unique in that
- 14 it will be the first and only full service soul
- 15 food restaurant in the region. All right.
- 16 In addition, it will feature some
- 17 Latin American cusine so on and so forth. I
- 18 asked her because there was so many people
- 19 there if she can come back and, you know, show
- 20 me her I. D. or whatever. I didn't know who
- 21 she was. Well, she hung around with me for
- 22 quite some time. She came back a number of
- 23 times, bottom line she hassled me. Here is a
- 24 man trying to create business -- legitimate
- 25 business in Scranton and I am hassled by a city

1 employee -- I think a city employee. This is

- 2 not a good thing and not a right thing. I know
- 3 my time is up. I will be here --
- 4 MS. GATELLI: If you can stay after,
- 5 we will get more information. I apologize if
- 6 you were treated rudely. Mrs. Schumacher.
- 7 MS. GATELLI: Mr. Porter, I will
- 8 speak to you after the meeting because there's
- 9 quite a few people waiting.
- 10 MR. PORTER: Not a problem. I was
- 11 finally given a permit.
- 12 MS. GATELLI: Just keep it all
- 13 there. If you want to go now and Neil can make
- 14 some copies for us. Neil, can you make some
- 15 copies of some of his items? Mr. Porter, would
- 16 you go over to the office, please? Neil will
- 17 make some of these copies for us.
- 18 MS. SCHUMACHER: Marie Schumacher,
- 19 resident and member of the Scranton and
- 20 Lackawanna County Taxpayers and Citizen's
- 21 Association. I would like to continue
- 22 following up on some of the questions that I
- 23 was seeking answers for that I have asked over
- 24 the months and never received answers.
- 25 And I will try to be brief so

- 1 there's time within my three minutes for you to
- 2 respond. Mrs. Gatelli many, many moons ago you
- 3 said you were going to have the solicitor
- 4 research the requirement to place liens on
- 5 properties where demolition has occurred and
- 6 the property is still in private hands. I
- 7 would like a report on that. Mr. McGoff has
- 8 left. Interesting. Well, I have several for
- 9 him.
- 10 I will note them for the record
- 11 because he is the liaison with D. P. W.,
- 12 correct? In this very room back at least a
- 13 month ago the bids were open for the doggie
- 14 park at Connell Park. Mr. Brazil stated the
- 15 week of September 24th there would be a bid in
- 16 the -- request for bids in the paper for the
- 17 East Elm Street storm water project. I still
- 18 haven't seen that. Mr. Brazil still doesn't
- 19 answer phones.
- 20 He doesn't return telephone calls.
- 21 And there is -- there are several questions on
- 22 that. I would like to from Mr. McGoff --

- 23 months ago he promised flood sirens for lower
- 24 Green Ridge. I would like to know when that
- 25 flood siren was installed. I would like to

- 1 know the status of the hiring of an engineer
- 2 for the City of Scranton.
- 3 And I would like to know precisely
- 4 how much the arbitrations for the police and
- 5 fire have cost the city to date. so answers?
- 6 MS. GATELLI: The only answer I have
- 7 for you about the liens is the mayor uses it as
- 8 an economic development tool and does not place
- 9 liens on some demolitions. I don't know if
- 10 council has the authority to place those liens
- 11 on their own.
- 12 We can have Attorney Minora do that,
- 13 but generally it is the law department that
- 14 prepares the lien for a demolition property.
- 15 MS. SCHUMACHER: That seems to be a
- 16 grounds for discrimination if the mayor grants
- 17 gifts to some residents and not to others,
- 18 others he charges. So I think that's a serious
- 19 pending legal issue. Now, since Mr. McGoff is

- 20 back I will ask him.
- 21 MS. GATELLI: I don't want you to
- 22 interpret that as that I agree with that
- 23 because I don't agree with that either. I
- 24 think people should pay when they have
- 25 demolition on their property.

- 1 MS. SCHUMACHER: Mr. McGoff, when
- 2 was the flood siren installed that you promised
- 3 the residents of lower Green Ridge?
- 4 MR. McGOFF: I don't think I ever
- 5 promised that I would install a siren.
- 6 MS. SCHUMACHER: Not you personally.
- 7 MR. McGOFF: I said I would look
- 8 into it for them. There's not been one placed
- 9 there.
- 10 MS. SCHUMACHER: Several things for
- 11 the department of public works, when will the
- 12 East Elm Street storm water project be put out
- 13 for bid? Mr. Brazil said it would be the week
- 14 of the 24th September.
- 15 MR. McGOFF: I don't have a date on
- 16 it. I don't know.

- 17 MS. SCHUMACHER: What is the status
- 18 of the hiring of an engineer for the City of
- 19 Scranton?
- 20 MS. GATELLI: I know there is a part
- 21 time engineer.
- 22 MS. SCHUMACHER: Should who also
- 23 works for -- as I understand if it's -- if it's
- 24 Mike Luciani, he also works for the one of the
- 25 contractors. I think there is a conflict of

- 1 interest there but --
- 2 MS. GATELLI: I would say only if he
- 3 worked on his own project.
- 4 MS. SCHUMACHER: He doesn't return
- 5 calls either. Exactly how much, Mr. McGoff,
- 6 have the arbitrations on the police and fire
- 7 contracts cost the city to date?
- 8 MR. McGOFF: I do not know.
- 9 MS. SCHUMACHER: Okay. Thank you.
- 10 MS. GATELLI: Mr. Stucker.
- 11 MR. STUCKER: We need a light on
- 12 Mulberry by that -- where the -- when you down
- 13 Capouse down -- right where that -- there's no

- 14 light there.
- 15 MS. GATELLI: I think Mr. Courtright
- 16 said he was going to look into that for you.
- 17 MR. COURTRIGHT: We will take care
- 18 of that, Jim. What about the -- the drains,
- 19 they are all full of leaves? Do you want to
- 20 get city out there like last year with the
- 21 blower to pick up the leaves? I went by that
- 22 -- the -- that bar. I went by. The grass is
- 23 still up yet. You never got down there to cut
- 24 that. And the laundry -- the city owns the
- 25 laundry parking lot, that's all filled with

- 1 weeds around that middle thing in the middle of
- 2 the road, the little parking lot.
- 3 MS. GATELLI: Okay. We will report
- 4 that, Jim.
- 5 MR. STUCKER: They are walking down
- 6 the street around the corner -- there's people.
- 7 I don't want to mention their names right next
- 8 to the bar, they've been harassing me a lot
- 9 -- the barber shop next to Murphy's bar. They
- 10 keep harassing me every time I go up and down

- 11 that sidewalk. I told the cops about it. I
- 12 want somebody out there tell them just leave me
- 13 alone. They are blaming me for breaking a
- 14 window, and I didn't break it. I want some
- 15 chief or somebody go out there and tell them
- 16 leave me alone.
- 17 MS. GATELLI: Walk on the other side
- 18 of the street, Jim. Don't go near them.
- 19 MR. STUCKER: I don't go by them. I
- 20 just walk.
- 21 MS. GATELLI: Go the other way so
- 22 they don't bother you.
- 23 MR. STUCKER: All right, okay. What
- 24 about Parrot Avenue? Are you still going to
- 25 get the holes there fixed by Judge's Lumber?

- 1 MS. GATELLI: Yeah, we'll send them
- 2 up, okay.
- 3 MR. STUCKER: Okay. I hope you have
- 4 a good Halloween.
- 5 MS. GATELLI: Thanks, Jim. Thank
- 6 you. Have a good night. Anyone else?
- 7 MR. LAVARSKY: Tom Lavarsky, city

8 council. I am Tom Lavarsky, also a member of

9 the Scranton Lackawanna County Taxpayers.

10 Several weeks ago I came to this podium and

11 asked city council to see if there was some

12 alternative to tearing down the post office

13 building in south side.

14 Since then several people have

15 approached me with suggestions. One of them

16 was for the Book Mobile to be located down

17 there seeing as they need space. Another was

18 to have something like the Weston Field house

19 where there's game rooms, et cetera, for the

20 kids, pool tables, ping-pong tables, things of

21 that nature.

22 Another one and probably the best

23 one was to locate the branch office or the

24 branch for the library in that building. And

25 another suggestion was to use it as a studio

1 for channel 61 all of which I think are good

2 suggestions, and I would suggest that city

3 council look in -- instead of our fixation with

4 tearing down buildings to put this building to

5 use. Thank you.

6 MS. GATELLI: Thank you.

7 MR. MORGAN: Good evening, council.

8 I'm also a member of the tax group, and I -- I

9 would like to thank Mr. Rogan and Mr. Piccolino

10 for coming to the tax group and discussing in

11 front of the group and in front of the

12 residents of Scranton some of the issues that

13 are hopefully very important to them. And I

14 would also like to thank Jim Minicozzi and Mrs.

15 Orleski for coming and answering questions.

16 And, you know, you can't tell people who to

17 vote for because that's not right. But you

18 know something, at least they showed up and

19 they took part in the forum and they didn't

20 duck, bob or weave, okay. And I think that was

21 really important, and it showed leadership

22 ability in my opinion.

23 The other thing is Mr. Dudek got up

24 and spoke about a couple things. You know

25 what? I think he's somewhat on the mark. I

88

1 would like to say I think Mr. Joe Talimini has

- 2 been really listening to the people of this
- 3 city or maybe his appearances at the tax group
- 4 writing some of his articles from there -- he's
- 5 really learned a lot about the real situation
- 6 of this city that I think council and just --
- 7 in some degree has missed. This city is on its
- 8 -- absolutely on its knees, and I think that
- 9 Mr. Dudek had some of it right. I think the
- 10 transfer fee for transferring realty needs to
- 11 be abolished.
- 12 There's so many homes in the city
- 13 for sale it's mind boggling. You see signs
- 14 where somebody is trying to sell their home and
- 15 underneath it they have for sale by owner signs
- 16 also. I mean, you go through neighborhoods and
- 17 there's three or four houses for sale on the
- 18 block. Even the Scranton Times has finally
- 19 caught on to the fact that we're innidiated
- 20 with property here for sale. The other thing
- 21 is the wage tax, 2.4 percent.
- 22 That should be abolished. It should
- 23 go to zero. Then maybe some of the people who
- 24 fled the city from overtaxation maybe they will
- 25 come back. Maybe we have to live within our

1 means and cut our budget to into the ability of

2 the residents to pay it, and maybe that's why

3 our middle class has fled the city because they

4 had the ability to leave. I think that's a

5 real problem. I really do.

6 I find it so troubling that council

7 has so few answers to the legislation that

8 passes before you. And when you're asked a

9 question you say, well, I don't know the answer

10 to that. Well, we had it last week. I think

11 that when you're dealing with things as

12 important as this budget or any other city

13 business that's enacted by this council, you

14 should have all the facts and you should know

15 them. You should own that. That should be in

16 your mind.

17 You shouldn't have to go back and

18 look for sources of information. You should

19 control that information. You should have read

20 it all. And I really think that's a serious

21 problem. Or when you come and you take a look

22 at how you asked for information on something

- 23 after it's been passed, that time was before
- 24 that. Thank you.
- 25 MS. FRANUS: Fay Franus, Scranton.

•

- 1 When Mayor Doherty took office many years ago
- 2 when he hired his administration and since then
- 3 since he's become mayor, he has given his
- 4 administration staff 40 to 60 percent pay
- 5 raises.
- 6 Well, that's illegal and in complete
- 7 violation of the recovery plan, his recovery
- 8 plan that he picks and chooses when he wants to
- 9 use it. I would like to ask you, Mr. McGoff,
- 10 what have you done to ensure that there is no
- 11 way to cut back on mayor Doherty's spending
- 12 before you granted and burdened the taxpayers
- 13 with your 25 percent tax increase? What have
- 14 you done?
- 15 Have you asked the mayor to tighten
- 16 his belt before you gave him this money before
- 17 you allowed him to spend this money for his
- 18 administration staff, for consultants and
- 19 lawyers and maybe more consultants for people

20 that -- should just hired one person to do the

21 job instead of hiring four consultants to help

22 them? What have you questioned him on this?

23 MR. McGOFF: I don't think you

24 really want a response.

25 MS. FRANUS: Yes, I do. I would

1 like to know what you have said to Mayor

2 Doherty when he gave all these raises to the

3 administrators? What did you do because -- you

4 didn't get elected. You got appointed by Ms.

5 Gatelli and Ms. Fanucci and the mayor. You

6 took and oath of office to represent the

7 people, and you haven't done that. You owe

8 them -- the people that you swore to represent

9 -- you owed them the right to go to the mayor

10 and deny him that tax increase and deny him all

11 his spending but you didn't do that. I am

12 asking what have you done? What did you do?

13 MR. McGOFF: You're trying to answer

14 your own question.

15 MS. FRANUS: I want you to answer

16 it.

17 MR. McGOFF: Is the question what

18 have I done to prevent the mayor from passing a

19 budget?

20 MS. FRANUS: What did you do to stop

21 the mayor from spending all that money when he

22 gave all those raises? Did you not question

23 him? Why did you give the tax increase? That

24 money -- wouldn't need the tax increase if you

25 stopped Mayor Doherty from giving all those

1 raises, which was illegal in the first place.

2 MR. McGOFF: What raises are they?

3 MS. FRANUS: For all his

4 administration staff, example, Bill Fiorini, he

5 35,000. When the mayor took over he got

6 51,000.

7 MR. McGOFF: Was I here when --

8 MS. FRANUS: No, he's done it all

18 authorities, buildings, our buildings not --

- 9 resolved this five years ago if the mayor would

- 13 We could have settled the contracts
- 14 without the spending the tons of money spent on

- 1 vacates the appeal. It no way stops the appeal
- 2 process. We will confer with our attorney and
- 3 my bet is we will appeal the judge's opinion to
- 4 a higher court. The city is claiming victory,
- 5 but the opinion was expected and predicted to
- 6 go against the unions in local court.
- 7 We have been fighting with the city
- 8 since they would not is sit down at the
- 9 bargaining table with us. This is a setback
- 10 but nowhere near defeat for the unions. The
- 11 mayor again said, if the unions appeal the
- 12 decision they would now have to pick up the
- 13 legal bills. The mayor has to remember a

- 14 pleasantly plum couple has been singing but
- 15 it's not over until it's over.
- 16 He has tried to break the unions,
- 17 hasn't worked. Morale in the police
- 18 department, probably the other departments,
- 19 nonexistent. Grumblings of highly experienced
- 20 officers about leaving for jobs where they will
- 21 be respected and more money is echoing down the
- 22 hallways of the police department. Could I
- 23 finished this?
- 24 MS. GATELLI: Yes.
- 25 MR. ANCHERANI: It's been 32 years

- 1 since I started working for the police
- 2 department. And no matter what is said by city
- 3 officials, I have never before seen anything
- 4 like the exodus from the police department like
- 5 I see now. As I said last week, the exodus has
- 6 begun, wasted experience, wasted money for
- 7 every police officer that leaves. And there's
- 8 many good officers that are going to leave.
- 9 Thank you.
- 10 MS. GATELLI: Thank you.

- 11 MR. GERVASI: Dave Gervasi. I am a
- 12 tax payer and resident and vice president of
- 13 the fire fighters union. We wanted to get
- 14 here. Of course, I want make a comment about
- 15 the newspaper today on this award. It was a --
- 16 actually quite amusing since it hit the front
- 17 page, page 8 and editorial, second editorial
- 18 and a cartoon.
- 19 Well, this disgrace of a newspaper
- 20 knows full well this court case means nothing.
- 21 The city officials and the city attorneys know
- 22 this court case means nothing as well as the
- 23 unions know this court case means nothing. As
- 24 a matter of fact, the city officials because of
- 25 the wording of the award -- everybody

- 1 scratching their head at this point -- what

18 I got some whoppers, couple of snickers, a

3 department heads received. Pop rocks, tens of

4 millions of no bid contracts and the cops and

- 5 firemen got a rock. That's the only part that
- 6 isn't inaccurate. We didn't get anything.
- 7 Their budges went up over \$22 million since the
- 8 mayor took office. And you know who was to
- 9 blame for that? Not us. We didn't get
- 10 anything. We didn't even get a rock. So was
- 11 it trick or treat on the newspaper's part? I
- 12 would say treat. Happy Halloween. See you in
- 13 Commonwealth court.
- 14 MS. GATELLI: Anyone else?
- 15 MS. KRAKE: Good evening, council.
- 16 The mayor is saying that he did not violate the
- 17 recovery plan. Well, he has violated his own
- 18 recovery plan. He's violated everything from
- 19 the day he walked in the door. He's violated
- 20 the intent of Act 47 which was strictly
- 21 economic recovery. And, in fact, I would like
- 22 to go even before that. We were not
- 23 distressed. Mayor Connors had brought us out
- 24 of distressed status.
- 25 We had all received cost of living

1 raises. There was absolutely no reason for us

- 2 to pick up with another recovery plan except to
- 3 get rid of unionized employees in the city.
- 4 Excuse me. I am out of breath. From the
- 5 beginning, the mayor has violated the trust of
- 6 every citizen in the city. He violated it with
- 7 his recovery plan. He blamed the employees for
- 8 something that was not true that we were

- 10 He has raised your taxes and not
- 11 because he gave increases to unionized
- 12 employees but because of the increases to his

3 am a resident of the City of Scranton. I

4 really hadn't planned on speaking this evening,

5 but bear with me. I did notice the article in

6 the paper as I passed a machine because I won't

7 bother buying it. I thought it was rather

8 ironic how the mayor is telling what a

9 wonderful thing this is for the city, it's

10 marvelous.

11 Well, what about the 300 families

12 who hadn't got a cost of living pay raise since

13 2001? Does anybody care about them? Because

14 they care about everybody else because they are

15 the ones that are providing the public safety

16 protection for the residents of the city. They

17 own homes. The property taxes went up in the

18 county. The city raised them 25 percent. The

19 cost of the heating their homes have doubled.

20 Inflation has gone up.

21 Do you know what this decision did?

22 This decision caused every fire fighter and

23 every police officer a 26.2 percent pay

24 deduction -- pay reduction from what they were

25 earning in 2002 because of the way costs have

•

1 gone up in the city. Do any of you really

2 think that's something good for the city? Do

3 you really think as that rag would have you

4 think that it benefits anybody in this city to

5 do that to people who every day risks their

6 lives for each and everyone one of us? Is it
