ORDINANCE – AUTHORIZING AND APPROVING THE RIGHT OF WAY ACQUISITION OF A PORTION OF CITY –OWNED PROPERTY LOCATED ON THE 100 BLOCK OF HARRISON AVENUE (8,711 SQUARE FEET) IN THE CITY OF SCRANTON TO THE COMMONWEALTH OF PENNSYLVANIA, DEPARTMENT OF TRANSPORTATION (“PENNDOT”) AS PER PENNDOT’S OFFER TO PURCHASE AND SUMMARY OF JUST COMPENSATION AND TO AUTHORIZE THE MAYOR AND OTHER APPROPRIATE CITY OFFICIALS TO ENTER INTO AN AGREEMENT OF SALE TO PURCHASE SAID PROPERTY FOR THE SUM OF TWENTY-ONE THOUSAND FOUR HUNDRED DOLLARS (\$21,400.00) FOR THE PURPOSE OF REMOVING THE HARRISON AVENUE BRIDGE AND REPLACING THE HARRISON AVENUE BRIDGE.
