## NOTICE OF PROPOSED SUBSTANTIAL AMENDMENT EMERGENCY SOLUTION GRANT PROGRAM (ESG) 2014 ANNUAL ACTION PLAN

The City of Scranton received notice that the total allocation through the U. S. Department of Housing and Urban Development under the Emergency Solutions Grant Program (ESG) is in the amount of \$213,519.00 for 2014. Scranton through the Office of Economic and Community Development requested \$160,000.00. Since the total funding for the program exceeds by more than ten (10%) percent from the amount identified in the 2014 Action Plan the City of Scranton is required to do a Substantial Amendment to the 2014 Annual Action Plan. Fortunately, Scranton received an additional \$53,519.00 under the program to address the needs of homeless people in emergency or transitional shelters.

All written comments and/or questions must be received by the City of Scranton's Office of Economic and Community Development, Municipal Building, 340 North Washington Avenue, Scranton, Pennsylvania 18503 no later than Thursday, May 22, 2014. The telecommunication device for the hearing impaired may be accessed by calling 570/348-4233. Homeless individuals or previously homeless individuals are urged to comment in order to obtain their input in considering and making policies and decisions regarding the distribution of the Emergency Solution Grant Program to eligible sub-recipients. Substantial amendments to the City of Scranton's Action Plan can be made only after the public has been notified of the City's intent to modify it and after the 30 day comment period from the date of this publication to review and comment on the proposed substantial change to it. Only after both the U. S. Department of Housing and Urban Development (HUD) and the City of Scranton execute the grant agreement can the City of Scranton execute contracts with Sub-recipients and funds can be expended.

The original Ordinance was adopted on October 24, 2013 by Scranton City Council File of Council No. 47 - 2013 for the 2014 Action Plan that is effective January 1, 2014 and December 31, 2014.

The total allocation will be used on Street Outreach, Emergency Shelter, Homeless Prevention, Rapid Re-Housing and Administration for 2014.
