The successful bidder within ten (10) days notification of the award of the contract shall be required to furnish a performance bond and labor and materials bond in the amount of one hundred percent (100%) of the total contract price. The contract will be awarded to the lowest most responsible bidder; however, the City of Scranton reserves the right to reject any or all bids or any part of any bid and to waive any or all informalities in the bidding in connection with said project. Bidding shall be in compliance with Section 603 of the Administrative Code of the City of Scranton. The contract, when awarded, shall be subject to the Davis Bacon Prevailing Wage Act. All work shall start on or before March 13, 2017 and be complete by April 28, 2017. The successful bidder shall be an equal opportunity employer.
